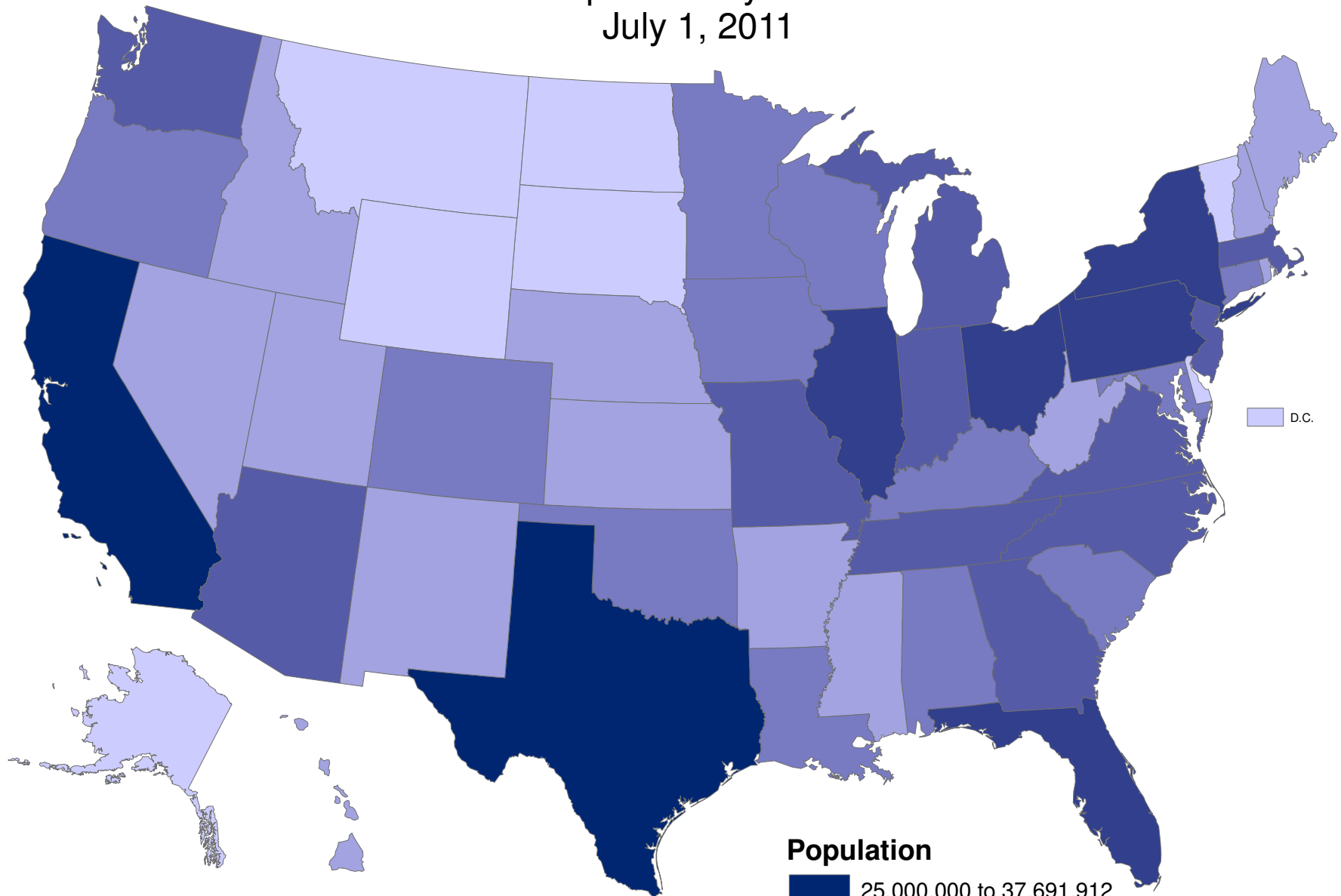

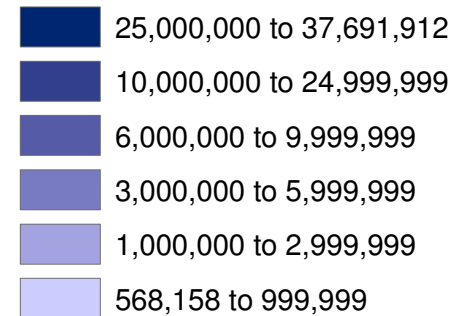

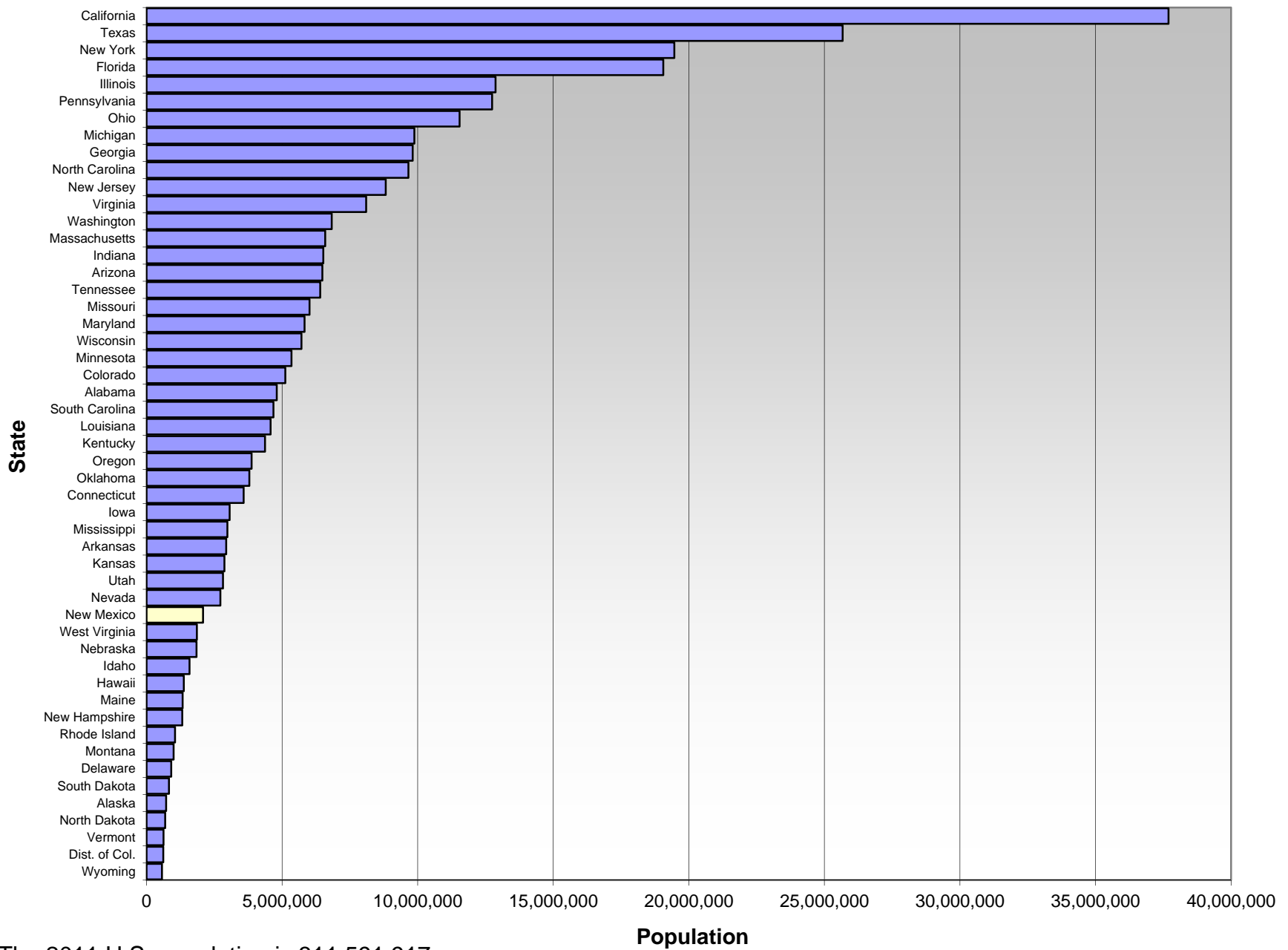

Population by State: July 1, 2011

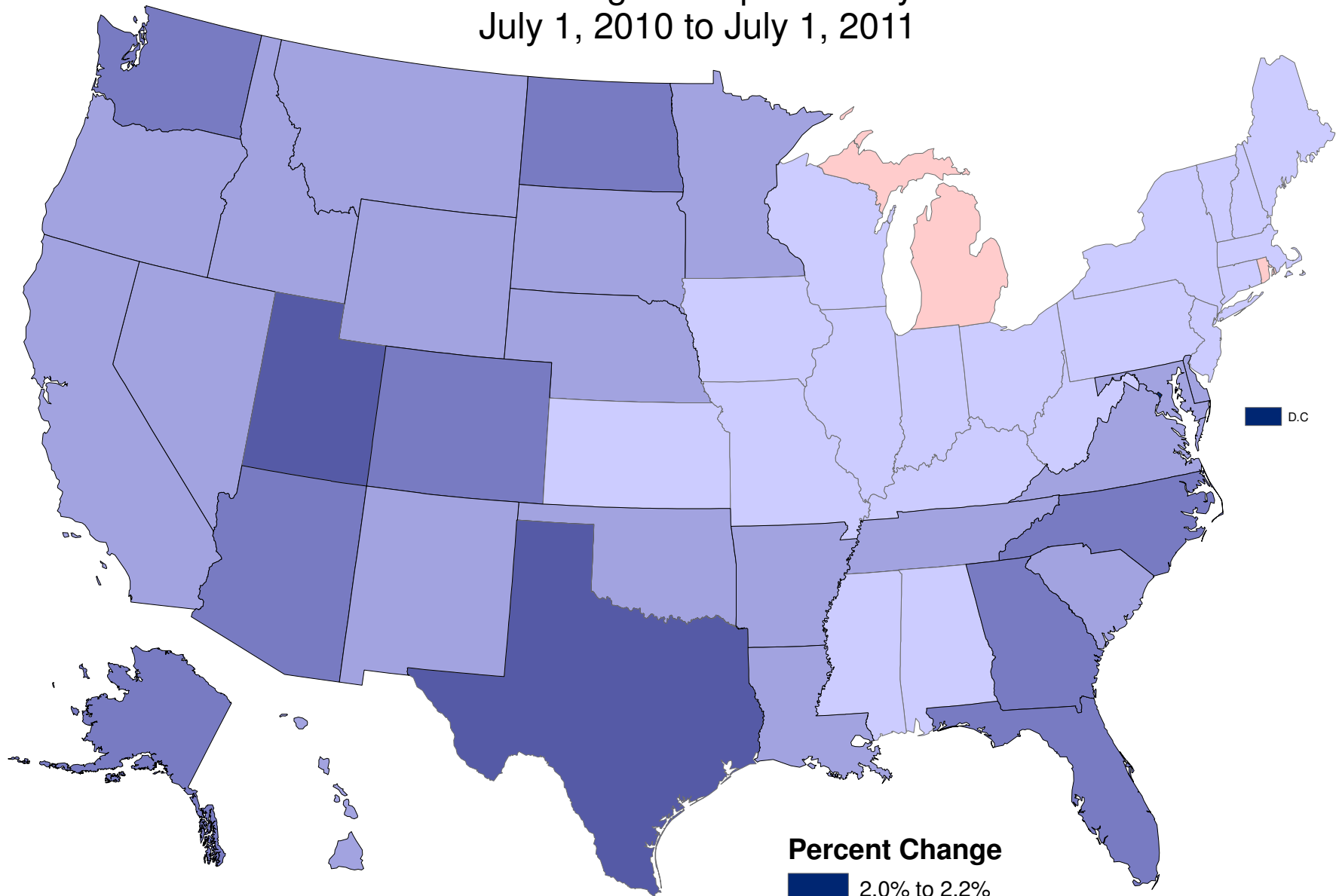

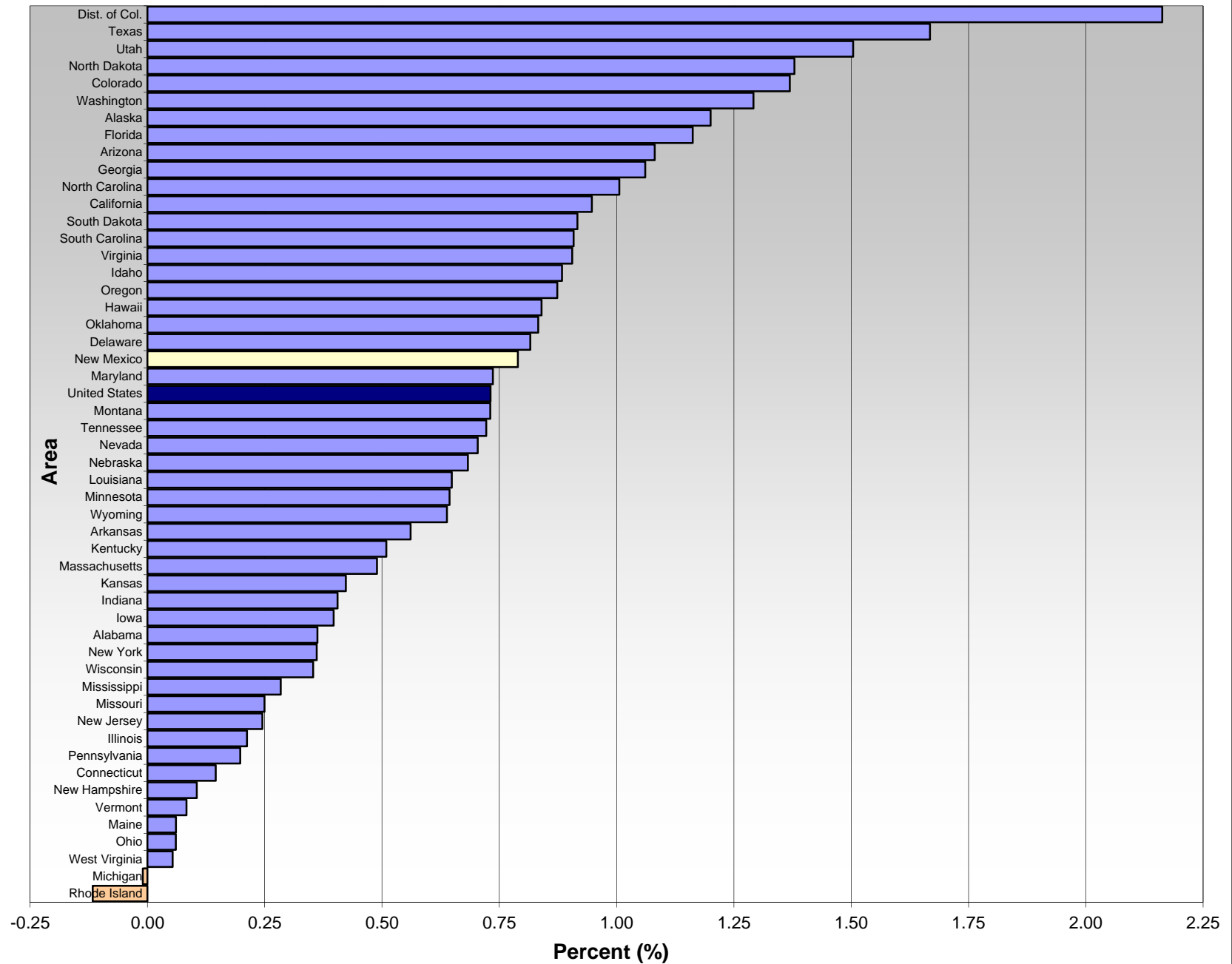
Percent Change in Population by State July 1, 2010 to July 1, 2011

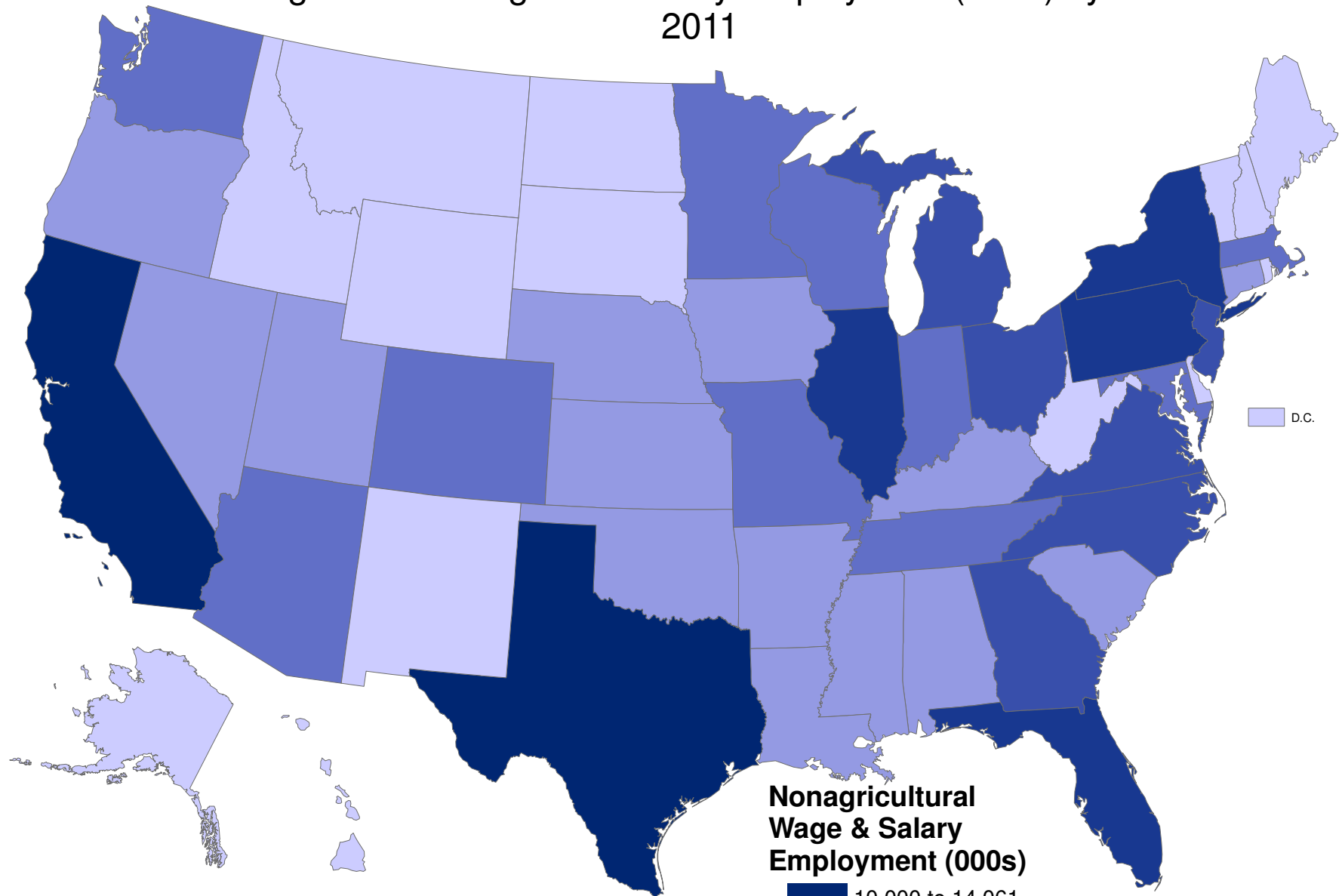
Percent Change in Population by State: July 1, 2010 to July 1, 2011



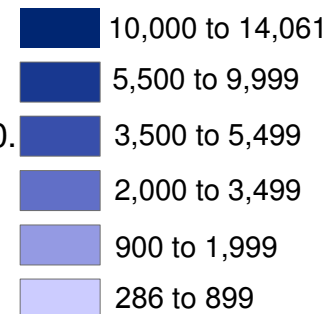

Nonagricultural Wage and Salary Employment (000s) by State 2011



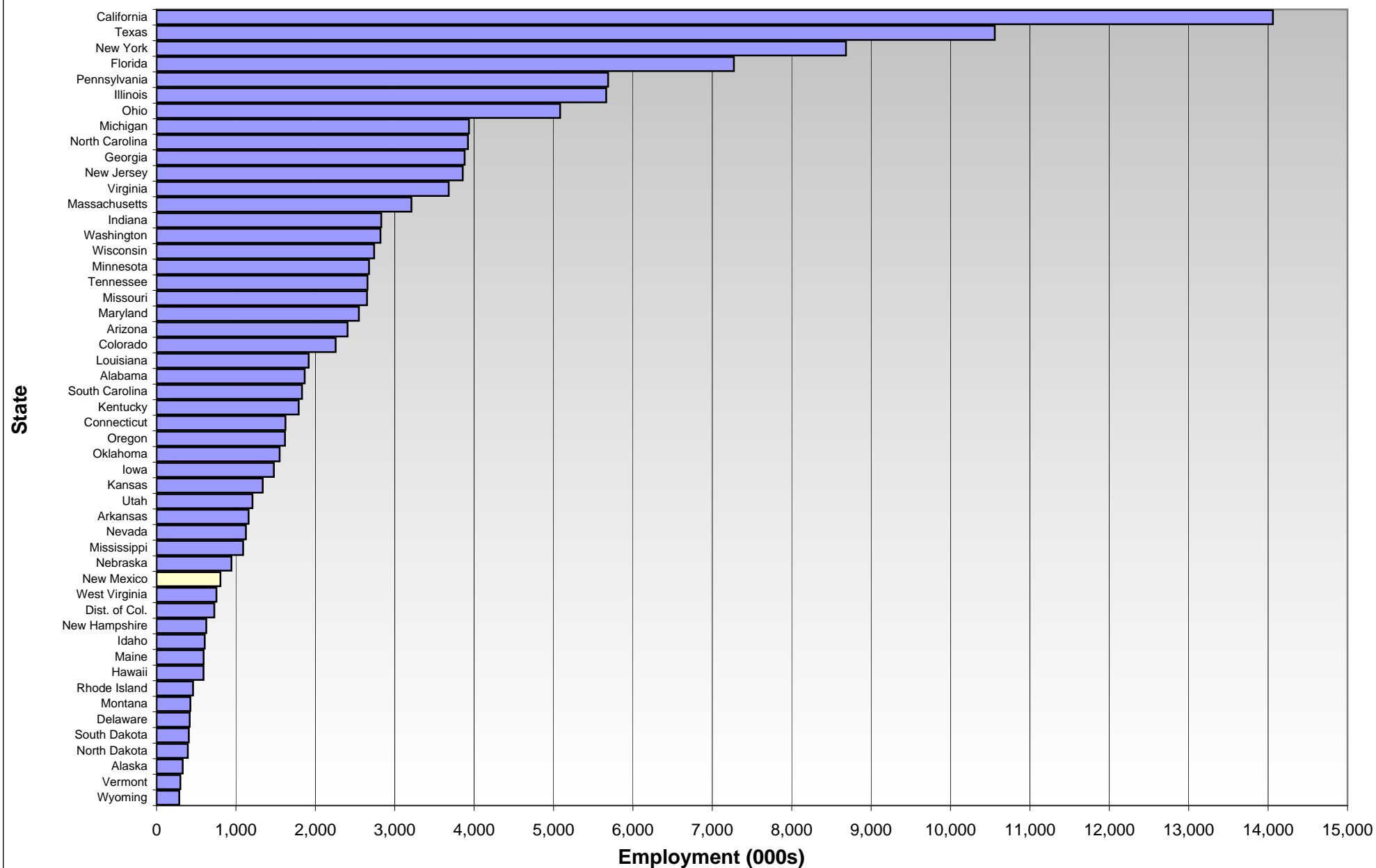

Nonagricultural Wage and Salary Employment (000s) by State: 2011

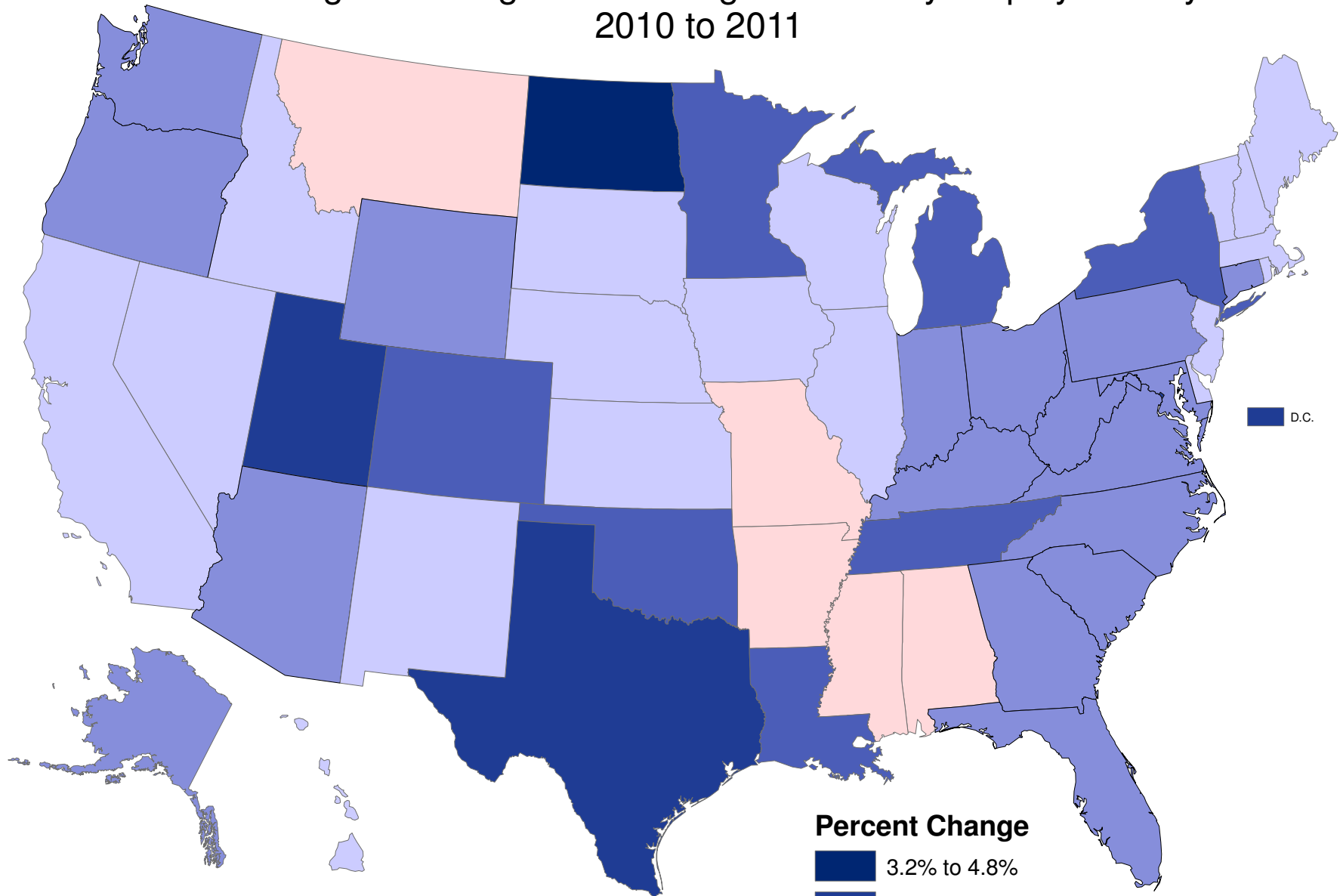

Percent Change in Nonagricultural Wage and Salary Employment by State 2010 to 2011



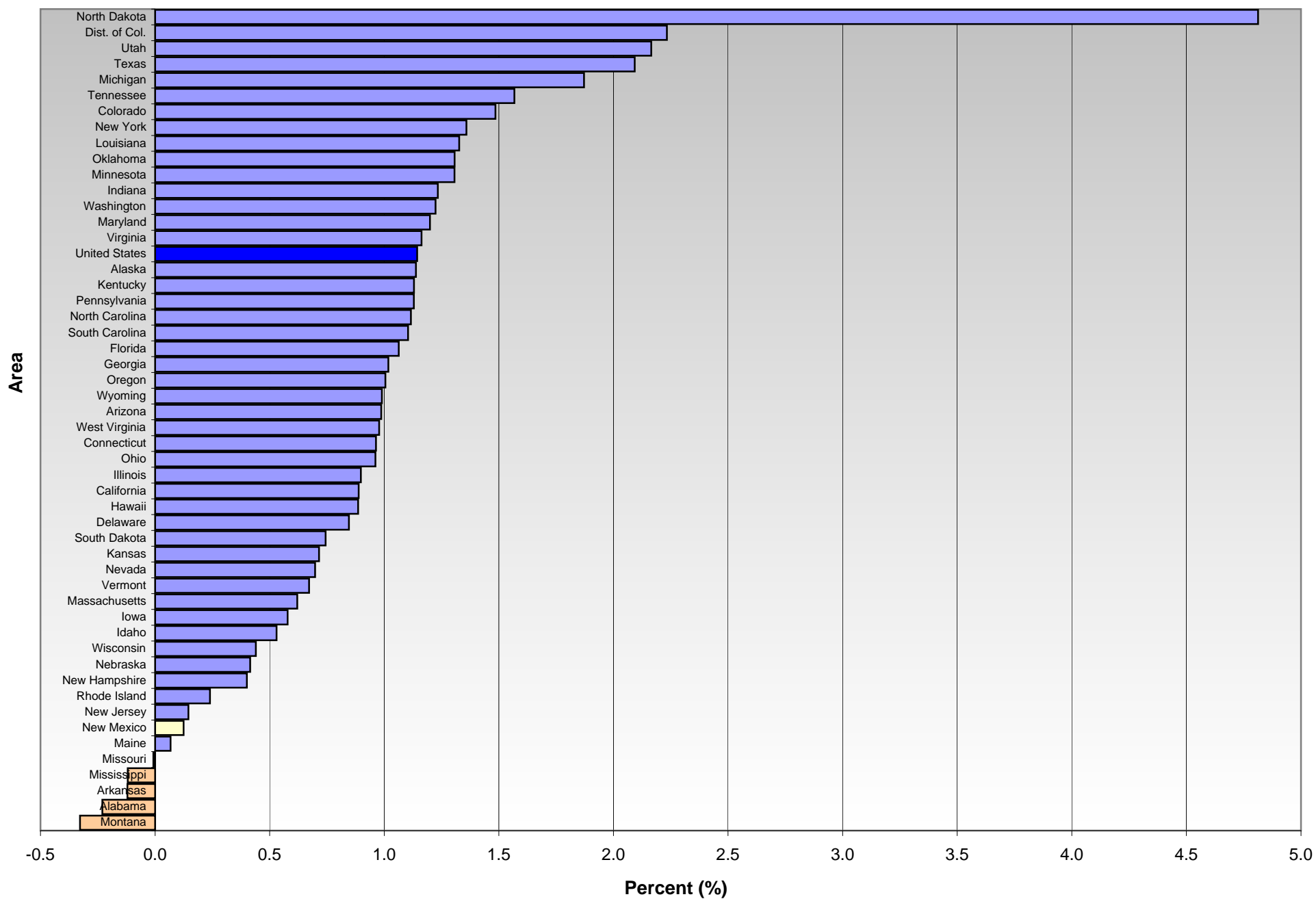

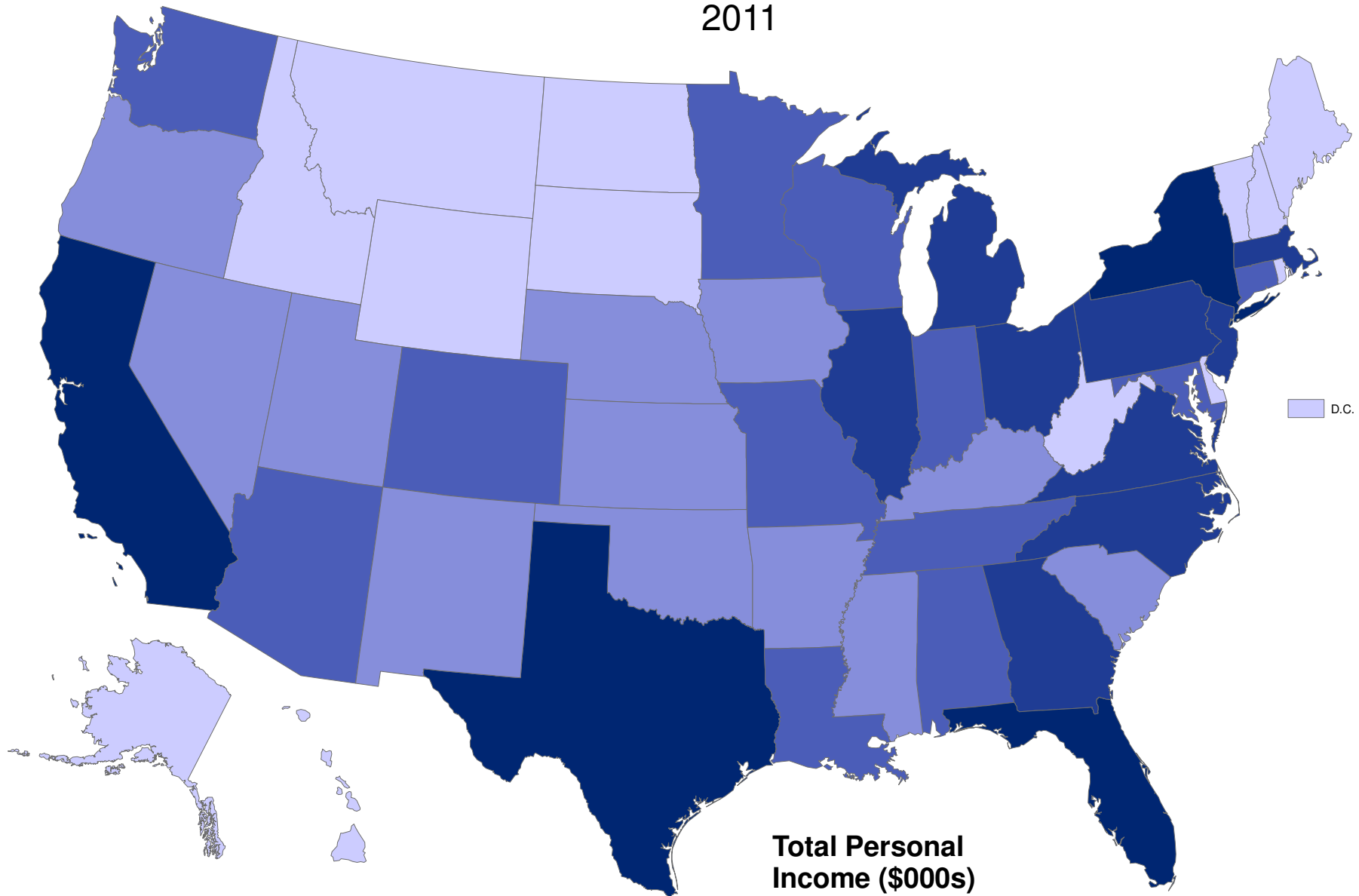
Percent Change in Nonagricultural Wage and Salary Employment by State: 2010 to 2011



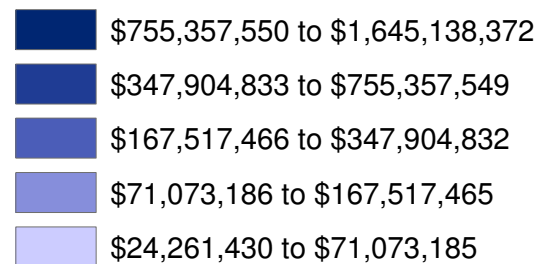

Total Personal Income (\$000s) by State 2011



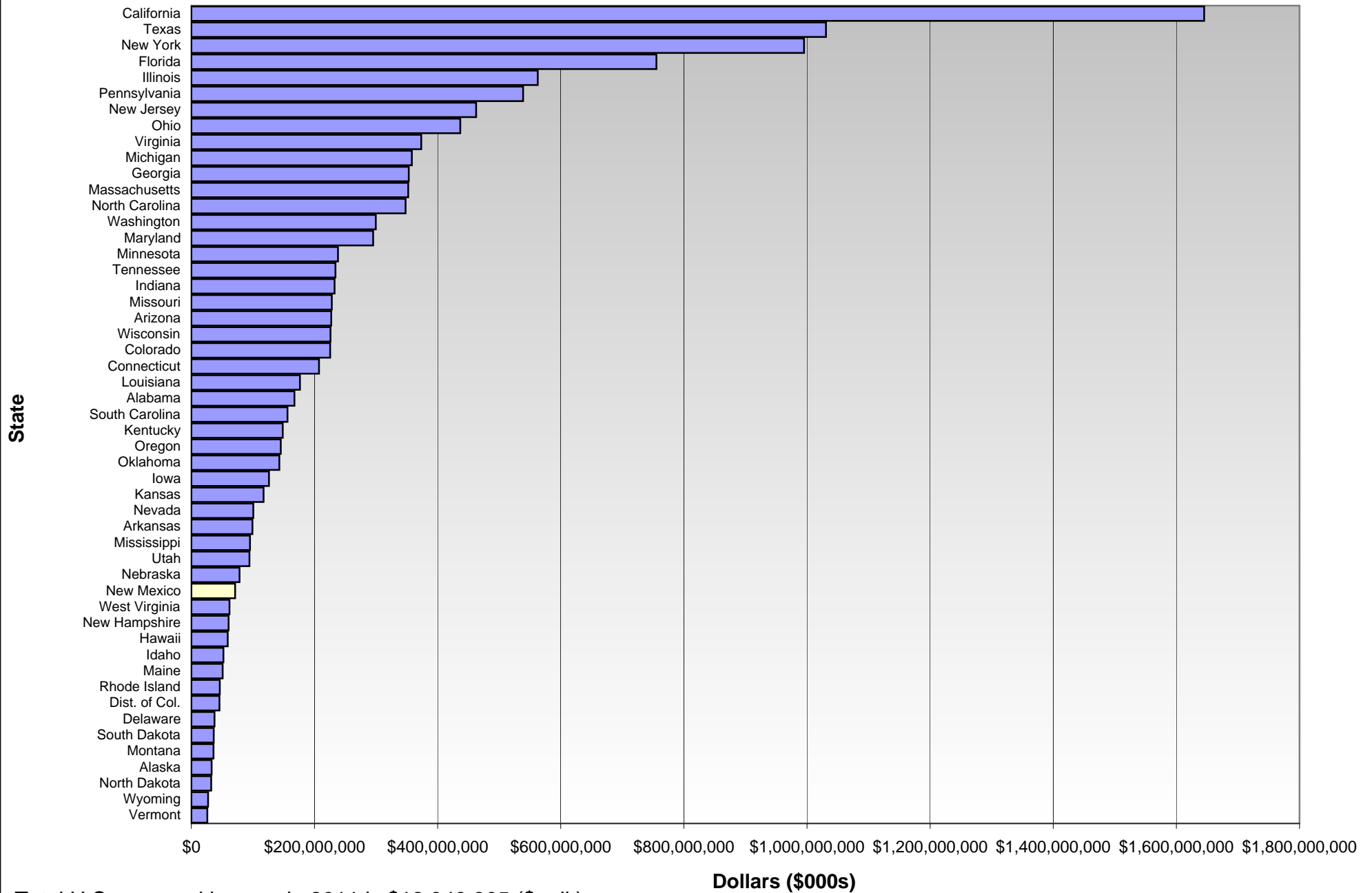

Total Personal Income (\$000s) by State: 2011

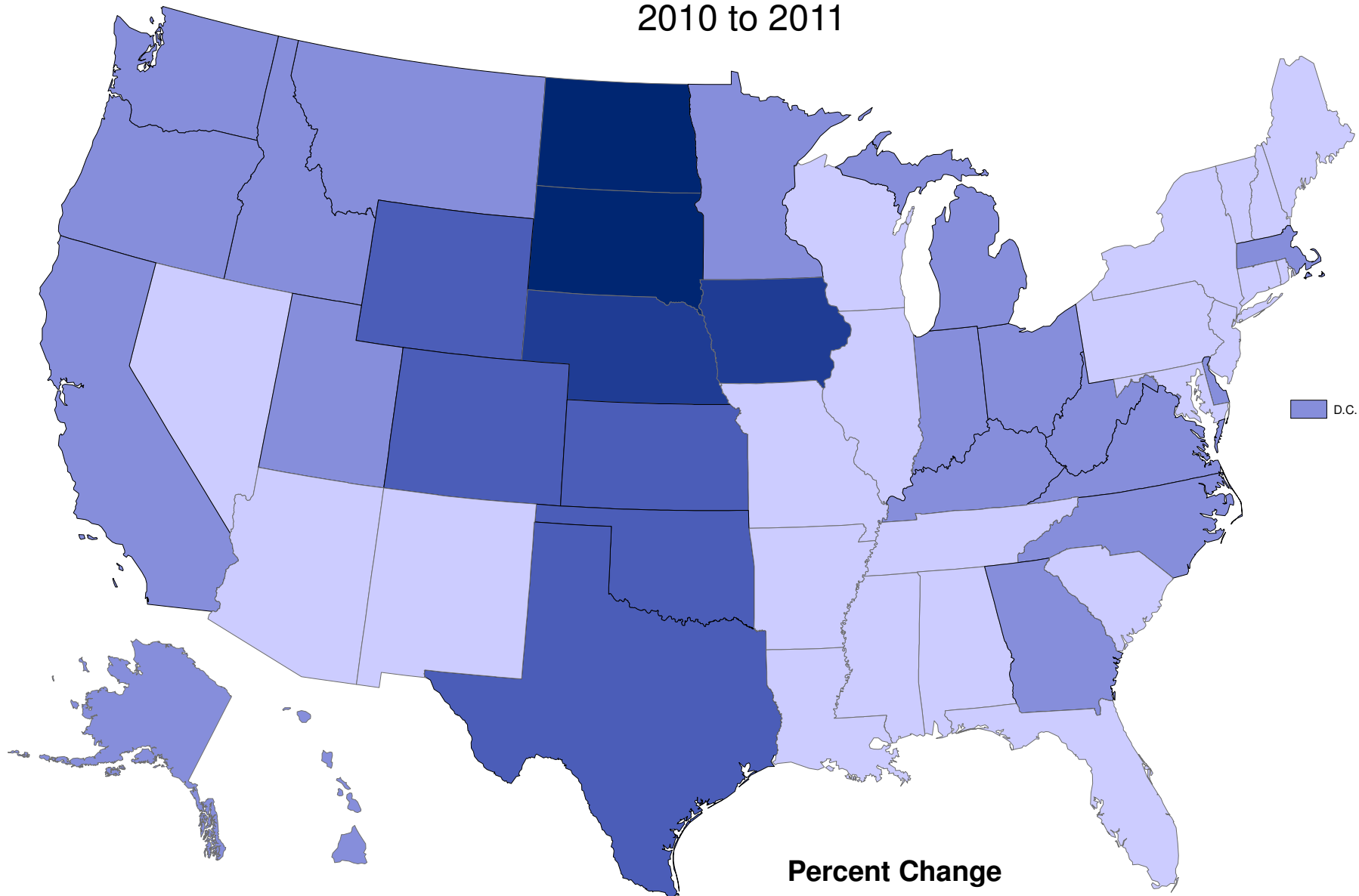

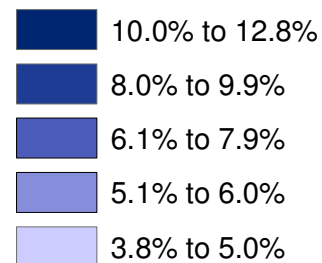
Percent Change in Total Personal Income by State 2010 to 2011



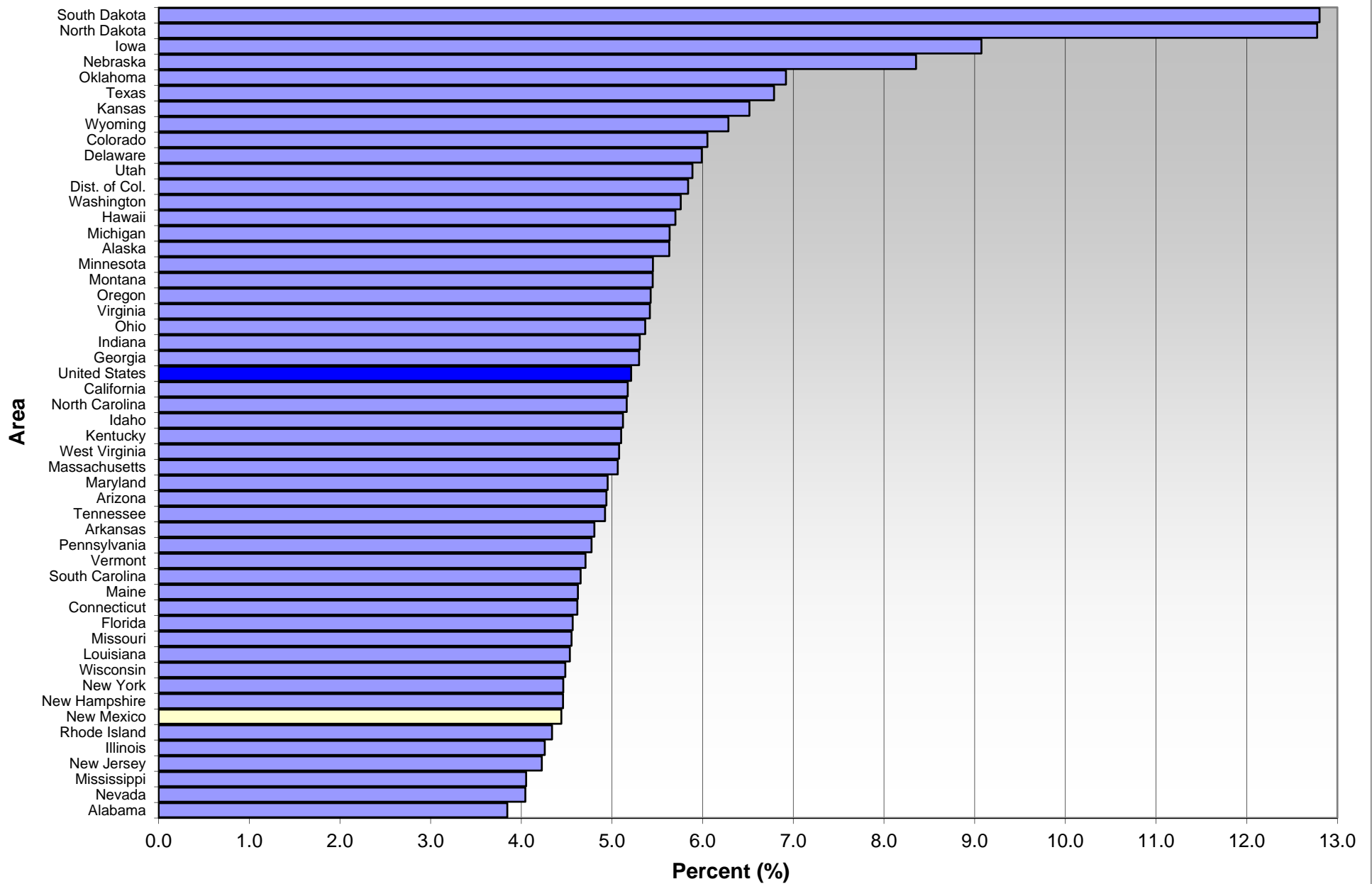

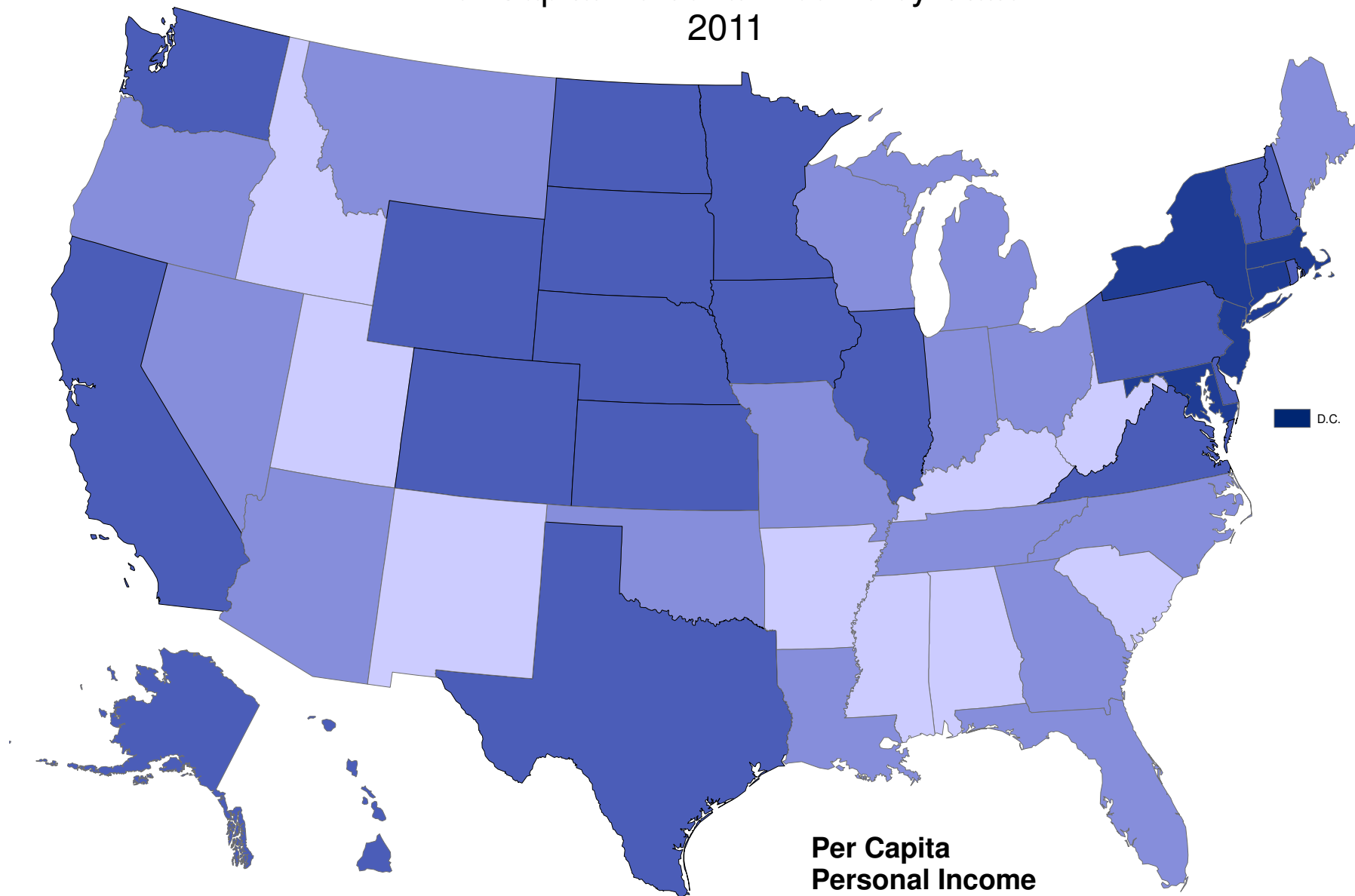
Percent Change in Total Personal Income by State: 2010 to 2011

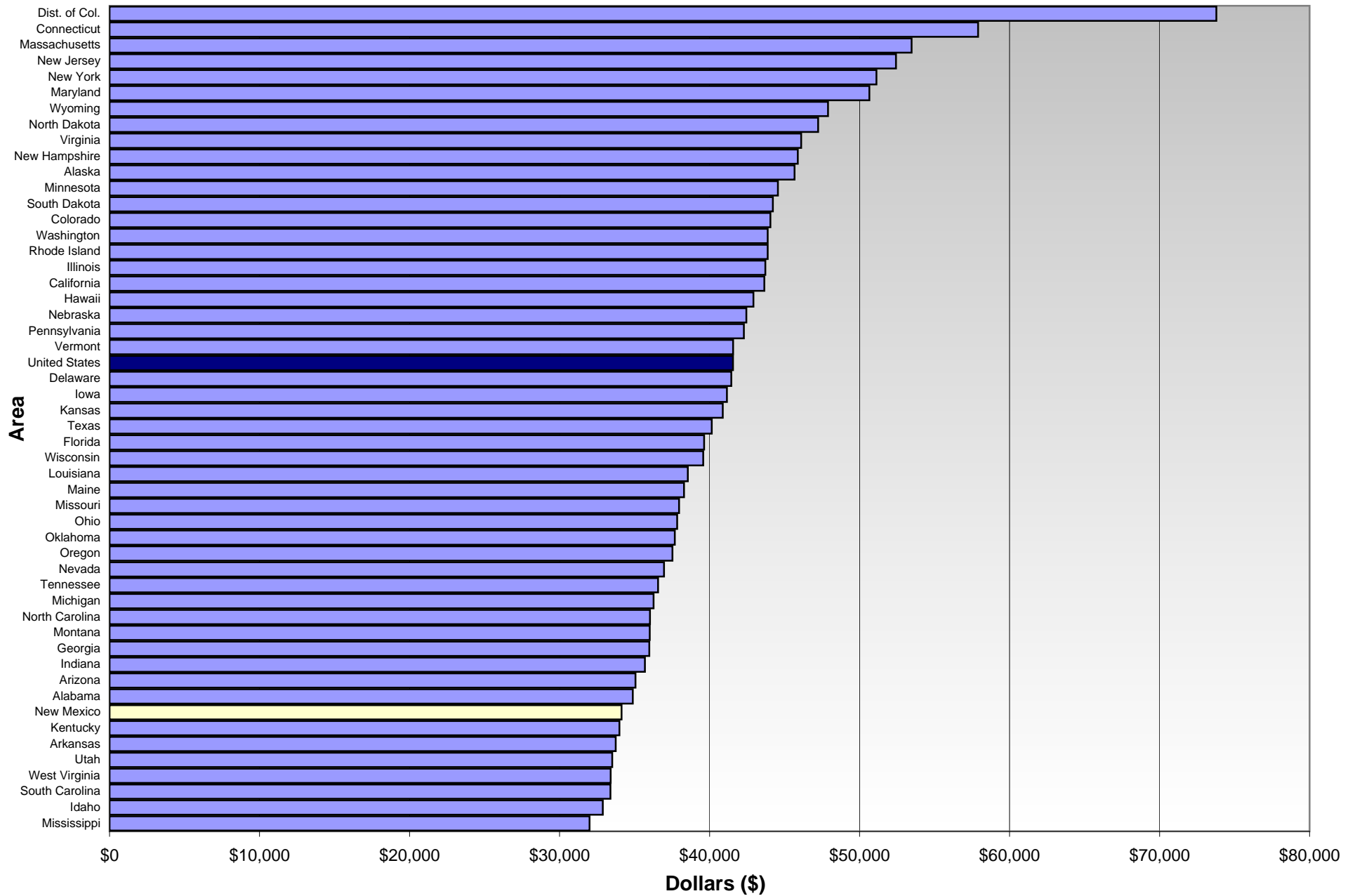
Per Capita Personal Income by State 2011

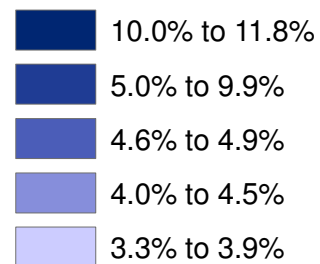

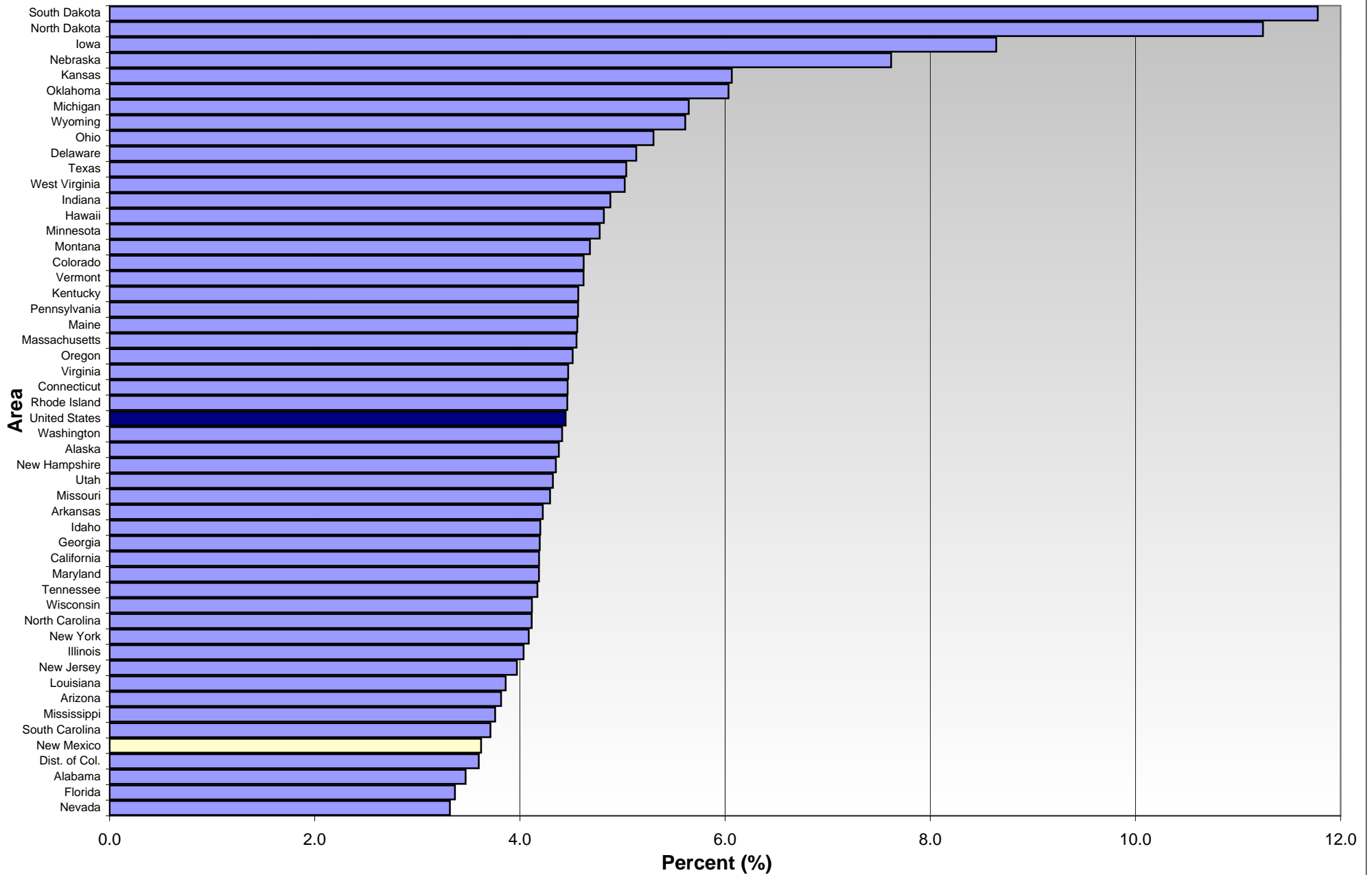

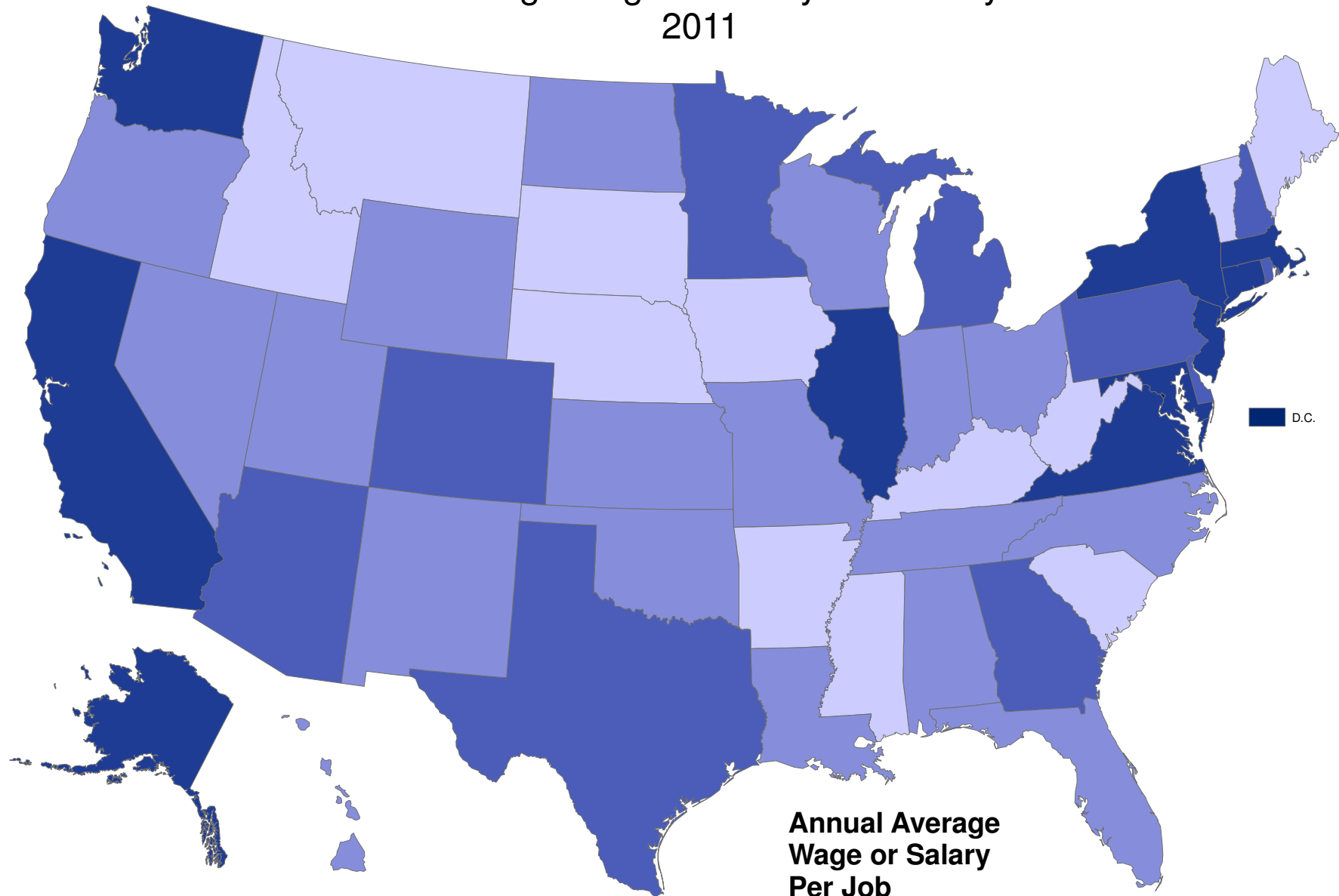
Percent Change in Per Capita Personal Income by State: 2010 to 2011



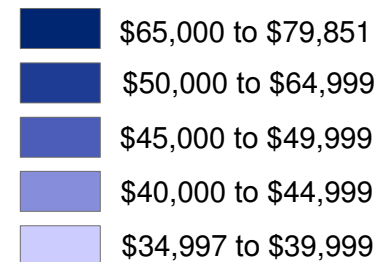

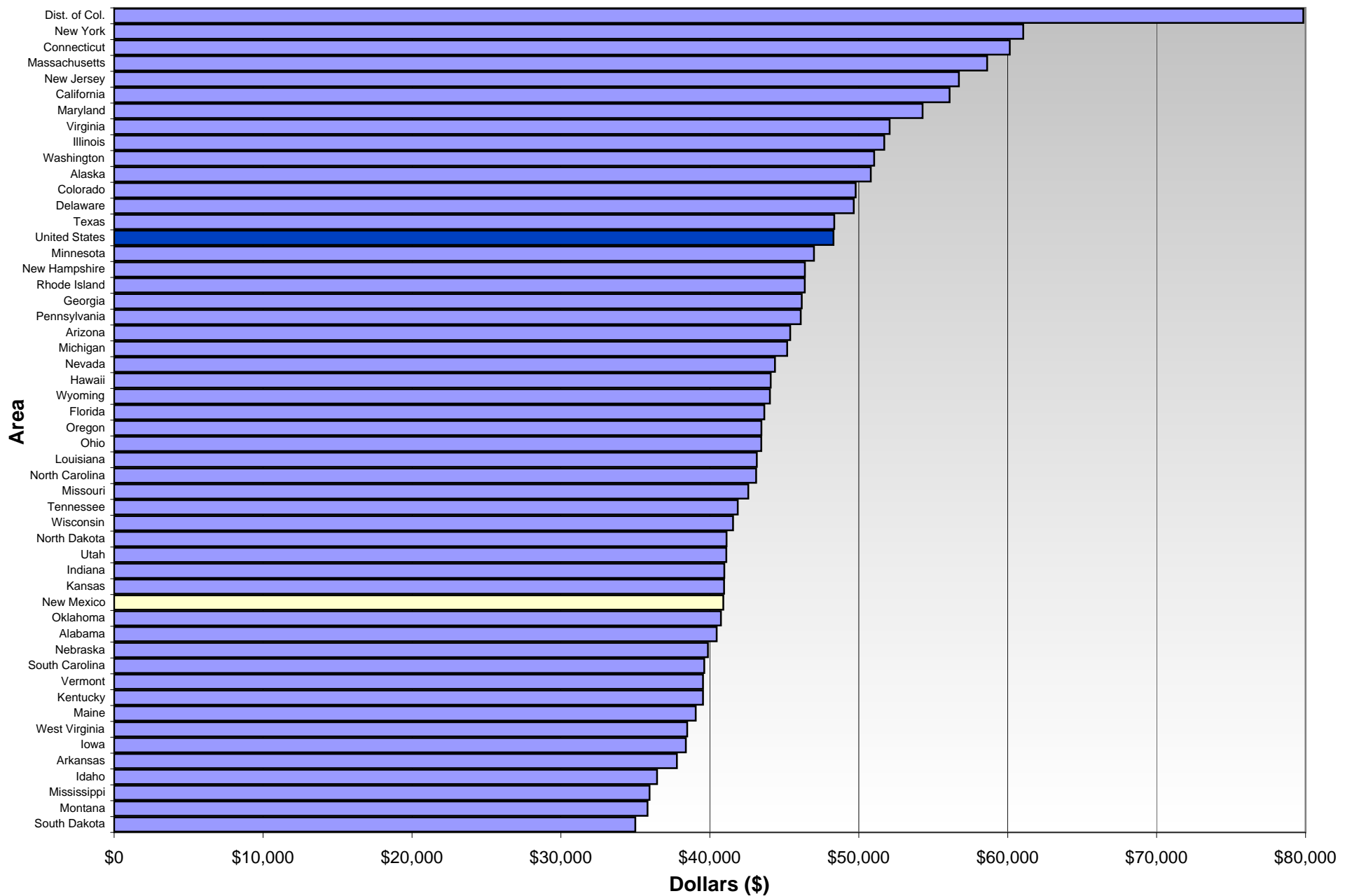

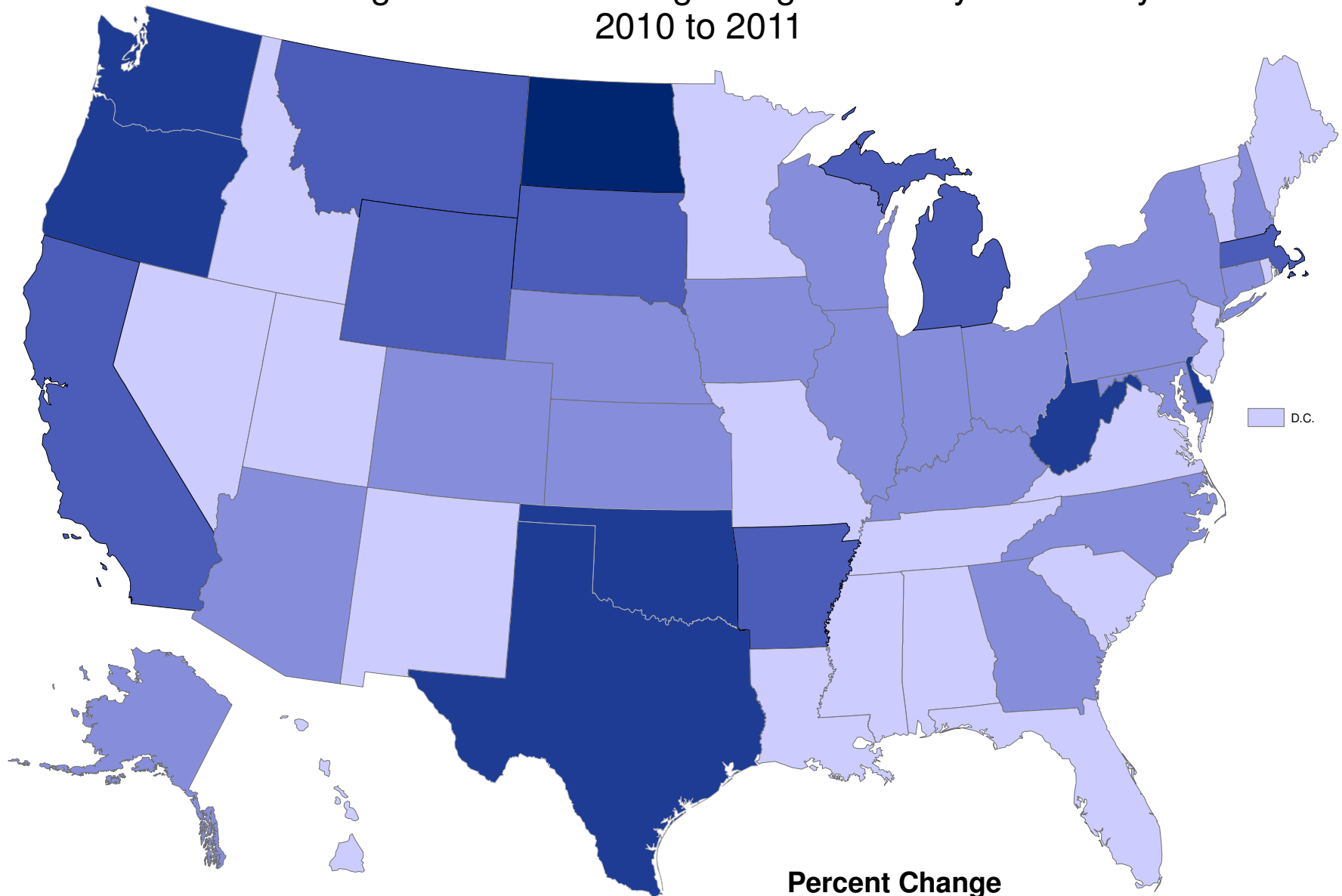
Annual Average Wage or Salary per Job by State: 2011



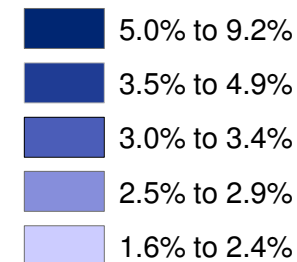

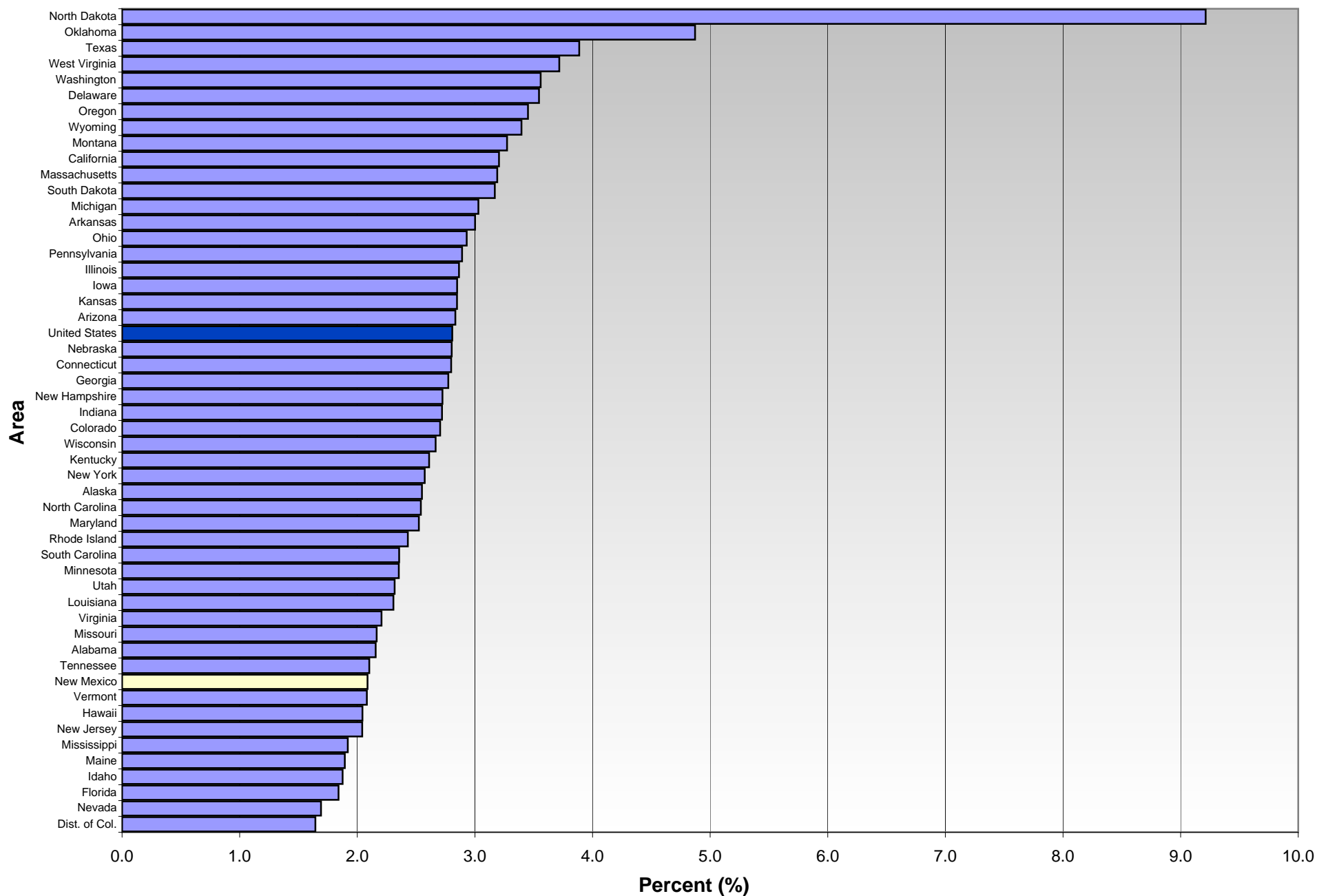

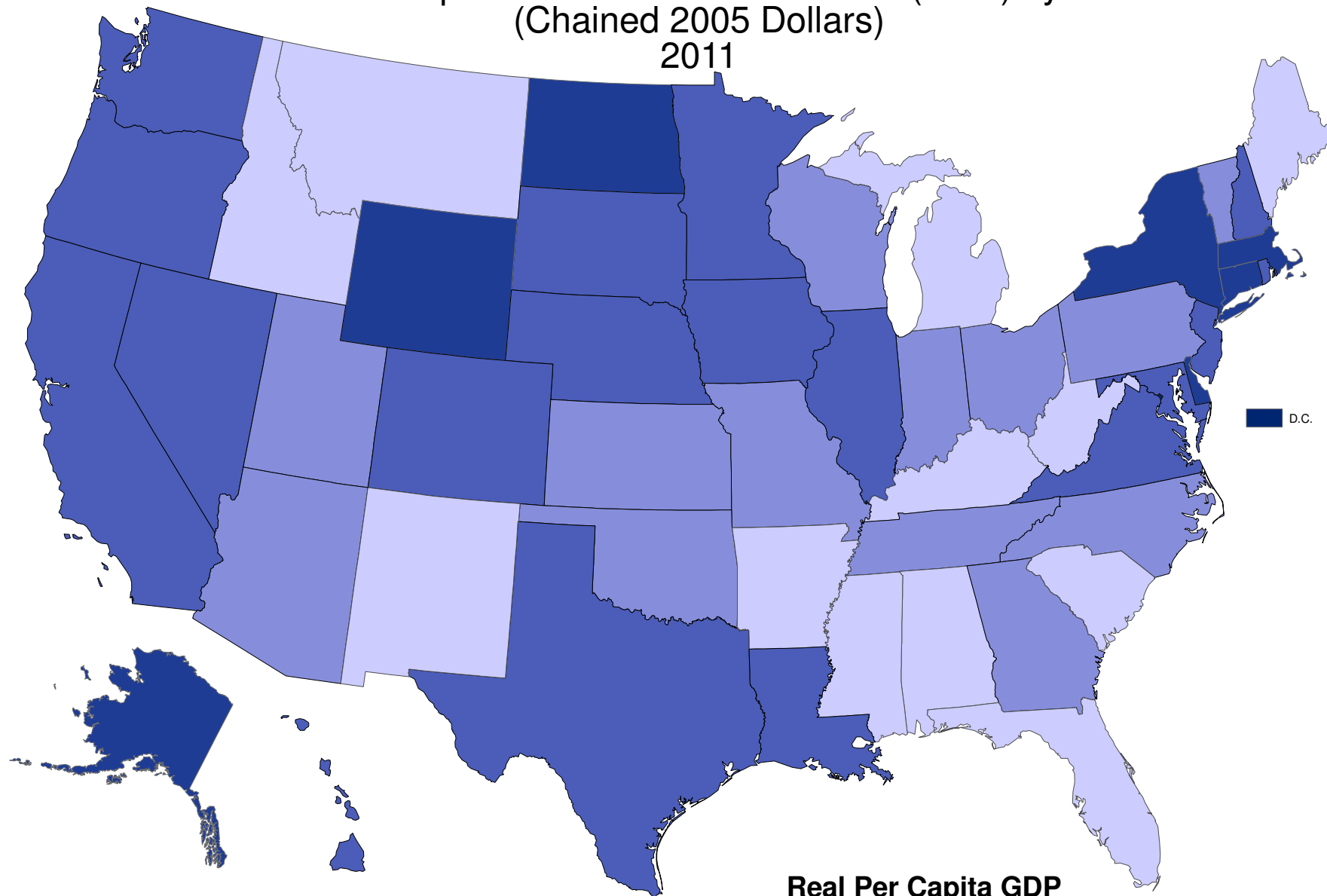
Percent Change in Annual Average Wage or Salary per Job by State: 2010 to 2011

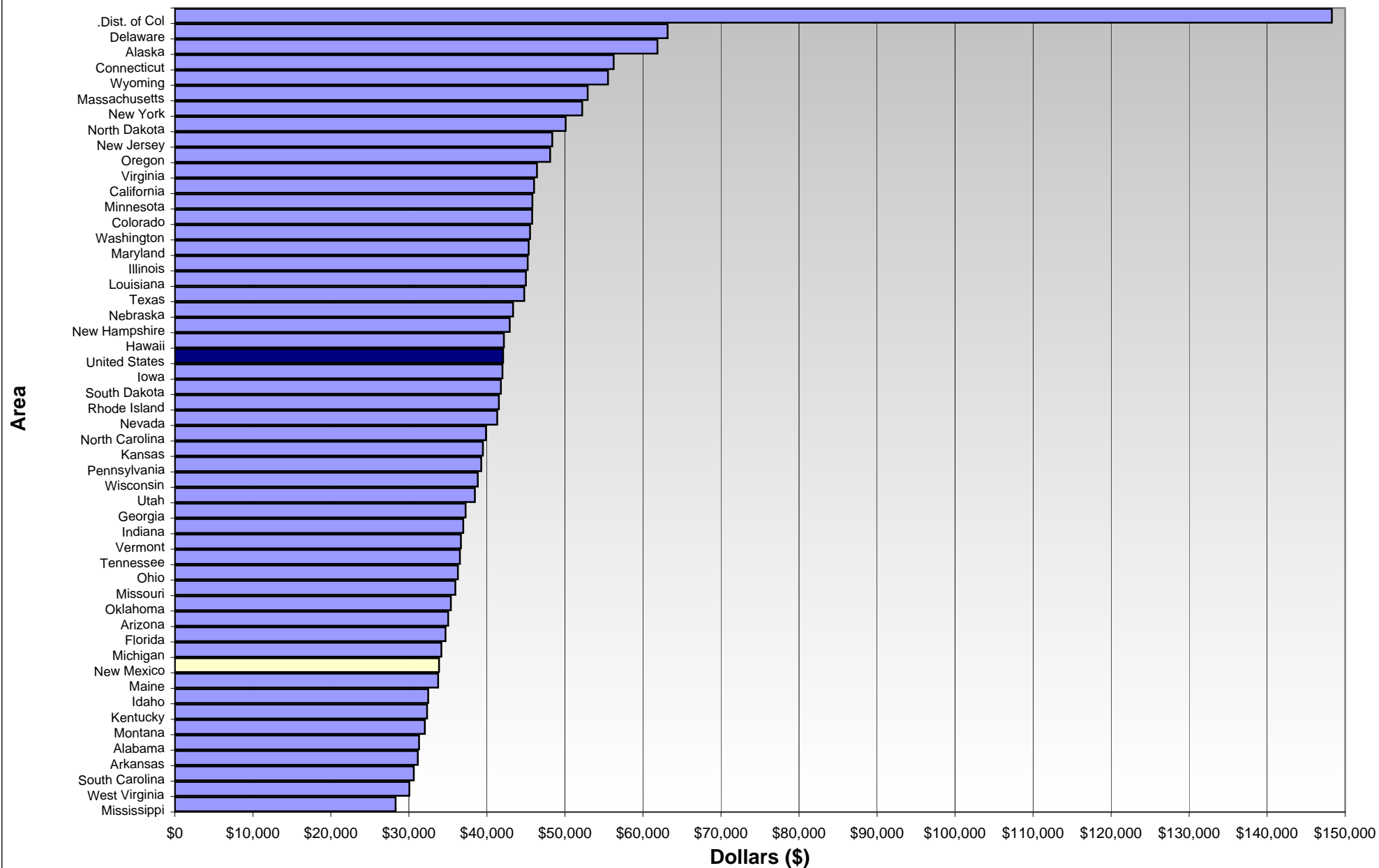
Real Per Capita Gross Domestic Product (GDP) by State (Chained 2005 Dollars) 2011

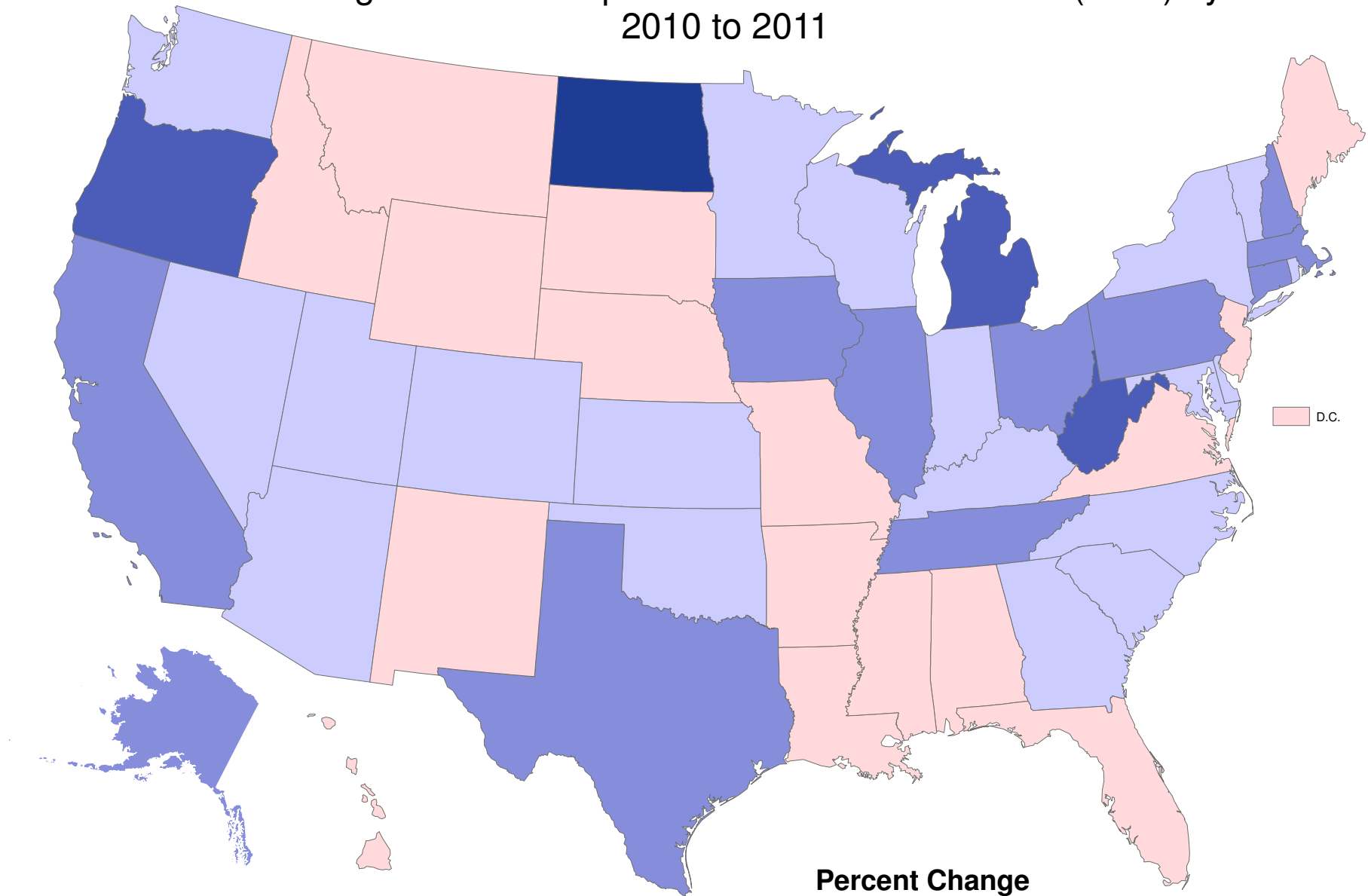
Real Per Capita Gross Domestic Product (GDP) by State: 2011 (Chained 2005 Dollars)



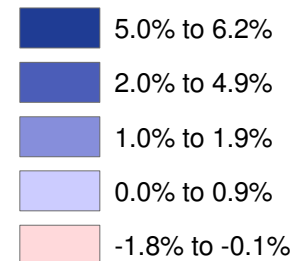

Percent Change Real Per Capita Gross Domestic Product (GDP) by State 2010 to 2011



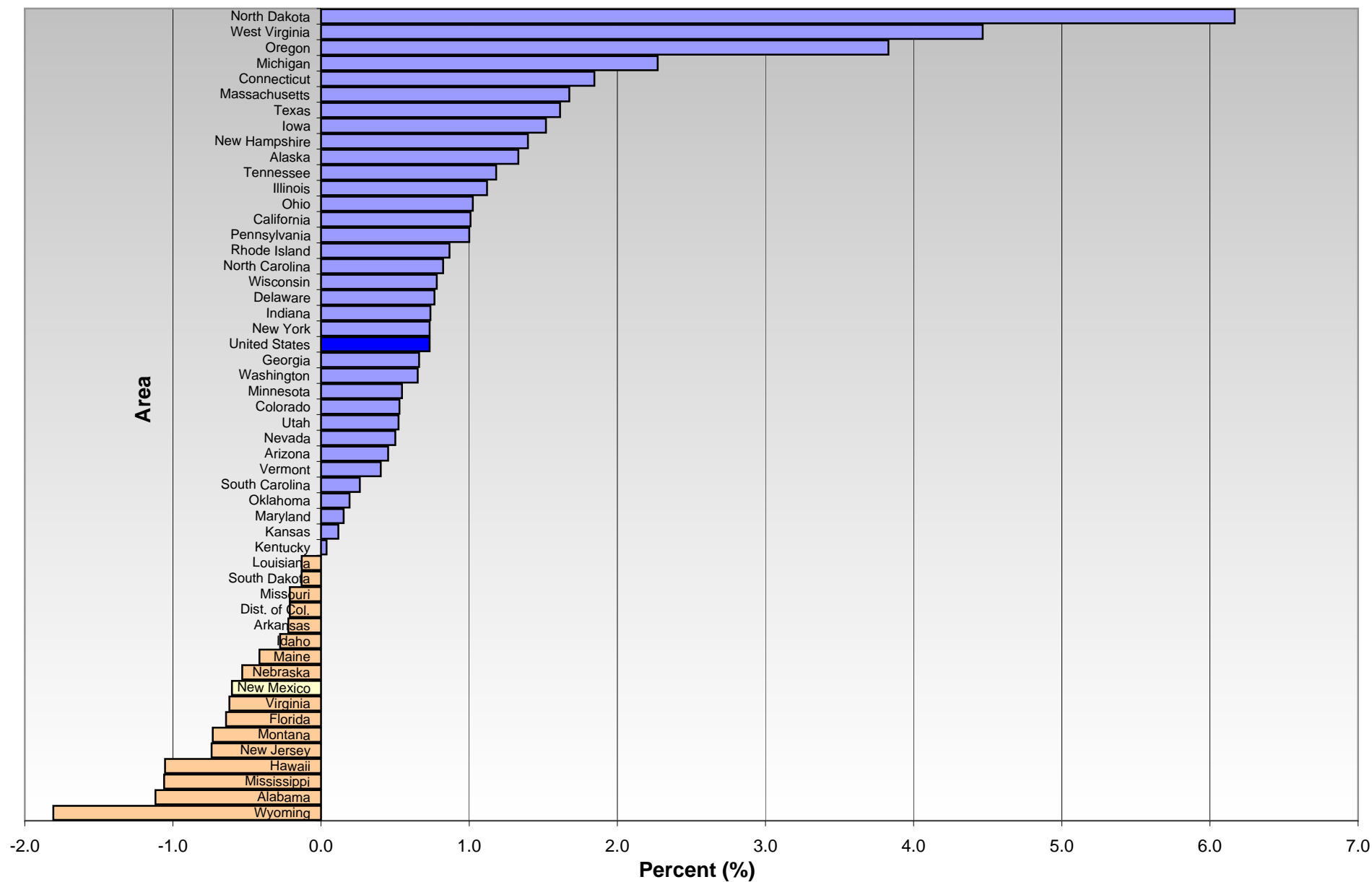

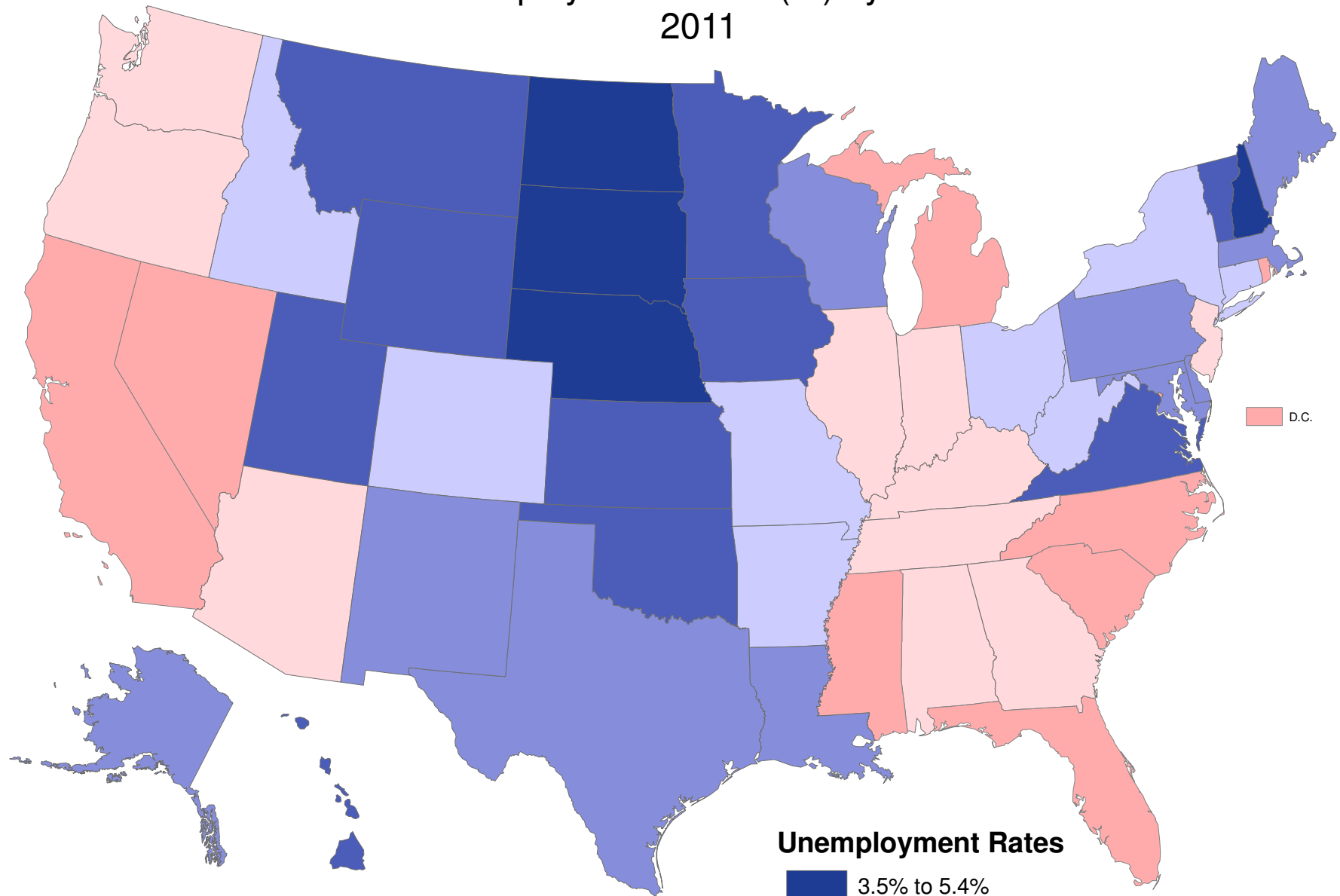
Percent Change in Real Per Capita Gross Domestic Product (GDP) by State 2010 to 2011

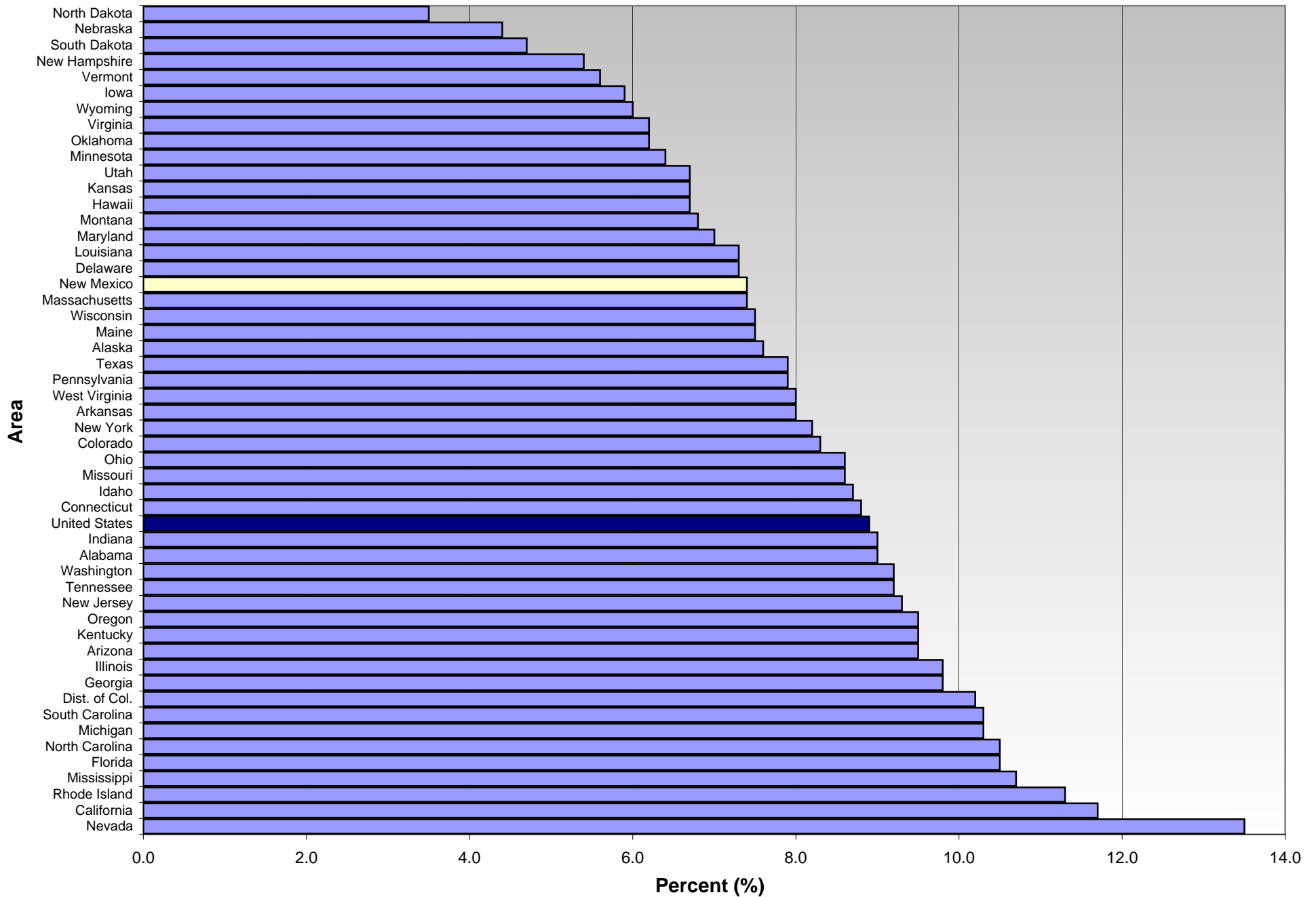
Unemployment Rates (%) by State 2011

Glossary

Annual Average Wage/Salary per Job – Average wage and salary disbursements are total wage and salary disbursements divided by the number of wage and salary jobs (total wage and salary employment). Wage and salary disbursements consists of the monetary remuneration of employees, including the compensation of corporate officers; commissions, tips, and bonuses; and receipts in kind, or pay-in-kind, such as the meals furnished to the employees of restaurants. It reflects the amount of payments disbursed, but not necessarily earned during the year.

Civilian Labor Force - The civilian labor force is the total labor force, excluding persons in the Armed Forces. The civilian labor force consists of both employed and unemployed persons 16 years of age and older.

Employed - Employed persons are those individuals, 16 years of age and older, who did any work at all during the survey week as paid employees, or in their own business, profession or farm, or who worked 15 hours or more as unpaid workers in a family operated business. Also counted as employed are those persons who had jobs or businesses from which they were temporarily absent because of illness, bad weather, vacation, labor-management dispute, or personal reasons. Individuals are counted only once even though they may hold more than one job. Employment figures relate to place of residence, and not to place of work. Persons in the Armed Forces are excluded.

Unemployed - Persons 16 years and over who had no employment during the reference week, were available for work, except for temporary illness, and had made specific efforts to find employment sometime during the 4-week period ending with the reference week. Persons who were waiting to be recalled to a job from which they had been laid off need not have been looking for work to be classified as unemployed.

Nonagricultural Wage and Salary Employment (Jobs) - Nonagricultural wage and salary jobs refers only to employees on establishment payrolls during the survey week in each month and excludes self-employed persons, unpaid family workers, domestic workers, agricultural workers, the Armed Forces, and workers involved in labor-management disputes. Nonagricultural wage and salary employment figures relate to place of work of the workers and not to their place of residence. The payroll records may count a person more than once to the extent that multiple job holding exists during the payroll period. In addition, the payroll data include commuters who live outside the labor area, but not commuters who work outside the area.

Per Capita Personal Income – Per capita personal income is the total personal income of an area divided by the resident population.

Personal Income – Personal income data are by place of residence. Total income includes income received by persons from all sources. It includes income received from participation in production as well as from government and business transfer payments (such as, Social Security benefit payments and Medicaid payments to health care providers on behalf of low income persons). It is the sum of compensation of employees (received), supplements to wages and salaries, proprietors' income with inventory valuation adjustment (IVA) and capital consumption adjustment, rental income of persons, personal income receipts on assets, and personal current transfer receipts, less contributions for government social insurance.

Population – Total population is the mid-year estimate of all persons residing in the state.

Real Per Capita Gross Domestic Product (GDP) by State – GDP by state is the value added in production by the labor and capital located in a state. GDP for a state is derived as the sum of the GDP originating in all industries in the state. In concept, an industry's GDP, referred to as its "value added", is equivalent to its gross output (sales or receipts and other operating income, commodity taxes, and inventory change) minus its intermediate inputs (consumption of goods and services purchased from other U.S. industries or imported). *Real GDP* is an inflation-adjusted measure of each state's gross product that is based on national prices for the goods and services produced within the state. *Per capita real GDP* is calculated by dividing the real GDP for a state by the resident population of the state. In its calculation, the Bureau of Economic Analysis uses the Census Bureau's annual mid-year population estimate.

Unemployment Rate - The unemployment rate is the number of unemployed persons residing in an area expressed as a percent of the area's civilian labor force.
