HOUSE BILL 2, which funds state government, public and higher education, was approved by the New Mexico House of Representatives earlier this week and now goes to the NM Senate. As passed by the House, the budget bill had a compensation increase of 5 percent for both faculty and staff, with an additional .75 percent for retirement. The bill, in its current state, also features zero tuition credit and an increase in building renewal and replacement from 40 to 70 percent.
