**Question:** I need to drop a management course after the published deadlines. I already talked to my instructor and he's going to give me a WP. What do I need to do now?

**Answer:** Pick up a yellow card at the Advisement Center. Fill in your information, write your phone number on the back of the card, and bring it to your instructor. Bring the card back to Advisement for the Assistant Dean to sign; this typically takes 24-48 hours and one of the Advisement staff will call you when you can pick up the card. Please be advised that the Assistant Dean will not sign the card if it has not been signed by your instructor first. Take the signed card to Records and Registration and they will drop you from the course.
