# Anderson Scholarships and Fellowships



### ANDERSON'S WEEKLY CAREER TIP

#### THE HIDDEN JOB MARKET:

TAP INTO JOBS THAT AREN'T PUBLICLY POSTED There are THREE ways jobs are found and if you understand how effective each one is you will know where to appropriately spend your time.

• THE APPLICANT POOL- A person leaves a job or a new position has been opened. The company posts the opening publicly; in the newspaper, in professional journals, on the web, etc. This is considered by many as the only way to find a job but this is not the fact. A review of the candidates occurs, then selection of interviewees and after the interviews an offer is extended to the "best" candidate. SUCCESS: 25% OF JOBS ARE FILLED THIS WAY.

• THE CREATED POSITION- Either a hiring manager or a job seeker identifies the need for a new position. A proposal is created by either party and the job is written around the skills of the job seeker. SUCCESS: 5% OF JOBS ARE FILLED THIS WAY.

• THE NETWORKED JOB SEEKER- The job seeker identifies the companies he/she would like to work for, targets their network to find out and make contact with the hiring managers of the organizations BEFORE an appropriate opening becomes available. If allowed, many hiring managers will bypass the applicant pool process and hire the proactive candidate. In other situations, they may go through the applicant pool process but the proactive candidate will usually have an advantage over the other candidates because they have made contact or developed a relationship with that hiring manager. SUCCESS: 70% OF JOBS ARE FILLED THIS WAY.
