CONCLUDING REMARKS DEAN LEO M. ROMERO*

It is my pleasure to present the concluding remarks at the close of the Second Annual Conference of the United States-Mexico Law Institute. I think it is important to note that this Institute represents the cooperative efforts of the University of New Mexico School of Law and the Mexican Law Committee of the Section on International Law of the American Bar Association. The United States-Mexico Law Institute also welcomes to this conference the participation of the Asociación Nacional de Abogados de Empresa. It appears to me, talking to a number of individuals here, that the Second Annual Conference is a success. There are approximately one hundred and twenty people attending the conference; of that number, about twenty-five are Mexican lawyers. Plans for the third conference will begin immediately.
