Helpful Facility Search Information:

- From the ECHO home page, choose "Advanced Tools" icon.
- Choose "Advanced Facility Search" in the pop-up window for advanced tools.
- Choose "Water" for "Choose a Search Type".
- Choose "Industrial Stormwater' for "Choose a Water Program Area".
- Scroll down to the "Facilities Characteristics" window.
- Choose "Contains Each Term" under "Find Facility Name(s) That:".
- Enter Facility Name: <u>Sandia National Laboratories</u> [The facility name may disappear immediately after entering. Note that it has been added to the "Search Criteria Selected" window].
- Enter Facility ID Number: <u>NMR053122</u>
- In the "Search Criteria Selected" window on the left side of screen, choose "Data Table" for "Results View", then click "Search".
- On the next webpage, in the "Facility Search Results" window, click on the red icon with a "C" under the "Reports" column in the Sandia National Laboratories row.
- On the next webpage, in the "Detailed Facility Report" window, in the list under "Related Reports", click on "CWA Effluent Charts" at the small purple icon with an "E".
- Select Permit Number: NMR053122
- On the next webpage, in the "Effluent Charts" window, next to "Specify Date Range" select the desired Date Range for the data¹.
- Click "Download All Data" at the top of the table (with the down arrow).
- Choose format/program and download the worksheet showing all data on the DMR for that Permit ID.

¹ Date ranges for Sandia National Laboratories monitoring periods are: July 1st – July 31st, August 1st – August 31st, September 1st – September 30th, October 1st – October 31st.
