Vice President Liu called the meeting to order at 6:01 PM. Senator Crawley moved to approve the agenda, seconded by Senator Ladha, passing 18-0-0. Senator Hudson moved to amend the agenda to include Joint Resolution 10S, seconded by Senator Crawley, passing 18-0-0. Senator Bui moved to dissolve the Senate and moved into committee as a whole, seconded by Senator Liu. Senator Hudson requested a personal privilege to preside over the committee as a whole.

The committee as a whole then moved on to Bill 8S. Senator Shank moved to call the previous question, seconded by Senator Bui, passing 17-0-0. Bill 8S passed by a vote count of 17-0-0. Senator Salazar requested permission to enter the chamber.

The committee as a whole then moved on to Joint Resolution 10S. Senator Shank moved to amend clause 8 to read, "Mexican Students," seconded by Senator Shank, passing 18-0-0. Senator Marquez moved to amend clause 9 from, "additional year will," to read, "Senate Bill 113 will allow," seconded by Senator Liu. Senator Shank moved to secondary amend to strike "the," to read, "fund the solvency," seconded by Senator Liu, passing 18-0-0. Senator Ladha moved to amend the second to the last clause to strike "further," to read, "Now, therefore be it resolved," seconded by Senator Lautenschleger, passing 18-0-0. Senator Liu moved to amend the resolution striking the extra space, seconded by Senatro Bui, passing 18-0-0. Senator Williams moved to amend clause 4 to include, "(LESC), and," seconded by Senator Crawley, passing 18-0-0. Senator Liu moved to amend clause 5 from, "from state colleges," to read, "from New Mexico State Colleges," seconded by Senator Thompson, passing 18-0-0. Senator Martinez moved to friendly amend to strike "State" from clause 4, accepted. Senator Lautenschleger moved to amend "resolved," to read, "resolved," seconded by Senator Bui, passing 18-0-0. Senator Ortiz

requested permission to enter the chamber. Chair Hudson initated a roll call vote. Joint Resolution 10S passed by a vote 19-0-0.

Senator Bui moved to dissolve the committee as a whole, seconded by Senator Crawley, passing 19-0-0.

The Senate then moved on to Bill 8S. Vice President Liu initiated a roll call vote. Bill 8S passed by a vote count of 20-0-0.

The Senate then moved on to Joint Resolution 10S. Vice President Liu initiated a roll call vote. Joint Resolution 10S passed by a vote count of 20-0-0.
