Full Senate Meeting

August 18, 2012

Vice President Liu called the meeting to order, seconded by Senator Crawley.

Senator Crawley then moved to approve the agenda for the meeting, seconded by Senator Thompson. The vote was in affirmation, 20-0-0.

Senator Crawley also moved to approve the minutes, seconded by Senator Ladha. The minutes were approved as is by a unanimous vote.

Senator Hudson requested a personal privilege and Vice President Lui approved.

The Senate then moved to bill 99F. Senator Frias gave the authorship speech.

Senator Rodtang moved to strike out line 42. Senator Meyers seconded this motion. This motion passed with a unanimous vote.

Senator Kutter moved to amend line 33, seconded by senator Crawley. This motion passes with a unanimous vote.

Senator Crawley moved to recess for two minutes and Senator Rodtang seconded. The motion passed with an 18-2-0 vote.

Senator Meyers moved to amend recess. Senator Kutter seconded this amendment, and the motion passed by a vote of 19-1-0.

Vice president Lui called the meeting back to order.

Senator Frias initiated a friendly amendment to line 41, seconded by senator Crawley. This friendly amendment was accepted.

Senator Rodtang presented another friendly amendment, seconded by Senator Stevens, also accepted.

Senator Ladha moved to amend line 44, and Senator Crawley seconded. The amendment carried by a unanimous vote.

Senator Lautenschleger proposed a friendly amendment to strike line 41. This amendment was not accepted. The final amendment passed by a unanimous vote.

Senator Jordan moved to amend line 49, seconded by senator Crawley, passing with a unanimous vote.

Senator Hudson moved to postpone 99F. After discussion senator Hudson withdrew his motion to postpone 99F.

Finally Senator Santisevan moved to call the previous question, seconded by Thompson. The motion passed unanimously.

The Senate voted on bill 99F. The legislation failed by a vote of 3-15-2.

Vice President Lui called to adjorn.
