## Associated Students of the University of New Mexico Full Senate Meeting September 26, 2012

Vice President Lui called the meeting to order at 6:05 PM September 26, 2012. All Senators present at this time except Senator Kutter and Senator Rodtang.

Senator Crawley moved to approve the minutes seconded by Senator Jordan. Senator Jordan moved to approve the agenda, seconded by Santistevan. Then Senator Frias moved to approve the agenda in include emergency business, Joint Resolution 1F as the first order of business, seconded by Senator Romero. This amendment passed by a vote of 18-0-0.

Senator Kutter requested permission to enter to chamber.

Senator Jordan moved to move Joint Resolution 1F to the committee of the whole, seconded by Senator Marquez. Senator Meyers requested a personal privilege to preside over the meeting. Senator Hudson requested a personal privilege. Senator Crawley moved to amend the 3<sup>rd</sup> and 5<sup>th</sup> whereas clauses, seconded by Senator Thompson, passing by a vote of 17-0-1. Senator Hudson requested permission to enter the chamber. Then Senator Crawley moved to amend the 3<sup>rd</sup> whereas clause, seconded by Senator Ladha, passing by a vote of 18-0-0. Then Senator Ladha moved to amend the second whereas clause, seconded by Senator Santistevan, passing by a vote of 18-0-0. Senator Crawley then moved to make a secondary amendment to Senator Ladha's amendment, passing by a vote count of 18-0-0. Senator Hudson moved to call the previous question, seconded by Senator Crawley, passing by a vote of 18-0-0. Senator Romero moved to amend the second to last line, seconded by Senator Jordan, passing by a vote of 18-0-0. Senator Jordan moved to call the previous question on joint resolution 1F, seconded by Senator Thompson, passing by a vote of 18-0-0. After that, Senator Crawley moved to dissolve the committee as a whole, seconded by Senator Ortiz. The motion passed by a unanimous vote of 18-0-0. Senator Salazar requested a personal privilege. Senator Frias moved to amend the 5<sup>th</sup> whereas clause, seconded by Senator Crawley, passing by a vote of 18-0-0. Senator also moved to amend the 3<sup>rd</sup> whereas clause, also seconded by Senator Crawley and also passing by a vote count of 18-0-0. Finally Senator Jordan moved to call the previous question on Joint Resolution 1F. The motion passed by a vote of 18-0-0. Joint resolution passed by a vote of 18-0-0.

Senator Salazar requested permission to enter the chamber.

Senator Thompson requested a personal privilege. Bill 2F passed by a vote of 18-0-0.

Senator Thompson requested to enter the chamber. Bill 3F 18-0-0.

Senator Crawley moved to amend line 27 of bill 4F, seconded by Senator Santistevan, and passing by a vote of 18-0-0. Then Senator Santistevan requested a personal privilege. Senator Frias moved to amend bill 4F, seconded by Senator Crawley and passing by a vote of 18-0-0. Senator Santistevan requested permission to enter the chamber. Bill 4F passed by a vote of 18-0-0.

Bill 5F passed by a vote of 19-0-0.

Bill 6F passed by a vote of 16-3-0.

Bill 7F passed by a vote of 19-0-0. Senator Martinez requested a personal privilege.

Bill 8F passed by a vote of 18-0-0.

Appropriate 10F passed by a vote of 17-0-1.

Senator Thompson moved to block appropriations 12F, 13F, and 15F-19F, seconded by Senator Stevens, and passing by a vote of 19-0-0. Senator Stevens moved to remove appropriation 11F from the block, seconded by Senator Kutter, passing by a vote of 19-0-0. Then Senator Borowski moved to remove appropriation 14F from the block. Senator Kutter also seconded, and the motion also passed by a vote of 19-0-0.

Senator Martinez requested to enter the chamber.

Senator Crawley moved to call the previous question, seconded by Senator Ladha, and passing by a vote of 19-0-0. Appropriation 10F passed by a vote of 17-1-0.

Appropriation 11F passed 18-1-0.

The block, including appropriations 12F, 13F, and 15F-19F, passed by a vote of 18-1-0.

Senator Frias moved to call the previous question on appropriation 14F, seconded by Senator Crawley. The motion passed by a vote of 19-0-0. Appropriation 14F passed by a vote count of 18-0-1.

Senator Martinez moved to block appointments 12F through 20F, seconded by Senator Ladha. The motion passed by a decision of 19-0-0. The block of appointments then passed by a vote of 18-0-1.

The meeting adjourned at 9:04 PM.
