Associated Students of the University of New Mexico Full Senate Meeting September 12, 2012

Vice President Liu called the meeting to order at 6:01 PM.

Senator Crawley made a motion to approve the minutes, and Senator Ladha seconded this motion. The vote was in affirmation with a count of 15-0-0.

Senator Hudson made a motion to approve the agenda, and Senator Ladha seconded this motion. The vote was in affirmation with a count of 15-0-0.

Senator Meyers asked for a point of personal privilege, which was approved by Vice President Liu.

Senator Meyers asked for permission to enter the chamber, which was approved by Vice President Liu.

The Senate then moved to Bill 1F, and Senator Borowski gave the sponsorship speech.

Senator Meyers made a motion to amend Section 4 Subsection B in Bill 1F, and Senator Santistevan seconded this motion. Senators Lautenschleger and Meyers both discussed this amendment.

Senator Meyers made a motion to withdrawal amendment to Section 4 Subsection B in Bill 1F, and Senator Stevens seconded this motion. The vote was in affirmation with a count of 15-1-0.

The Senators then voted on Bill 1F, and the vote was in affirmation 16-0-0.

The Senate moved to Appropriation 5F, and Senator Romero gave the sponsorship speech. The vote was in affirmation with a count of 15-0-1, with Senator Romero abstaining.

The Senate moved to Appropriation 6F, and Senator Romero gave the sponsorship speech.

Senator Rodtang moved to block Appropriations 6F-9F, and Senator Jordan seconded this motion. The vote was in affirmation with a count of 15-1-0, with Senator Romero voting against the motion.

The Senators then voted to Block Appropriations 6F-9F. The vote was in affirmation with a count of 15-0-1, with Senator Romero abstaining.

Senator Salazar asked for a point of personal privilege, which was approved by Vice President Liu.

Senator Salazar asked for permission to enter the chamber, which was approved by Vice President Liu.

Senator Crawley motioned to block appointments 5F-11F, and Senator Rodtang seconded this motion. The vote was in affirmation with a count of 15-1-0, with Senator Romero voting against this motion.

Senator Santistevan discussed the motion to block appointments 5F-11F. The Senators then voted to block appointments 5F-11F. The vote was in affirmation with a count of 16-0-0.
