Full Senate Meeting

October 31, 2012

Vice President Liu called the meeting to order at 6:01 PM, with 18 senators present, senators: Borowski, Crawley, Frias Gonzales, Hudson, Jordan, Ladha, Lautenschleger, Marquez, Martinez, Meyers, Ortiz, Romero, Salazar, Santistevan, Stevens, Stone, Thompson. Senators: Kutter, and Rodtang came in tardy.

Senator Crawley moved to approve the minutes, seconded by senator Borowski. This motion passed by an affirmation of 18-0-0.

Senator Crawly moved to approve the agenda, seconded by senator Hudson. This motion passed by an affirmation of 18-0-0.

Senator Rodtang then requested permission to enter the chamber.

Senator Stevens requested a personal privilege.

The Senate then moved onto new business, bill 9F. Senator Steven's requested permission to enter the chamber. Bill 9F passed by a vote of 19-0-0.

The Senate then moved onto the Fall 2012 Budget Bill. Senator Kutter requested permission to enter the chamber. Senator Frias moved to call the previous question, seconded by senator Kutter. The budget passed by a vote of 19-0-1.

The Senate then moved on to appropriation 28F. Appropriation 28F passed by a vote passed by a vote of 19-0-1.

Senator Frias moved to block appropriations 29F, 31F-34F, and 36F-40F, seconded by senator Kutter, passing by a vote of 19-0-1.

Senator Hudson moved to remove appropriation 30F from the block, seconded by senator Stevens, passing by a vote of 20-0-0.

Senator Thompson moved to remove appropriation 35F from the block, seconded by senator Crawley, passing by a vote of 20-0-0.

The senate then moved on to appropriation 30F. Senator Stevens moved to amend appropriation to reflect the original request, seconded by senator Ladha, passing by a vote of 20-0-0. The amendment replaces \$600, with \$616. Appropriation 30F passed by a vote of 19-0-1.

The senate then moved on to appropriation 35F. Senator Hudson requested a personal privilege. The appropriation passed by a vote of 18-0-1. Senator Hudson requested permission to enter the chamber.

Senator Crawley requested a personal privilege.

Senator Jordan moved to block appointments 43F-46F, seconded by senator Frias, passing by a vote of 19-0-0. Senator Crawley requested permission to enter the chamber. The block passed by a vote of 19-0-1.

The meeting was adjourned at 7:41 PM.
