Devoted to legal matters of particular interest to New Mexico attorneys, the Law Review published a special issue on "The New Mexico Equal Rights Amendment - Assessing Its Impact", which was timed for publication immediately prior to the January 1973 session of the State Legislature. Other topics published during the past year were: "Economic Side of Wrongful Death in New Mexico", "The Grand Jury: True Tribunal of the People, or Administrative Agency of the Prosecution", "Law of Standing in New Mexico", "Indians and Federal Income Taxation", and "Ad Valorem Tax Status of a Private Lessee's Interest in Publicly Owned Property".
