## LATE NEWS.

### PLACES FOR PRESS WORKERS.

CHICAGO, Sept. 27.—Fifteen hundred applications for seats in the press gallery have been received, while provisions have been made for only 700. This place is immediately in front of the grand stand and will be eagerly sought after by newsgatherers. No person will be admitted to this numbered section who is not a practical newspaper worker, engaged in the legitimate business of compiling and transmitting news.

### A MISERABLE LIFE.

DETROIT, Sept. 27.—Harold Beckwith, the young millionaire who committed suicide in his bath tub, was one of the high rollers of the United States. About a year ago he with a party of roystering friends went through Colorado and New Mexico to old Mexico and southern California. He was in Albuquerque and Las Vegas Hot Springs, in both of which places he is said to have made a record. Of the million dollars left him by his father he has in a year squandered hundreds of thousands. His death is a relief to kindred and friends.

### INDIGNANT STUDENTS.

CINCINNATI, Sept. 27.—The attempt of the faculty of Du Puy university, in Indiana, to muzzle the press by expelling the editor in chief of the college paper, the *Mirage*, has raised a war which threatens to depopulate the school. Several hundred students have signified their intention to leave for other colleges if the editor is not recalled and the paper reinstated. The last issue hit the board of trustees in a vital spot, hence the action of the faculty.

### HAS CHOLERA.

SAN ANTONIO, TEXAS, Sept. 27.—Last night Dr. H. M. Sweringer, state health officer, forwarded a report to Gov. Hogg in which he stated that he had attended two cases of suspected cholera. One, Samuel Harris, died Sunday, Sept. 25; the other, Charles Hansler, who had come from Hamburg, via Havre. Hansler was improving and the doctor believes the cases to be only sporadic cholera.

### THE TEXAS WAY.

DALLAS, Sept. 27.—At the convict camp, six miles west of here, "Commodore" Miller and twelve other prisoners attacked and overpowered the guard, took their guns, and are still at large. Armed parties and bloodhounds are out in pursuit, and it is believed there will be a battle before the convicts will be retaken.

### STILL COMING.

NEW YORK, Sept. 27.—Five cases of cholera have developed on the *Bohemia*, from Hamburg, now at quarantine. These were at once removed to Swanburne island, where one died. The cabin passengers of the *Bohemia* have been taken off, but the steerage are still on board. No cholera in the city.

### FEWER NEW CASES.

HAMBURG, Sept. 27.—The cholera abatement continues. Only 146 fresh cases were reported today and fifty-seven deaths.

### RUSSELL NOMINATED.

BOSTON, September 27.—At the Democratic state convention today Governor Russell was unanimously nominated.

## PAZ ON WATROUS.

Watrous, situated at the junction of the rivers Mora and Sapello, formerly known as La Junta, is one of the healthiest locations in New Mexico. It can not be judged by its lonesome appearance from the railroad car, as seen from that point it is viewed from its worst aspect. To be appreciated it must be known. It is the shipping point for a large extent of back country, and that country one of the prettiest parts of the territory. The heat of summer never raises the thermometer over 98 degrees, nor does the icy chill of winter depress it, as a rule, under zero.

As a pleasure resort it has not the attractions of the hot springs, nor the brass bands and other allurements of Las Vegas. As a health resort it can vie with the greatest advertised locality in the United States.

John M. Blair, of Blairsville, N. J., is reported to be worth all the way from \$50,000,000 to \$100,000,000. He has never sold a share of stock in any enterprise with which he has been associated, and has money invested in scores of railroads, some of which he absolutely controls.

A British authority on railroad statistics makes the following comparisons: "To carry 329 tons of coal an English railway would use about 40 wagons with a total length of 640 feet and a total weight of 290 tons; an American railway would use about 13 wagons with a total length of 312 feet and a total weight of 117 tons. To carry 329 tons of general merchandise English practice would use, on the average, 165 wagons with a total weight of 800 tons; American 66 cars with a length of 1584 feet and a weight of 660 tons. These figures apparently show English railroad managers in a bad light," says the Engineering and Mining Journal, "but there are other reasons, as a matter of fact, that outweigh the advantages that would be obtained by the adoption of large cars."

# RAILWAY TALK.

Hon. Jefferson Reynolds arrived from the east last night in very good spirits, occasioned by the fact that he feels so sanguine that the Denver & El Paso road is now an assured fact. While east he received the very best assurances that the money could be had whenever needed, after the towns along the line had shown their faith in the enterprise by subscribing to the preferred stock. One firm with whom Mr. Reynolds conversed said it was the best and most promising enterprise in the railway line they had seen for a long time. A railroad running along the base of the Rocky mountains, north and south, connecting the towns mentioned, they said, was sure to have a good traffic because it reached and was convenient to all the business furnished by the entire mountain ranges, while an east and west road only tapped a small section of the region it passed through.

Mr. Reynolds was assured in Denver that Gov. Evans, T. M. Patterson and H. M. Porter would all be here at the meeting of the executive committee of the Short Line road on the 1st. The Denver people are beginning to wake up to the fact that the road will be of the greatest value to Denver and they must have it, and they are very sure that there will not be the least trouble in Denver's subscribing her share to the stock of the company. The meeting here will be a very important one, and there will probably be a full attendance, the only exception being White Oaks, whose representative is out of the territory at present.

In addition to the above, Mr. R. said that the grass near Las Vegas was the best grazing this side of La Junta. The country around Las Vegas is the best watered in the territory, and with the advent of the new road will settle up very fast and prove the garden spot of New Mexico. "We have the best country and the finest climate in the United States, and it is time the people of Las Vegas awoke to the fact and worked to let it be known to the world," was Mr. R.'s concluding remark.

# THE CAMPAIGN.

Messrs. Catron and Morrison are greeted with large and appreciative audiences wherever they speak. The first meeting was held at Raton by Mr. Catron alone, and the next night they both spoke at Blossburg, where Mr. Catron paid special attention to his opponent in the congressional race, while Mr. Morrison spoke on the tariff and strikes.

As a mining town their audience were interested in the following figures on strikes which Mr. Morrison gave them:

In 1881 there were 471 strikes in the United States; 1882, 454; 1883, 478; 1884, 443; 1885, 645, and in 1886, under Mr. Cleveland, 1401, involving over a half million persons. In 1887 there were 943 in the United States and 3164 in England. The British Board of Trade officially announced 1028 strikes, and in 738 of these 392,981 persons took part.

In the recent Durham strikes 100,000 miners went out from March 12 to June 1, and then accepted a reduction of 10 per cent. So this country cannot compare with England for strikes.

At Springer, Saturday, there was a good crowd in attendance, many ladies being present, and the speaking lasted till 11 o'clock, with unabated interest.

Ocate was visited on Sunday afternoon. When about two miles out the speakers were met by 200 men on horseback, who escorted them in and gave them a hearty welcome. The speeches here were enthusiastically received, particularly Col. Morrison's remarks on the wool tariff, which the people could appreciate as most of them were sheep growers. One man there assured them that Mr. Catron would receive 25 per cent more votes than Otero did two years ago.

At Wagon Mound the room was crowded so many could not get in. The speaking was listened to with close attention by the audience who were much pleased with the speeches.

## THE MONETARY CONFERENCE.

There has been no arrangements yet concluded for holding the international monetary conferences. Correspondence on the subject of the place for the meeting was interrupted by the cholera scare and it is now as uncertain as ever where the conference will be held.

A date for its assembling, which cannot be well announced until after the place of meeting has been agreed upon, is, of course, equally a matter of doubt.

Treasury officials say it is doubtful the basis of the report printed in some of the Western papers that Senator Allison, of Iowa, one of the commissioners from the United States, could not attend the conference but would remain in Iowa during the campaign. There is no probability now that the conference will be held until after the election, so that the senator may, without regard to that event, continue his campaign services without interruption.

But the delay may result in losing to the country and conference the services of Senator Allison. He is chairman of the senate committee on appropriations, and his absence would seriously cripple the committee in its work. This especially is true at this time. The next session of congress will be a short one, lasting but three months, including the holiday recess.

The work of the committee is usually done, to a considerable extent, in the month that intervenes between election and the meeting of congress. In view of the importance of the task committed to him by the senate it is not improbable that Senator Allison may conclude that he can be of more service in Washington than at the monetary conference, and decide to remain at home.

There has, however, been no official correspondence upon the subject, it has only been informally considered as one of the probabilities.

## UNCLE ALLEN IS NOT SCARED.

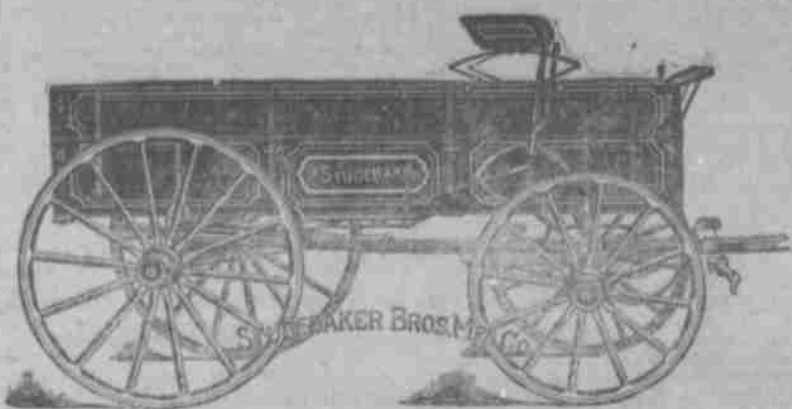
