GENERAL SCHOOL INFORMATION

A. Significant achievements during academic year 1962-63

As noted in previous reports, the law school's most serious problems have for several years been declining enrollment and lack of adequate scholarship funds. Some progress in the solution of both of these problems was noted in last year's report. More can be noted here.

Insofar as declining enrollments were the product of attrition in the law school student body, our raised admissions standards of a year ago seemed to hold forth substantial promise. Attrition for academic reasons in last year's first-year class -- the first class under the new admissions standards -- was only 14% as against a prior average of 39%, although attrition for nonacademic reasons was 29% against a prior average of 19%.

Attrition for academic reasons in this year's first-year class was back up to 35%, but attrition for nonacademic reasons was down to 5% -- due in substantial part to our improved scholarship resources. Thus, total attrition in this year's first-year class was 40%, as against 43% last year and a prior yearly average of 58%.

Last year's report noted that, because of increasing applications, we had applied our raised admissions standards with

no loss in total enrollment. This year, applications continued to increase and, under the same standards, our total enrollment increased 30%.

Applications continue to increase, though not as rapidly as last year, indicating another substantial increase in the entering class this fall. And improved attrition rates indicate an increase also in the second- and third-year classes. Our projected enrollment for 1963-64, compared with the actual enrollment for 1962-63 is:

Our scholarship resources have continued to improve.

Mrs. William Calhoun Witte has established an annual \$1,000
scholarship in memory of her father, the late Pearce C. Rodey.

Mrs. Anna K. Reisiger, of Truth or Consequences, has created a scholarship of \$1,000, and the family and friends of the late
Thomas J. Mabry, Sr., have begun the establishment of a scholarship in his memory. In addition, the law school will receive during the coming academic year a gift of \$50,000 from the estate of the late Mrs. Ira Rothgerber which will provide an additional \$2,500 annually in scholarship funds.

In February, 1963, the law school was inspected by the American Bar Association, one of its accrediting agencies, which conducts such inspections periodically. The concluding paragraph of the inspector's report reads as follows:

The evaluator and the Adviser feel unreservedly that the Regents and President of the University, the Dean and the faculty of the law school, and the bench and bar of the State, are entitled to high commendation for their serious and continuing interest in the work of the subject school and their fearless defense of the standards of excellence which have been maintained notwithstanding the pressures which appear to be inevitable in a public-related institution to lower them. The subject school is "not just another law school." It is a good law school. A good job has been done to The authorities are determined to do even better.

The inspector noted only one serious problem in the school -- a weakness in the administration of the library due to the illness of the librarian, Mr. Arie Poldervaart. Effective July 1, 1963, Mr. Poldervaart was retired for disability.

B. Significant plans and recommendations

Mr. Myron Fink, now the law librarian at Loyola
University, Los Angeles, will replace Mr. Poldervaart as Law
Librarian. Mr. Fink is extremely well trained and vigorous
and we expect a substantial improvement in the organization and
administration of the library which will be reflected in the
entire operation of the school.

With other interested departments of the University, the law school has participated in plans for establishment of a

Water Resources Institute in anticipation of the passage of S. 2, 88th Cong., 1st Sess., providing for federal aid to such institutes in state colleges and universities. The program of such an institute at this University would provide extraordinary opportunities for the use of unique talents on our faculty and we are confident that both the law faculty and the Natural Resources Journal, published by the law school, can make a substantial contribution to the success of the program.

Dean Vern Countryman will be on leave of absence for the academic year 1963-64, during which time he will serve as Visiting Professor at Harvard Law School. Professor Robert Emmet Clark will serve as Acting Dean for 1963-64, as he did for 1958-59.

C. Appointments to staff

Myron Fink was appointed Associate Professor and Law Librarian effective September 1, 1963. Professor Fink received his B.A. from Cornell University With Distinction in Philosophy in 1948, his LL.B. <u>cum laude</u> from New York Law School in 1951 and his LL.M. <u>magna cum laude</u> from New York Law School in 1962. He received his M.S. in Library Science from Columbia University in 1957. He is a member of the New York bar, where he practiced for seven years. Since 1958 he has been Assistant Professor and Law Librarian at Loyola University, Los Angeles.

Daniel L. Rotenberg of Duquesne University School of Law was appointed Visiting Associate Professor for one year beginning July 1, 1963. Professor Rotenberg received his A.B. from Indiana University in 1953 and his LL.B. With Distinction from the same University in 1955. He taught at the University of Indiana from 1957 to 1959 and since 1959 has been a member of the faculty at Duquesne.

Carl M. Selinger of Albany Law School was appointed Visiting Assistant Professor of Law for one year beginning July 1, 1963. Professor Selinger received his A.B. from the University of California at Berkeley in 1955 and his LL.B. cum laude from Harvard Law School in 1958. He was a teaching fellow at Harvard in 1960-61 and since 1961 has been a member of the law faculty at Albany.

D. <u>Separations from staff</u>

Assistant Professor Ted Finman, who had been on leave of absence during 1962-63 to teach at Rutgers University, resigned effective July 1, 1963, to accept a position on the law faculty of the University of Wisconsin.

Law Librarian Arie Poldervaart retired July 1, 1963, due to ill health.
