Disposition refers to what was done with the animals reported, e.g., "banded and released" or "deposited in the Museum of Southwestern Biology." **Include all animals taken or handled during the current permit year**, even if some have not been fully identified when this form is submitted. In such case, report the identity as unknown and then supply complete information within one year in a follow-up report. Spreadsheets, catalogues, accession logs, or similar documents may be used in lieu of filling in the report portion of this form. **as long as ALL of the information requested in this form is included** (Geographic location information is recommended. Please note to have complete geographic information you must supply both the Coordinate System and the Datum). Filing an annual report is a condition of your permit. Continual failure to file a timely report or an incomplete report could result in suspension of your permit.
