## LAND OFFICE FEES.

The following circular letter relating to fees for executing affidavits and depositions, and addressed to registers and receivers of U. S. land offices, has been issued by the general land office at Washington, D. C.:

"Section 2294 of the Revised Statutes of the United States, as amended by the act of Congress of March 4, 1904 (33 Stats. 59), prescribes the maximum fees which may be charged and collected for the preparation and official execution of affidavits and depositions, intended for use as evidence in connection with any entry of the public lands, as follows:

For each affidavit, 25c.

For each deposition of claimant, or witness, when not prepared by the officer, 25c.

For each deposition of claimant, or witness, prepared by the officer, \$1.

The same statute prescribes a penalty of not less than \$100 dollars fine for any violation of its prohibition against the exaction of a greater fee for any of the services therein specified.

It has come to the knowledge of this office that owing to a misconstruction of this statute, it is the practice of many of the officers authorized to prepare and execute the papers therein enumerated to regard those documents required in the submission of annual proof of expenditure on desert land entries as depositions, and to collect a fee of \$1 for each such document prepared by them. The essential form and contents of such papers constitute them affidavits rather than depositions, and for any officer to demand and receive a fee of more than 25 cents for their preparation and execution is in contravention of the statute above referred to.

You will at once transmit a copy of this circular to each and every officer in your district who is, by law, authorized to administer oaths in connection with the submission of such proofs, to the end that continued violations of the statute against excessive fees may be prevented.

## American Horses.

The development of types of light horses has been notable in the United States, but, according to a bulletin recently issued by the department of agriculture, with a single exception the draft-horses have been foreign strains transplanted. Of the light horses, the Narragansett pacer was a famous type in colonial days. Later came the Morgan, the standard-bred and the saddle-horse. The specialization of these types has been a national business and, in spite of importations from abroad, the native stock has developed and held its own. Of draft-horses, on the other hand, the only native type was the Conestoga, a breed that has now become completely extinct, and has left no discernible traces on the native stock. For heavy work, therefore, Americans must depend entirely upon the imported Percherons, Clydesdales and Shires. The national traits which have resulted in these conditions are evidently somewhat different from what has been supposed; for the speed mania is what has caused the light types of horse to be developed and the heavy ones to be neglected. American breeders have sacrificed other qualities, which, in the opinion of the department of agriculture, are more important, in order to lower track records by a second or two. In the minds of most persons, Virginia, Kentucky and other parts of the south are most commonly associated with the pedigrees and development of the finest types of horses. To all who hold that opinion it will be instructive to trace, through the pages of the bulletin, the number of great strains of racing, carriage and saddle blood which, although commonly associated with the south, in reality go directly back to New England.

## Nothing from Nothing Leaves Nothing.

Recently a man wrote to the New York Times saying that he was a little over 50 years of age, and having worked all of his life to acquire enough money to make him independent, and having succeeded, he had retired, and was now trying to make himself happy with nothing to do. ## HAS UNWELCOME JOB

"BOB" MELDRUM TO CLEAN OUT WYOMING CATTLE RUSTLERS.

Typical Gun Fighter Will Be Pitted Against Unknown Number of Desperadoes — Men Who Know Say He Will Win.

Denver, Col.—"Bob" Meldrum, a typical gun-fighter of frontier days, has been given the job of "cleaning out" the cattle rustlers who have been making life miserable for the cattlemen



in one of their last western strongholds—the Little Snake river country, on the Colorado-Wyoming line, near Utah.

Pitting one man against a band of outlaws who would just as soon kill a human being as a steer, does not look like the accepted idea of "fair play," but those who know "Bob" Meldrum have no fears as to the outcome. The cattlemen of the Little Snake river country are backing the sinewy, keen-eyed deputy sheriff against all the "bad men" who infest that part of the country.

For years the country adjoining the Little Snake river has been the haunt of characters more or less undesirable. It is a wild and unfrequented country, remote from railroad. On the vast ranges run countless thousands of cattle and sheep. There have been bloody conflicts between the cattle and sheep men, but finally their differences were adjusted through the recognition of a "dead line." The sheep are kept north of the Colorado-Wyoming line, and the cattle range south of that line, except when being driven to the railroad for shipping purposes.

Before this "dead line" was established clashes were frequent between herders and cowboys, and many partisans of the sheep and cattle barons lost their lives in duels with rifles. Cattle rustling used to be a flourishing industry in this locality also, and some of the old log cabins along the Little Snake river have been the gathering places of bands of desperate outlaws, ready for any mischief, from cattle rustling to robbing trains.

"Bob" Meldrum made his reputation as deputy at Baggs, where he broke up the rustler army and drove the last one out of the country.

Meldrum's fame as a gun fighter spread and he was in active demand wherever there was trouble. He was for some time employed by the mine owners of Cripple Creek and Tellur-

ide, during Colorado's bloody war of mining interests. Later he appeared at Boise during the Haywood-Moyer trial. Always his appearance on the scene resulted in a sudden quieting of boisterous spirits. Men who had announced that they "were hunting for trouble," vanished when the trouble appeared in the form of this quiet, determined gun fighter, whose revolver handle is so notched with death scars that it looks as if a bear had been chewing it.

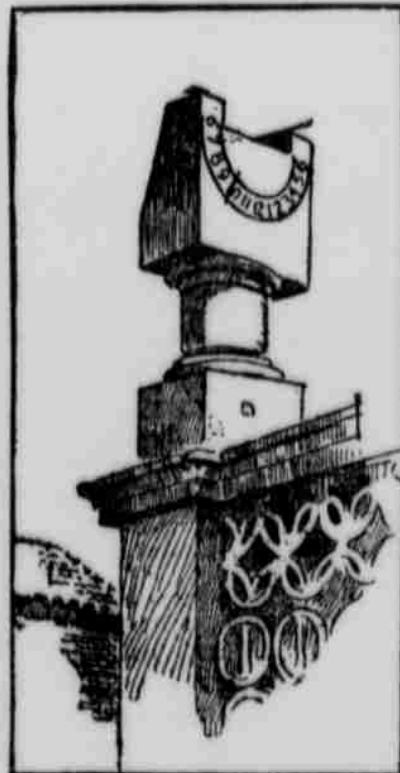
During Meldrum's absence from the Little Snake river country, the industry of cattle rustling showed a decided revival, until now it is said to be almost as flourishing as it was before the day of Tom Horn. The cattle owners claim that there is a regular system of "railing" stock out of the country. They say that most of the "homesteaders" who have taken out small ranches along the Little Snake valley and its vicinity are not legitimate ranchmen, but are cattle rustlers, who "pass on" the stolen stock into Wyoming and Utah. In this way, it is claimed, thousands of head of cattle are being rustled every year.

It is to break up this system that "Bob" Meldrum has been called upon.

## THE SUNDIAL IN MEXICO.

Primitive Timekeepers Still Popular in the Southern Republic.

Mexico City.—The sundial still is in common use in many parts of Mexico. These primitive time indicators are to be seen upon many of the buildings in the towns and cities. Even in the capital of the republic, with its many great clocks, sundials are to be found upon many of the ancient buildings. It is in the smaller towns, however, where the sundial is still relied upon by the natives as the true marker of time. Upon the high plateau, where the weather is seldom cloudy, the sundial is in service most hours of the day. Some of these dials are two or three centuries old. They are carved out of stone with artistic precision. In order that the general public may obtain the benefit of the sun's markings the sundials usually are

# HUMAN SALAMANDER

MARVELOUS PSYCHIC POWER IS  
DISPLAYED BY MECHANIC.

Feats of Fred E. Foskett Are Investigated by Prof. William James of Harvard and Others and Arouse Wonder.

Boston.—The marvelous psychic power of Fred E. Foskett, a young machinist of Orange, Mass., has attracted the attention of Prof. James of Harvard and other leading members of the Boston branch of the American Society of Psychical Research, who have given him tests.

The first of the tests was held at the home of Prescott F. Hall. Prof. William James and several well-known physicians were there, and test conditions as nearly perfect as possible were made. Foskett was seated in

the center of a room before a small table. There he performed every feat of the Hindoo fakir and the Buddhist adept.

On the table was an ordinary kerosene lamp with a chimney and a flat wick, a pan and several quarts of alcohol. According to the reports of those present, Foskett succeeded in every test.

Before beginning the test Foskett from 20 to 30 deep breaths.

First test was made with ordi-alphur matches. Foskett lighted

then, one after the other, holding one hand so close to the other that the flames curled around them. He then lighted the lamp and held his hands above the wick, while the flames curled over them and the soot completely blackened them.

From one of these tests to another Foskett went, while the scientists held their breath and watched every motion until he came to the climax. In this he poured a quart of alcohol into his basin, lighted it and then washed his hands, bathing them for nearly ten minutes in the burning fluid, washing it up over his arms and to his face—literally bathing himself in blazing alcohol. That completed the test.

As soon as it was finished the physicians present examined Foskett, and they could not find the slightest trace of a burn or blister. Foskett told them that the flames did not give him the slightest sensation of burning; that he felt comfortably warm and pleasant, and nothing more.

The second tests were made the next afternoon at the home of Prof. James in Cambridge, and under the same conditions as the day before. Considerable mystery is thrown about them. Mr. Hall said they were so startling that he did not care to discuss them until they had been tried again. Another scientist who was there said that Foskett performed all

of his experiments of the day before, and then "absolutely and positively dematerialized."

"He seemed to dissolve into thin air as we watched him. Was gone 41 seconds and then materialized. It was so startling that we, I am afraid, lost sight of the test conditions, and we have asked him to appear before us again. It seems unbelievable, but it certainly seemed so. We hardly know what to think about it."

Prof. James refuses to talk about the tests.

According to those who were present, Foskett seems in a passive state during the tests, and he says he thinks of nothing in particular. Those who examined him discredit the hypnotic theory.

It is intimated that the secret lies in taking the deep rhythmic breaths, which, it is declared, is the foundation of the development of the power taught in India and the orient centuries ago. By certain methods of breathing, it is taught by the ancients that in solitude and fasting the power of handling fire, receiving messages from astral bodies and other phenomena can be accomplished.

## COUNTY COURTHOUSE IN TEXAS.

All Official Business Is Transacted in a Tent.

Houston, Tex.—The town of Chapin, the new county seat of Hidalgo county, Texas, was not in existence two months ago. It now has a population of several hundred people and is growing rapidly. During the first few weeks after the site of the town was named as the location of the county seat a small tent served as the courthouse. In this tent were kept all the records of the county, which is one of the oldest in the state, and the official business of the different county officers was transacted there. The officers used the tent as a sleeping place during the early period of the town's existence. The site of the tent was in a little cleared spot in the midst of a wilderness of brush and cactus.

The ancient Mexican hamlet of Hidalgo was the county seat of the county of the same name for nearly a half century. It is a quaint, sleepy adobe-built town, situated close to the banks of the Rio Grande and several miles from the railroad which was built up the Rio Grande valley for 50 miles a few years ago. With the coming of the railroad many new settlers came into the rich valley and began to clear the lands and establish irrigation enterprises. These new citizens now outnumber the old-timers of the county, and they caused an election to be held on October 10 on the proposition of removing the county seat from Hidalgo to a point nearer the center of the county. At the time the election was held the town of Chapin existed only on paper. Its prospective site was a wilderness of chaparral, 20 miles from the railroad. The county seat removal proposition was carried, however, by a majority of 90 votes. The contest was a bitter one and state rangers had to be called in to prevent serious trouble between the contending factions.

The day after the election the leaders of the Chapin county seat movement learned that injunction proceedings against the removal of the county records from Hidalgo were about to be instituted. In order to defeat this plan the courthouse at Hidalgo was entered that night and all the county records taken out and piled into a wagon and hauled across the country to the site of the proposed town of Chapin, where the courthouse was established in a tent.

This is the birthday of the NEWS. It starts out with this issue on Volume No. 10, and we trust it may see many more tens before joining the silent majority.

The next big holiday, perhaps the biggest in the calendar, is the 17th of Ireland, and the sons of the "Green Isle" are making preparations to fittingly celebrate the occasion. It will be a gr-r-eat day.

Like Hamlet, the occupation of Delegate Andrews seems to be gone. But an El Paso exchange thinks that he could still be used in Juarez in the bull ring. A Pennsylvania bull would attract an immense crowd.

We cannot ignore the fact that the republican gang at Santa Fe are alone responsible for the defeat of statehood. They secured the removal of an honest governor, because he refused to wink at the high-handed methods of the old gang in looting the treasury. The same gang was responsible for the recall of the special agents sent to investigate the charges that had been repeatedly made by responsible parties; and their purpose was plain to be seen—they didn't want to face a jury on a charge that might cause them to don stripes for a season. The gang, according to the testimony presented to the senate committee, would have accomplished the assassination of the special agents if they had not been called off. The senate was in possession of more information of the "freebooting" practiced in the territory than the general public was aware of. To their credit, be it said, most honest republicans in the territory backed up Mr. Hagerman, but they were no match for the gang. We cannot condemn the action of the senate; for with the evidence before it no other action could be expected. Are the people of the territory willing to be classed with the gang that killed statehood? Their willingness to be governed by the gang evidently led the senate committee to believe that the mass of the people of the territory were little better than their representatives.

## 22¢—HOUSEHOLD—OMELET WITH COLD HAM.

Makes One of the Daintiest of All Breakfast Dishes.

An omelet, made with finely chopped cold ham and chopped parsley, forms a dainty breakfast dish. Chop finely some pieces of cold ham and add a teaspoonful of chopped parsley and a seasoning of salt and pepper. Well whisk the whites and yolks of two eggs separately, add the beaten yolks to the chopped ham and just before cooking the omelet, quickly stir in the whites previously beaten to a stiff broth. Put a good sized piece of butter into the omelet pan and when the butter has melted, pour in the omelet. Stir the omelet with a spoon or fork one way till it begins to thicken and when the under part is nicely browned, turn the omelet over in oval shape and serve immediately.

### BREAKFAST OR LUNCH DISH.

Stuffed Kidneys a Welcome Addition to the Menu.

Four or six small kidneys, two tablespoonfuls of butter, two ounces of bread crumbs, one teaspoonful chopped parsley, pepper and salt and a little lemon juice. Skin the kidneys and split them lengthwise, but not quite through. Leave enough to act as a sort of hinge. Rub them inside with melted butter, and broil them over a clear fire for ten minutes.

Have ready the stuffing of crumbs, parsley and butter, well seasoned with salt and pepper. Heat in a small saucepan and add the lemon juice.

Dish the kidneys and put some of this mixture inside each. Fold them over, sprinkle with salt and pepper and serve very hot.

### Brown Bread Pudding.

Take about half a loaf of bread and cut into slices, or use left-over pieces; spread each piece with butter and lay in a pan. Pour over this enough cold water to cover well and let soak about five minutes. In the meantime break one egg into your pudding pan and beat it well; add one-half cup brown sugar, one-half cup corn sirup, one-third teaspoon each of cinnamon, allspice and nutmeg, powdered; then lightly squeeze out the water from the bread by handfuls, crumbling it into the other mixture. Be careful to get all the butter that may come off into the water. Mix well and bake one hour. Sauce: One quart water, butter size of a walnut, half cup vinegar, three-fourths cup sugar; let boil a few minutes and thicken with two tablespoons flour rubbed smooth in a little cold water. Take from stove and add one teaspoonful vanilla.

### To Clean Sponges.

Soiled sponges can be quickly freshened by rubbing the juice of a lemon well into them then rinsing several times, first in hot water and then in cold.

Too much care cannot be taken to keep a sponge absolutely fresh, as microbes are apt to congregate otherwise. An occasional sunbath is excellent and a thorough washing with ammonia water every few weeks should not be omitted.

In using a sponge for a young child, or indeed for anyone, no matter how carefully it is supposed to be washed, it should be run through very hot water before using.

### Ham Fritters.

Heat to boiling point one cupful of stock. Thicken with a tablespoonful each of flour and butter cooked together, and add to it one cupful of cold cooked chopped ham, one egg well beaten, and dry mustard and Worcestershire sauce to season.

Heat thoroughly, take from fire and cool. Make a fritter batter of one cupful of sifted flour, two teaspoonfuls of melted butter, a scant cupful of hot water, the beaten white of an egg, and a pinch of salt. Shape the ham mixture into small balls, dip in fritter batter and fry in deep fat.

## Gossip of Washington

What Is Going On at the National Capital.

### Sets New Record for Cabinet Members



WASHINGTON.—When Theodore Roosevelt retires from the presidential office, on March 4 next, he will have made a record for numerous cabinet appointments. The last cabinet meeting he presides over will be composed almost solely of comparatively new men. There will be but one man, Secretary Wilson, who attended the first cabinet meeting that Roosevelt held in the autumn of 1901. There will be only one other. Secretary of the Treasury Cortelyou, who was at the cabinet table in March, 1905, when Mr. Roosevelt entered upon his present term.

In the seven and a half years of his tenure, Mr. Roosevelt will have had 29 different cabinet officers, but not as many different men, for Mr. Root has served under him first as secretary of war and then as secretary of state. Mr. Cortelyou has had three cabinet positions under Roosevelt—

commerce and labor, post office and treasury. Attorney General Bonaparte first came into the cabinet as secretary of the navy.

No other president has made so many changes. There have been six secretaries of the navy since Mr. Roosevelt entered the White House—Long, Morton, Moody, Bonaparte, Metcalf and Newberry; and five postmasters general—Smith, Payne, Wynne, Cortelyou and Meyer. There have been two secretaries of state—Hay and Root. The recent announcement that Secretary Root is to resign as soon as he is elected to the senate from New York and that Assistant Secretary of State Robert Bacon of New York and Boston will succeed him assures three secretaries of state during President Roosevelt's time. Mr. Roosevelt has also had three secretaries of the treasury, three secretaries of war, three attorneys general, three secretaries of commerce and two secretaries of the interior.

When Mr. Bacon becomes secretary of state three of the nine members of the last Roosevelt cabinet will be men who were favorites at tennis and have been counted as members of the tennis cabinet.

### Amusing Stories on Tariff Revisers



A GOOD deal of amusement was created at the hearing of the committee on ways and means the other day, when a newspaper article was brought to the attention of the committee, stating that "the ways and means committee, which is now engaged in the task of framing a bill to protect American industries, had purchased toweling bearing the mark, 'Made in Great Britain.' The clipping was passed along to the committeemen, and finally one of them sent this word down to a member of the press.

"When the session is over turn up the chair upon which you are sitting and read the mark." This was done, and it was revealed that the chair was "Made in Vienna."

Further inquiry disclosed that the gymnast upon the walls of the committee room was imported from Canada, that the carpets on the floor came

from Brussels, and that the woodwork of the imposing "throne" upon which the committeemen sit at hearings, was brought over from Italy.

"In fact," said a Democrat, "the only article of domestic production around the committee room these days is the hot air supplied by the witnesses who appear before us."

All of this recalled to Democratic members of the committee a ludicrous incident that occurred during the consideration of the Dingley bill in the house, 11 years ago. Nelson W. Dingley of Maine was in charge of the tariff measure at that time. He was speaking to the theme, "We should encourage American industries."

Mr. Dingley was followed on the floor by Jerry Simpson of Kansas, whose nimble wit and comic stories are a part of the traditions of the house. Mr. Dingley wore a high hat, and invariably brought it into the house with him, laying it on the chair adjoining the one he occupied.

"The gentleman should practice what he preaches," shouted Mr. Simpson, moving toward the unsuspecting Mr. Dingley. Picking up Mr. Dingley's headgear, Simpson continued: "I find a label in the gentleman's hat, reading thus: 'Made in London.'"

### Katherine Elkins to Become a Nurse



THE end of the romance of Katherine Elkins and the duke of the Abruzzi is to be like the final chapter of an old-fashioned novel, in which the heroine flees with her memories to convent walls and the hero betakes himself and his wounded heart to the wilderness of the world to seek forgetfulness.

The authoritative announcement that there would be no marriage between Miss Elkins and the Italian prince and cousin of a king was hardly cold when the cable brought from

Rome the report that the duke was planning to be off to the unexplored mountain fastnesses of India.

It is now learned that Miss Elkins' attitude toward society for the next six months at least, and perhaps longer, will be more serious than was anticipated.

Arrangements have been made by Miss Elkins to begin the serious work of study in the homeopathic general hospital in Washington.

The course which Miss Elkins will have to follow, under the rules of hospital training, will include attendance at all lectures, clinics and operations. 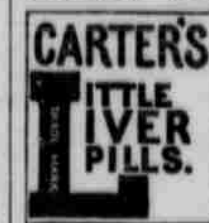
