LANDSLIDE FOR ANDREWS

Republicans of City and County Precincts Swat Elfego and Don Jesus, Balloting Two to One Against Bossis; Former Delegate in Congress to Control Convention Tomorrow by Big Majority, and Will Be Endorsed Without Opposition as a Candidate From Bernalillo for Place on State Ticket.

W. H. Andrews, former territorial delegate in congress, was an easy victor over Elfego Baca in the Republican primaries held in Bernalillo county last Friday, and is assured of the endorsement of the county convention which meets tomorrow in his candidacy for the Republican nomination for congress.

Mr. Andrews is assured of 79 votes in the convention, leaving only 29 votes for his opponent, Elfego Baca, and there is as good as an even chance that the Andrews total will amount to an even higher figure when the convention meets. With this majority in his favor, there is no doubt that an instructed Andrews delegation will be sent to the state convention in Santa Fe.

The vote of the country precincts, which the Baca forces had counted upon to go solidly for their man; proved a distinct surprise and was a great disappointment to the supporters of the former Socorro county man. From the beginning the Andrews supporters had predicted that they would make important inroads on these supposed Baca strongholds, but even they did not count upon so sweeping a victory in the country precincts as they achieved.

A total of 37 certain Andrews delegates were elected in the county outside the city, as against 29 for Baca. The primaries in the country were held in the afternoon and the result of the voting became known in the city before the polls were opened. The effect was distinctly encouraging to the Baca forces, as it meant that it would be necessary for them to carry both city precincts in order to go to the convention with a majority.

The vote in the city proved a landslide for Andrews. In precinct No. 12, comprising the northern half of the city, the Andrews delegates polled 281 votes as against 123 for Baca, or more than two to one, while in Precinct No. 26, where the heaviest vote was cast, Andrews received 329 as against 151 for Baca, or a majority of over two to one. The total vote of the city precincts was 610 for Andrews and 274 for Baca.

The defeat of Baca was conceded by his supporters even before the polls closed in the city. Sheriff Jesus Romero, Nestor Montoya and others who have stood firmly for Baca, admitted that Andrews had carried the county and stated that they would give hearty support to the Republican ticket.

Mr. Baca could not be seen last night for a statement, but he has previously announced that he

would not support Mr. Andrews even if he is nominated by the Republicans.

Whipped to a frazzle, to a pale blue pulp, in the city of Albuquerque, the Baca-Romero forces also were administered a stinging rebuke in the outside precincts.

From the mountain precincts on the east, to the river precincts in the south and west, Don Jesus, Senor Elfego and their henchmen were trimmed enthusiastically and decisively.

Jesus Romero carried Precinct 13, Old Albuquerque, which is his home precinct. The Andrews people, however, made no fight in Precinct 13. Don Jesus was present at the polls personally in Precinct 8, Los Griegos, and worked indefatigably in the interest of the Baca-Romero contingent. W. H. Gillenwater was present in this precinct in the interest of the Andrews candidacy. Andrews easily won the four delegates allotted to Precinct 8. Mr. Gillenwater is not a resident of Precinct 8, but his ranch is located in that precinct and his residence is just over the precinct boundary line. The presence of both Romero and Gillenwater in this precinct was a test of strength between the two leaders. That Gillenwater won out in a walk significantly demonstrated the fact that Don Jesus has lost his power in the county, and that he was lucky to carry his own precinct.

Credit for the victory in Precincts 12 and 26, city of Albuquerque, is due to Capt. W. H. Gillenwater, who organized and directed the campaign. Captain Gillenwater energetically took over the campaign when Elfego Baca and Jesus Romero arrived at the conclusion several weeks ago that they could drive the Republicans of the city of Albuquerque to water and also make them drink.

The fight for Andrews in the outside precincts was directed by Frank A. Hubbell. Mr. Hubbell, with his wide acquaintance among the voters in the mountain and river precincts, made a campaign which was effective, as was shown by the votes polled for the Andrews delegates.

In Pajarito, Mr. Hubbell's home precinct, the Baca-Romero machine had arranged to have the primary held at the school house. During the day Jesus Romero notified the chairman to change the polling place from the school house to the chairman's own home. When voters, favorable to Andrews, appeared at the specified polling place at the school house, they were informed that the voting was being done at the

chairman's house. Some sixty voters went to the chairman's house to offer their ballots. The chairmen warned them that they were trespassing on private ground and ordered them off the premises. They went. Needless to say they were not given an opportunity before the polls closed to cast their ballots.

In Precinct No. 3, Alameda, Andrews secured two delegates, Baca also receiving two delegates in that precinct. In Precinct No. 4, Ranchos de Albuquerque, Andrews easily won the four delegates. In Precinct 35, Los Duranes, there was no opposition to the Baca-Romero candidates and they were elected. In Precinct 1, San Jose, the four delegates will probably be divided, with the chances in favor of the Baca-Romero delegates. In Precinct 9, Los Ranchos de Atrisco, the Andrews forces won the four delegates, and in Atrisco also, the Andrews ticket elected two delegates with very little opposition. In Precinct 2, Del Rio, the Andrews voters appeared in force, but neither the precinct chairman nor the Baca-Romero supporters appeared at the voting place designated.

It was apparent throughout the day in the various precincts that the native population opposed Elfego Baca mightily. Indeed, the Spanish-American voters were as much opposed to Elfego as were the Anglo-Americans. Baca worked like a trojan throughout the day, but his work was ineffective. Those in close touch with the situation did not hesitate to say that Elfego had been double-crossed by his own people; that many voters had solemnly promised him that they were "for" him, and then voted against him at the polls.

Jesus Romero, who believed until yesterday that he was invincible in Bernalillo county, was a much discouraged man last night. Don Jesus conceded early yesterday afternoon that he and Baca had been beaten and that Andrews would control the convention by a substantial margin. Romero did but little work, contenting himself with being a spectator at the polling place in Precinct No. 12.

Immediately after announcement of the result of the vote cast in the county, showing that the Andrews candidates had been elected by an overwhelming majority, Romero declared that he would support Andrews in the convention.

The campaign, especially in the city precincts, resolved itself into a fight in which "Swat Elfego Baca" was the slogan. Elfego was swatted. Many men, who ordinarily manifest no interest whatever in primaries, went to the polls especially for the purpose of registering a vote against Baca, and indirectly a protest against Jesus Romero's attempt to butt into affairs in the city of Albuquerque.

Senator Andrews will go into the Bernalillo county convention with at least 79 votes out of a total of 108. It is very likely that before the convention is called to order, there will be a stampede and the senator will get the entire delegation.

Husband Slain

Wife of Victim May Face Trial as an Accessory to the Murder.

Word comes from Deming to the effect that the love for another man's wife and the ever fatal triangle of two men and a woman is responsible for the fact that Gus West, a cowboy 23 years old and well known in this section, is in the Grant county jail charged with the murder of Geo. King in his little ranch house on the Mimbres. King was found dead Monday night, with a Springfield rifle, bullet apparently entering the back near the shoulder and came out near the pit of the stomach. The bed was covered with blood and the room had trails of blood all around, where King had wandered before death had overtaken him.

After the shooting, West and Mrs. King went to the home of Adolph Hirsh, about a mile from the King ranch and reported that West shot King in self defense. West later disappeared and officers wired to Magdalena in search of West, as his people live there. The first trace of West was found at the Diamond Bar ranch, where he got a meal. West was caught 25 miles from Magdalena by an officer of that place and turned over to Sheriff McGrath of Grant county, who took his prisoner to Silver City.

The story which leads up to the tragedy is similar to hundreds of others, where a woman becomes infatuated with a younger man than her husband, who was about 30 years old. About two years ago Mrs. King and West became acquainted and a strong attachment sprang up between them, when West became a boarder in the King household. About a year ago Mrs. King and West, it is alleged, ran away together and went to Texas. Through the efforts of two brothers of Mrs. King, a reconciliation was effected between husband and wife and King went to Texas to bring his wife back. Telegrams found on West after his arrest show that Mrs. King sent him word to join her in El Paso, while she was on her way with her husband to New Mexico and that everything was all right. West did not meet them in El Paso, but met them later in Deming and the trio traveled together by train to Santa Rita. King furnishing West a railroad ticket. The three lived together at the ranch house for ten days when the shooting took place.

Letters found on West show that King had begged him to stay away from his wife. King's six-shooter and a roll of money amounting to \$107 was found on West. It is alleged by the officers that Mrs. King will be charged with being the accessory to the murder. The case will be tried at the September term of court.

Andrews Stands Pat

W. H. Andrews, endorsed for congress by the voters of the county Friday, declared last night that he stood pat on the original returns as published in the Morning Journal of Saturday, seventy-nine votes for Andrews and twenty-nine votes for the Baca-Romero combination.

DANGERS IN NORTH SEA

Itinerary of Cruisers Tennessee and North Carolina, Carrying Cargoes of Gold for Relief of Marooned Americans, May Be Changed; Tourists Stranded Because of Great War Not Now in Immediate Need of Succor; Those in Northern Country Must Seek Southern Ports Before They Can Embark for Home.

Washington, Aug. 11—Mining of the North sea as part of the plan of the European war not only may close most of the northern European ports to navigation, but the gold laden cruisers Tennessee and North Carolina and neutral passenger vessels bearing Americans from Europe will be confronted with new danger.

The American government was formally advised during the day by the British embassy here that inasmuch as Germany had been "scattering mines indiscriminately," Great Britain could no longer refrain from planting mines near her own ports.

It is believed that Americans in northern ports will remain there for the present or make their way south and southeast to such ports as Marseilles or Lisbon to obtain passage for the United States.

May Change Itinerary

An itinerary for the cruisers Tennessee and North Carolina, bearing millions in gold for the relief of Americans, has never been announced, but as both Great Britain and Germany have given warning of the dangers in the North sea, it is being taken for granted here that neither of the American warships will venture into those waters. After touching at Falmouth, England, the treasure ships probably will land at some port in France and then head for the Mediterranean, endeavoring, it is thought, to reach Americans in both Germany and Austria from points in the Adriatic.

Neutral Ports Blockaded

One diplomatist pointed out today that the ports of four neutral nations, Norway, Sweden, Denmark and the Netherlands, as well as one of the belligerents—Belgium—were practically blockaded through the promiscuous planting of mines in the North sea.

The Hague convention which regulates the use of the contact mines, stipulates that the belligerents shall undertake to do their utmost "to render these mines harmless within a limited time, and should they cease to be under surveillance, to notify as to danger zones as soon as military exigencies permit."

Formal Notice of Danger

Naval observers here believe, however, that in view of the titanic struggle this article in the convention will be of little moment.

The formal memorandum presented by the British charge d'affaires was delivered to the state department so that ships

under neutral flags might be turned back.

I only one or two places in Europe, notably at Genoa in Italy, and in Sweden, does the financial embarrassment of Americans continue, according to reports received today by Secretary Garrison. Nearly all of the European governments are believed to be desirous of establishing heavy credits with America to draw upon in payment for the vast quantities of food and supplies of other kinds which they must have during the continuance of hostilities and for a long time afterward.

Credit for Americans

Secretary Garrison thinks, therefore, that as soon as the first panicky feeling is over and financial conditions have been readjusted, the mere announcement that the United States or any individual has deposited specie in an American bank, subject to the draft from European countries, will be sufficient to establish credit for Americans in Europe. Everywhere on the continent Americans are gathered at the seaports and arranging for transportation homeward.

Official reports to the state department from Hamburg today cleared up the last apprehension for the safety of Americans in the German empire, with the exception of those special cases which have been taken up by Ambassador Gerard.

Father Rabeyrolle Forced In to French Army While On Visit.

Santa Fe, N. M., Aug. 11.—Sad is the plight of Father A. Rabeyrolle, for several years pastor of Guadalupe church in this city, being transferred to Las Vegas from here.

A few weeks ago he left on a visit to his former home in France. Last week he was impressed for service in the French army despite his protests and is now a private in one of the French regiments that is being hurried to the frontier. Father Rabeyrolle had an application for citizenship papers pending in the New Mexico courts, having been in the United States considerably above the required time and has cabled to the state department and to District Judge David J. Leahy so that steps might be taken to release him from military duty in France.

A recent decision of the U. S. Supreme court seems to annul that clause in land patents which provides that land shall revert to the government in the event it is found to contain oil or minerals after it has been patented. The court says in handing down this decision that the facts as to whether the land contains mineral or oil must be determined before the land is patented. This first effect of this decision perfects title to seventy million dollars worth of oil lands in California to the transcontinental railways.

An exchange says: Our attention has been called to the fact that we never saw a bald-headed woman. Well, what of that? There are a good many things we never saw. We never saw a woman sit on a drygoods box and surround herself with filthy pools of extract of tobacco sprayed through her teeth. We never saw one go fishing with a bottle of bait in her hip pocket, sit on the damp ground and go home drunk at night. We never saw a woman yank off her coat, give her pants a hitch, spit on her hands and swear she could whip the biggest man in town. Come to think of it, there are a good many things we never saw a woman do, and don't want to, either.

The Albuquerque Evening Herald dated July 27th, contains the following:

"Boys and girls of Albuquerque and New Mexico should be encouraged to learn the Spanish. Not because a considerable portion of our people are Spanish speaking, although a thorough knowledge of Spanish is very useful in that regard but because next to the English the Spanish language is the dominant language in the western hemisphere and will come to more and more use in the United States as our relations grow closer with the Central and South American nations, as they are bound to do with increasing rapidity from this time on.

In New York City, in Boston and in Baltimore and Philadelphia, high school students are being encouraged to elect Spanish as the modern language course likely to be most permanently useful. Surrounded in our every day life by Spanish-

speaking people, the opportunity for our boys and girls is a splendid one; too valuable an opportunity to lose. No child should be permitted to grow up in New Mexico without acquiring thorough command of the Spanish, which is made easy with very little textbook work because of its constant use in the everyday life around us.

The little boys and girls of Spanish-speaking parents in our common schools are eager students of English, and facile students. More and more of the young people of the United States are turning to South or Central America. To these the command of Spanish is essential. To all of our boys and girls it will prove of practical service no matter where or into what walk of life they may go."

War Will Benefit United States

President Wilson denies the newspaper allegation that he recently remarked that the pending European war will be of great benefit to the United States, but whether the president used the remark or not, it is a self-evident fact that this country will profit greatly by the grievous days that have fallen upon Europe.

It may be that during the early days of the European war there will be a little tightening in financial circles, but with the pouring of millions of the new emergency currency into circulation by the treasury department, any contraction of the circulating medium would appear unnecessary and impossible. There is plenty of money now in the United States with which to transact the business of the United States, and the time is not far distant when the wealth of Europe will be pouring into this country in return for the things Europe is compelled to have, and the result is going to be high prices for all the United States has to sell, and the running of all United States manufacturing enterprises under high pressure in order to supply the European demand. This is going to mean plenty of work and high wages for every American who desires to work, and the complete banishment of all thoughts of hard times. That is the view taken not only by thinkers of this country, but openly commented upon by leading European newspapers. The London Statist says:

"A great war in Europe will probably bring economic advantages to the United States. It will enable it to sell its great crops in places which will give a much greater income than if there was no war.

"Almost every industry will derive more or less advantage. American investors and bankers should get in much profit from the ability to buy back from Europe great quantities of securities at attractive prices in payment for the foodstuffs and raw material exported from the United States.

"The United States can become, as it has this week, the world's greatest market for capital, and if the American people rise to their opportunity they can do a great deal to mitigate the disastrous economic consequences which would otherwise result in many countries from a great European war.

"It is obvious that for the time being the money markets of Europe will be closed to the demands for new capital of Canada, Brazil, Argentina, Mexico and other countries, and at such a time the prestige of the United States would be immensely enhanced if it were to take the place of Europe and meet the pressing needs of these borrowing countries.

"It is possible that the United States may participate in the great loans that will have to be raised in Europe if almost the whole continent becomes engaged in war. Possibly the participation will be indirect rather than direct.

"For the United States to gain benefit from the position as the wealthiest nation in the world it is essential that American investors should not only have confidence in the future of their own country, but also believe that war, or no war, the world will continue to progress.

"In brief, a great war in Europe will give the United States an opportunity of assuming the post of world banker, by supplying capital freely to countries and individuals in all parts of the globe who need it and can provide the required security. Should the American people take advantage of the golden opportunity afforded them by the outbreak of war, it will mean not diminished but increased prosperity for the United States."

Advices from Willard are to the effect that Torrance county will have a splendid exhibit at the New Mexico state fair at Albuquerque this fall. All the best exhibits gathered for the local fair will be sent to Albuquerque, and as the Estancia valley has had one of the best years in its history this year, it is expected to be able to show up with the best there is in New Mexico at Albuquerque.

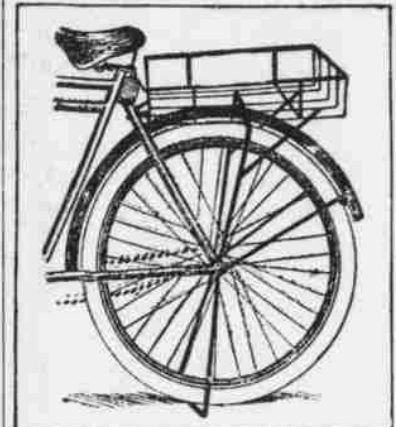

Hon. Saturnino Baca, county school superintendent, left this morning for Los Lunas to attend the county Republican convention.

Every Republican turned out last Monday night to attend the precinct primaries which were carried successfully and with great harmony.

F. E. Mayhew, of Albuquerque, has been called to this place to fill the vacancy occasioned by the illness of John Mack, a time-keeper in the S. F. shops.

Walls to Represent King Alfonso at Mexico City.

A report was current in constitutional circles in El Paso that Senor Manuel Walls Merino will be appointed Spanish minister to Mexico, immediately upon the recognition of the constitutional government, which is expected to follow the occupation of Mexico City. Senor Cologan y Cologan, the present minister, it was said, would be recalled, being persona non grata with the constitutionalists because of alleged sympathies with the Huerta regime.

Senor Walls Merino, who is consular of the Spanish legation at Washington, is at present with General Carranza on a special mission for his government. Last week he spent several days in El Paso while waiting for his passports to enter Mexico. He has been connected with the legation at Washington for the past twelve years.

Southwest Settling Rapidly

Arizona and New Mexico newspapers are teeming with items of new homes being built, new farms being opened, and telling combined stories of thrift and prosperity that serve to demonstrate the fact that both of the new states are settling rapidly and their citizens are finding the things to do that count for much in the scale of general prosperity. —El Paso Times.

With their marvelous mineral resources constituting an inexhaustible source of wealth, unrivaled climate, limitless possibilities and potentialities it is not surprising that New Mexico and Arizona are filling up rapidly with the most desirable type of home-seekers and that capital is being freely invested.

The story of growth and development of Arizona soon to be written is going to prove full of wonderful things and will tell of wonderful accomplishments in a wonderland.

Great as has been the growth in population and wealth of the two states it has only begun, and when affairs in Mexico become straightened out; Arizona, at least, is going to surprise the whole country with the extent and speed of her progress. —Douglas Daily Dispatch.

Baca Bluffing

"The Albuquerque Morning Journal" of last Monday contains the following:

"I will have fifty-six delegates in the Bernalillo county Republican convention, any statements made by my opponents to the contrary notwithstanding," said El-fego Baca last night.

Mr. Baca, it will be recalled, was gently retired to oblivion in county politics last Friday, when the Andrews forces trimmed him by a two to one vote in city and county precincts.

Baca would not quote detail figures as to precincts to show

how he will have fifty-six votes in the county convention. However, he was positive in his declaration that he will be there with a majority of the 108 votes.

"I am in the race to stay," said Baca. "I will be in the convention and will show a strength that will surprise those who oppose me."

European Notes

Confirmation of the reports that Liege had been taken by the Germans apparently was given by dispatches received from Berlin yesterday, although advices coming from Belgian, French and British sources maintained that the forts there were still in the hands of King Albert's men. It was asserted in these dispatches that although the city was invested, "there had been no serious occupation of the town by the Germans."

An official dispatch issued by the Belgian general staff, said the advanced German troops were being pushed back and that the German offensive movement had ceased.

A junction of Belgian, British and French troops in Belgium is reported to have been effected and a clash between German and French cavalry south of Namur is said to have taken place.

Athens dispatches say large Turkish forces have been concentrated on Bulgarian territory by agreement with Bulgaria.

Emperor William is reported to have left for the Alsatian frontier to join the German general staff.

The British admiralty announces that German submarines attacked a British cruiser squadron but that the British ships escaped undamaged, while one German submarine was sunk.

France has requested the Austrian ambassador to explain Austria's intentions in an alleged movement of Austrians across Germany to the French frontier.

Cholera is said to have broken out among the Austrian and Serbian troops.

Paris dispatches say the Germans in Belgium are short of provisions.

A cablegram from Pekin says serious "conversations" are proceeding between the Tokio and London governments concerning whether Japan will participate in an attack on the German colony of Tsing-Tau.

The French and Belgian governments have directed that the resources of the two countries shall be the common property of France and Belgium.

The Crime of the Century

In commenting on the outbreak of general war in Europe, the New York World says:

In Vienna there is a doddering old man, the offspring of a tainted house, who sits on the throne of the dual empire.

In St. Petersburg there is a weak, well-meaning neurotic, who by the accident of birth happens to be the czar of all the Russians.

In Berlin there is a brilliant, talented, ambitious manipulator of politics who is German emperor by grace of the genius of Bismarck, Moltke and Roon.

Of these three men, only the

one in Berlin has more than mediocre abilities; yet the three are permitted to play with the lives of millions of men, with property worth thousands of millions of dollars, with the commerce and industry and prosperity and laws and institutions, not merely of empires and kingdoms, but of continents. It is left to them to determine whether the world is to witness the most deadly and devastating war of all history.

The thing would be laughable, ridiculous, if it were not so ghastly.

In an able editorial on the same subject the Houston Post says:

History will indict monarchy for this orgy of murder, this defiling riot of the elemental passions that now begins to roar about the temple of Christian civilization. It could not have happened in a democracy where in truth and justice reigned. It could not have sprung from the serene lives of a God-fearing peasantry, such as inhabit the great countries of Europe, nor could it have germinated among the thrifty artisans whose skill have wrought much of the fabric of European greatness.

Only among the ambitious and crafty politicians and the envious and jealous princes of a system of privilege could the calamity have found its origin. Monarchy, royalty, nobility and the fawning parasites that trail in the pathway of pomp and heraldry are the deadly influences that combined to light the torch and set the people at each other's throats.
