2	President's Report	On 2/25/13, Clark attended the ERB Stakeholders meeting where they discussed solvency recommendations. Bills are still pending in the legislative committees. Provost Abdallah included staff in his Five-Year Compensation Plan and he will present this to the Regent's Finance & Facilities Committee, although Clark said she did not see this as an agenda item.
