County Seat Hearing Postponed.

Contrary to expectations, the county seat hearing did not come up at Alamogordo last Monday, the hearing having been postponed until tomorrow (Saturday). A letter from the attorneys for Lincoln informed the attorneys for Carrizozo that, in case the matter remained in court, an application would be made to take further testimony in the case, and if granted, the taking of testimony would begin at once. If this is done, a referee will be appointed, the evidence taken, and the case resubmitted on the new evidence. What effect this will have on the case, as to its status in court, is more than the average mind is capable of grasping, and we wouldn't even hazard a guess as to the course the matter may take in the future. It is true that it was understood that Lincoln would appeal to the supreme court of the United States, but in doing so it was thought the appeal would per force be on the record made at Santa Fe in the supreme court of the territory. Now, it is impossible to say, and the further we go the worse mixed we get.

Died Alone.

George Lee and Charles Henley came in Friday afternoon last and reported to Justice of the Peace Massie that they had found a man dead in a cave, or dug out, in the malpais, about six miles southwest of town. The justice had a coroner's jury summoned, consisting of Walter C. Miller, Clay Van Schoyck, Thomas Johnson, S. W. Perry, Edward Andrews and W. B. Wagoner, and proceeded to visit the scene of death and hold an inquest.

The dead man, from the papers found on his person and about his place, proved to be Bernard Bartag, and a letter from a brother also showed that he was a native of Germany. The indications were that the dead man had been dead for at least two weeks, although there were no witnesses to substantiate the belief except the physical surroundings. The deceased was known to few, lived alone, seldom commingled with his fellow man, and though occasionally seen in town, was not generally known by name.

A contract found among the papers showed that the deceased had one hundred sheep on the shares from a brother of Walter C. Miller, and in addition to this the coroner's jury found the sum of \$2.27 and two guns. His cave or dug out was practically without furniture and almost devoid of bedding, only a rude arrangement being used for this purpose and the covering indicated little comfort, a few pelts and one tarpaulin. The jury rendered a verdict to the effect

that the deceased came to his death from unknown causes; and yet the opinion of all was that the meagre shelter and the still scantier bed clothing brought about death by freezing, or exposure to the cold of some two weeks previous to the date of the discovery of his body.

The sheep that had been run by the deceased had not been in the corral, apparently, for some days, but were later discovered, although short of the original number. The remains were interred where they had been found.

Methodists to Build Church.

At the quarterly conference of the Methodist church of this district, held at Tularosa last Saturday, a committee on church building was appointed, and the erection of a church edifice for the Methodist faith in Carrizozo was placed in the hands of this committee. The committee consists of Clarence Spence, Walter E. Winfield and the pastor of the church, Rev. B. W. Allen.

The plans have been drawn and approved and everything arranged for an early beginning on construction.

The building is to be of cement blocks, lower part rock face and upper part pebble dash, style colonial. The building will be 36x51 feet on the inside, and so arranged that it may be curtained off into four Sunday school rooms or one large room. The estimated cost is \$5,000, which includes seating.

Teams are now hauling sand for the manufacture of the blocks, and if no serious weather intervenes the work of moulding the cement blocks will begin in the near future.

IMAGINE AGE GIVES FLAVOR

That Seems the Only Explanation as to Why Fresh Nuts Are Never Served on Shipboard.

"Whence do all the old nuts come, and where do they go?" was the question put to a New York Times reporter by a broker who had just returned from his semi-annual trip to Europe.

"On my many voyages across the Atlantic and in the eastern seas," the broker went on to say, "I have never seen fresh nuts on the dining tables which were laden with all the delicacies of the season. The only person I ever met who had seen fresh nuts was a grizzled quartermaster, who looked old enough to have sailed the raging main with Paul Jones. He said tersely:

"I've seen 'em wunst. On the Tanjong Pagar pier at Singapore in sacks, but they never come aboard the ship."

"Fellow-passengers with whom I have discussed the problem were of the opinion that the steamship companies had some big cave where all nuts were stored for a few decades until they had aged.

"Capt. Pritchard, the retired commodore of the Cunard line, once told me that the island of Tobago, where Robinson Crusoe lived, was the clearing house for nuts, and the companies sent them there in sacks to be exchanged after they had been afloat for three years. This was corroborated by Capt. Arthur P. Mills of the American liner Philadelphia, who said that an old shipmate of his, Capt. Ben Brails, had carved his initials on a Brazil nut and put it back on the dish while his ship was crossing the North sea, and got the same nut on another vessel four years later in the Straits of Shimonoseki, Japan. This had such an effect on the mind of Skipper Brails that he marked all kinds of nuts with his initials and the date and wrote letters to all his old shipmates requesting them not to crack any of his marked nuts if they met them on their voyages."

Veteran stewards, when asked why the companies do not put fresh nuts on board their ships, say that perhaps the companies are afraid they will disagree with the passengers.

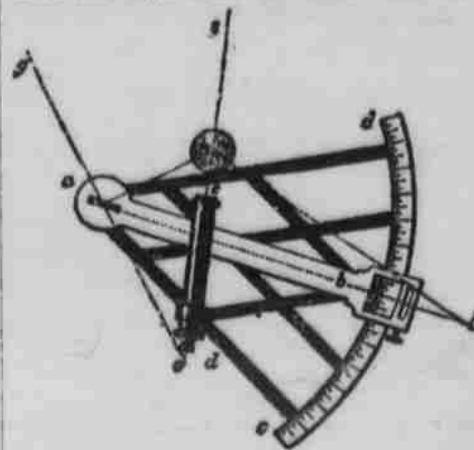

PRACTICAL USE OF SEXTANT

Instrument Determines Angular Distances Between Two Stars—How It Is Done.

The use of the sextant is to determine the angular distances between two stars. This is done by means of reflecting mirrors and a telescope. The telescope is directed so as to receive in direct line the rays from one of the two stars under observation, and to receive by reflection from mirrors the rays from the other star un-

der observation. The mirror (m) is directly in the line with the telescope, and the upper part of the disk containing the mirror is of plain glass, which transmits the light from the star directly. The lower part of the disk contains a mirror. The other mirror (a) is fixed on a movable limb of the sextant. When this limb is fixed at zero the two mirrors are parallel. The limb is moved about and with it the mirror (a) until the ray of light (g.a.) is reflected through the mirror (a) to the mirror (m), and thence directly into the telescope, so that the two stars are seen coincident by the observer, the one directly and the other reflected twice from the two mirrors. The angle between the stars is twice the angle between the mirrors. The angle between the mirrors is read directly on the graduated arc of the sextant.

SAFETY DEVICE FOR CRIBS

Straps Arranged to Hold Small Child in Bed and Prevent It From Uncovering Itself.

Mrs. F. Sallinger, of New Rochelle, N. Y., has perfected an invention which provides an improved safety strap for holding a small child in bed and preventing it from uncovering it-



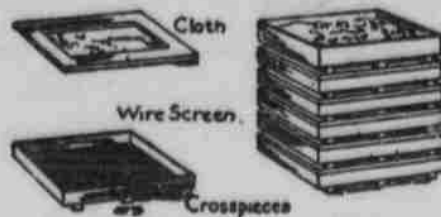
Safety Strap for Cribs.

self by its tossing and kicking. Two straps are provided, which pass lengthwise around the bed at each side of the child, while there is a cross strap that may be adjusted to any desired position over the child. The cross strap is provided with an elastic section which enables the child to move freely within the limits imposed. The straps are provided with reinforced eyelets, through which safety pins may be passed to fasten the straps to the bedding.

INCUBATION OF FISH EGGS

German Method of Hatching Out of Water Gives Excellent Results With Trout and Salmon.

Hatching fish eggs out of water may sound absurd, but it is nevertheless true that the most important stage of the hatching may be passed out of water and that this makes possible a considerable simplification of the hatching apparatus. The method has

been tried in Germany with trout and salmon eggs and has given excellent results.

The eggs, thoroughly washed, are spread to an even thickness on trays about 6 inches square and but 1/4 inch thick, says the Popular Mechanics. The bottoms of the trays are formed of cloth, made fast to the under side of a frame very much like that of a window screen. These egg trays hold about 1,000 eggs each, and each one rests on a second type of tray, called an "air tray." This tray is also 6 inches square, and 1 1/4 inches deep, the bottom being formed of fine mesh wire.

One of the illustrations shows a pile of these trays arranged alternately, beginning with an air tray, and having at the top a third kind of tray. This is called the "upper air tray," and is 4 inches deep, filled with bog or wood moss.

Placed in a cellar or other cool place, all that is required is to pour a small quantity of pure water into the top tray each day in order to maintain the humidity of the lower trays, and to inspect the egg trays once a day for the removal of dead eggs. When the embryo becomes plainly visible inside the egg, they are transferred to the ordinary underwater apparatus and will hatch in a few days.

GOOD CAKE RECIPES

FORMULAS THAT HAVE BEEN
TRIED AND PROVEN.

Devil's Food Cake Easily Made and
Success Always Insured—Soft Molasses Cookies—Banana Shortcake—Popcorn Crisp.

Devil's Food Cake.—Grate into a dish one-quarter cake of unsweetened chocolate, add one-half cup of boiling water and one teaspoon soda; let stand until other part of cake is mixed.

Cake part—Two cups of brown sugar, half cup each butter and sour milk, 2½ cups flour; pour in the chocolate mixture and bake in layers.

Filling for same—Two cups brown sugar, half cup of sweet milk, butter size of an egg; boil a little, stirring all the while. Do not let it boil too long as it will sugar.

Soft Molasses Cookies.—One cup molasses, half cup water, half cup lard, half teaspoon each of cinnamon and ginger, one heaping teaspoon soda. Boil water and lard together, put in soda, stir well, add to molasses, mix as soft as you can without having too sticky. Bake in moderate oven. These should be thick, soft and delicious. Recipe is over 100 years old.

White Cookies.—Two cups granulated sugar creamed with one cup butter, one cup of thick sour milk or cream, one teaspoon soda dissolved in one teaspoon of hot water, nutmeg to taste, just enough flour to handle the dough easily; roll out and cut, sprinkle with sugar and press a raisin in center of each; bake in a rather quick oven to a delicate brown.

Popcorn Crisp.—Boil one cup molasses and one cup sugar together till it is the right consistency for candy. Have five quarts of popped corn, free from hard kernels, in a large pan, over which pour the mixture, stirring in at the same time so the molasses will be evenly distributed. When cold it will be crisp and delicious.

GOOD HINT ABOUT IRONING

How One Housekeeper Keeps Clothes
Clean While Putting on Finishing Touches.

A housekeeper who is noted for her labor saving devices attached a big pocket to the ironing board when ironing skirts and dresses which will drag upon the floor.

The pocket is made of unbleached muslin with a wide hem at each end, and is so long that when it is attached to the sides of the board it will nearly touch the floor.

A double piece of muslin is put on the corners of the hem to re-enforce it, and these corners are pinned at the sides after the garment has been put on.

As it is ironed, the garment falls within this loose pocket, and is kept from contact with the floor.

Pound Cake.

Take a pound of sifted sugar and a pound of fresh butter, mix them with the hand for ten minutes, and add to them nine yolks and five whites of eggs, well beaten. Work all together and add a pound of flour sifted with four level teaspoons of baking powder, some caraway seeds, four ounces of candied orange peel cut into slices, a few currants, well cleaned. Mix all together very lightly.

To Keep Material White.

Dresses and other articles made of delicate white material often become yellow with lying. To prevent this, take a good-sized pillow case and blue it thoroughly. In this place the dress and baste or pin the open end of the case, so as to keep out all dust and air. When you open the blue bag your dress will be white, without resorting to the ruinous "tub" or dry cleaning process.

ROYALTY AS THE GODFATHER

STATEHOOD POSTPONED.

At twelve o'clock noon, March 4th, the 61st Congress of the United States passed into history, and with its death went the hope of statehood for New Mexico for the time being. The resolution approving the constitution of New Mexico was unanimously passed by the lower house of congress, but when it reached the senate little time remained for its consideration. In the senate an amendment was attached to the house resolution to include Arizona, and a statement made on the floor by Senator Owen, of Oklahoma, that if Arizona was not admitted with New Mexico he would oppose the admission of New Mexico alone. It being evident that a filibuster for time would prevent a vote on New Mexico alone, the senate took a vote on the combined resolution, and it was lost by a vote of 45 to 39.

There has been a great deal said concerning this result, and many papers in the territory, in an attempt to make political capital out of the result, have blamed the democrats for failure to grant statehood to New Mexico. In view of the fact that every department of the government was, prior to adjournment, in the hands of the republicans, this statement seems a little far-fetched. Now the truth of the matter is that there is not now, nor has there been for many years, any democratic opposition to the admission of New Mexico, and the votes on the question in both houses confirms this statement. And on this last proposition to approve the constitution the democrats in the senate voted practically unanimously for the resolution, only three of the entire membership of the party in the senate voting against the resolution. This being the case, there were, then, just forty-two republicans in the United States senate who opposed the admission of New Mexico on the final test. This, however, is nothing new, statements to the contrary, notwithstanding.

President Taft has carried out his threat, or his stated purpose, whichever it may be termed, and has called an extraordinary session of congress, the date of convening having been fixed for the 4th of April. The main purpose of the call is to effect a reciprocity agreement with Canada, and bring about relations with the Canadian government and our own that will insure some relief from the burdens of the high cost of living. That this is a step in the right direction, a great majority will agree, including a vast number of the president's own party; but many believe it will fall short of expectations and that a further reduction of tariff du-

ties will be necessary to bring about the desired result. To this end the democratic majority in the lower house, where all revenue bills must originate, will enter into the consideration of a reduction of tariff duties. And, it is the general belief that the Ways and Means committee of the House will prepare bills for such reduction, schedule by schedule, and by so doing secure the support of the liberal element of the republican party in the senate and finally the approval of the tariff reductions by the president himself.

The United States supreme court has decided that West Virginia must pay its portion of the debt of the old state of Virginia at the time of the division. The new state's portion, exclusive of interest, is \$7,000,000.00. Being the mother of a state is almost as advantageous as being the "mother of presidents."

More lame ducks were stalking about Washington after twelve o'clock noon last Saturday than at any time in the history of this country. Many senators and representatives have bidden adieu forever to the privilege of addressing "Mr. Speaker," and "Mr. President."

It is the opinion of many that there is a possibility that the extra session of congress may admit New Mexico to statehood. If, however, such is not done, we will wait with patience—we have lots of that—for the regular session this coming winter.

Bailey is the biggest man in the United States senate, and in more ways than one. In the last, he almost equals Roscoe Conkling.

California is to be the next state to adopt the initiative and referendum. And the state is not in the control of the democrats at that.

Statehood will come this congress or the next, or, certainly sometime, or, at any rate, soon thereafter.

Secretary Ballinger Resigns.

Secretary Ballinger has resigned as a member of President's Taft's cabinet. For almost two years, to be accurate, soon after he became secretary of the interior, mutterings of deep discontent were heard over some of his rulings. Charges of a most serious nature were preferred against him, and, unfortunately for the secretary, they were generally believed by the public. One of the results of the agitation for his removal was the dismissal of Gifford Pinchot, chief forester, Roosevelt's particular friend. The effect of that dismissal was an estrangement between President Taft and his immediate predecessor, and the beginning of a bitter campaign which has not yet ended. President Taft has stood firmly by his secretary, and so did a committee appointed to investigate the charges against the secretary. And even now, as the secretary retires to private life the president gives him a most touching testimonial of his affection, asserting that the secretary has been a badly abused man. The principle brought out by sticking to a man universally condemned but whom he still had faith in is to be commended in the president, but his judgment is susceptible to serious question, for the final retirement of Ballinger means more peace in the administration family than it has enjoyed for many moons. Walter L. Fisher, of Chicago, succeeds to the vacancy.

HOT POT DELICIOUS DISH

It is Made of Mutton, Sheep's Kidneys, Oysters, Potatoes and Spanish Onions.

One and a half pounds of the best end of neck of mutton, two sheep's kidneys, six oysters, one and a half pounds of potatoes, half a pound of Spanish onions, one tablespoonful of butter, one cupful of stock, salt and pepper.

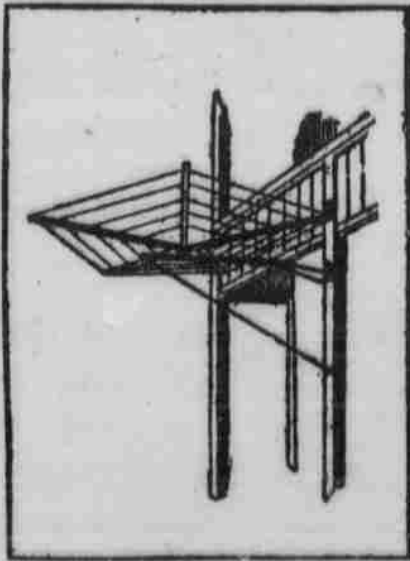
Cut the meat into neat, small joints, trimming off all but a thin rim of fat. Wash and peel the potatoes, then half cook them in boiling salted water. Peel and slice the onion. Skin and core the kidneys, and cut each into six or eight strips; also cut the oysters in halves. Fill the casserole with layers of, first, meat, next kidneys and oysters, then onions, slices of potato and seasonings. The top layer should be of either halves or quarters of potato. Pour in the stock, put the butter in small pieces on top of the potato. Put on the lid, and bake in a moderate oven from two and a half to three hours.

For the last half hour take off the lid, so that the potatoes may get nicely browned. If the gravy seems drying up too much, add more stock, and just before serving pour in a little more stock. Serve in the casserole; this will insure the stew being really hot. If more convenient, the potatoes need not be partly cooked beforehand, but in this case the meat sometimes gets rather overdone if the potatoes used happened to be slow cookers.

BEST OF CLOTHES DRYERS

It Spreads Out Like a Fan or Folds Up Like a Bundle of Sticks.

A clothes dryer that will be a boon to flat dwellers has been designed by a New York man, and is shown in the illustration. It is adapted to extend from a window or balcony, and when not in use can be folded up into such a small compass as to be scarcely noticeable. A bar with a groove in it



is hinged to the window sill or porch post and held in horizontal position by a wire or cord fastened above it. In the groove slides a hub, which has spokes extending from it, and cords connect these hubs, like the cross sections of a spider's web. Indeed, the dryer resembles a huge spider's web when extended. As will be noticed there is ample space to hang a large wash on this dryer, which can be drawn in to a point where it is easy to reach and the clothes put on. When out of use the hubs and supporting rod can all be drawn into parallel position with each other and the whole drawn back against the post, like a bundle of sticks.

Flaxseed Lemonade.

Steep two tablespoonfuls of flaxseed in one quart of hot water for ten minutes. Strain and add the juice of three lemons, a large cupful of sugar and a wineglassful of wine. Drink either hot or cold. This is an excellent drink for persons suffering with colds or lung troubles.
