Statehood in Sight.

Washington, D. C., April 10.—Congressman Flood, of Virginia, and Houston, of Tennessee, called on president Taft today in the interest of Arizona and New Mexico statehood. Flood, who is chairman of the committee on territories, said after the interview that he was satisfied the president would sign the resolution approving both constitutions as soon as congress has passed it.

It is the general belief here that statehood at this session for both territories is certain and that the president will sign the resolution admitting the territories. This, it is pointed out will do away with the necessity of his approving or disapproving the Arizona constitution, to which it is known he is opposed. The senate has adjourned until Thursday.

Las Vegas Kidnappers Confess.

The sensational developments in the Rogers kidnapping case at Las Vegas as was predicted in the News last week happened last Saturday night, when by the confession of Joe Wiggins, a former life convict, Will Rogers, uncle of little Waldo Rogers, was arrested for complicity in the child's abduction. For his return \$12,000 ransom was paid, Will Rogers acting as agent for Mrs. Rogers. Wiggins was arrested late Saturday and his confession at once.

At 11:30 Saturday night, following the confession of Will Rogers, the 20-year-old youth who apparently conceived the kidnapping plot, officers went to the home of A. T. Rogers, Sr., where the young man lived and found intact the \$12,000 ransom money paid for the return of little Waldo Rogers. Will Rogers, in his confession, told where the money was hidden. It now develops that the brother, John Rogers, had no knowledge of the crime, the kidnapping being planned by Will Rogers and the stealing of the child done by Joe Wiggins, an ex-convict pardoned from the New Mexico penitentiary, where he was serving a life sentence for murder. Not until the confession and the recovery of the money did A. T. Rogers, Jr., father of the stolen child, believe his brother was implicated in the crime. It is said that Will Rogers is being closely guarded as it is feared he may attempt suicide.

Young Rogers became acquainted with the ex-convict Wiggins while the latter was a trusty in the gang of prisoners employed on the public highways near Las Vegas.

County Seat Hearing Postponed.

The county seat hearing came up before Judge Wright at Alamogordo last Saturday. The nature of the proceeding was on the \$15,000.00 bond, the approval of which would keep the injunction in force, and its disapproval the dissolution of the injunction. Affidavits and abstracts of county records were filed by both plaintiff and defendant, to substantiate which required the taking of testimony. The court postponed the hearing to May 1st, on which date the Lincoln county district court will convene at Carrizozo, and at which time evidence will be submitted in corroboration of the affidavits filed. Therefore, until this hearing, everything remains as before.

A Voice From the Lone Star State.

In making an appeal to the Texas legislature for a state provision for the care and cure of consumptives, T. H. McGregor, a member from Austin, and at one time afflicted with tuberculosis, told of the horrors of the disease, his suffering, his struggle with the great white plague, and finally of his triumph over death and his belief that consumptives can be cured. He said in part:

I have held onto a mesquite limb at Comfort, Texas, and felt the blood run from my mouth and saw the stars shine and wondered if I would ever see them again; I have clung to the guy rope of my tent and wondered which way the fight would go. I know the disease responds to treatment.

As an introduction to his address, he called attention to the anti-lobby law, which requires that a person speaking for a measure must tell whom he represents. Mr. McGregor spoke as follows:

I sat as a spectator in a committee room of this body and heard an eminent lawyer begin a great legal argument with the statement that he appeared for a corporation. The statement was made in the observance of the law of the land and the rule which governs this body. Taking my cue from him, I shall tell you whom I represent. I come, if you please, for the old, whose shrunken shoulders speak a long and constant pain, and whose crackling cough sounds even to the hollow echoes of the tomb; and I come for the middle-aged, too often the flower of the moral and mental manhood of the state, whose recurring temperature and quick heartbeat speaks the presence of the world's greatest enemy.

And then I come for the young manhood of Texas, the boys, the hope and promise of the state, on whose high brows is set the seal of the white plague; and then I come also for the girls of Texas, the sweetest flowers that bloom on all her prairies or blossom in all her valleys, and whose beauty and maiden purity radiate all our hopes, and yet too soon do their forms feel the touch of that destroyer and on ruddy lips comes the carmine of death.

And then I come for the motherhood of Texas, whose sunken eyes and pale face make a veritable melody of misery as she lays her withered hands, with large ligaments and swollen veins, upon the heads of little children, whose orphanage the state could prevent. And then I come for the babes who, pillowed upon their mothers' breasts, draw infection from the fountain of life. And then I come for those who halt by new-made graves and moisten withered flowers with tears, and then I come for the strong, to make not an appeal, but a demand, looking to the health and citizenship of the state.

FRILLS OF COOKERY

THINGS THAT MAKE THE FOOD MORE APPETIZING.

Oyster Cocktails in Halves of Grapefruit, Sugared Sweet Potatoes and Chestnuts in Burning Brandy, and Other Hints.

Have you served oyster cocktails in halves of grapefruit? They look pretty and taste well as a first course at dinner or luncheon. Generally the grapefruit is not eaten, but it can have the sections separated for those who dislike wasting so appetizing a cup.

Do you realize what a pretty dessert is made from a ring of vanilla ice cream with heaped-up gelatine in the center?

Of course you have served sugared sweet potatoes in burning brandy, but have you ever put a boiled chestnut on top of each slice or a section of fried apple?

A delicious way to serve cheese with the salad course is to mix a large cake of cream cheese with whipped cream until very light, then stir through it bar-le-duc until highly colored.

When lettuce is ungainly and not especially tender have you tried shredding the border to your salad, marinating it first in French dressing? It looks as well as the hearts and has a delicious flavor.

Sections of oranges carefully skinned and well chilled make a pretty and appetizing border for a mound or vanilla ice cream. There can be an outer border of whipped cream.

A novel dessert is mince tarts covered with vanilla ice cream. For an impromptu supper these pies are often covered with welsh rarebit. The mixture is not so deadly as it sounds.

Smelts fried in bread crumbs and masked in mayonnaise or sauce tartare, taste and look better than the fish without sauce.

Have you served sweetbreads fastened with a silver skewer and wrapped in a crisp slice of bacon.

Gelatine to be served in thin glasses will be much clearer if poured directly into those glasses and allowed to cool in them. Before sending to the table heap with whipped cream.

Do you know that a few tablespoonfuls of good whisky or brandy greatly improves all wine jelly? Also that the flavoring should not be added until the gelatine has slightly cooled?

Are you sure to wash all fruit before sending it to the table? Not only does it mean fewer germs, but the color of the fruit is more artistic. All fruits should be served cold—which does not mean half frozen.

Do you know there is no more refreshing way to eat oranges, especially for the semi-invalid, than to squeeze the juice in a tall, thin glass, which is then filled with shaved ice? Take through a straw.

Stewed Beef Heart.

After washing the heart well, cut it into small square pieces; put them into a saucepan with enough water to cover them. If any scum rises, skim it off. Now take out the meat, strain the liquor, put back the meat, add one sliced onion, two tablespoons of chopped parsley, a head of celery chopped fine, pepper, salt, paprika and two heaping tablespoons of drippings or butter. Stew until the meat is very tender. Mix together one tablespoonful of browned flour, with a little water, stir this into the pan, allow to boil up and serve.

Rocks.

One and one-half cups sugar, one cup of shortening, three eggs, three cups of flour, one teaspoonful of soda dissolved in one-half cup of hot water, one tablespoonful of cinnamon one cup of raisins, three-quarters cup of nuts. These are delicious and may be kept for a long time.

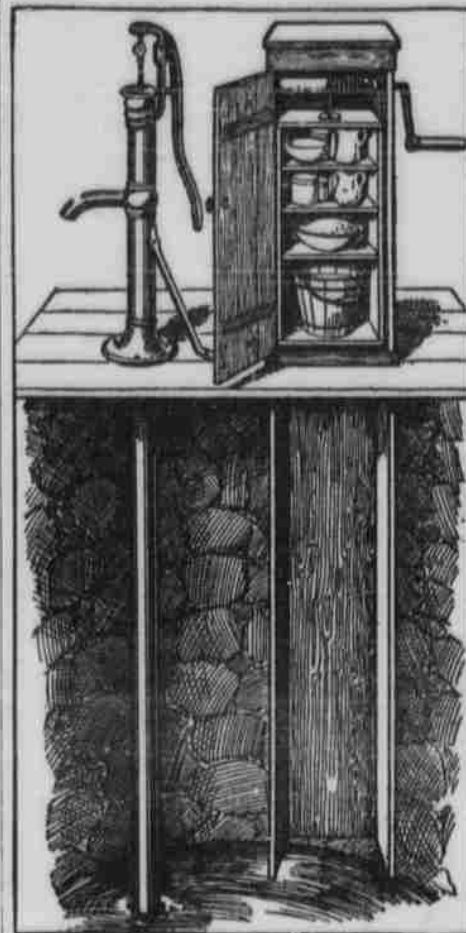

REFRIGERATOR FOR COUNTRY

Scheme for Keeping Things Cool in the Well When Ice Is Not Procurable.

A country place is not always situated where ice can be procured during the summer months and a substitute refrigerator must be provided. A resident of a country place devised a cooling apparatus which he placed in his well. The device consisted of a box about one foot square made of



boards having a length to reach almost to the water level and to extend about four feet above the platform of the well. A short box containing several shelves is made to slip easily into the long one similar to a dumb waiter. This smaller box is lowered and raised with an old-fashioned windlass. The smaller box containing the shelves is filled with things to be kept cool.—Popular Mechanics.

HINTS FOR THE HOSTESS

Attractive Way to Serve Banana Ice Cream—How to Combine Apricots With Curacao.

Banana ice cream has quite a festive appearance when served in sherbet glasses and decorated with frosted slices of bananas and preserved cherries, which should be stoned and entirely freed from superfluous juice. To frost the bananas, dip the slices into a thin white icing similar to a cake frosting. The slices should be merely glazed and not heavily coated. If it is inconvenient to frost the bananas the slices may be used plain.

Snowballs of ice cream are very attractive when served with snowballs of cake on a wintry night when real snow is flying out of doors. To prepare the cake, cut out rounds of white lady cake, free it from crust and dip it into cocoanut frosting. If a little cocoanut is sprinkled over the ice cream balls the two will look so much alike that one can hardly tell the difference.

A famous chef served apricots with Curacao. Remove the juice from a pint can of apricots. Add a tablespoonful of sugar and the rind of an orange to the juice. Let it boil ten minutes; then remove the rind. Stir in two tablespoonfuls of Curacao and pour it over the fruit. Serve when cold.

A few spoonfuls of Curacao add a delicate flavor to sliced and sugared oranges.

Almond flavoring is very nice with boiled dumplings and batter puddings in which cherries or peaches are used. Do not, however, have more than a suggestion of this flavor.

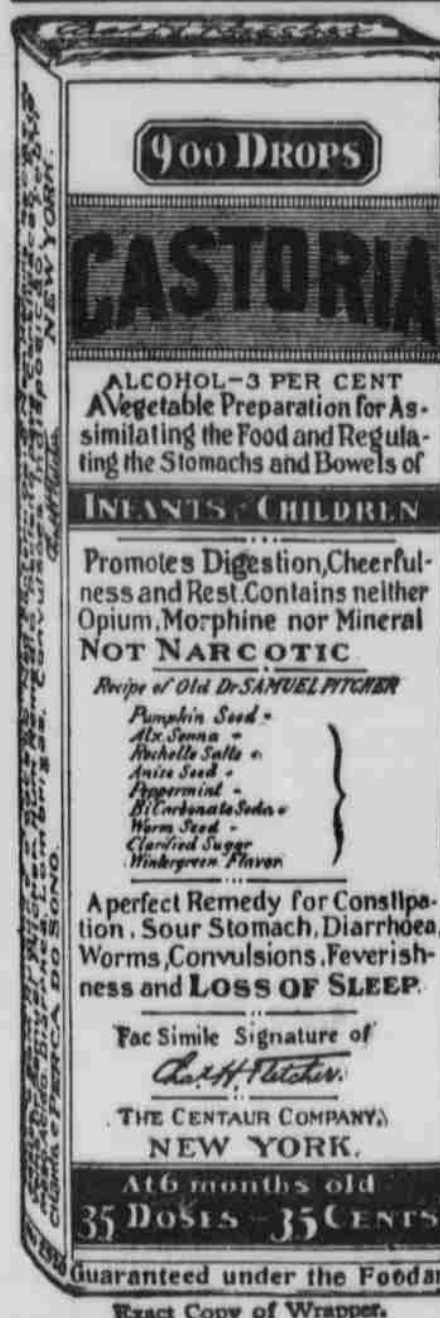

PECULIAR STATEHOOD SITUATION.

As the days lengthen the prospects for statehood appear to wane. And yet we hear some comforting reports from Washington, at that. It seems quite likely that some kind of resolution will get through at the special session, granting statehood to both New Mexico and Arizona, but it seems equally sure that the resolution will be so worded that it may be devoid of immediate benefit.

The difficulty is that the president is dissatisfied with the Arizona constitution and some of the senators are equally dissatisfied with the New Mexico constitution. An effort will be made to reconcile the differences and permit both territories to enter the union at the same time. One day the dispatches indicate this may be accomplished, and the next day we read a contradiction that blasts our hopes.

So far as the special session is concerned, on the matter of statehood, only one thing appears quite certain, and that is, if the president refuses Arizona admission the fate of New Mexico is sealed by an adverse action of congress. If the president insists on a revision of the Arizona constitution the congress will demand some changes in the constitution of New Mexico. To comply with these demands will take time and time means the delay of statehood to the regular session in December. New Mexicans, however, have an overstock of patience, and yet another year's waiting will, no doubt, exhaust the supply.

THE CRITICAL PERIOD.

The critical period with the fruit growers is now here, and the danger will not be entirely past until this month has ended. The most serious losses to fruit growers in this county have occurred the latter part of this month. We have witnessed promising prospects on the first of April and by the first of May have seen the entire fruit crop of the county blackened and withered by frosts.

The fruit crop of Lincoln county is one of the county's most valuable products, and its destruction means a severe loss, not only to the growers but to the dealers and consumers. Every effort should be made by the orchardists to save this valuable crop, and, with the exception of an extraordinary cold, the loss by frost can be successfully combatted. Smudge pots are in general use throughout the country in the larger orchards, and the smaller orchards may obtain similar results, in the absence of smudge pots, by hauling manure from stables and lots, depositing it in orchards, and on cold nights fire

the manure piles which will produce an excellent smudge. A smudge one night might save a year's crop of fruit. Is it not worth the trial?

Thomas L. Johnson, one of the most striking characters this nation has produced in late years, has joined the silent majority. He was twice elected to congress and five times mayor of the city of Cleveland. Many years ago he was self-designated the "stormy petrel," and he lived up to the designation. A man of strong character, rugged honesty and unflinching determination, he left an imprint upon the pages of American history that will grow brighter with time. A man of wealth, though a friend of the poor, and he gave his best efforts for the alleviation of the sufferings of mankind. No man could be inspired by a nobler sentiment and no epitaph more enduring.

HOW TO COOK ONIONS

THEY NEED NOT ALWAYS BE PLAIN BOILED OR FRIED.

Formula for Stuffing Them With Sausage and Egg—Variations in Preparing Potatoes and Cauliflower.

The days are here when the average housewife who must cater for herself is put upon her mettle as a marketer. Onions we always have with us, and they are excellent in other ways besides plain boiled or fried, as they commonly figure in the household plan. For instance, they can be stuffed, the sweet Bermuda onions being specially good for the purpose. Here is one popular formula:

Large specimens are selected and boiled until nearly tender, but not quite so. The inside is taken out, leaving just a shell. Mince the part taken out with three cooked sausages, a hard-boiled egg, two tablespoonfuls of bread crumbs, seasoning as liked, an ounce of butter, four drops of tabasco and a little minced parsley. The shells are filled with this mixture, cracker crumbs scattered over the top, a tiny bit of thin bacon is put on each, after which they are baked 30 minutes, or until agreeably soft.

Potatoes, the dependable, have the culinary virtue of being infinitely variable. For instance, when boiled and baked and fried they have become a little wearisome and the homely tubers are no longer young enough to carry a sauce gracefully, try them baked with eggs. For a moderate-sized dish in this style you will need four cold-boiled potatoes and six hard-boiled eggs, all cut in slices about a fourth of an inch thick.

Put a layer of the potatoes in the baking dish, which must be well buttered, seasoning with salt and pepper, and cover with a layer of the eggs. Repeat this, and pour over the result two cups of thin white sauce. Cover with cracker crumbs soaked in butter, and bake until brown on top.

For those to whose digestions the sturdy sausage fillings would be anathema, this more delicate method may appeal.

Cook and scoop out the vegetables as before, but stuff with a filling made of equal parts of chicken (cooked), soft stale bread crumbs, and the removed part of the onions. This should be slightly seasoned with salt and pepper, if liked, and is to be moistened with a little cream or melted butter. Sprinkle with crumbs soaked in butter and bake as described above.

In cooking cauliflower, try simmering it tender in half milk and half water, it greatly improves the flavor and appearance of the flower. Afterward the liquor, which will have boiled down in the process, for this vegetable should never be cooked with the lid on the vessel, may be thickened with butter and flour, after which one has a tasty sauce without further trouble.

Cleaning Bagdad Rugs.

It is very difficult to wash a Bagdad couch cover or rug successfully. The colors are almost sure to run when treated in the ordinary way. Before beginning operations separate the strips. Then wash each one in a separate water. Use white soap and lukewarm water to which a little salt has been added after a soda has been raised by brisk stirring. Do not rub the strips on a washboard, but merely dip them into the water and stir them briskly, then quickly rinse them and hang them over a clothes horse in the kitchen away from the sunlight. Be careful when drying that the strips do not overlap. When almost dry press out the wrinkles with a hot iron. If the middle strips have become slightly worn exchange them with those on the outside, when sewing the cover together again.

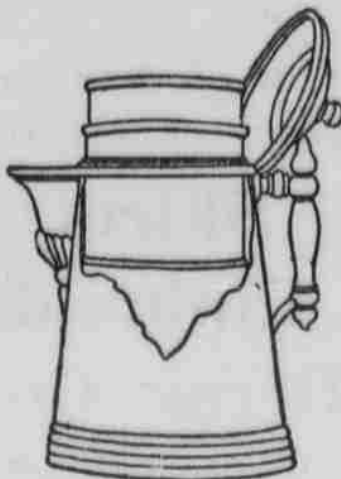

NOVEL COFFEE PERCOLATOR

Its Advantage Is That the Essence Is Extracted Without Boiling the Ground Berry.

A device for making coffee that is said to be a big improvement over the old-style coffee pot has been designed by a New York man. This is called the coffee percolator and the advantage is that the essence of the coffee is extracted without boiling the ground berry, a process which is said to liberate the injurious tannic acid. The percolating device consists of two metal cups, one to fit in the other and both to rest in the top of an ordinary coffee pot or any similar vessel. The lower cup has a fine metal strainer and has a rim which supports it on the pot. The other cup has perforations so graduated as to regulate the



flow of water by gravity. The coffee beans are ground thoroughly and the dust placed in the lower cylinder. The upper cylinder is then inserted and boiling water is poured into that. Through the graduated perforations this water will slowly trickle into the cup below and seeping through the coffee will absorb its essence and drip into the bottom of the pot. The cups are then removed and the liquid poured.

HOW TO COOK HAM RIGHT

Kansas Man's Chef Tells the Secret of Preparing a Porcine Confection That Is Delicious.

Perry may not know much about biological influences or the processes of nutrition; he might find it hard to distinguish between carbohydrates and proteins; but Perry can cook ham. Perry, of course you remember, is President Water's man Friday. To see Perry affectionately regard the Waters collection of old hams is to see something you will never forget. To eat some of his sausage is to record one more reason for wishing to live.

"I have interviewed Perry on the cooking of these old hams," said President Waters. "This is his general plan:

"He first thoroughly washes the ham with a scrubbing brush to get all the mold off and have it thoroughly clean. He then soaks it in warm water for about twelve hours, keeping the ham submerged. Then he puts it into a dishpan in which he has placed a plate or pie pan to keep the ham from coming into contact with the bottom of the pan, covering it with another dishpan. He boils it for about three hours for a small or medium-sized ham, or four hours for a large one. After taking it off Perry removes the skin, rubs a handful of New Orleans or brown sugar over it, covers it lightly with mixed spices, puts it into a hot oven and bakes it for about half an hour. It is then cooled and served cold."—Kansas Industrialist.

Baked Smelts.

Bone one and one-half pounds of smelts, lay in a buttered baking pan skin side down, season with salt and dredge with flour; baste with butter and bake about ten minutes in a hot oven. Can be prepared the night before.
