PROSPECTS BRIGHT FOR IMMEDIATE STATEHOOD

For Both Territories--Sixty-one Years
Since New Mexico Entered
the Contest.

Washington, D. C., June 5.—Now that the senate committee on territories has commenced holding hearings on the statehood resolution which passed the house May 22nd, it looks as though the territories of Arizona and New Mexico had entered on the last lap of a marathon race for statehood, which especially in the case of New Mexico, is a world beater for endurance, 61 years having elapsed since the territory entered the contest.

The contest, however, appears all but won, and there are few if any discouraging features, perhaps the only one worth mentioning being the desire on the part of the regular republicans to delay statehood until the spring of 1912, in the hope of thus gaining a party advantage by keeping Arizona out, an advantage which it is admitted on every side they will need if they are to longer retain a majority in the senate.

Friends of New Mexico have ventured the opinion that the statehood resolution might be pigeonholed in the senate territories committee, and never get into the senate at all. This would be an extremely good way to aid in preventing a vote this session, if, and it's a big "if" too, the regular republicans controlled the committee on territories, but they do not. When the committees were organized in the senate, the "insurgent" republicans demanded two places on every committee, but the regulars would not grant this on any of the big committees where the two insurgents by combining with the democrats could secure a majority on the committee. This was true on almost all the big committees, finance, foreign relations, etc., but somehow the regulars overlooked the territories committee. Perhaps they thought it would not play a very important part in the session. At any rate they put two insurgents on this committee. The committee numbers 12, five democrats and five regular republicans, and the insurgent republicans. The five democrats, Owen of Oklahoma, Chamberlain of Oregon, Shively of Indiana, Johnson of Maine and Hitchcock of Nebraska, with the two insurgent republicans, Brown of Nebraska and Bristow of Kansas form a majority of the committee regardless of how hostile the members might be to statehood. So it happens that at a time when the regulars want the worst kind to prevent a vote on the statehood resolution, for

reasons explained last week, they are not able to depend on what in times past has been a favorite method of stifling legislation, that is let it die in the committee.

Norris Brown, one of the insurgents, was the first man in the senate this session to introduce a resolution admitting the two territories, and Bristow, the other insurgent, is a fast friend of the territories, so their support for statehood is assured, while statehood is a part of the democratic program for this session and is supported by all the senators on the committee. So even were Chairman Wm. Alden Smith, of Michigan, hostile to statehood, which he is not, although he is an "organization" man, and must obey orders when his chief speaks, it would be impossible for him to smother the statehood resolution in the committee.

Thus it is sure of getting into the senate where there will be considerable debate, over minor matters, but the majority is easily in favor of statehood. Bailey is probably the only democrat who will vote against it, and he says that is because the initiative, referendum and recall are in Arizona's constitution, but others say that the great and only Bailey is still smarting under a rebuke administered to him by the Arizona constitutional convention when he attempted to dictate what the constitution makers should put into their constitution. But he has been disarmed to this extent, in that he has announced that he will be satisfied with voting against the statehood resolution, and will not actively fight it, nor insist that other democrats vote against it.

But eliminating Bailey's vote and the vote of the regular republicans, there are enough votes left to give statehood a handsome majority, variously estimated from 6 to 20 whenever it comes to a vote. The republicans will try dilatory tactics, that much seems assured, but with the time for adjournment not set, it is not believed they can prevent a vote. With twelve insurgent republicans robbing the regulars of actual republican control and also favoring statehood, it seems probable that either the democrats or the insurgents will use the same tactics on some measure the republicans favor in order to secure a vote on statehood. In other words, reciprocity is a strong Taft measure, and it is rumored that Taft himself is back of the attempt to defeat statehood this session. Supposing then the democrats and insurgents should refuse to line up for reciprocity unless they were promised a withdrawal of the opposition to a vote on the statehood resolution, even if no regular republicans voted

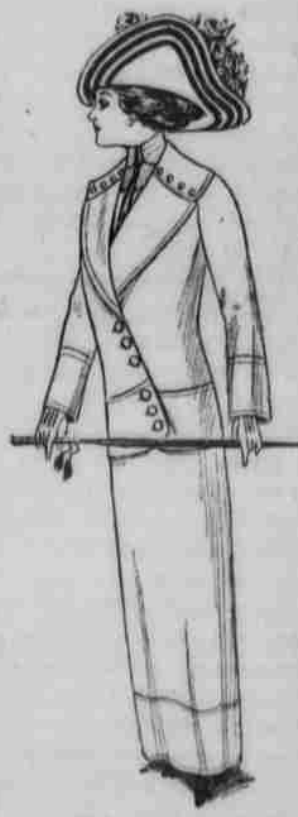

COLLEGE MEN WHO FAIL.

In every college there is a class of never-do-wells, generally composed of the sons of the rich. They go to college for the life there, to take part in social festivities, etc., and they care very little about study. College is to them merely an excuse for persuading their parents to permit them to spend four years in riotous laziness. At some colleges there are special courses, "easy courses," for such pupils. The college is not to be blamed for the inherent weakness of those men, although blame does attach to them for permitting students to waste their opportunities and their time. The smaller colleges are much more careful of the morals of those in attendance than are the great universities, where students are supposed to have reached the age of discretion, says the *Charlton News and Courier*. Discipline in the universities is largely a question of surroundings. Professors are there to teach, not to spend their time in enforcing discipline. The result is bad; not because the older men are unable to govern themselves, but because so many parents insist on sending mere boys to universities. Where they ought to be sent, is to the small college, finishing their work, if need be, at the university, when they have had enough experience to appreciate freedom from rigid control and to know how to manage themselves. To send a boy of 18 to a university where the vast majority of those in attendance are grown men is to invite his ruin.

It has long been a favorite that girls are smarter than boys, especially in school and college. Dr. Taylor, president of Vassar, explains the reason. "Women," he says, "go to college to learn; men do not. While a good many men do succeed, there are many more who are interested in sport, and even those who do study do not take any pride in letting the others know they are working. Girls are conscientious; they are far more humiliated by failure than men." Dr. Taylor admits there are physiological reasons why the girl is smarter than the man at the college age, says the *New York American*. But it is also probable that the restrictions imposed on girls in the past have tended to make them concentrate attention on their studies. College men have as many interests as their inclinations prefer; it is usually not until after they graduate that they settle down to making a living. Meanwhile they can afford to yield the palm to their sisters for superiority in youthful scholarship.

Platinum is taking pains to emphasize that it is more valuable than gold, its price having gone up to \$43 per ounce. A quarter of a century ago its price was practically the same as that of gold, but its industrial and scientific use has increased so as to enhance its value. The rise in the past six months has been \$10 per ounce. In 1906 it was up to \$40, and a year later had dropped to \$20, which indicates speculative operations rather more strongly than the depreciation of gold.

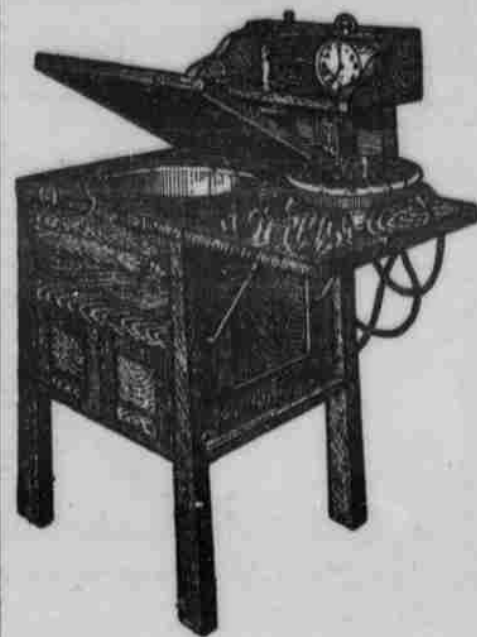
MAKES FOR ECONOMY

LATEST IMPROVEMENT ON THE FIRELESS STOVE.

Electric Device Insures Both Convenience and Cleanliness—Use of Alarm Clock Is Also a Most Useful Innovation.

Those familiar with the economies of the fireless cooker will appreciate the combination of this device with the convenience and cleanliness of the electric stove.

The outside of the stove is made of finished hardwood. The containing compartment is lined with non-rustable metal between which and the woodwork is a fireproof non-conducting packing, through which wires pass to the electric stove located in the bottom of the receptacle. If the length of time required to bring a certain meat or vegetable to a boil is known, the dish containing it is placed in the receptacle, and the



Combined Fireless Cooker and Stove.

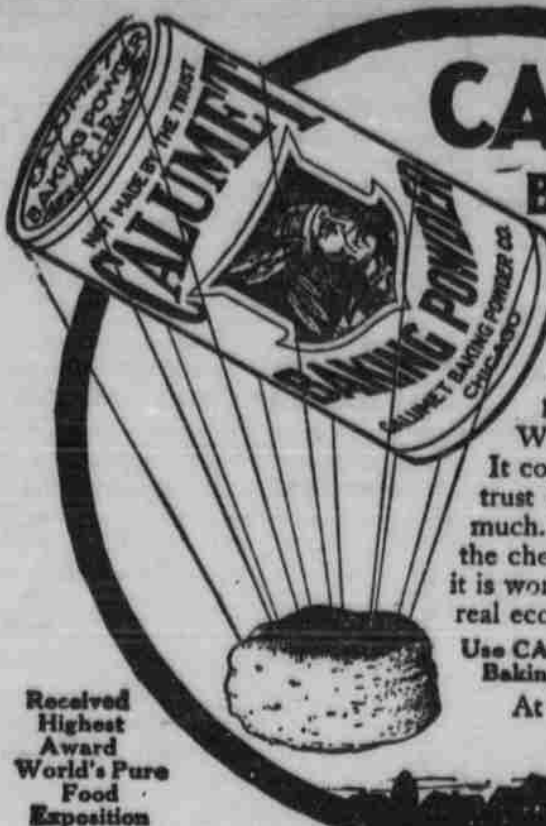
cover closed. Then the alarm of the clock is set to go off in 20 minutes, a half-hour, or in such time as the case may require. Closing the switch starts the cooking. When the time is up the clock sounds the alarm and at the same time opens the switch, and the cooking then continues as in a fireless cooker. This stove enables "the lady of the house" to start the evening meal, go shopping while it is cooking and return to find it ready to serve piping hot. A drop shelf is provided on the side, while a compartment beneath the cooker permits the storage of cooking utensils.—Popular Mechanics.

Strawberry Pie.

Make nice rich pie crust, put the bottom of the pan turned upside down on table; put three or four fork holes in the crust to keep from raising up from the pan. Bake by itself. When baked light brown take the crust, turn on a plate, then the crust is ready to fill. Have ready one quart fresh picked strawberries, sweetened to taste, fill the crust with the strawberries, cover the top of the berries with the whites of two well-beaten eggs, sweeten with sugar. Put in the oven just long enough to light brown the whites of the eggs.

Hermits.

Stir to a cream two cups of sugar and one cup of lard. Add one cup of molasses, two well-beaten eggs, two level teaspoonfuls of soda dissolved in one cup of warm water, two teaspoonfuls of cinnamon and one each of cloves and salt. Add six cups of sifted flour and one cup of fruit (English currants, seeded raisins or chopped prunes), mix soft and cut in any shape preferred. Fine gingerbread men and horses can be made with this batter where the cook possesses the requisite artistic temperament and small children are to be catered to.

It's funny how the democrats are about to succeed in having a republican senate turn New Mexico down. Those same New Mexico democrats can't do anything with the democratic members of the senate—they are going to vote for statehood—but they seemed to have secured the ear of the republican members. It is to be hoped that the republicans in the senate will discover their error before it is everlastingly too late.

One of the dangers, if it ever was a danger, in the way of statehood has been removed, according to dispatches. President Taft has signified his willingness to sign the joint statehood resolution, if passed by the senate. The only danger now appears to be "senatorial courtesy," which may result in killing the measure with words. There is no longer a doubt, if a vote can be obtained; for a majority of the senate is unquestionably for the resolution.

Judge Fall has issued a clarion call from Washington, addressed to the plunderbund of New Mexico, in which he urges them to save statehood from its friends (?), the republicans in the United States Senate. The plunderbund is silent, answering only with tears—tears because congress has seen fit to criticize that instrument, which in fiction, is called a constitution. Congress found holes in that instrument through which a coach and four could be driven, and poor Judge Fall is the only one in Washington to refute the misstatements of New Mexico democrats who are, in spite of all he can do, about to induce a republican senate to allow us statehood. Why all this silence by those who a short time ago told us the constitution was altogether lovely and one in ten thousand. Tears, only tears.

The Call of New Mexico.

Governor Mills has issued a proclamation designating Thursday, June 22nd, as the day upon which the Call of New Mexico shall be made. The governor suggests that each citizen send out a postal card; that commercial clubs and boards of trade send out larger quantities, descriptive of their localities, and that every newspaper publish some descriptive article on the territory, showing the advantages of our towns and districts and enlist the interest of friends throughout the country. Any one desiring to send out one or more of these cards may get them at the News office.

Law Relating to County Seats.

Chapter 87—An Act to Amend Chapter 38; approved March 21, 1907.

That Chapter 38 of the Acts of the 35th Legislative Assembly of New Mexico be, and the same is hereby, amended so as to read as follows:

"Section 1. That all sheriffs, treasurers and probate clerks of the various counties in New Mexico shall establish and maintain their offices and headquarters for the transaction of the business of their respective counties and shall there keep all the books, papers and official records pertaining to their respective offices. Provided, That such offices shall be provided for such officers at the expense of the respective counties.

"Sec. 2. Any county officer who shall fail to comply with the provisions of this act shall upon verified complaint by any taxpayer residing in the county in which such delinquent officer is serving, filed in the district court having jurisdiction over such county, setting forth the facts as to such violation of this act, and after hearing upon such notice as the court shall prescribe, and proof of such facts to the satisfaction of the presiding judge of such court, be summarily removed from his said office and such office declared vacant by judgment and decree of such court, and thereupon any vacancy so created shall forthwith be filled in the manner prescribed by law."

Sec. 2. All laws and parts of laws in conflict herewith are hereby repealed, and this act shall take effect and be in force from and after the date of its passage."

The foregoing is the last word on the subject, and, in view of the fact that the board of county commissioners has provided for quarters for the officers and also vaults for the records, further argument appears superfluous.

Base Ball Organization.

A meeting of those interested in base ball was called Tuesday afternoon, to effect an organization. Jno. A. Haley was chosen manager and Wm. M. Reily secretary-treasurer. The following day the players signed up and elected B. T. Dingwall captain. Those signing were:

FRENCH METHODS OF COOKING

These Two Ideas in Serving Potatoes May Be of Interest to American Housewives.

Pommes Hollandaise.—For a family of four boil six good-sized white potatoes; peel and cut them into quarters; put them in a porcelain-lined pan with a tablespoonful of butter and a pinch of finely chopped parsley; season with salt and white pepper and warm them thoroughly without browning. Serve on a hot dish.

Potato Quenelles or Croquettes.—Peel, wash and drain six medium-sized mealy potatoes; cut them in quarters, put them in a saucepan, cover them with water, add a little salt, cook for 30 minutes and drain. Then beat the potatoes up in a bowl or mortar with an ounce of fresh butter, and when they are well mashed add the yolks of three eggs. Season with salt, pepper and a tiny bit of grated nutmeg; mix all well and then divide into 12 or more parts, shaping each round or like a cork. Dip the croquettes separately into raw beaten egg; roll in finely powdered bread crumbs, and fry a golden color in boiling olive oil for three or more minutes. Serve on a folded napkin with mashed sprigs of parsley alongside.

USEFUL HINTS FOR THE COOK

Small Things, but They Mean Much in the Preparation of Really Successful Meal.

When cooking eggs always break them separately in a cup, for one bad egg will spoil all that have been broken before. For poaching or frying, it is better to break them singly in a saucer, from which they can be easily slipped into the pan without breaking the yolk.

A tablespoon of vinegar, and a little salt should be added to each pint of boiling water used for poaching eggs.

There is much nourishment, also medicinal properties, in fish, and as a rule it is cheaper than meat. If fresh fish cannot be obtained, salt fish, if properly cooked, is quite as nutritious.

Too much cannot be said about the nutritive qualities of cornmeal, which ought to be used more than it is in every household.

Stuffed Baked Potatoes.

From the blossom end of a dozen tomatoes—smooth, ripe and solid—cut a thin slice and with a large spoon scoop out the pulp without breaking the rind surrounding it; chop a small cabbage and a good sized onion fine and mix with them fine breadcrumbs and the pulp; season with pepper, salt and sugar and add a cup of sweet cream; when all is well mixed fill the tomato shells, replace the slices and put the tomatoes in a buttered baking-dish, cut ends up, and put in the pan just enough water to keep from burning; drop a small lump of butter on each tomato and bake half an hour or so until well done; place another bit of butter on each and serve in same dish.



Be very careful to keep the lids of saucepans clean, for the flavor of one dish may cling to a lid which has not been washed and spoil a second dish which is prepared in the same pan.

Wash a saucepan in plenty of hot water; but never wash cake tins or frying pans. Wipe them well with a piece of paper, which is afterward burned, and polish them with a dry cloth.

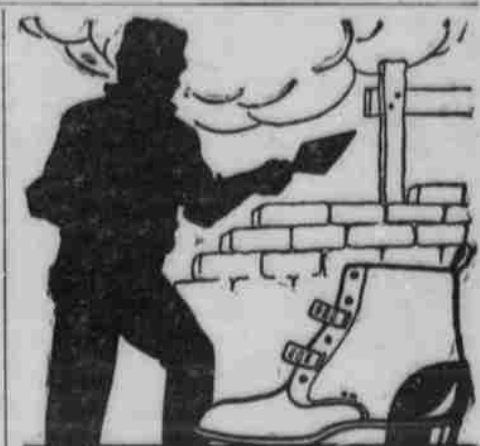

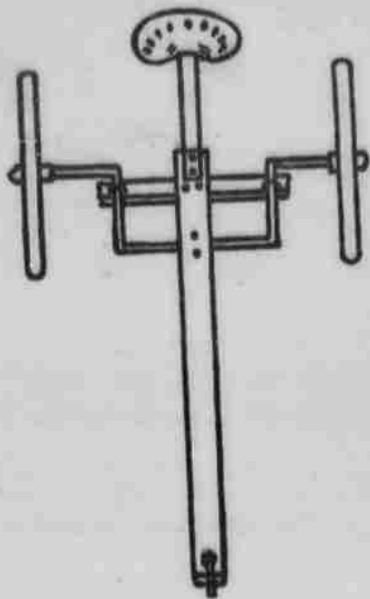




HARROW CART IS EFFICIENT

Old Walking Cultivator is Converted in Few Minutes—Boys Will Do More Hard Work.

Converting the old walking cultivator into a light but very efficient harrow cart is very quickly done, according to a writer in the Home-stand. Secure the wheels, frame, tongue and a short piece of 2x4 long enough to reach across the frame close up to the axles; this makes a brace for the frame, and forms a firm attachment for the seat and tongue. For a seat, one from some other piece of farm machinery will answer very well. A clevis may be attached to the end of the tongue for coupling the cart to the harrow ring. Make



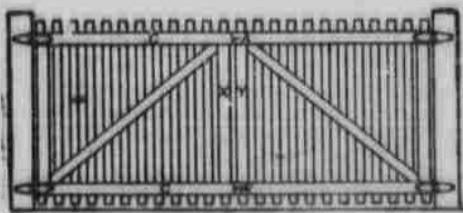
Efficient Harrow Cart.

HOW TO HANG DOUBLE GATE

Simple and Easy Method of Construction So That It Will Swing Perfectly When Completed.

A simple and easy method of constructing and hanging a double gate so that it will swing perfectly true when complete is shown in the accompanying sketch. Make the gate in

one piece by running the crosspieces C from one post to the other. Leave a small space between the upright pieces X and Y so that they will swing free of each other when the gate is cut in two. Hinge the gate to the posts at all four corners, testing the crosspieces with a level. Then saw the gate in two at A and A and the two halves will swing perfectly true and match each other.

Don't Burn the Litter.

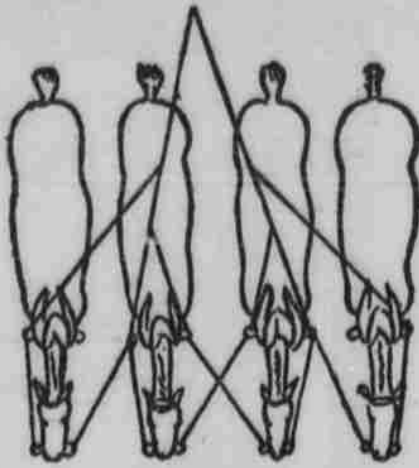
Don't burn up any kind of coarse litter that accumulates around the feedyard, but save to mulch different plants in the garden. If some manure is mixed with the litter so much the better. Such mulch will make melons, cucumbers and many other plants bear more heavily and will save cultivation after they are well started.

HITCHING FOUR-HORSE TEAM

Point in Favor of Arrangement Shown in Illustration is Absence of Tied Cross-Lines.

It is often amusing to notice the arrangements of lines on four horse teams, says the Prairie Farmer. When improperly arranged much annoyance is caused by uneven pulling by the different horses and the horses' work is much harder.

When hitched four abreast the arrangement shown herewith gives ex-

cellent satisfaction. Place the lines on the center team, as if driven alone, and from each line have a branch extending over and fastened to the outer bit ring of each outside horse. Tie each outside horse to the hame of the one next him.

The point in favor of this arrangement is the absence of tied cross-lines between the center horses giving more freedom, and proves very satisfactory where two rather unruly horses are hitched with two less fractious, the latter being in the center.

WHITE PLAGUE OF CUCUMBER

Sciara Worm Has Arrived and Manner in Which to Abolish It—Davis Perfect Not Attacked.

Another "white plague" has arrived, and this time it is the cucumber that suffers. This pest, familiar to those who grow cucumber plants under glass, is the Sciara maggot (Sciara-inconstans). It is a slender, white worm with a shiny, black head, and measures not more than a quarter of an inch. It lives in the soil among the roots of the new plants. Its custom is to gnaw the rootlets. After a plant is attacked it makes little or no new growth and in its sickly condition produces few if any cucumbers. The leaves turn brown and the plants wilt in the sun.

The adult of this worm is known as the fungus gnat. It is a very small fly and lays its eggs in fresh horse manure. It is through the fresh manure that these pests are introduced into greenhouses. The use of old manure rather than fresh will keep them out. Should they appear, water in which tobacco has been soaked should be poured about the roots of the affected plants.

Certain cucumbers seem to be immune to the attacks of these worms. Tests made indicate that the variety known as the Davis Perfect is not subject to the attacks of the maggots.

for it. Such things do happen. They are extremely possible. In fact scarcely a session goes past without some trade of this kind. For this reason, the wise ones say that a vote on statehood can not be prevented this session.

Back of all the politics, however, in almost every senator is a sense of "fair play" which has been outraged in times past by the way the territories have been treated, and this is going to be responsible for a big majority in favor of statehood when they find the day is lost and a vote cannot be prevented. How some of the senators feel about it is illustrated by a conversation with one of them the other day. In discussing the question he said, "I am getting tired of being a party to such a game. That New Mexico and Arizona should longer be denied full partnership in the union of states is an injustice to over 500,000 people that under any other conditions or on any other question than statehood would not be tolerated for a minute. Do you know that New Mexico, by every rule governing the case, is entitled to just the same representation in the senate and house, that is two senators and two representatives, as New Hampshire, North Dakota, South Dakota, Oregon, Rhode Island and Vermont. Do you know that New Mexico would have a larger representation in the house than any of the following states: Delaware, Idaho, Montana, Nevada, Utah and Wyoming. Yet, rather than lose their control of the senate, which they are going to lose anyway, and because Taft wants to succeed himself, and needs New Mexico's delegation in the convention, they are trying to keep New Mexico out until next spring and keep Arizona out even longer. I do not think such high-handed methods can be kept up much longer with success, and I look for both territories to come in by a big majority in the senate, as soon as a vote can be reached, just because almost every senator realizes the injustice that is being done."

When a vote might be had can not be foretold now, but a vote will be held on the direct election of senators on June 12th and that will leave statehood and reciprocity the two most important measures before the senate. There will be weeks of debate on the reciprocity bill, so that it is possible that statehood can be disposed of in the meantime.
