## ARIZONA.

### Condensed News of the Neighboring Territory.

The Grant county bill was killed by the council.

Palm Springs continues to be laden with locusts and worms.

Arizona has an Indian population of between 30,000 and 35,000.

Railroad reports say that the S. F. & P. is doing a great business.

The Saginaw Lumber company has resumed operations at Williams.

Gen. McCook spoke good words for Arizona on his return to Denver.

The Fort Thomas reservation has been ordered thrown open to settlement.

A miner named Babler had one leg crushed off in a mine near Phoenix.

The new board of control will visit the reform school at Flagstaff next week.

The new road to Phoenix from the north, via Prescott, is already becoming quite popular.

The baggage cases have been transferred from the district court at Phoenix to Yavapai county.

Of the twenty-five prisoners confined in the county jail at Tucson, only one of them is an American.

The council defeated the house bill which provided for exempting indigent miners from taxation.

The new classification of counties will make Graham a second-class county, Navajo a fifth, and Apache a sixth.

The Arizona Copper company has posted a notice that they will not receive any wood delivered on more back burrow.

The new classification bill which provides salaries and provides for six counties, is a law. It takes effect January 1, 1932.

Hon. W. C. Barnes, of Apache county, was one of the most indomitable fighters in the house for the Navajo county bill.

Ash Fork is improving rapidly, having doubled in population and in the number of its buildings during the past sixty days.

Work has commenced on the new Catholic church at Williams. Father Frey, of Flagstaff, is supervising the construction of the building.

One feature noticeable in the business revival in Arizona is that is not confined to any section, but is as broad as the territory itself.

The Phoenix Gazette says that a dealer estimates that the trade in Indian blankets, baskets and pottery brings \$500,000 yearly to Arizona.

H. N. Freeman, president of the Arizona Central bank and Flagstaff, is heartily in favor of building the Durango, Flagstaff and San Diego railroad.

The Silver Belt states that in a baseball game between the married and single men in Globe last Sunday, the married men were "done up."

The department of justice at Washington has agreed to allow Arizona \$18,768.25 for keeping United States Indian prisoners in the Yuma penitentiary.

If about a dozen of the fraudulent land grants of southern Arizona are knocked out by the land court the country will soon settle up with prosperous farmers.

The Harvey house at Ash Fork is nearing completion. The ranges are now being placed in the kitchen and the house will be open for business in a few days.

There are 27 prisoners in the Yavapai county jail, while eight Indian witnesses reside on the county woolpile and pass away the time cracking aboriginal jokes and vermin.

Merrill Brown are contemplating the erection of an opera house at Jerome. The Jerome Chronicle says the building will be 50x75 feet, two-story frame, nicely finished on the outside and inside.

The territorial board of equalization, as appointed by Governor Hughes, is composed of the following well known men: Coldwater, of Prescott; Boone, of Phoenix; and Underwood, of Tucson.

A gang of five tramps in Prescott assaulted Otto Miller, who was stabled in the bowels by one of the men. The wound is serious. The man who did the cutting is under arrest for the crime.

The Frodo of the West mine in Washington camp, Arizona, has been leased to G. L. Fitzgerald, of El Paso, who will proceed immediately to the extraction and shipment of copper ore. He expects to ship about 20 tons daily.

Capt. Meyer, acting Indian agent at San Carlos, has been officially notified that the right-of-way across the White Mountain reservation has been granted to the title Valley, Globe & Northern railway, and instructing him to permit the survey to proceed.

The Prescott Courier says: Chas. Campbell came in town yesterday with a \$1,200 gold brick, the result of 28 tons of ore from his Elk mine run through the Mesal Milling Co.'s mill, on the old Jennings group. Dr. Kendall is also interested in the Elk mine.

A passenger coach has been attached to both the morning train from Prescott to the north and the morning train from Phoenix to the north, instead of the caboose, so that passengers who desire it can make the ride in the day time between Prescott and Phoenix.

Jas. W. Whalley, town councilman of Tucson, whose disappearance recently caused alarm, was discovered dead in the storehouse under the grand stand at Union Park. A law line written on an envelope and signed by the deceased stated that he had committed suicide by taking poison. The cause of his suicide was a financial trouble.

A Chinese merchant was found murdered in his place of business at the corner of Cushing and Meyer streets, Tucson.
