A Change of Heart.

That a great majority of the people of New Mexico were more interested in statehood during the constitutional campaign last winter than they were in the instrument itself is evidenced by the changed expressions made by newspapers and speakers. Many wanted a more flexible constitution and cast their ballots accordingly, while many more, anxious for a better instrument, but still more anxious for statehood, voted for the constitution. The proposition in the constitutional election was to adopt or reject—there was no middle ground, the constitutional convention refusing to submit amendments. However, this is changed, or a change is proposed by congress, and if the resolution becomes effective the people of New Mexico will be given an opportunity to amend their constitution. Some of the strongest supporters of this resolution are to be found among those who gave their ardent support to the adoption of the constitution, and their advocacy of the resolution is conclusive proof that our constitution needs amending and that the plan proposed is an equitable one. It is with pleasure that we note this change in sentiment; not only because we advocated it during the constitutional campaign, which now affords comfort in the endorsement of our position, but because it is fair, and will give the people a chance to improve the instrument. The New Mexico State Democrat strongly supported the constitution, but now advocates with equal vigor the resolution, and the article is herewith reproduced principally because it comes from a pro-constitutionalist:

"Messrs. Catron and Waters have written letters, so the report goes, to Mr. Andrews opposing statehood under the Flood resolution, saying they would rather wait a year longer than to go in now. Ah! Mr. Catron, where is your political acumen, is it on a vacation or do you prefer to play into the hands of your opponents for United States senatorship? This action of yours is no doubt greatly pleasing to Gov. Mills, Judge Fall, and Charlie Springer. Aren't you afraid, Mr. Catron, that if you wait a year or two longer the legislature of New Mexico will have little use for republican candidates for the United States senate from the state of New Mexico? The cards

were shuffled by 79 republicans of the constitutional convention and that 'mean thing,' H. B. Fergusson, cut them. If the republican party representatives of the senate are not smart enough to give us a fair square deal immediately there'll be a new deck with the joker left out, an honest shuffle, a fresh deal with not a possible chance of republicans obtaining a hand that will win a jack-pot. Get your ear to the ground, Mr. Catron, listen, and you will hear footsteps of senators climbing in the statehood bandwagon. The fellows aforementioned are a few laps ahead of you now in the popular 'forward movement.' If you don't hurry, Mr. Catron, and get in the game you will be landed on the ice gorge, and you'll realize what a splendid game of freeze-out your opponents play."

A LITTLE POKE AT CHARLIE.

"There is no denying it, politicians of New Mexico and Arizona, too, have been a little too active and enthusiastic in Washington in their anxiety for statehood. In other words they have had too much to say as to what the people desire and under what sort of a constitution they wish to live, while the people as a whole were not consulted at all since the adoption of the two constitutions. * * * New Mexicans can be thankful for one thing anyway, especially those who want statehood right away. Charles A. Spiess did not go to Washington to work for statehood the second time. Charlie had been told by some of his republican friends that congress, senate and the president would be 'agin us,' if he'd show his face in support of immediate admission or at any other time."

THE REAL SITUATION.

"Practically the whole of the republican press tried to mislead the public into the belief that the Flood Joint Resolution 14 as it passed the lower house was designed to defeat New Mexico for admission to the union of states. That New Mexico was in anyhow automatically, with all the ills that the constitution is afflicted with, and what need they care about the fairness of letting in Arizona. 'We will just keep Arizona out indefinitely,' said these wise republican papers—and the perniciously partisan republican politicians. But now, after a thorough investigation of the true sense and meaning of the Flood resolution they are convinced of its absolute fairness to both territories and both political parties, they no longer malign and slander the democrats who were instrumental in bringing about a condition that will make a state of New Mexico and a state

PLANT TREES.

If in 75 years the present supply of timber in this country will be exhausted, at the present rate of consumption, the admonition to plant trees becomes eloquent with meaning. There is great value in trees, says the Kansas City Times. The big lumber fortunes have been made in the main, not in buying and selling lumber, nor even in manufacturing lumber for sale, but in buying vast tracts of timber land and holding them for the inevitable advances in timber prices incident to the rapidly decreasing supply. Now, it would not profit any man or corporation to buy large areas of land that could be profitably used for agriculture, fruit growing or grazing, and set them in trees; but it would be profitable for all who own timber lands that could not be profitably used for other purposes to maintain them as permanent forests, using only the matured trees and cutting them and clearing the slash in such a way as to give the best possible protection to the immature timber. Also, it would be profitable to every owner of land to plant trees on any part of it that cannot be utilized for other purposes. If this great nation could inspire its landholders with this one purpose for a given time, to the end that all land that should be planted with trees would be so planted, the problem of the future lumber supply would be solved.

The treasure chamber beneath the palace of Necessidades, Lisbon, Portugal, has been opened and examined by the minister of public works at the request of King Manuel, who feared for the safety of the crown jewels and certain personal property of the royal family. The jewels and valuables were found in the underground chamber intact. An inventory showed them to be worth upward of \$3,000,000. Among the jewels was the diadem of ex-Queen Amelie and a necklace given her by her father, the Comte de Paris, valued at \$200,000. There was found also a table service of solid German silver, weighing over a ton, also a crown and scepter of gold studded with precious stones; also several bricks of gold, the largest weighing 45 pounds. The minister of finance announces that all valuables which are the private property of Manuel and his mother will be returned to them. Those belonging to the state, such as the crown and scepter will be placed in the national museum.

As it would have been clearly superhuman self-control which would have checked an attack under the circumstances, the assault was condoned by a law recognizing the limitations of human nature.

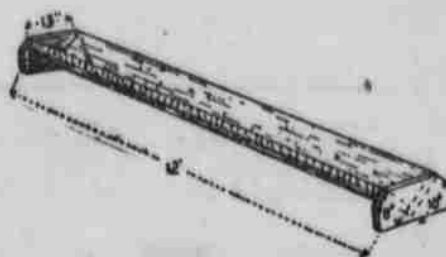
FEED SOW AND YOUNG PIGS

Little Animal Should Be Fed So as to Gain From Half Pound to Pound Every Day.

(By G. J. SPERRY.)

At farrowing time the sow should be fed nothing but very thin slop for the first 24 hours and only very slightly for several days. At the end of a week the ration should be rapidly increased and should consist of such milk producing foods as shorts, bran, ground peas, milk, etc. From then on while suckling her pigs, the sow should be fed heavily. It has been found very profitable to feed sows so heavily that they gained in weight. The gain thus produced in the young pigs indirectly through the sow, was cheap and more economical than that lateral gains.

When the pigs are two or three weeks old they will begin to take food given them from a separate trough made but a few inches deep. Skim milk or a thin porridge of middlings is greatly relished at this time. As soon as they begin to eat freely they should

be crowded with feed, since the most economical gains in the life of the pigs are made at this time. Pigs should be fed so as to gain in weight from one-half pound to a pound a day from the time they are three weeks old until they are marketed.

Young growing pigs should have plenty of green pasture, pure water and grain. The old method of allowing pigs to grow for a year on pasture or in wood lots without other feed is expensive and not now practiced by those who make a success in growing hogs for pork. On pasture alone hogs make too slow gains for profit, and cannot be brought to a marketable condition. Pigs at pasture, however, make the best use of the grain fed to them.

Some of the best green feeds for hogs are alfalfa, clover, rape, cow peas, peanuts, artichokes and sweet potatoes. Hogs are wasteful grazers and the fields of pasture crops should be arranged with movable fences in such a manner that the hogs can pasture only on a small portion at a time. A

succession of crops should be grown so that the hogs will have continuous pasture throughout the season.

When young nursing pigs begin to scour, it is evident that the milk of the sow is disagreeing with them and immediate attention therefore should be directed toward improving her ration. Most often the trouble comes from over feeding on corn, or other rich food, just after farrowing, and pigs of fat, flabby, pampered, cross, nervous, constipated sows, are most apt to suffer. Sudden changes of food, or feeding sour or decomposing slop, or food from dirty troughs, or sour swill barrels, also tend to cause diarrhoea either in nursing pigs or those that have been weaned, and all such causes should be prevented or removed.

To correct scouring in nursing pigs,

give the sow 15 to 20 grains sulphate of iron (copperas) in her slop night and morning and if necessary slightly increase the doses until effective.

A portable fence with support to be used for enclosing temporary quarters and lots is illustrated. The support should be securely nailed to stakes driven into the ground on each side.

SPRAYING CHUTE FOR STOCK

Apparatus Has Been Used With Much Success to Relieve Animals of Ticks and Mange.

An alley or race for confining stock to be sprayed. The fences are two feet apart and 25 feet in length, accommodating three animals at one time. The floor should be of cement, so sloped as to drain away the surplus

spray. An earth floor soon becomes miry and renders the work disagreeable.

It is seldom that stock submits patiently to being sprayed. As it is frequently necessary to spray cattle and horses in order to free them from some pest, ticks, mange or other trouble, the easiest method of carrying forward the work should be employed.

Where many animals are to be treated it would be advisable to construct a chamber or chute through which they may be driven from a yard and the spray applied from all directions as they pass. Such an apparatus has been used with much success to relieve stock of ticks and mange in the west, and could readily be constructed and conveniently used to dose a herd of cattle with coal oil or crude oil emulsion, in fact, any sort of spraying material, to save the animals from annoyance.

A single strong force pump with one man to operate it, and provided with several delivery nozzles placed in the walls of such a chute, some

overhead, others at the sides and still others beneath all kept playing while the stock is being driven through, would do the work effectively.

AVOID RHEUMATISM IN HOGS

Disease is Commonly Caused by Allowing Animals to Sleep in Damp and Filthy Quarters.

Rheumatism is commonly caused by allowing hogs to sleep in damp, filthy and improperly ventilated quarters. The system of ventilation should be such that there will be no direct currents of air striking the animals. The sun should have free access to the houses at all times. This will keep the sleeping quarters in a dry, sanitary condition.

When affected with rheumatism, the animals generally become unthrifty, and fail to make proper use of their feed, the appetite becomes dull, which gives rise to the rough, scraggy coat. Prevention should be the first aim of the owner, and to accomplish this, the yards, pastures and houses should be made dry and clean. Damp bedding and cold floors should be avoided. If the hog house has a cemented floor, false wooden floors should be provided, especially in the sleeping apartment of the building.

Other treatment is of little avail if comfortable sanitary quarters are not provided.

NEW MEXICO DAY.

Don't forget Thursday, June 22nd—it's New Mexico Day. If you have acquaintances in the states who might become interested in New Mexico, write them a letter, or at least send out some postal cards, on that day. Tell them of the opportunities New Mexico has to offer investors and home-seekers. Tell them of our cheap lands; tell them of our agricultural possibilities, with a properly developed irrigating system; tell them of our vast mineral deposits; tell them of our limitless grazing area; tell them of our beautiful churches, substantial school houses and good schools and of the best people on which the sun ever shone; and when you have told all that, tell them if they don't believe what you have told them to come to New Mexico and you will tell more.

The house committee has decided to call T. Roosevelt to the stand and see what he knows of the absorption of the Tennessee Coal and Iron company by the steel trust. We shall, possibly, soon know the distinction, if not the difference, between a good and a bad trust.

The prospects for statehood are growing brighter day by day. The senate committee on territories will begin hearings at once on the Flood joint resolution recently passed by the lower house. A majority of that committee favors the resolution, and will make a report accordingly. A favorable report by the committee will be followed by an affirmative vote in the senate. Filibustering, if combined with an early adjournment, casts the only shadow in our pathway.

The reciprocity agreement with Canada, endorsed by the president and passed by the house, is still tied up in the senate. Standpatters want to amend the agreement, but the president is fighting amendment, with the belief expressed that amendments would have the effect of killing reciprocity. The death of the measure is what the old guard wants, and it is not particular whether it comes by amendment or by the direct method. Standpatters recognize that reciprocity is the en-

tering wedge that will ultimately split protection into flinders; hence the determination to defeat Canadian reciprocity.

Direct Election of Senators.

Washington, D. C., June 12.—The senate tonight by 64 to 24 votes passed the resolution amending the constitution to provide for election of senators by direct popular vote. The Bristow amendment giving to the federal government supervision of such elections was adopted 44 to 44, the vice-president casting the deciding ballot. The house has already passed the resolution.

The resolution as amended and passed follows:

"That in lieu of the first paragraph of section three of article 1 of the constitution of the United States, and in lieu of so much of paragraph two of the same section as relates to the filling of vacancies, the following be proposed as an amendment:

"The senate of the United States shall be composed of two senators from each state, elected by the people thereof, for six years; and each senator shall have one vote. The electors in each state shall have the qualification requisite for electors of the most numerous branch of the state legislatures.

"When vacancies happen in the representation of any state in the senate, the executive authority of such state shall issue writs of elections to fill them; provided that the legislature of any state shall empower the executive to temporary appointments until the people fill the vacancies by election as the legislature may direct.

"This amendment shall not be so constructed as to effect the election or term of any senator chosen before it becomes valid as part of the constitution."

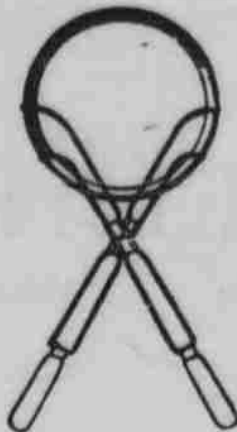

PIE TONGS USEFUL ARTICLE

If for No Other Purpose They Will at Least Keep Cook's Fingers Out of Dish.

An addition has been made to the tong family in the shape of a pair of pie tongs. They are the work of a Connecticut genius and enable the cook to tote a pie about without touching it with her fingers. Two pieces of heavy wire are doubled upon themselves so that they form gripping members at one end. The other end is inserted in a handle. Midway along



the wires are rectangular plates which are pivoted upon each other, making what resembles a big pair of scissors. Pies usually run a little over the edge of the plate and cannot be picked up without the fingers coming into contact with the crust, to say nothing of the difficulty in picking them up when they are not on a plate without a great deal of handling. The tongs overcome this difficulty as the gripping ends lap over far enough to pass under the pie and support it firmly.

BRAN USEFUL AS CLEANSER

For One Reason It Has Absolutely No Injurious Effect on the Most Delicate Colors.

Bran is good for cleaning and stiffening. To make bran water tie a cupful of bran in muslin, put this into two pints of water in a clean saucepan and simmer until the water feels glutinous. Leave the muslin loose, to allow the bran to part with its gluten.

A second and even third water may be taken off the bran in the same way. Bran has no destructive effect on colors and seems to act mechanically as an absorbent and to stiffen the article slightly.

It is most useful for colored embroidery or art work of any kind.

Bran water is sometimes employed for the washing of cretonne with a colored background. The article is washed in the bran water, rinsed, wrung, rolled in a cloth and then ironed on the wrong side. The cretonne is better if slightly dried before the ironing process takes place.

Mushrooms With Toast.

Rub the tops of the mushrooms with a piece of flannel dipped in salt. Have some butter heated in a saucepan, into which put the mushrooms with salt, cayenne pepper, and mace; let them stew gently until the butter has almost disappeared, then add cream and the grated rind of lemon. Set back where they will only simmer until quite done. Have toasted bread cut in rounds, serve the mushrooms on them and squeeze a little lemon juice on each.

To Save the Tablecloth.

Nothing is more provoking to the careful housewife than to have a perfectly clean tablecloth liberally bespattered with gravy the first time it is used. Get a large table napkin—one to match the cloth, if possible—and a piece of white oilcloth an inch smaller than the napkin. Put the oilcloth where the meat-dish will stand, and spread the napkin over it. The gravy cannot penetrate the oilcloth, and thus a considerable saving in the washing bill is effected.

PROPERLY MADE PUFF PASTE

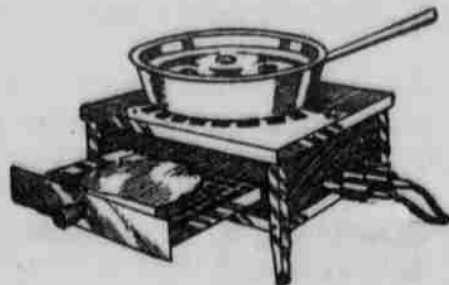
Directions Not Hard to Follow, but Are of the Utmost Importance.

One pound of butter and one pound of flour; wash the butter in ice water, dry and put on ice to cool; sift flour into a cold bowl; pour ice water with juice of half a lemon into flour, enough to make a stiff dough; put your hands in ice water, pat out the butter into an oblong shape; dredge marble or board with a little flour, put on the dough and dredge slightly; roll from you gently with a rolling pin into a square about half an inch thick, put butter in the center, fold over the sides so that they will lap, fold from the top toward you, roll out carefully, fold again, set on ice 25 minutes, then roll out three times, folding as before, keeping the rough ends toward you; fold again, set on ice 25 minutes, then roll out three times, folding as before, keeping the rough ends toward you; fold, set on ice 20 minutes, roll again three times; put on ice 15 minutes and roll again. Do not press heavily with the roller; mix in cool place. Puff paste is nicer rolled on marble; it will keep for a week covered with a damp cloth.

DOES TWO TASKS AT ONCE

Combination Electric Toaster and Cooker Makes It Easy to Prepare Breakfast Quickly.

By the use of a combination electric toaster and cooker, the breakfast eggs or cereals may be cooked on top of the stove, while the toast is browning



in the toaster. One operation does not interfere with the other in any way, as the heating coils are underneath the openings in the top of the stove and above the toaster, which is in the form of a drawer.—Popular Mechanics.

Sift one pint flour with one-quarter teaspoonful salt, two tablespoonfuls sugar, and one and one-half teaspoonfuls baking powder. Rub in two rounding tablespoonfuls of butter and moisten with two-thirds cupful of milk and a beaten egg. Mix together quickly and well and pat out with the hands until about an inch thick. Fit into a square buttered pan and press into the dough a layer of stewed prunes, halved and with the skin side down. Pour over two or three tablespoonfuls melted butter, dust with sugar and a trifle of cinnamon, and bake twenty minutes.

Carpets on Floor.

To clean carpet on floor, take four ounces alcohol, one 10-cent cake soap, two ounces borax, shave soap and dissolve in two quarts water boiling hot. Add borax when dissolved, add one gallon of water, boil fifteen minutes, take from fire, and add as much water as necessary. Take good stiff brush and go over one width of the carpet at a time, dipping brush in fluid often, then go over all again with clean water. Your carpet will look like new.

Turkey Filling Sandwiches.

Chop finely the meat of a left-over turkey. Put into saucepan, adding two tablespoonfuls of finely chopped celery, with salt and pepper to taste. Stir over the fire until hot. Then add a soft-boiled egg, and leave until cold. Spread the turkey mixture upon thin slices of buttered toast. Cut into halves or quarters, and place on a folded napkin.

of Arizona before the adjournment of the extraordinary session. It must be remembered by the democrats of New Mexico, however, that the republican papers in this territory made no concession to democrats on the hypothesis of 'equal justice to all.' It is a true bill of 'must' with the republican party not only of New Mexico, but nationally also. The lightning of self preservation has struck them and has awakened their think tank to a realization that if they do not now work with the democrats for immediate admission there is great danger that the would-be republican plunder state, (without the Flood amendment) won't be a state at all. By the breathing of democratic atmosphere all over this great country of ours, inoculating the people with the true democratic doctrine the election next year is likely to bring forth a victory for the people as against favoritism to the trusts. Democrats will lay no flattering unction to their souls in the dream that the republicans are helping us democrats the infinitesimal part of one-fourth the size of a knat's heel. They are compelled to tote fair because of the probability of losing three republican electoral votes in 1912, while the democrats will probably gain three electoral votes in Arizona. The territorial democratic executive committee gave the republicans of New Mexico—what the military gentleman, Major Ernest Meyers, terms—the coup-de-taut. The stand-pat republican senators when confronted with the real status will have to fish or cut bait, and if they do neither they will be cutting New Mexico's political nose to spite Arizona's beautiful democratic face. The latter will recover next year with a democratic president, congress and very probably a democratic senate, but the former is taking grave chances of remaining a political invalid for an indefinite number of years unless she would consent to come in as a democratic state in 1913.

The editor of this paper has not weakened in his belief that, as the republicans have been found with shoddy political goods, and do not wish to be convicted, the Flood Joint Resolution will—(if the territories senate committee reports the resolution) be passed and we will be to all intents and purposes citizens of the United States."
