Article IV General

Sec. 1 Adoption of Constitution: This Constitution shall be effective when approved by a two-thirds vote of the University Faculty present and voting and ratified by the Regents.

Sec. 2 Amendments: This constitution may be amended by a two-thirds vote of the Voting Faculty present and voting and ratification by the Regents. Amendments shall lie on the table for thirty days before final action.

Sec. 3 By-Laws: This Constitution shall be supplemented by By-Laws of the Faculty when such are adopted by a majority vote of the Voting Faculty; and by By-Laws of any College when such are adopted by majority vote of that College Faculty. Such By-Laws will normally include: (1) interpretations and implementations of this Constitution; (2) the tenure and the duties and responsibilities of the standing committees of the University Faculty; (3) other faculty regulations; and (4) college regulations.

Sec. 4 Distribution: This Constitution and the By-Laws of the Faculty shall be kept up to date as amended and distributed to the Faculty of the University at least once each year.
