# THE WORST of the DEATH PENALTY

"I see no other defensible position than to strive for pain-reduction....If in doubt, do not pain. Look for alternatives to punishments....Social systems ought to be constructed in ways that reduce to a minimum the perceived need for infliction of pain for the purpose of social control. Sorrow is inevitable, but not hell created by human beings." - Nils Christie

The death penalty is for punishment.
Punishment is the deliberate infliction of pain by people representing those in power in the name of a greater good. Punishment and justice are not the same things. There is little evidence that

punishment produces
lasting positive change.
It is much more likely to
be life destroying and
life distorting rather
than life enhancing. It
is perfectly true that a
small portion of those in
prison have done terrible
things to others. What is
tragic is that those
things cannot be undone.
What we can do is work to
keep such things from
happening again and to

heal those who have already been hurt. In order to do that, we <u>must</u> help those who have done the harm.

We must also remember that the overwhelming number of people in prison and on death row are there because of racism and poverty - they are there for who they are, not for what they have done. Most people in prison haven't harmed anyone.

Excessively long prison sentences only hurt - they help people become more angry and less functional. Killing people who have been convicted of killing people - and who, of course, may be innocent and are certainly poor and disproportionately people of color - only perpetuates the cycle of violence and vengeance.

Although the beliefs and feelings that lead to executions come from pain and the desperate desire to restore balance and sanity in a situation that feels chaotic and out of control, hurting back, deliberately inflicting pain, does not heal or strengthen or help us live in safety or be our best selves.

Some punishments are worse than other because

they are more damaging and irrevocable than others. Those that completely take over and control a person's entire life are the worst of all. These punishments include both outright killing and the sentence of "life without the possibilty of parole," which is rightly named "death by imprisonment" by Bob Gross. Just as there were caring people in the last century who refused to join the efforts of the Society for the Improvement of Infant Chimney Sweeps because they opposed having infants as chimney sweeps altogether, so too today, we stand with CURE and we demand the aboliton of the death sentence, including "life without."

"Using punishment to deter individuals from causing further harm assumes rational thinking. It is flawed psychology. But punishing one in order to deter others is a scapegoating process. Societies then extend scapegoating from individuals to groups who become expendable people. In the U.S. correctional system, scapegoating applies to the poor and people of color .... Punishment looks backward, not to bring benefit ... " -Virginia Mackey

## TOO TRUE

Everyone female knows when they think about it that women in prison must be victims of violent abuse. The only good news is that this horrendous state of affairs is now getting some public notice.

Amnesty International released a report in early March that even USA Today reported on. It is titled "Not part of my sentence"

Violations of the Human Rights of Women in Custody.

The report states that women in U.S. prisons undergo a "shocking array" of abuses, including rape by guards and male prisoners.

A former federal prisoner in California comments accurately: "I've always said I'm not the first woman who's been subjected to this cruelty, and I'll probably not be the last."

CLASS ACTION FOR HEBREW ISRAELITES

State Farm VA February 16, 1999

Members of the African Hebrew Israelites of Jerusalem, whose Spiritual Leader is Ben Ammi Be Israel, are in the beginning stages of filing a class action against the Virginia Department of Corrections (VDOC) to establish: a vegan diet for all Israelites in the VDOC who are practicing the faith, to permit all practicing Israelites to be allowed to observe the Sabbath day, which is from sunset Friday until sunset Saturday, and to establish a Hebrew Israelite service at all VDOC institutions, so the teachings of Israelites can be afforded to the inmate populations throughout the VDOC. We were recently informed by the ACLU of Texas that Texas State Senator Royce West (D-Dallas) has filed a bill (76R2285 Pep-D HB 275), the intent of which is to deny all TDCJ prisoners in close custody and in administrative segregation access to radios. (As of this writing), the bill has been filed, but is not law yet. We have a chance to vote down this bill if we mobilize promptly and express our disapproval.

#### PRO-

Appleton MN March 1, 1999

Four months ago we were transferred from the Halaw Hight Security Facility in Aiea HI where inmate beatings and killing at the hands of "correctional officers" were an everyday part of life.

Here at the Prairie Correctional Facility, owned and operated by CCA, we inmates are treated with the utmost respect. We have access to numerous educational programs, life skills and drug rehab. We are allowed our own TVs, cassettes, coffee pots, guitars, keyboards....

#### CON -

Lawrenceville VA March 1, 1999

Here in Virginia, there is one private prison, in Lawrenceville VA. It is a 1,500 man medium security facility which is owned and operated by Corrections Corporation of America (CCA). This privately owned prison is grossly understaffed, the officers are under trained, there is very little outside recreation and few programs and no law library at all. Prison officials here only care about one thing, and that's making money....

#### FORMAL COMPLAINT

Santa Fe NM March 5, 1999 To: Amnesty International

We, the prisoners here in Santa Fe NM, U.S.A., North Facility, Unit I are requesting your intervention. NM Governor Gary Johnson and Secretary of Corrections Robert Perry have issued unwritten orders to torture inmates physically and emotionally. We are being assaulted by guards on a daily basis. When chemical agents are used, they are excessively used on all inmates in the housing unit. This month alone there have been at least 20 beatings by guards. (continued on next page)

On February 23, 1999, at approximately midnight, prison staff known as the "goon squad" entered Unit I and sprayed \$517.45 worth of pepper spray on us. This is an excessive amount of chemical agent. The inmates that were asleep woke up choking and coughing. The chemical agents flowed from cell to cell through the venilation system. We were not given medical treatment for the excessive amounts of chemical agents we were forced to inhale.

(Much of) the New Mexico prison population is infected with the hepatitis B virus...

#### EID UL FIT'R AND EID UL ADHA

Memphis TN March 7, 1999

The Eid ul Fit'r and the Eid ul Adha are two holidays for all muslims who are incarcerated in federal and state prisons. These are religious feasts, elaborate meals of celebration. The Eid ul Fit'r (Ramadan Achievement) is the first part and the second part is the Eid ul Adha (Sacrifice of Abraham)...Yet the Bureau of Prisons only allows one ceremonial meal for muslims, while other religious groups are allowed several ceremonial meals. At F.C.I. Memphis it had been agreed to include dishes prepared by outside volunteers.

#### SEEDS OF RELIGION

Ina IL March 9, 1999

The seeds of Native American religion are finally springing to life within the Illinois DOC. Please be a part of this new life if you practice Native American ways, particularly the way of the pipe. Please spread the word to any and all prisoners who are called this way...Several medicine men are being screened as Native American spiritual advisors, able to conduct pipe ceremonies and related activities, and should soon be made accessible to those who practice Native American religious ways...Become involved by making a written request to your prison chaplain specifying your desire to practice Native American religion and to meet with the medicine man. If necessary, follow up by using the grievance and religious request procedures outlined in the rulebooks...A large Chicago law firm is handling the case, Ellis v. ## Crime of the Month

When Tamoxifen, touted as a breast cancer prevention drug, hit the media last April, the drama of the moment was enhanced when the National Cancer Institute halted the trials of the drug, "so that all women in the trial (meaning those in the placebo group) could be given the chance to use Tamoxifen."

But wait. The drug has been tested on 13,000 healthy women over the age of 35 defined as at high risk for breast cancer based on the assumption that age, heredity, and other unalterable facts are the only measurable cancer risk factors.

News reports indicated that the drug carried a slight risk of fatal blood clots and uterine cancer, but examination of the trial

results indicated that these risks in fact were a 150% jump in uterine cancer cases, a three-fold increase in blood clots in the lungs and 60% rise in clots in major veins. Three women taking Tamoxifen died from lung blood clots.

Based on raw numbers the reports claimed a 49% reduction in breast cancer risk, but in absolute terms the reduction amounts to 1%. Additional studies in Italy and Britain showed no reduction in cancer risk.

Even the FDA refused to approve the drug for cancer prevention, but the manufacturer can still advertise it for short-term reduction of risk.

It seems that some drug pushers get all the breaks. That is our Crime of the Month.
