ROAD PROJECT DISCUSSED

By Members of the Commercial Club and Citizens Generally

ROSWELL TO MALAGA

Committee of Three to be Appointed by County Commissioners at a Later Date

TO SECURE GOVERNMENT ROAD ENGINEER

The members of the Commercial club and citizens generally met at the club rooms at 4 P. M. Monday to discuss the project of a highway from Roswell to Malaga. The meeting was called to order by Mayor McLenathan, who stated the object of the meeting was to discuss the project of a highway from Roswell to Malaga. There were several plans proposed, among them to appoint representatives to go to Roswell to take up the matter with the committee of the Commercial club and others of Roswell.

The county commissioners who were present offered to appoint a committee of three to be named later.

Mr. Patrick, road overseer at Artesia, stated that he had much encouragement from the farmers and others and Mr. Osborne stated he would give six days with a team to assist in building a highway from Roswell to Malaga and several others offered the same kind of assistance.

County Engineer made a statement that he had a report from the government that they would build a road from Roswell to Malaga and a request made for an engineer to look after the work.

Mr. McLenathan stated that he had the matter up to you and he believed the chairman could be secured.

Mr. Beeman stated that as a delegate from the Farmers Union, at Loving, that they were and farmers would give all the road in District No. 3. Mr. Patrick, as road overseer for District No. 2, stated that the road from their district. Mr. Lusk, supervisor of District No. 1, stated that on account of the country between Carlsbad and Malaga being barren and unsettled, the work in that district should be provided for from some other source. It was the general sentiment of the meeting that Carlsbad would build the road through District No. 1.

Moved a committee be appointed from the club to go to Roswell to the Products Exposition which was left to the officers of the club to select.

Mr. McLenathan advised that all go to Roswell the 6th instant to attend the Products Exposition. He stated that the railway company would provide a special train for a company of \$276.00.

Motion of Mr. Osborne, seconded by Mr. Carter, to engage a special train as stated at \$276 was duly put and carried unanimously. Mr. Osborne made a motion which was duly seconded that a committee be appointed to get out and rustle for people to go. Carried. E. T. Carter, Professor Poore, C. W. Beeman, W. H. Woodwell and R. M. Thorne, were appointed.

The matter of road to the Guadalupe and Black river was brought up by Mr. Beeman who stated that Road District No. 3 had but \$1,800 each year to

spend and that was spent to repair roads leading to Carlsbad and that the funds for this are now exhausted except \$150.00 and asked that a small amount of \$150.00 to assist in building a road to the mountains to be used in conjunction with the county's \$150.00.

Mr. Tom McLenathan, the road man from the mountains, was present and stated that the road was in bad condition. A committee consisting of Fred Dearborn, John Smith and Charles R. R. was appointed to sign roads in all the county to improve the road.

A letter was read from the El Paso Herald stating that the representative business men would be here at midnight, Oct. 4th, to spend the time until 1911. A. M. Thompson, Nelson C. M. Thompson, seconded by E. E. Hartshorn, and a committee be appointed to secure a road to take the visitors out to the dam. Messrs. Richards, Hartshorn, Graves, Duggan, Carter, Kerr and Christian were appointed as given committees.

Moved a committee on program be appointed. Carried. The following were chosen: Captain E. P. Lusk, W. T. Reed, Dr. Cowan, R. M. Fossenden and J. R. Lane.
