Page 2 - Faculty Constitution

Article IV, General

Sec. 1. Adoption of Constitution: This Constitution shall be effective when approved by a two-thirds vote of the University Faculty present and voting and ratified by the Regents.

Sec. 2. Amendments: This Constitution may be amended by a two-thirds vote of the Voting Faculty present and voting and ratification by the Regents. Amendments shall lie on the table for thirty days before final action.

Sec. 3. By-Laws: This Constitution shall be supplemented by By-Laws of the Faculty when such are adopted by a majority vote of the Voting Faculty and by By-Laws of any College when such are adopted by majority vote of that College Faculty. Such By-Laws will normally include: (1) interpretations and implementations of this Constitution; (2) the tenure act of the University; (3) a statement of promotional policy; (4) a statement of the duties and responsibilities of the standing committees of the University Faculty; (5) other faculty regulations and (6) college regulations.

Sec. 4. Distribution: This Constitution and the By-Laws of the Faculty shall be kept up to date as amended and distributed to the Faculty of the University at least once each year.

REVISIONS TO

Proposed Master of Administration Degree and to Explanatory Material

The proposed degree shall be entitled Master of Industrial Administration

Whenever the degree title Master of Administration appears in the text, the objective, industrial, shall be inserted before Administration.

Paragraph 11-C shall be deleted and a new paragraph substituted as follows

The Master of Industrial Administration degree includes within its core certain courses which should offer an opportunity for graduate students within the College of Business Administration to gain a responsible competency in the art of managerial controls and practices, and in policy - and decision-making procedures as these apply to the internal operation and direction of any functional organization.
