# IN THE NAME OF DEMOCRACY

The good news is that according to the Associated Press on June 15, 400 men were freed from Abu Ghraib prison in Iraq on June 14, although it had been announced that the release would total 650. Dozens of other men have been notified they would be released this week, but the prisoners don't trust that the US will honor such promises.

The Monday, June 14 releases were the 5th major ones since the torture of Iraqi detainees became public. The US will continue to hold 4,000 to 5,000 prisoners said to be "a threat" to the US occupation of Iraq. According to the Taguba report, 70% to 90% of Iraqi civilians held at Abu Ghraib were in prison by accident.

The US has also promised to improve its prisons in Afghanistan, which include a network of 20 jails. Recently

inspected by a general Jacoby, allegations of abuse there include the deaths of at least 3 prisoners.

The Associated Press has also obtained US Army records showing that the noncommissioned officers who heard complaints of prisoner abuse at Abu Ghraib from at least 5 US soldiers as early as last fall, did little to stop the mistreatment.

As a New York Times columnist wrote: "The message with regard to the treatment of prisoners in the US has been clear for years: Treat them any way you'd like. They're just animals. The detainees in Iraq were treated like animals too, a logical extension of the way we treat prisoners here at home."

Other recent disclosures include the "torture memo," written in August 2002 by the Justice Department at the request

The Name of DEMOCRACY, cont. of the CIA and the White House. It states that it "may be justified" to torture al-Qaeda suspects and speculates that international law, which categorifically prohibits torture, "may beunconstitutional."

The "Rumsfeld memo" was written in March 2003 at the Pentagon. It declared not only that the US president has thepower to evade international law and to torture prisoners from other countries, but also that interrogators who follow the presiden'ts commands can, in addition, be held immune from prosecution.

And what is congress doing? Not much. The House of Representatives is now silent and the Senate Armed Services Committee is moving at such a leisurely pace that it's hard to believe there will be much of a report ready before the November elections.

Amnesty International (AI) released a report on May 26 plainly stating an unusual amount of truth: The Bush administration has "openly eroded human rights" which has made the world a more dangerous place. "As a strategy, the war on terror is bankrupt of vision and berefit of principle. Sacrificing human rights in the name of security at home, turning a blind eye to abuses abroad, and using preemptive military force where and when it chooses have neither increased security nor ensured liberty." Hundreds of people from other countries remain in indefinite detention without charge or trial outside the US mainland.

The AI includes further information that torture or other ill-treatment was frequently

reported. "Detainees suffered extreme heat while housed in tents and were supplied with insufficient water, inadequate washing facilities, open trenches for toilets, no changes of clothes, and no books, newspapers, radios or writing materials. Detainees were routinely subjected to cruel, inhuman or degrading treatment during arrest and the first 24 hours of detention. Former detainees stated they were forced to lie face down on the ground, were held handcuffed, hooded or blindfolded, and were not given water or food or allowed to go to the toilet. Torture and illtreatment included prolonged sleep deprivation; prolonged restraint in painful positions, sometimes combined with exposure to lough music; prolonged hooding; and exposure to bright lights." And on and on. We know the story.

As a US battalion commander near Baghdad has said: "With a heavy dose of fear and violence, and a lot of money for projects, I think we can convince these people that we are here to help them." A White House spokesperson has put it this way: "People in those countries did not have the kinds of protections that we're used to in the United States, and now they do."

Even the American Correctional Association has said publicly: "We do not deny that there is abuse in America's correctional systems." This behavior is not acceptable. Our symbolic question is: "Who made the hoods?"

# SAD SUPREME COURT SYLLABUS

"SCHRIRO V. SUMMERLIN, NO.03-526, Respondent was convicted of firstdegree murder and sentenced to death under Arizona's capital sentence scheme then in effect, which authorized the trial judge, rather than the jury, to determine the presence of aggravating circumstances that make the defendant eligible for the death sentence. The State Supreme Court affirmed on direct review. While respondent's subsequent federal habeas case was pending in the Ninth Circuit, this Court decided that Apprendi v. New Jersey, 530 U.S. 466, 490, required the existence of an aggravating factor to be proved to a jury rather than a judge under Arizona's scheme. Ring v. Arizona, 536 U.S. 584, 603-609. The Ninth circuit invalidated respondent's dath sentence, rejecting the argument that Ring did not apply because respondent's conviction and sentence had become final on direct review before Ring was decided. Held: Ring does not apply retroactively to cases already final on direct review. Pp. 3-10.

(a) A "new rule" resulting from a decision of this Court applies to convictions that are already final only in limited circumstances. New substantive rules generally apply retroactively, but new procedural rules generally do not--only "'watershed rules of criminal procedure' implicating the fundamental fairness and accuracy of the criminal proceeding" are given retroactive effect. Saffle v. Parks, 494 U.S. 484, 495. Such a rule must be one "without which the likelihood of an accurate chviction is seriously diminished,: Teague v. Lane, 489 U.S. 288, 313. Pp. 3-4.

(b) Ring's holding is properly classified as procedural. It did not alter the range of conduct or the class of persons subject to the death penalty in Arizona, but only the method of determining whether the defendant engaged in that conduct. P. 4-6.

(c) Ring did not announce a watershed rule of criminal procedure. This Court cannot confidently say that judicial factfinding seriously diminishes accuracy. Pp. 7-10.
341 F.3d 1082, reversed & remanded."

# **Crime of the Month**

While commemorating the life of expresident Ronald Reagan recently, the US corporate media was busily rewriting history. Many journalists and news commentators could not say enough about this "vital, optimistic leader," evoking a picture of his role as a western movie hero telling outlaws to put down their guns.

After congress finally passed sanctions against the apartheid government of South Africa, Reagan vetoed the measure. In Central America, Reagan's record is even worse. His 8 years in office was one of the bloodiest eras in western hemisphere history. The death toll was staggering: more than 70,000 political killings in El Salvador, more than 100,000 in Guatemala and the responsibility for 50,000 deaths

in Nicaragua. As the Nicaraguan foreign minister of the 80s says, "Reagan was the butcher of my people. We should not ever forget the crimes he committed."

In the US, Reagan was the backer of what even Bush Sr. characterized as "voodoo economics," causing one of the biggest deficits in US history. Still, the corporate media cheered him on as he fired all the air-traffic controllers in 1983 after they struck for better pay and working conditions.

No doubt Reagan will be remembered by some as one of the most important US presidents of the 20th century, but much of the credit is due to corporate media's interest in airbrushing the story and their uncanny ability to look the other way.
