Notice of Sale

WHEREAS, In the District Court of the Seventh Judicial District within and for the County of Valencia, State of New Mexico, in a certain cause numbered 2048, and entitled Adolphe Didier, Trustee for the Board of Trustees of the Belen Land Grant, a corporation, as such Trustee, and the Board of Trustees of the Belen Land Grant, a corporation, plaintiffs, versus Abran Abeyta and Emilia S. Abeyta, his wife, defendants, there was made and entered on the 2nd day of January, 1919, a certain final judgement and decree finding and adjudging that the defendant, Abran Abeyta, was indebted to the plaintiffs on account of two promissory notes dated November 16th, 1914, the first in the sum of \$25,000 due and payable on or before March 1st, 1915; and the second in the sum of \$10,000 due and payable on or before March 1st, 1916, both payable to the order of the Board of Trustees of the Belen Land Grant at the Socorro State Bank, Socorro, New Mexico, with interest thereon at the rate of 6 percent per annum, and 10 percent additional as attorney's fees if not paid at maturity and thereafter placed in the hands of an attorney for collection, and

WHEREAS, it was found that neither the said promissory notes nor any part thereof nor the interest thereon had been paid, and that the amount of said indebtedness, principal and interest, on the first day of January, 1919 was the sum of \$43,487.50, and

WHEREAS, the defendants made, executed and delivered to the plaintiff, Adolphe Didier, as Trustee of plaintiffs Board of Trustees of the Belen Land Grant, and for the purpose of securing the payment of said promissory notes and of the moneys paid by plaintiffs for taxes in said decree set forth, a certain mortgage and deed of trust dated the 16th day of November, 1914, and conveying to said plaintiff, Adolphe Didier, as Trustee, the lands and premises in said deed of trust and in the complaint in said cause, and hereinafter described, and

WHEREAS, the plaintiffs have paid as taxes on said premises in the Counties of Socorro and Valencia, and for the benefit of the defendants, such sums as amount with interest thereon at 6 percent per annum to the first day of January, 1919, to the total sum of \$1398.70, which sum was by said final judgement and decree adjudged to be due from defendants to plaintiffs and to be secured by the lien of said deed of trust and payable out of the moneys arising from the sale of said premises as in said final decree directed, and

WHEREAS, said final decree found and adjudged the defendants to be indebted to plaintiffs in the sum of \$4348.75 as attorney's fees, due and payable under the terms of said promissory notes, and the said deed of trust; which sum was adjudged to be secured by the said deed of trust and payable out of the moneys arising from the sale of said premises as in said final decree directed, and

WHEREAS, during the pendency of said cause Adolphe Didier, Trustee, died, and Placido Jaramillo, Sheriff of the said Valencia County, was by order of said Court substituted as plaintiff in the place of said Adolphe Didier, deceased, and

WHEREAS, the indebtedness aforesaid together with the sum of \$250.00 allowed as compensation to the said Trustees and the sum of \$100.00 allowed to F. C. H. Livingston, referee, together with the costs of this suit were by said final judgement and decree declared to be a lien upon the premises in the said deed of trust and in the complaint in said cause, and hereinafter described, and the said premises were by said final judgement and decree ordered and directed to be sold and the proceeds thereof applied to the payment of the costs of said sale and of the cost and allowances in said cause and of the indebtedness due to the plaintiffs, as aforesaid, and

WHEREAS, F. C. H. Livingston was designated and appointed as a referee of said Court to make said sale and distribute and apply the proceeds thereof;

NOW, THEREFORE, the undersigned, F. C. H. LIVINGSTON in pursuance of the order and direction of the Court in the above entitled cause, will on Tuesday the 6th day of May, 1919, at the hour of two o'clock in the afternoon, sell at Public Auction, for cash in hand, at the front door of the Post Office at the town of Belen, Valencia County, New Mexico, to the highest and best bidder, the following described premises and real estate situated in the counties of Valencia and Socorro in the State of New Mexico:

Beginning at a point at which the north boundary of the Servilleta Grant intersects the east bank of the Rio Puerco; thence east one hundred thirty-two and 44-100 (132.44) chains to the right of way of the Atchison, Topeka and Santa Fe Railway; north twenty-three (23) degrees, twenty-two (22) minutes east along the said right of way, fifty-four (54) chains; thence north seventy-one (71) degrees, eighteen (18) minutes west, fifty-two (52) chains; thence north one (1) degree, fifteen and one half minutes (15.5) west, one thousand

three hundred forty-nine and 9-100 (1,349.09) chains to the north boundary of the Belen Grant; thence meandering the east bank of the said Rio Puerco in a southerly direction, along the east bank of the Rio Puerco, to the place of beginning.

The amount of the indebtedness to pay which said sale is made is the sum of \$49,584.95, together with interest thereon at the rate of 6 percent per annum from the first day of January, 1919, and the costs of this suit amounting to \$11.70 and costs of this sale to be taxed.

Be it further resolved, that it is the intention of the board of County Commissioners of Valencia County to have this, the new Bridge constructed at a point due east of the road traversing the town of Los Lunas from west to east, and that the State Highway Commission is hereby requested to have the bridge site surveyed and a suitable structure designed provided however, if in the opinion of the State Highway Engineer the cost of structure at this point is excessive in cost, in comparison with the cost at a site over a distance of five hundred feet of this location, that he is requested to submit his finding and estimates to the board of county commissioners of Valencia County, before proceeding with the design of the structure.

Be it further resolved, that the county clerk is hereby instructed to transmit a certified copy of this resolution to the state highway commission of the state of New Mexico.

Resolution on petition of 11 citizens and tax payers of Los Lunas, Valencia county N. Mex. Whereas, a petition signed by 11 citizens and tax payers of Los Lunas, has been presented to this Board under the provisions of sections, four and twelve of house bill number 238 of 1919 session of the New Mexico state legislature, as amended for the opening of roads described as follows: Commencing at a point on the south side of the blacksmith shop of John B. Raff and lands of the estate of Andres A. Romero deceased, thence north through the lands of the said estate of Andres A. Romero deceased and lands of Eduardo M. Otero to the public road, continuing north through lands of Carlos Baca where it intersects the proposed road run-

ning east and west which shall begin at a point connecting with the county court house property on the west end, through land of Demetrio Vallejos, Carlos Baca, Fred D. Huning, Francisco Aragon y Baca and Jesus Maestas, and whereas in the opinion of the board of county commissioners of the county of Valencia the immediate opening of said roads is required, and whereas such action has been approved by the county road superintendent therefore be it resolved, that the county clerk is hereby instructed to cause a survey of said road to be made by a competent engineer and to file the plat of said road in the permanent records of this office.

Be it further resolved that the district attorney is hereby requested to bring condemnation proceedings against any and all present owners of the right of way on the aforesaid road who do not make satisfactory agreements with the county road superintendent.

Be it further resolved that the county clerk is hereby instructed to issue warrants with which to pay for land for road as soon as condemnation proceedings have been completed.

Resignation of Bidacio Martinez as justice of the peace of precinct No 18 was accepted. County treasurer's report of Dec. 1918, Jan., Feb. and March 1919 were approved. Sheriff's report of Feb and March were approved. County clerk's report of Feb. and March 1919 were approved.

Be it resolved by the board of county commissioners of Valencia county that the county clerk be and is hereby instructed to issue a warrant of \$490.00 four hundred ninety dollars, in favor of Placido Jaramillo sheriff of Valencia county, to defray expenses of medicine and surgical attention while at the hospital, from wounds received from Pantalion Lovato a fugitive of the law.

The board of county commissioners then sat as board of finance. The first national bank of Belen presented their renewal additional bond of \$10,000.00 which was approved. Upon claim of Mr. Paul Dalies that the first national bank of Belen did not have their share in Valencia county as depository of the Valencia county funds. Therefore it was resolved by the county commissioners of Valencia county, that the first national bank of Belen be and is hereby made a depository of the funds of Valencia county in accordance with the law and their bonds.

The chairman of the board of county commissioners is authorized to approve bond of \$20,000.00 twenty thousand dollars, from the state national bank of Albuquerque as depository of Valencia county funds on receipt of bond properly executed. Be it therefore resolved, that the Treasurer of Valencia County be and is, hereby instructed, that after the approval of the State National Bank's bond of \$20,000.00 twenty thousand dollars as a depository of the funds of Valencia County, to deposit only from moneys collected by said Treasurer and not from the moneys which had previously been collected, not to exceed the amount as prescribed by the law of their bond.

The Board of County Commissioners, as Board of canvassers, proceeded to canvass the result of the election held in Belen, Valencia County, N. M., on the 1st day of April, 1919, for officers of the Village of Belen.

The result was as follows:

For Mayor Bernard Jacobson received 98 votes.

For Trustee Jose Jaramillo y Chaves received 98 votes.

For Trustee Benedicto Tafuya received 98 votes.

For Trustee John W. Craig received 98 votes.

For Trustee Estanislado Garcia received 98 votes.

For Clerk Paul B. Dalies received 98 votes.

Upon which certificates of election were ordered to be issued by the Clerk to the different Officers so elected.

Final Report of A. E. St. Morris as County Road Superintendent was approved. The Clerk is hereby instructed to write to the National Surety Co. of New York at Denver, Colorado, for the cancellation of Bond given by said Company for Mr. A. E. St. Morris as County Highway Superintendent; its cancellation to be made on the 15th day of May, 1919.

The clerk is hereby instructed to issue warrant of \$150.00 in favor of Richard Poil to be used by him in buying stamps for all county officers. The clerk is also instructed to issue warrant of \$45.68 in favor of the state highway engineer, to clear overdraft made on project No. 4. The clerk is hereby instructed to issue warrants not to exceed \$425.00 out of the Wild Animal Bounty Fund in payment of claims in numbers respectively as per number of claims. The meeting thereupon adjourned subject to the call of the chairman.

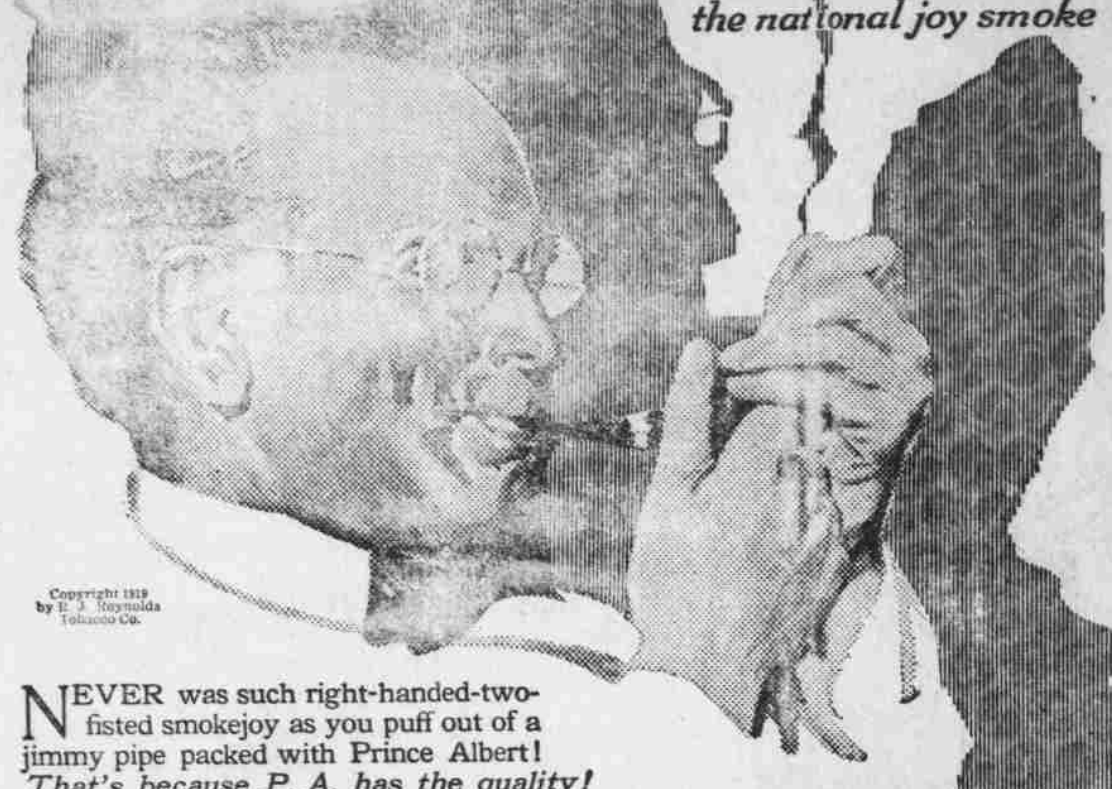

Where the War Money Went

THE ORDER AND THE BILL

From our entry in the war to the end of 1919, Uncle Sam's outgo was more than 26 billion dollars. But of this nearly 8 billion were lent to other nations—and that was some of the best fighting finance, as you will see a little later.

By spending and lending 26 billion in nineteen months we saved six months' further warfare, and perhaps a year.

We also saved at least 100,000 American soldiers' lives and four times as many wounded.

Nor was this all. For had the war continued through 1919 our further expense this year would have been not less than 25 billion dollars, and more likely 30 billions. So that through the nineteen months of war spending if we deduct money raised to lend Allied nations, we find that every dollar raised by Liberty Bonds and War Savings stamps came pretty near saving the spending of two dollars in 1919—the year of fighting that never came.

November, 1918, we had a cargo fleet of 2,335,000 deadweight tons, which transported to France 5,979,000 short tons of cargo. Of the 2,048,008 American soldiers sent over, 898,449 were carried under the American flag.

Uncle Sam built in France 937 miles of standard gauge railroad and 538 miles of narrow gauge—a total of 1,475 miles nearly as much standard gauge railroad as there is in Connecticut—almost another Lackawanna system. Counting in the narrow gauge, there is more mileage than the railroads in Maryland, and nearly another Chicago, Great Western system. In locomotives, 1,333 standard gauge engines were shipped to France, and 1,055 erected; 406 narrow gauge locomotives shipped to France; 18,013 standard gauge cars shipped to France and 14,302 erected; 3,751 narrow gauge cars shipped over. In this country the Armistice found half as much railroad equipment again, ready for shipment or under construction; 599 standard gauge locomotives, 32,685 standard gauge cars, 217 narrow gauge locomotives, 4,872 narrow gauge cars.

When the war ended our army abroad was equal to the British Expeditionary Force—2,013,039 officers and men in Europe and Siberia. Back home we had 1,690,234 more in training, and were steadily turning them out of the training camps after 4 months' drilling.
