## NOTICE OF SUIT

Notice is hereby given to the above entitled defendants that a suit has been commenced and is now pending in the District Court of the State of New Mexico, within and for the County of Valencia by the above named plaintiff against the above named defendants the object and nature of which is to establish and quiet the plaintiff's title in and to the following described land in Valencia County, State of New Mexico against the adverse claims of the defendants:

All that certain piece of land situate lying and being in precinct No 3 of Jarales, County of Valencia and State of New Mexico being bounded, described and containing as follows, to wit: Beginning at a point formed by the intersection of the centre line of the Acequia Los Garcias and the Southerly line of Predicando Baca land located on the North of land hereby conveyed running thence Westerly and along said land of Predicando Baca to the top of the hill, one hundred and forty yards to the Entrada of Juan de Jesus Sanchez, thence Easterly and along said Entrada on the Northerly side thereof to the centre line of the said Acequia Los Garcias, being the Southeast corner of the land hereby conveyed, thence Northerly along the said Acequia One Hundred and forty yards to the point or place of beginning. ## County Commissioners proceedings.

### REGULAR SESSION

The Board of County Commissioners met in regular session July 7, 1919. There were present: Manuel Garcia, chairman, Tranquilino Jaramillo and Abel Vigil members of the board, Placido Jaramillo, Sheriff and Diego Aragon Clerk.

The minutes of the previous session were read and approved. Adelino Sanchez County School Supt. appeared before the Board of county commissioners, presented estimates as to Funds for school purposes, which estimates were left to be acted upon on the 12th day of July 1919.

The following resolution was passed. Whereas, it is the desire of the board of county commissioners of the county of Valencia, State of New Mexico, to co-operate in the development of Agriculture and particularly in that branch of endeavor, which arouses in the growing children and interest in this development as well as teaches them the best and most approved scientific methods of cultivation and Animal Husbandry, and Whereas, it is possible to secure the services of a County Club Leader by entering into co-operation agreement with the Federal and State Agricultural Authorities at the total cost to the county of Valencia of four hundred fifty dollars \$450.00.

Therefore be it resolved, that the sum of \$450.00 dollars is hereby appropriated for the afore-said purpose, said amount to be paid when required by the New Mexico Director of Agricultural Extension Service upon presentation of duly signed vouchers.

Be it further resolved, that the county clerk is hereby directed to transmit three copies of the foregoing resolution to the Hon. A. C. Cooley, Director of Extension Service, State College, N. M. The county clerk is hereby instructed to write a letter to Hon. Rupert F. Asplund Director of the Taxpayers Association stating that the board of county commissioners will hold a session on the 12th day of July, 1919.

A petition containing 426 names of Tax Payers of Valencia county N. M. was presented for the building of a Public Bridge across the Rio Grande at sight near the present Los Lunas old Bridge; pursuant to the provisions of Sects. 1302 to 1307 inclusive of N. M. Statutes 1915 Annotated, was duly approved.

Upon claim of various citizens of Los Lunas the board of county commissioners directed the county road Superintendent to make proper drainages on standing

waters near the Roads.

Report of Fred C. Tondra, Selso Jaramillo and Daniel Lucero as viewers and appraisers of the Los Lunas proposed road was approved.

Protest against petition presented for the changing of the public road from Grants to San Mateo was approved.

Petition asking help for a destitute woman from Belen was rejected.

Coroner's Jury report of citizens from Bluewater on dead body of an Indian near Bluewater was approved.

Report of Dr. Wittwer as county health officer was approved.

A petition from citizens of Belen, Jarales and Bosque for the surveying and construction of drainage by opening the outlets of the Old Arroyo and making of it a Public outlet of waters into the Rio Grande, which was approved.

Be it resolved that the county Surveyor is hereby instructed to come and make immediate arrangements for the surveying of Roads and drainages in the county, as per needs and orders of the board of county commissioners; The clerk is also hereby instructed to write to Jas C. Harvey Surveyor for Valencia county at Santa Fe, N. M. to be present if possible at the meeting of said board at Los Lunas N. M. on the 12th day of July, 1919, and to transmit a certified copy of this resolution to above mentioned county Surveyor.

Estimates of A. E. St. Morris State Highway Superintendent on Roads No's 1, 6 and 9 were approved.

Resignation of Felipe Serna as Justice of the Peace of Precinct No 6 was approved.

County clerk's reports for April May and June were approved.

Sheriff's reports for months of April and May were approved.

County clerk is hereby instructed to draw warrant of \$150.00 dollars in favor of Richard Phol to buy stamps for the use of county officials.

All Road Warrants paid by order of county road superintendent during quarter ending June 30, 1919 were audited and approved.

No more business being on hand the board then adjourned to meet on July 12, 1919.

## SAVING HABITS TAUGHT US BY WORLD WAR

One of the things which this country will bring out of the war is an increased interest in securities by people who ever before considered such investment says R. H. Windsor, in Popular Mechanics Magazine. The small investor formerly thought of bonds and stocks only in terms of thousands, wholly beyond his reach, and as entirely belonging to banks and men of wealth. The war savings stamps, and the government bonds of \$50 denomination up, have not only encouraged thrift, but have opened the eyes of the small investor to the fact that to be a bond owner does not require a large ransom. Now we have some 20 million bond holders, and where formerly only 1 percent, in 7 was thriving, now 5 out of every 100 are saving. We do not suppose up to the stern thriftiness of the French, who, by extreme economy, paid off the war indemnity which the French had incurred, in an incredibly short time. But proportionately we have made a good start, for we have from the beginning been a national war savings because our resources of every kind were so enormous. Some were even ashamed to save and thought it smart to spend lavishly as fast as they earned. This condition permeated the entire land. We may well take genuine pride in a good start on the road to sound common sense and thrift. The very fact of saving increases self-respect. The flowery speeches of a thousand orators in more than a century are forgotten, while these words of wisdom by Benjamin Franklin live on:

Save a little of thy income, and thy hide-bound pocket will soon begin to thrive and thou wilt never cry again with an empty stomach; neither will creditors insult thee, nor want oppress, nor hunger bite, nor will nakedness freeze thee. The whole hemisphere will smile brighter, and pleasure spring up in every corner of thy heart.

Remember that money is of a prolific, generating nature. Money can beget money, and its offspring can beget more, and so on. Five shillings turned is six, turned again it is seven and thence, and so on until it becomes one hundred pounds.

### NINTH WEEK OF FORD CASE

Famous Million Dollar Libel Case Continues in Mt. Clemens—Edsel Ford is Called to Stand by Newspaper.

Mt. Clemens, Mich.—Editors who directed the policy of The Chicago Tribune, and editorial writers who put that policy into printed words, were the witnesses produced by the defense during the ninth week of the Ford Tribune \$1,000,000 libel case.

Tiffany Blake, chief editorial writer of the Tribune, was one of the most interesting witnesses. Mr. Blake testified that he had deliberately permitted the characterization of Mr. Ford as an anarchist because it seemed to him to sum up Mr. Ford's activities. He testified at length, under cross-examination, concerning the attitude which his paper took in favor of war with Mexico but against war with Germany, and admitted that The Tribune had in mind the material benefits which would accrue to the United States in the event of intervention, and the fact that no such gains could be reaped from war with Germany.

### Ford Was in the Way.

During the course of his testimony Mr. Blake characterized the utterances and the attitude of Mr. Ford as "notorious." Ford counsel took the stand that Mr. Ford's position could not have been notorious to readers of the Tribune because The Tribune never referred to the alleged statements which it is now using as a means of justifying its attack. Its attitude towards Mr. Ford, counsel attempted to show by questioning the witness, was based upon the fact that just when it seemed that the paper's long campaign for war with Mexico was about to be successful, and troops were being hurried to the border, it suddenly found Henry Ford in its way.

Submarine warfare, in the estimation of The Tribune, the witness said, was never sufficient cause for war. Mr. Blake admitted that the newspaper did not demand armed redress after the sinking of the Lusitania, and that when the President used the Sussex case as a test, The Tribune continued to declare that the submarine issue was no cause for war.

An editorial from The Tribune was introduced and Ford counsel proceeded to read from it, "If we win in Germany, what do we win?"

"Yes, what do we win," interjected the witness.

"Blessed if we know," continued the editorial.

"Yes, blessed if we know," broke in the witness again, "we don't know today."

"You stated," said Ford counsel, "that when the government finally decided on its position that you supported it and stopped argument against war with Germany. Do you consider that when the President has presented an ultimatum and broken off diplomatic relations that you were supporting him and the nation by continuing to tell the people that the President had no ground for war with Germany?"

"Yes, because the submarine issue was not a good ground for war."

"Well, when the President broadened the issue by telling the country that we must enter the war to make the world safe for democracy, did you argue for war on these broader grounds?"

"No, we did not."

Overlooked Ford's Offer.

"Did you know, Mr. Blake, that Mr. Ford was the first person in the United States to offer himself, his ability, his factories and all he had, to assist the government in the event of war—did you know that?"

"No, I did not know that."

"Your perusal of The Tribune did not give you that information about Mr. Ford?"

"No."  
R. R. McCormick, president of The Tribune company, and one of the editors of the paper, was another witness. Mr. McCormick testified that The Standard Oil and International Harvester interests, in which Tribune

stockholders have holdings, never in any way directed the policy of the paper towards Mexico. His testimony also touched the matter of salaries, which The Tribune cut off as soon as men entered the service of the nation in the great war, although it had continued salaries when its employees were called to the border. The fact that the army pay had been doubled, that married men were discharged from the guard and that conscription had been put in force, caused the paper to change its policies, Mr. McCormick stated.

E. G. Liebold, general secretary to Mr. Ford, and Edsel Ford, the president of the Ford Motor Company, were called to the witness stand by The Tribune late in the week. Mr. Liebold testified concerning a letter which he had written in response to a communication which sought to interest Mr. Ford in a device which would deal out death.

#### GEORGE WASHINGTON ON ADOPTION OF CONSTITUTION

During the years 1787 and 1788, George Washington in over 50 different letters expressed his hope that the Constitution for a League of thirteen states might be ratified; many of his remarks are extraordinarily applicable in the present discussion of our ratification of the Covenant for the League of Nations. "The Constitution that is submitted, is not free from imperfection, but there are as few radical defects in it as could well be expected, considering the heterogeneous mass of which the Convention was composed and the diversity of interests that are to be attended to. As a Constitutional door is opened for future amendments and alterations, I think it would be wise in the People to accept what is offered to them."
