Pursuant to H. B. No. 405, being Chapter 138, Laws 1919—The following amendments to the Constitution of the State of New Mexico will be submitted to the qualified voters at the Special Election to be held September 16, 1919.

COMMITTEE SUBSTITUTE FOR HOUSE JOINT RESOLUTION NO. 30.

Proposing an Amendment of Section 8, of Article IX of the Constitution of the State of New Mexico, Entitled "State, County and Municipal Indebtedness."

Be It Enacted by the Legislature of the State of New Mexico:

Section 1. That it is hereby proposed to amend Section 8 of Article IX of the State Constitution so as to read as follows:

"Sec. 8. No debt other than those specified in the preceding section shall be contracted by or on behalf of this state, unless authorized by law for some specified work or object; which law shall provide for an annual tax levy sufficient to pay the interest and to provide a sinking fund to pay the principal of such debt within fifty years from the time of the contracting thereof. No such law shall take effect until it shall have been submitted to the qualified electors of the state and have received a majority of all the votes cast thereon at a general election; such law shall be published in full in at least one newspaper in each county of the state, if one be published therein, once each week for four successive weeks next preceding such election. No debt shall be created if the total indebtedness of the state, exclusive of the debts of the territory, and the several counties thereof, assumed by the state, would thereby be

made to exceed one per centum of the assessed valuation of all the property subject to taxation in the state as shown by the preceding general assessment. The legislature may, however, in order to provide funds for construction and maintenance of public highways and bridges enact laws authorizing the issue of bonds, debentures or certificates of indebtedness, payable at such times as the legislature shall determine out of tax levies, receipt from motor vehicle licenses, or other licenses or revenues, without submitting such laws to the qualified electors of the state, and notwithstanding that the indebtedness so created may temporarily increase the total indebtedness of the state to an amount exceeding the foregoing limitation: Provided, that bonds issued for such purposes payable from ad valorem taxes levied upon tangible property shall not at any time exceed the sum of two million dollars (\$2,000,000) except to meet allotments of Federal Funds made to the state to aid in construction and improvement of roads."

SENATE JOINT RESOLUTION

NO. 8.

A Senate Joint Resolution Proposing The Amendment of Section 3 of Article XIV, and Section 13 of Article XII of the Constitution of the State of New Mexico Relative to Educational and Public Institutions.

Be It Resolved by the Legislature of the State of New Mexico:

Section 1. That Section 3 of Article XIV of the Constitution of the State of New Mexico be amended so that said section shall read as follows:

"Section 3. There is hereby created a Board of Control consisting of four (4) members to be appointed by the Governor, each for a term of two years, and at a salary of \$3,000.00 per annum, and not more than two of whom shall belong to the same political party at the time of their appointment. Such Board of Control shall have the management and control of all State educational institutions enumerated in Section 11 of Article XII of the Constitution and of all state institutions enumerated in Section 1 of Article XIV of this Constitution and of all State educational, charitable, penitentiary or reformatory institutions (other than the public schools) heretofore or hereafter established. This provision shall become effective on and after the 1st day of January, 1921. The Legislature shall prescribe the powers and duties of such Board of Control, and until such provision is made such Board of Control shall have, with respect to each of said institutions, the powers and duties now vested in the Boards of Regents or Boards of said institutions."

Sec. 2. That Section 13 of Article XII of the Constitution of the State of New Mexico be amended so that said section shall read as follows:

"Section 13. On and after the 1st day of January, 1921, the said State Educational Institutions shall be controlled and managed by the Board of Control created by Section 3 of Article XIV of this Constitution."

You are hereby notified that there has been filed in the above entitled court, a suit numbered and entitled as above, the general objects of the action being to partition and quiet title to a tract of land known as the Nicolas Duran de Chavez Land Grant, and more accurately described as follows:

Said land is located within the County of Valencia in the Territory, now State of New Mexico, bounded on the north by an east and west line drawn through the northern side of the ruins of the house of the said Nicolas Duran de Chavez, said ruins being then about a mile and a half (1 1/2) south of the town of Los Lunas; on the east by the Rio Grande del Norte; on the south by the northern boundary of the Belen Grant; on the west by the Rio Puerco, the area of said land grant being about fifty thousand acres.

Which is the description set forth in the decree of the United States Court of Private Land Claims, confirming said land to the heirs and legal representatives of Nicolas Duran de Chavez, dated August 23rd, 1893.

And further the general objects of such action are to enjoin certain of said defendants from acting as commissioners for said Land Grant, and to enjoin them from making any sale or disposition of said lands, pending this litigation, and to compel them to account for any monies received by them while claiming to act as commissioners of the Nicolas Duran de Chavez Land Grant.

A los arriba mencionados acusados, y todos los herederos desconocidos o herederos desconocidos designados como acusados:

Ustedes estan por esta notificados que ha sido protocolado en la arriba intitulada corte, un pleito numerado e intitulado como arriba, los objetos generales de la accion siendo para separar y aquietar titulo a un trecho de terreno conocido como la Merced de Nicolas Duran de Chavez, y mejor descrita como sigue a saber:

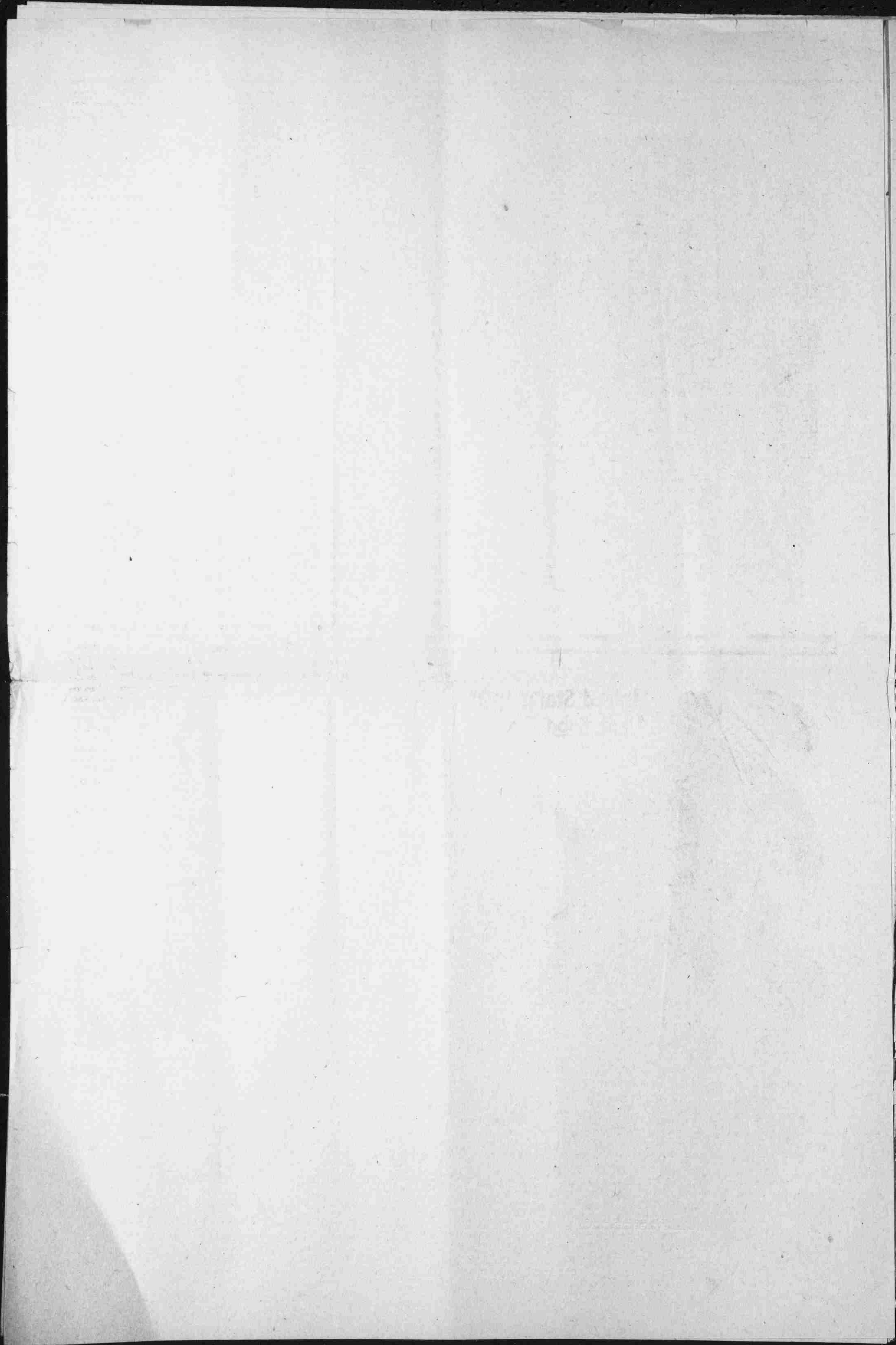

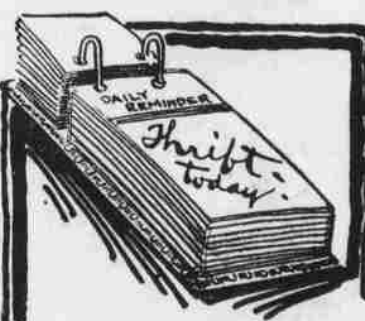
