DIAGNOSIS UNDISPUTED

The diagnosis is undisputed. Prison medical systems are and have been critically and chronically ill. In 2002 (that is five years ago!), The National Commission on Correctional Health Care released the report, "The Health Status of Soon-to-be Released Prisones" with the scathing, but unfortunately not surprising finding that "indisputably tens of thousands of inmates are being released into the community every year with undiagnosed or untreated communicable disease, chronic disease, and mental illness."

The prognosis is bleak as prison officials and both state and federal governments persistently fail to comply with prescribed treatements for improvement. Despite governments' legal and moral obligations to provide health care for prisoners, it has been necessary

to bring numerous class action lawsuits in the attempt to enforce this right. In 1993, 40 states were under court orders of this nature and many continue to be

For example, most recently, the Prison Law Office has taken the California prison system to court in a federal class action lawsuit regarding dental care. Perez v. Tilton, ND Cal. No. C-05-5241. A settlement was reached and Judge Thelton Henderson entered an amended stipulation and order on August 21, 2006, finding that prisoners' constitutional rights had been violated.

Under the settlement, prisoners may still raise dental care problems in administrative hearings and may still file individual lawsuits concerning dental care. There are provisions for screening, education and regular dental exams.

An individual treatment plan is supposed to be developed for every prisoner who needs dental treatment. Every facility is to always have a dentist on call and emergency dental care is to be available 24/7.

Even under the best case scenario, the terms of the settlement are scheduled to take place in stages until 2011. It remains to be seen whether this settlement has teeth sufficient to enforce compliance.

In a preceding case, Plata v. Davis, 329 F.3d 1101 (9th Cir. 2003), California's entire \$1.1 billion-a-year prison medical system was taken over by an outside administrator. In May 2005, however, the CDC was back in court and Judge Henderson ordered the most sweeping medical takeover in U.S. prison history, citing "incompetence and outright depravity in the rendering of medical care." In that system, a prisoner died every week because of medical negligence or malpractice.

State officials have conceded the shoddy care received by prisoners and have not appealled the ruling.

California is not alone in its prison system medical care scandals. There are also class actions in Texas and Ohio and serious problems in the Delaware prison system. Women prisoners in Wisconsin and Texas have especially harrowing experiences. The struggle continues.

WOMEN ON DEATH ROW

Women make up about 10% of murder arrests, but only 2% of execution sentences and only 1% of the people on Death Rows. They are 59 of the 3,350 total on Death Rows in this country as of January 1, 2007. Of the jurisdictions with execution sentences, only 25 states have sentenced women to execution since 1976. That was when execution was reinstituted by the U.S. Supreme Court after it had been declared unconstitutional and then three years later was said to be okay if there were separate quilt/innocence and sentencing phases in the court proceedings.

California and Texas have the most women on Death Row, with 18 waiting for execution in each state. North Carolina has the next highest number of women with 16; Florida has 15. There are 11 women on Death Row in Ohio and 10 in Alabama. The other jurisdictions in which women have been sentenced to execution are:

Arizona, Arkansas, Delaware, federal (in Iowa), Georgia, Idaho, Illinois, Indiana, Kentucky, Louisiana, Maryland, Missouri, Nevada, New Jersey, Pennsylvania, South Carolina, Tennessee and Virginia.

Since 1976, 11 women have been executed. Seven of them had been convicted of killing a family member--five of them had been of killing their husbands, one of killing her lover and one of killing two of her children. These women have been on Death Rows for periods of from a few months to over 20 years.

The women on Death Rows range in age from 23 to 73. Eighty percent of them are between 30 and 50. Sixty percent of the women on Death Rows are described as white, 28% as African American, 10% as Latina and 2% as Native American. Those killed are described as 64% being white, 25% Latino, 8% as African American and 3% as Asian.

...The Federal Bureau of Investigation has been requested to conduct a preliminary investigation into the death of Terreth A. White. You can be assured that if the evidence shows that there is a prosecutable violation of federal criminal civil rights statutes, appropriate action will be taken...We will further consider allegations of excessive physical force by correctional officers if the persons involved in the incident(s) will write to us directly and provide specific information about the circumstances surrounding the incident(s). They should include the date(s) of the incident(s), the sequence of events leading up to and including the incident(s), a description of the injuries sustained, copies of medical reports and the names of involved law enforcement officials and possible witnesses...

Letters intended for publication must say "Do Print." If requesting responses, state if you can receive mail directly from those imprisoned. The Coalition makes information available on resources and services for prisoners. We strongly urge readers to keep copies of all papers, especially legal papers, sent to those offering assistance, and be careful about sending money. In most cases we do not have direct experience with the quality or reliability of the services provided by the groups mentioned. NONE OF US ARE LAWYERS.

MIM BANNED

According to several prison administrators, the director of the division of Adult Institutions for California issued a memo in December "directing an immediate ban on the receipt, possession, or distribution of literature/publications from MIM to or by inmates in the custody of the CDCR." MIM needs help to fight this through the legal system. Systematic rejection of all mail from an organization based on disagreement with the sender's politics is not legal. It appears prisons are violating their own rules by not notifying prisoners of the mail censorship.

Crime of the Month

Bechtel corporation recently took over the running of Los Alamos National Laboratory, long time bomb producer near Santa Fe, New Mexico, after years of scandals and security lapses there under the management of the University of California. Bechtel is now being paid richly to make nuclear weapons. Is this a good idea??

The company has a history of making lots of money by spending public funds, and while its projects are not always completed, it always get paid. The obliteration of Iraq's civic buildings, roads and power plants has proved to be a billion-dollar bonanza for Bechtel. Clearly the lesson is: To build you must first destroy.

For instance, Bechtel received a \$2.4 billion no-bid contract at the

beginning of the Iraq war to help coordinate and rebuild a large part of Iraq's infrastructure. But the company's reconstruction failures range from shoddy school repairs to failing to finish a large hospital on time and within budget. The special inspector general for Iraq reconstruction (SIGIR) released an audit of the Basra Children's Hospital Project showing it to be \$70 to \$90 million over budget and a year and a half behind schedule.

The company won't say how much of its revenue comes from its Iraq contracts, but it probably amounts to about 10% of the total haul.

Fouling the environment while feeding at the public trough is this month's crime and Bechtel is one guilty pig.
