3	President Elect's Report	On 10/23/12, Henley attended the Faculty Senate Government Relations Committee meeting. At that meeting, a Resolution, addressing ERB solvency principles, was approved. Per Marc Saavedra, Director of the UNM Community & Government Relations Office, UNM will wait until after the November general election to determine how to move forward with a position on ERB solvency issues.
