CERTIFICATE OF INCORPORATION OF THE NEVIS COMPANY, INC.

We, the undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the provisions of the Twenty-Third Chapter of the second session of the legislature of the State of New Mexico, as amended by Chapter 112 of the 1917 Session Laws and Chapter 100 of the 1919 Session Laws, do hereby certify as follows:

I.

The name of the corporation is "THE NEVIS COMPANY, INC."

II.

The registered office of the corporation is located at Bluewater, Valencia County, New Mexico, and William E. Nevis is designated as the statutory agent therein and in charge thereof, and upon whom process against the corporation may be served.

III.

The objects for which the corporation is established are:

To buy and sell, deal and engage generally in the wholesale and retail merchandise business, and to act as the agent of any individual or individuals, natural or artificial, in buying, selling or dealing far them in general merchandise; to engage generally in the business of mining, burning, producing, shipping, buying and selling, lime and lime products; to buy and sell hay, grain, alfalfa and other commodities and products; to acquire by purchase, lease or otherwise, lime kilns, lime claims and other mining properties and to mine and develop the properties so acquired; to build all necessary buildings, warehouses and other facilities to accomplish the purpose of the corporation; to engage in the business of raising, selling and preparing for market, produce, poultry and eggs; to buy and sell all kinds of tools and implements, including harvesters, binders, reapers, mowers, rakes and headers; to carry on the business of dealing in cattle, livestock and sheep, and also that of dealing in cattle and sheep generally and in all branches of such respective trades or businesses; to purchase, acquire, hold and deal in and in any manner dispose of or sell on commission, or otherwise, hay, grain, wheat and bread stuffs, and all other goods, wares, merchandise and commodities of a similar kind.

IV.

The corporation shall, in addition to the powers hereinbefore enumerated, have and possess all rights, powers and privileges

given to corporations by common law, to sue and be sued, to borrow money and secure the payment of the same by notes, mortgages, bond or deeds of trust upon its real or personal property; to rent, lease, purchase, hold, sell and convey such real and personal property as may be necessary and proper for the accomplishment for the objects and purposes of said corporation.

V.

The authorized capital stock of the corporation with which the corporation begins business is Fifty Thousand Dollars (\$50,000), divided into five hundred (500) shares of the par value of one hundred dollars (\$100) each.

VI.

The names and postoffice addresses of the incorporators and the number of shares of capital stock subscribed for by each, the aggregate of which shall be the amount with which the corporation shall commence business are as follows:

William E. Nevis, Bluewater, N. M., 80 shares, \$8,000.

M. H. Nevis, Bluewater, N. M., 10 shares, \$1,000

S. A. Miller, Bluewater, N. M., 10 shares, \$1,000. Total \$10,000

NEW MEXICO KING.

There is a writer for the Texas Oil Critic, Fort Worth, named Garfield Crawford. In the language of the wild and woolly west, he is some writer, a genuine "blow-in-the-noodle," oil booster, with an imagination that is all-wool-and-ayard wide, and then some.

Wealthy and wealthy men go in this country, and one of the leading sheep growers, also a political power in Valencia county and in the state as well, he is one of the most modest of men, and has no aspiration to kingship of any sort, let alone aspiring to a quintuple crown, as Mr. Crawford insists. He will be more surprised than any man in New Mexico when he receives the Journal at Rochester, Minn., and reads the following from the Texas Oil Critic:

The king is great. Long live the king.

Thus sang a bird of the long ago.

In this far distant section of Uncle Sam's vast domain kings thrive and prosper. We have cattle kings and sheep kings, oil kings, financial kings, and political kings. These kings while not clothed in purple robes nor adorned with crowns of gold and precious trappings, are kings.

Practical writers are going to disagree with me, for the political sharpshooters are telling us that here on this earth has been established a universal democracy, and that this democracy has been procured for us by democrats. Their argument sounds well here in Texas, but it means nothing to such men as the Hon. Ed Otero, king of New Mexico.

Otero can truthfully be called the king of New Mexico. He is a sheep king, a cattle king, a political king, and now he has added another crown for he is an oil king.

DO YOU KNOW?

Do you know the young fellow who works for \$25 a week and who is wearing a new winter suit that cost \$85?

A WORD TO DISABLED SOLDIERS.

Every man who was in the military and naval service of the United States during the late war and who on account of such service is not physically fitted to engage at once in a gainful occupation should at once notify the Bureau of War Risk Insurance in Washington, D. C.

Under the law this Bureau is charged with providing for service men discharged because of disability incurred in active service in the line of duty. Compensation and free medical treatment until such time as they are restored to physical fitness. During the summer of 1918 there was a general combining out of the military training camps of the country in an effort to bring up the standard of physical fitness, and many men discharged at that time may be unaware of their rights under an act of congress to compensation for disability and medical attention and hospital treatment where necessary. All cases of this or a like nature should be brought immediately to the attention of the Bureau of War Risk Insurance.

KEEP WARRISK INSURANCE

It is regrettable that so many former service men are not keeping up their government life insurance issued through the Bureau of War Risk Insurance in London. The fact seems to be due largely to widespread confusion as to the right of former service men to permanent gov-

ernment life insurance, and the process by which this insurance may be retained.

The demobilization of our armed forces was so rapid and was attended by such uncertainty on the part of service men as to the future civil occupations and permanent places of abode that it was not surprising that many of the men gave little thought to the matter of insurance. Others doubtless thought the original term insurance (War Time Insurance) ceased when they were demobilized and did not know it might be converted into one of the several forms of permanent government life insurance (Converted Insurance). Still others, immediately upon their return to civil life, felt financially unable to continue the insurance. They should now take advantage of the liberal provisions for reinstatement.

UNITED STATES DEPARTMENT OF AGRICULTURE.

Large Acreage of winter wheat in state shows splendid condition.

Crop for United States nearly 12,000 acres short of last year.

The Federal Monthly Crop Report just released for publication through the office of Field Agent R. F. Hare, of the Bureau of Crop Estimates, show that this state planted this fall 211,000 acres of wheat compared to 182,000 acres planted last year. Last year's crop passed the winter and spring with an abandonment of only 5 per cent of the planted acreage. The condition of the present crop is reported better on December 1st, than was last year's crop at that time.

In the United States only 38,770,000 acres of wheat has been planted this year, compared to 50,489,000 planted last year. The condition of this crop is only 85.2 per cent of normal, compared to a condition of 98.6 per cent of last year's crop at this time.

This report shows that New Mexico has produced 681,600 bushels of apples this year, and 75 per cent of these have been shipped from the county in which they were grown. Ghaves county reported having shipped 845 cars, San Juan county 200, Otero 60 and De Baca 12 cars.

WAGES OF FARM LABOR.

The bureau's investigation relative to wages of farm labor this year, compared to 1918, 1917 and 1910 show that the wages of the farm laborer have kept in this state with the high cost of living.

The report shows that the average wage by the month without board was as follows: For 1910, \$34.25; for 1917, \$48; for 1918, \$59 and for 1919 \$60.

This year day laborers commanded \$2.90 per day, last year they were paid \$2.38; in 1917, \$1.97 and in 1910 they were only paid \$1.58.

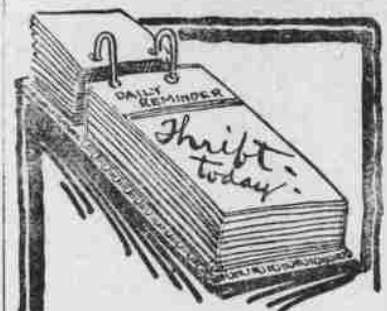

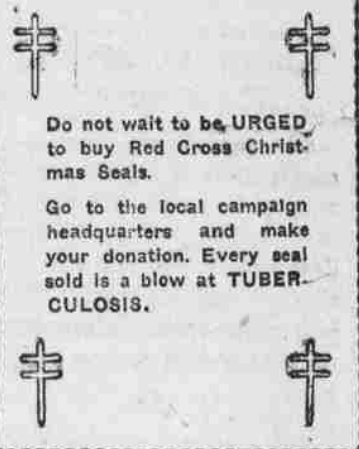
