**ARTICLES OF INCORPORATION**

**EXCELLENCE MOTOR COMPANY**  
(No Stockholders' Liability.)  
We, the undersigned citizens of the United States and of the State of New Mexico, being desirous of forming a corporation under the laws of the State of New Mexico, do make, sign and acknowledge the following articles and certificate of incorporation, to-wit:

1. The name of said corporation is EXCELLENCE MOTOR COMPANY. (No stockholders' liability.)  
2. The principal registered office of said Company in the State of New Mexico is at Belen, in the County of Valencia, and the Statutory agent of Company upon whom process against said corporation may be served, is F. C. H. Livingston.

3. The purposes for which said company is to be formed are the manufacture of various kinds of spark plugs, motors, machines, engines, machinery and contrivances for the generation and application of steam, electricity, gas or other agents for the production of power; the manufacture of cars, carriages, wagons, boats, and vehicles of every kind and description; the manufacture of machine supplies and devices and appliances incidental to the construction of motors, machines, engines and machinery; the acquisition and sale of inventions, patent rights, letters patent, trade-marks and copyrights covering any or all articles to be manufactured or dealt in by said corporation, or covering any advertising devices, or advertising matter to be used in connection therewith; the issuing of licenses under patents, trade-marks and copyrights; the sales as principal or as agent and the exporting and importing to and from foreign countries of any spark plug, vehicles, boats, motors, machines, engines, machinery, contrivances, or other articles manufactured by said corporation, or by other corporations or persons; the carrying on of any lawful trade or business incidental to the aforesaid purposes or any of them. Said corporation shall have power of purchase, acquire, hold and dispose of stocks, bonds, and other evidences of indebtedness of any corporation, domestic or foreign; to issue its own stock or bonds or other securities or obligations in exchange for stocks, bonds, or

other evidences of indebtedness of other corporations, domestic or foreign; to make and carry out contracts of every kind, and to transact any and all business which may be necessary or proper or convenient, which is not contrary to the laws of New Mexico, to the exercise and fulfillment of any of the aforesaid powers and purposes.

4. The amount of the total authorized capital stock of said corporation is Five Hundred Thousand Dollars, divided into Fifty Thousand Shares of the par value of Ten Dollars each. The amount of the capital stock with which the said corporation shall commence business is Two Hundred Shares or Two Thousand Dollars.

5. The names and post office address of the undersigned incorporators and the number of shares subscribed by each are as follows:  
W. J. Easterday, who has subscribed Fifty shares, whose post office address is Belen, New Mexico.  
Joe Bell, who has subscribed Fifty shares, whose post office address is Belen, New Mexico.

6. The term of existence of this corporation shall be Fifty years, from and after the date of the filing of these articles in the office of the State Corporation Commission of New Mexico.

7. The board of directors shall have the power to make and alter by-laws, but any by-laws made by the directors under the power hereby conferred may be altered or repealed by a majority of the stockholders.

8. The names of the directors who shall manage the business of said corporation for the first three months after the filing of this certificate of incorporation are, W. J. Easterday, E. G. Newmer and Joe Bell. After the expiration of said period of three months the board of directors shall consist of nine members, three of whom shall be elected for a period of one year, three for a period of two years and three for a period of three years, to be elected by the stockholders as provided by law.

9. The directors may hold their meetings and have offices, and keep their books and transfer books, at such places outside of the limits of the State of New Mexico as the said directors may by resolution, from time to time, direct.

**FRIEND OF PRESIDENTS**

Leonard Wood Made Good as White House Surgeon.

Leonard Wood was ordered to Washington in 1895—the morgue of the government official—to become assistant attending surgeon. The holder of this office often shares with the navy surgeon the responsibility of medical attention to the president. In addition he acts as medical adviser to army officers and their families and is the official physician to the secretary of war.

It was not an office that appealed to Captain Wood. It could not, since he was a man essentially of out-of-doors, of action and of administration. Yet he seems to have made such a success of the work that he became the personal friend of both Cleveland and McKinley. His relations with President Cleveland were of the most intimate sort, resulting from mutual respect and liking as well as from mutual understanding on the part of both men of the other's good qualities. He saw him in the White House at all hours of the day and night; saw him with his family and his children about him; noted their fondness for their father and his devotion to them. It was a quality so marked in Lincoln, so strong in most great men of the sound, calm, fearless, administrative sort.

Leonard Wood himself has exhibited the same quality in his own family. And in these days the perfect understanding of the father and his children, the simple family life that went on in the splendid old house in Washington which combined the dignity of a state and the simplicity of a home unequalled by any other great ruler's house upon this earth—all tended to bring out this native quality of the president's medical adviser.

## CUBAN STRONG FOR WOOD

Sentiment in Island for Him, Says Menocal, in Recalling His Great Work.

Chicago, May 3.—A strong endorsement for Leonard Wood in his candidacy for the presidential nomination has been made by General Mario G. Menocal, president of the Republic of Cuba.

President Menocal in his endorsement speaks of the active work accomplished by General Wood when he was governor-general of Cuba. He classes it as the most glorious achievement made by America in that island.

"General Wood practically demonstrated that real democracy is not incompatible with the principle of authority or with a strong government of powerful initiative," Menocal declares. "It will be found that without such a government democracy degenerates into anarchy and licentiousness."

"General Wood left in Cuba a friendly people who remember with admiration his admirable qualities and work, and who will always be grateful to the United States for all that he contributed to the welfare of the Cuban people."

## GREAT IN HIS PENMANSHIP

Leonard Wood Puts Himself in Class  
With Horace Greeley and  
Napoleon.

Leonard Wood's penmanship is his weakest point, but in that he has as prototypes, Horace Greeley, Napoleon and many other illustrious leaders. Clive Newcome Hartt, who was his stenographer at Governor's Island, writes:

"During the winter of 1916-1917 General Wood was traveling here and there speaking in behalf of preparedness. It was part of Captain Johnson's duties—Captain Johnson being an aide to the general—to keep in touch with his itinerary. One day the captain came into the office, and picking up the general's memorandum pad, scowled in perplexity at the words scrawled across the page in the general's imitable handwriting. The general watched him quietly for a few moments, then said:

"What's wrong? Fire away."  
"That was his usual signal that he was ready to listen to what one had to say."

"Er—excuse me, general," said Captain Johnson, hesitatingly, "but, but—I don't quite understand the memorandum. This reads 'Here for lunch' while my slate says you are not in town tomorrow—and I don't quite understand—that is, I've made no plans for lunch for tomorrow."

"Let me see it," said the general.

"He glanced quickly at the notation on the pad, and then said disgustedly: 'That doesn't say anything about 'Here for lunch.' It reads 'Leave for Ithaca.'"

## WOOD LEADS IN LITERARY DIGEST

Leonard Wood is More Than 9,000  
Votes Ahead of Nearest  
Competitor.

In its attempt to learn the composite choice of the nation for nomination for president, the Literary Digest, or the week of April 24 publishes the second installment of its presidential poll of 11,000,000 voters. The returns include 149,604 votes. Leonard Wood continues to hold a big lead.

Wood has 32,351; Hoover, 22,908; Johnson, 22,600; Harding, 10,432; Hughes, 5,922; Lowden, 6,449; Taft, 3,400. Among the Democrats, Edwards gets 7,568; McAdoo, 6,740; Wilson, 6,491; Cox, 5,649; Bryan, 3,885.

Hoover receives a Democratic vote of 9,974 which is larger than the Democratic vote cast for any avowed Democrat. McAdoo has the first place in the declared Democratic vote with 5,613 and Wilson is second with 5,342. The vote continues to come mainly from Ohio, New York, New Jersey, California, Texas and Washington.

New York Leans Ever Woodward.  
New York, April 24.—Although the people of Ohio will actually vote for the selection of only 48 delegates to the Chicago convention at the polls on April 27, the result of their balloting will materially influence 88 delegates from New York state at nomination time.

A poll of the Empire state's 88 delegates, elected on April 6, shows that they are for the strongest candidate, with a leaning toward General Wood because he is in the lead. The remarkable showing General Wood made in Illinois against Governor Lowden has boosted his stock with the 88 New Yorkers and they are now watching Ohio. If General Wood makes as good a showing against Senator Harding in Ohio as he did against Governor Lowden, this fact will practically insure the vote of the New York delegation for him.

John J. Lyons, a leading New York delegate elected to go to Chicago, said: "Two things are certain about the New York delegation: First, it is not for Senator Johnson, because all the Johnson pledged candidates for delegates were beaten by three to one or worse in the recent primary election; second, it is going to vote for the man who is nominated. At present it looks like Wood is going to be nominated, for he has split the delegation in one favorite son's state and it looks like he has a chance to split another favorite son's native state's delegation. If he does the New York delegation will regard him as the man most likely to get the nomination and will support him after a complimentary first ballot for Dr. Nicholas Murray Butler. A recent poll showed Wood was the first choice of 75 per cent of the people of New York state, and if to this sentiment is added the Illinois outcome and a similar result in Ohio, it can readily be understood why Wood would stand ace high with the New York delegation."

Garland for Wood.  
Hamlin Garland, the writer, has written a letter of indorsement of Maj. Gen. Leonard Wood, in which he says:

"General Wood knows the old world and the new. He has a wide acquaintance among the men of power and patriotism and can be trusted to form a cabinet of the highest ability. He has shown that he can hold the even hand over the labor problem. He is neither the business man nor the partisan of labor; he is a great and patriotic citizen, a civilian of vast experience, a soldier of noble spirit and notable self-restraint. 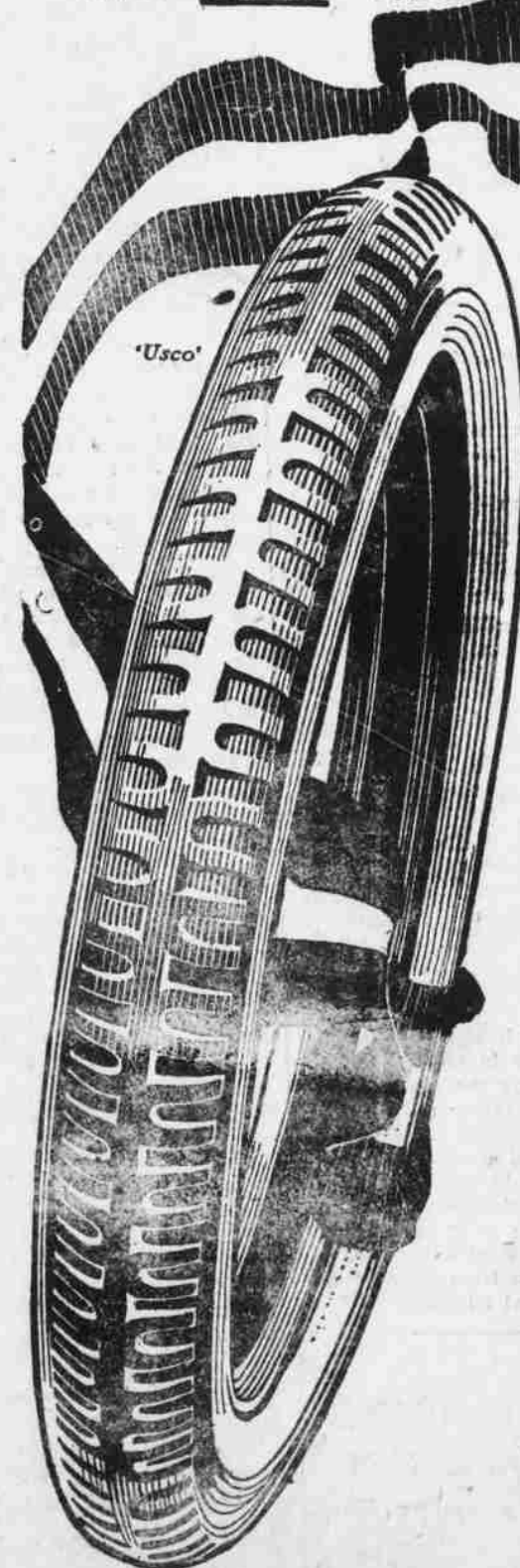
