## COLLECTION OF LICENSES.

**Solicitor General Bartlett Gives  
Opinion on New Laws.**

### DOUBTFUL POINTS CLEARED.

Solicitor General E. L. Bartlett, upon the request of H. H. Abbott, Chief of the First judicial district, has given a written opinion upon the construction of the new law for the collection of gaming and liquor licenses, which is of general interest and importance throughout the territory. The opinion is as follows:

First judicial district, attorney, H. H. Abbott, district attorney.

Dear Sir:—Your letter to me of the 20th ult., requesting my opinion on the construction of the new law, approved March 9, 1917, entitled "An act to provide for the inspection of gaming and liquor places and collection of licenses, and the manner of paying the commission on such licenses to sheriffs or treasurers of the county, or both," has been very carefully read. For the reason that a uniform construction and application of this law is not only desirable but absolutely necessary in the different counties in the territory, as well as in the First judicial district, and replying I would say:

The first five sections of the act make an entirely new law, devolving the duty upon the sheriff of each county to inspect every gaming house and saloon in the county and ascertain whether it is provided with the proper license, and, under the new law, the board of county commissioners has the duty of issuing the license. It is further made his duty upon the recovery of a license to collect the same. The act also provides for the collection of a license fee or failure to comply with the law now in force in regard to said licenses, to prevent the person so failing from being liable to prosecution for the same.
