GOOD ROAD TO ALBUQUERQUE

Duke City Committee Meets With Commission in Governor's Office

TUCUMCARI BURGLAR CAUGHT

Spanish Rendition of America Sung at Normal School Dormitory Dedication.

A. B. McGaffey, D. K. B. Sellers and W. H. Hahn, of Albuquerque, today attended a meeting of the territorial Good Roads Commission held in the office of Governor Mills at the capitol. Governor Mills, Land Commissioner R. P. Ervian and Territorial Engineer Vernon L. Sullivan, members of the commission, listened attentively to the Albuquerque representatives who had been sent by a Good Roads meeting at the Duke City. The Albuquerqueans succeeded in securing a promise that the road from Santa Fe to Albuquerque would be completed this winter. It is constructed as far as Algodones, but south from there, about two miles of heavy sand will have to be overcome. The Good Roads Commission will contribute \$4,000 and the Albuquerqueans said that Bernadillo county and Albuquerque would raise \$6,000, it being expected that Sandoval county in which the greater part of the road lies, will contribute its share of the \$6,000. The U. S. Indian service will probably also make another donation of \$500 as it did for that part of the road going over La Bajada hill. The road will be part of El Camino Real and will connect at Santa Fe with the road up Santa Fe canyon to the Pecos and also with the Santa Fe Trail to Las Vegas via Canoncito and Glorieta, on both of which the Good Roads Commission is doing fine work at present.

Territorial Funds.
Territorial Treasurer M. A. Otero today received the following remittances: Jackson Agee, Grant county, \$18,200.94; W. H. Merchant, Eddy county, \$4,204.31; Celso Lopez, Santa Fe county, \$1,728.29; Game Warden Thomas P. Gable, \$12.50.

Burglar Arrested.
Mounted Policeman J. Alexander Street of Tucumcari, who was recently appointed, already has made good by arresting at Pratt, Kansas, Ollie Kearney and taking him back to Tucumcari. Kearney is supposed to be responsible for several burglaries lately at Tucumcari, and Street reports that he has recovered \$300 worth of the stolen goods and intimates that Kearney has confessed.

Watch Out for Jessie Croffer.
The Mounted Police were notified today to be on the look-out for Jessie Croffer, supposed to be on the way to New Mexico from Sacramento, Cal., where she is wanted for stealing \$2,000 worth of jewels. Her game is to hire out as a servant girl and then to rob her employers. Jessie is 35 years old and is described as tall and angular and as blushing easily.

Educational Convention.
The Department of Education is today distributing programs of the convention of the New Mexico Educational Association at Las Vegas to be held after Christmas. The program is a crowded one and very interesting.

Governor Mills Returns.
Governor Mills returned last evening from Las Vegas, where he was present at the dedication of the new dormitory of the New Mexico Normal University. Governor Mills describes the dormitory as a fine structure which accommodates thirty-four girl boarders. The school now has an attendance of over 250 pupils. One of the features of the dedication was the singing in Spanish of "My Country 'Tis of Thee," as translated and copyrighted by Eleuteria Baca.

Tests of Material for Culverts.
Territorial Engineer Vernon L. Sullivan has just completed a number of tests, both in actual practice, and in the laboratory of different material for culverts and found that as to steel, corrugated iron and ingot iron, that the last named is by far the most durable for the purpose. Ingot iron culverts are at present being placed on the Scenic Highway in the Santa Fe canon to replace the timber bridges which have worn out. MURDER TRAGEDY AT LUCY

R. A. Gray, Forty Year Old Widower Is in Jail at Estancia

HE SHOT HIS YOUNG NIECE

Deceased Was Teaching School at Encino, Torrance County.

Miss Mary Williamson, a school teacher of Encino, was shot and instantly killed early yesterday morning near Lucy, Torrance county, by her uncle, W. A. Gray. According to Gray, the shooting was entirely accidental, or unintentional, and he is apparently quite broken up over it. Gray said that he and his niece were proving up on a claim near Lucy. Miss Williamson rode from Encino Saturday night in order to spend Saturday and Sunday with her uncle on his claim. The girl arose early yesterday morning and had begun to prepare breakfast. She went to Gray's room to awaken him. Gray says that he thought the girl was some one sneaking up on him to murder him and he immediately took his shotgun and shot the girl three times. Gray claims that he had forgotten that his niece was in the house. The body lay just outside of the shack, apparently where the girl had gone after being shot. One wound was visible about the region of the heart, evidently having been made with one load of buckshot. The dead girl is survived by a mother and sister, the latter residing in San Rafael, California. They have been notified of the tragedy.

Mounted Police Notified.

Mounted Policeman John W. Collier from Estancia today notified the headquarters of the Mounted Police that Gray is in jail at Estancia. According to Collier, the shooting took place at one o'clock in the morning and the girl's body was not found until four. Gray is a widower about forty years of age. The deed was committed with a shot gun, and a bloody handkerchief was picked up. Gray is a blacksmith by trade and insists that he shot at the girl thinking it was a burglar trying to break into the house. Lucy is on the Belen cut-off thirteen miles east of Willard and twenty miles southeast of Estancia. The Mounted Police are investigating the case.

MORE SUGAR WEIGHING FRAUDS ELSEWHERE?

Grand Jury at New Orleans Begins Exhaustive and Significant Investigation of Port.
New Orleans, Dec. 13.—The federal grand jury today began an exhaustive investigation of the methods of sugar weighing at this port. Special agents of the Department of Justice are here to assist the inquiry.

Made No Profits.
Washington, Dec. 13.—What is believed to be the greatest industrial trust in the world, next to Standard Oil—the American Sugar Refining Company, popularly known as the sugar trust—didn't make a dollar profit last year; at least that is what its officers have sworn in the returns filed in the treasury department under the provisions of the corporation tax law adopted at the last session of Congress. Instead of the trust making a profit the sworn statement claims that it ran behind more than three-quarters of a million dollars; to be exact, \$707,726.

MRS. HERBERT MASON CLAPP IS RELEASED ON BAIL

She Claims That She Shot Her Millionaire Husband By Accident During Quarrel.

Philadelphia, Dec. 13.—Although still in a serious condition the hospital physicians say that Herbert Mason Clapp, the well known club man and grand-son of Mason, the "Shoe Blacking King," probably will recover from the bullet-wound he received yesterday. Mrs. Marie Clapp, his wife, who was arrested on the strength of the statement of the wounded man that she had shot him, was released on \$2,500 bail late last night. She maintains that the shooting was accidental. A quarrel she said, took place over the opening or closing of a window and the shooting occurred while she and her husband were struggling for the possession of a revolver.

VIOLENT STORMS RAGE ON FRENCH COAST.

Armored Cruiser Edgar Quentin Runs Ashore But American Battleships Are Safe at Brest.

Brest, France, Dec. 13.—A violent storm raged over the harbor today. The visiting American battleships Minnesota, Idaho, Mississippi and Vermont, were held firm by the anchors, but the French armored cruiser Edgar Quentin was driven on the beach. It was floated later by tugs.

WHY NOT NEW MEXICO

No Place on Boundary Commission for Territory Most Interested

DOUBLE GOVERNOR'S SALARY

Mills and Sloan to Get \$6,000 a Year From Uncle Sam in Future.

Special to the New Mexican.
Washington, Dec. 13.—Representative Stephens of Texas, introduced a joint resolution that the President appoint a commission, and with a commissioner, appointed by Texas, re-establish the boundary of Texas and New Mexico. It is similar to the bills he sought to have Congress pass in previous sessions but which Delegate Andrews defeated.

The secretary of the treasury sent a communication to the House transmitting estimates of the secretary of the interior, increasing the salaries of the governors of New Mexico and Arizona to \$6,000 a year, an increase of \$3,000.

JUDGE NEIL REFUSES TO RECEIVE PETITION.

Protests Against the Manner in Which Trial of Coopers for Carmack Murder Was Conducted.

Nashville, Tenn., Dec. 13.—A petition asking that the Davidson county criminal court declare illegal and void the proceedings by which the case against Robin Cooper on the charges of the murder of Senator Edward Carmack was dismissed, was presented this morning by all attorneys who represented the state in the trial in which Cooper and his father Duncan Cooper were acquitted and by Sam C. Carmack brother of Senator Carmack. It charges that the effort to acquit the defendants was a fraud upon the state. Judge Neil refused to allow the petition to be filed. The next move will be to take the case before the supreme court on a writ of certiorari.

BROWNSVILLE BRIDGE OPENED TO TRAFFIC.

Historic Ferry Boat Over Rio Grande Will Be Discontinued on New Year's Day.

Brownsville, Texas, Dec. 13.—The international railroad bridge connecting Brownsville and Matamoros, Mexico, was formally announced open to traffic yesterday. The bridge has been used for the transportation of freight for several months but for some reason was closed to pedestrians and vehicles. The ferry boat which has been in operation between the two cities for half a century will be discontinued with New Year.

CHIEF JUSTICE WHITE DID NOT TAKE OATH.

Wishes to Pay Delicate Compliment to Judge Harlan By Permitting Him to Preside.

Washington, Dec. 13.—To the disappointment of the gathering that thronged the court room Justice White did not take the oath of office today as Chief Justice of the Supreme Court. It is believed to be Justice White's intention to pay Justice Harlan the senior member of the court a delicate compliment by permitting him to preside over the court, possibly until after the holiday recess.

ROYAL ARCH MASONS ELECT OFFICERS.

FIVE TREES FOR EVERY ONE

Reforestation to Be Pushed With Might and Main by Government

ELIMINATIONS ARE COMPLETED

Further Additions to Reserves Are Not Contemplated for Present.

Washington, Dec. 13.—As many trees will be planted under the direction of the Forest Service on the National Forests of the country during the present fiscal year as were set out during the last five years combined, according to Associate Forester Potter. This is the beginning of a plan to increase as much as possible each year the number set out. Eliminations and additions to forest reserves are practically completed and now it is possible to form some idea of the permanent boundaries of the forest reserves.

FIRST ATTACK ON TARIFF

Senator Cummins Favors Revision of One Schedule at a Time

ALDRICH AND LODGE AGREE

Heyburn, However, Having Protection of Wool in Mind, Begs to Differ.

Washington, Dec. 13.—Contending that the present tariff law imposes excessive duties and that the country at large demands its amendment, Senator Cummins of Iowa today delivered a speech in the senate in the advocacy of his resolution limiting the power of amendment of bills dealing with separate schedules of the tariff law. The speech was the first attack of the session on the Payne-Aldrich law, and it received careful attention. Mr. Cummins declared that under existing parliamentary usage of the House and Senate, the amendment of the tariff law is out of question, and he contended that the first step to be taken was the modification of the rules to render it possible to amend the tariff section by section. "During the recent political struggle," said Mr. Cummins, "I did not hear a single utterance by a Republican that did not admit that the law contains duties that ought to be changed, and it is the duty of Congress to especially act speedily, to put wool on the free list." Mr. Aldrich and Mr. Lodge agreed with Mr. Cummins that it is desirable to take up the tariff by subjects, and not by schedules. Mr. Heyburn disagreed.

GIRLS RESCUED FROM ROOF OF BUILDING.

Fed in Scanty Clothing From Drill in Physical Culture Class in Chicago Structure.

Chicago, Dec. 13.—Fifty screaming hysterical girls, attired in gymnasium clothes, were rescued from the roof of a burning building at 311 to 313 Wabash Avenue today by firemen. The girls were engaged in a gymnasium drill in the school of Physical Culture when the fire broke out. When the smoke began pouring into the hall, the girls feared to descend to the street and the instructor, giving them no time to put on their clothing, marshalled them to the roof. From the roof the frightened girls were carried down the fire escapes. None was injured, but there was some talk scamping for the neighboring office buildings, where the girls hid themselves from the smiles and stares of thousands of spectators and where they were supplied with more complete costumes. Besides the physical culturists, forty girl employees of desk and carpet companies occupying the building were assisted down the fire escapes. The fire damage was \$100,000.

OBJECTIONS TO APPOINTMENT OF NEGRO LAWYER.

Attorney General Wickersham Besieged By Both Sides to the Color Controversy.

Washington, Dec. 13.—Objections to the proposed appointment as Assistant Attorney General of William B. Lewis, a negro lawyer of Boston, and famous in the annals of football as a center rush at Harvard years ago, are being presented to Attorney General Wickersham. On the other hand, Booker Washington today to urge his approval of the appointment.

THIRTY DAYS IN JAIL FOR CONTEMPT.

Government's Star Witness in Brick Trust Trial Sentenced By Judge Landis.

Chicago, Dec. 13.—Mrs. Aileen Christopher, the government's star witness in the prosecution of the Brick Trust, today was sentenced to thirty days in jail for contempt of court for refusal to produce certain information before the federal grand jury. Her attorney, John A. Harper, was sentenced to seventy days for his part in the same refusal.

OXFORD DEFEATS CAMBRIDGE AT FOOTBALL BY 23 TO 18.

London, Dec. 13.—Oxford University defeated Cambridge by a score of 23 to 18 in the annual Rugby football match today.

WOMEN AND CHILDREN CRYING

Rumor of Battle Between Rebels and Federals at Pedernales

FIRING WAS PLAINLY HEARD

Chihuahua Is Uneasy Over the Report That Battle Is in Progress

El Paso, Dec. 13.—Passengers arriving this morning from Mexico declare that Chihuahua City was full of reports last night that a fight is taking place between the rebels and regulars at Pedernales. Reports brought to Chihuahua by a passenger from Madera, say that the firing could be heard as the train passed through Pedernales and that women and children were crying in the streets.

Texas Rangers to Watch Boundary.

El Paso, Dec. 13.—Chaplain Hughes commanding the Texas Rangers at Ysleta in this county, received a telegram this morning from the adjutant general of the state to report at once with all his men to the sheriff of Presidio county at Marfa. Presidio county extends to the Mexican line at Ojinaga in the region of which on the Mexican side of the revolutionists have been active lately.

SIX PRISONERS KILL THEMSELVES.

As Protests Against Barbaric Treatment of Russian Officials—Three Cut Their Throats.

St. Petersburg, Dec. 13.—The report that M. Sasonoff, who in 1904 assassinated Minister of the Interior Von Plehve, had died in prison at Zaratul is officially confirmed today. His death is attributed to suicide. Recently rumors that Sasonoff was fatally injured by flogging were in circulation. According to the Governor of the prison, the officers discovered a plot to release the political prisoners en masse. All communication of the prisoners with outer world was stopped and corporal punishment was ordered for two prisoners. As a protest against these measures, three prisoners severed their arteries at the wrists and three others including Sasonoff took fatal doses of morphine.

JACK JOHNSON WILL FIGHT IN FRANCE.

Agrees to Meet Winner of Langford Jeannette Bout if Purse of \$25,000 Put Up.

Chicago, Dec. 13.—Champion Jack Johnson agreed last night to meet the winner of the Langford-Jeannette fight scheduled to occur in Paris in February, in a 25 round bout to take place in France next April for a purse of \$25,000 provided the money be posted in America and an American is the referee. "I don't want any lemons handed me," said Johnson. "If they don't come across with my two conditions nothing is doing."

TWO MORE PLAQUES FOR PACIFIC COAST.

Immigrants From Far East Are Suffering From Hook Worm and Elephantiasis.

Washington, Dec. 13.—The hook worm has been discovered in Chinese, Hindu and other immigrants from the far east arriving on the Pacific coast. The Public Health and Marine Hospital Services regard the situation as critical. Rigid inspection has been established at San Francisco and other Pacific ports. Elephantiasis also has been discovered among Chinese immigrants.

ROOSEVELT TO MAKE SPEECH

It Is to Be a Corker According to Popular Anticipation

SUBJECT IS NOT ANNOUNCED

Distinguished Orator Will Talk as Spirit Happens to Move Him.

New Haven, Conn., Dec. 13.—The address here this evening of Colonel Roosevelt, who will be the guest and the only speaker at the banquet at the Chamber of Commerce at the Yale dining hall, promises to rank among the notable occasions in this city. Colonel Roosevelt will select his own subject and as he stated in a letter just received, he will speak as the spirit moves. Anticipations run high that he will deal vigorously with recent happenings in politics and national affairs.

INDUSTRIAL SCHOOL A CRYING NEED

Poor Boys and Girls Must Be Taught to Make a Living

NINE TENTHS QUIT SCHOOL

Before Seventh Grade, Says M. Friedman, Head of the Carlisle School.

"The crying need of this country today is the industrial school, to train boys and girls to make a living, and not to give them the foundation to fit them to enter a University which they will never see," declared M. Friedman, superintendent of the Carlisle Indian School at Carlisle, Pa., the largest in the world for it has 1,050 students. Mr. Friedman accompanied by Mrs. Friedman are on their way to the coast and he was interviewed at breakfast at the Montezuma hotel this morning.

Mr. Friedman became superintendent of Carlisle in 1907 and he is what Americans call a hustler. He looks it. Without an ounce of superciliousness, with clear eyes and a firm chin he shows poise, power and understanding. He has enjoyed the advantages of a brilliant education. Born in Cincinnati he attended the schools there and went through the technical course at the University of Cincinnati, graduating with high honors. Later he went to the University of California. He had twelve years industrial training during which time he studied closely the statistics to see just what need there is of industrial schools in this country. He spent three years as head of the industrial school at Phoenix; then three years as a teacher in the Philippine Islands, and then two years at Haskell Institute, Lawrence, Kansas.

If there is any man who knows industrial school work, Mr. Friedman ought to.

Ninety Per Cent Quit.

Mr. Friedman said, "I find from statistics that are thoroughly reliable that nine-tenths of the pupils who go to public schools quit schooling before they reach the seventh grade. What are these schools for? Judging by their present curricula? Why to prepare the young to enter the university. But nine-tenths never enter the university; they never even see the eighth grade of the school. They are then thrown out on the world to make their own living, to support themselves and their families perhaps, are they equipped for this great burden, this tremendous responsibility? I should say not. What can they do? What have they learned of the practical that has a monetary weight?"

"And yet we know by statistics again, that 72 per cent of the wage earners of the land earn their living by their hands. Here is where the industrial school steps into the breach and takes the pupil at an early age and gives him manual training, gives him a knowledge that shall put money in his purse."

"Even two hours a day taken from the study of the classics and mathematics and put at manual training is well spent and we find that it even brightens the pupil for his other work, serving as a kind of relaxation, throwing work on the muscles and taking it off the eyes, the mind. More and more it has become recognized that some kind of manual training is invaluable to every one but to the poor boy who will never get the education to fit him for a profession it is indispensable. The manual training of the hour in these United States is not in the entire world, but especially in this country which is filling up so rapidly. Is it any wonder then that the boy or girl thrown out into the world has a hard time to make a living? But when he is taught useful trades he will be able to face the wolf at the door and do it by solid work for which there will be a market."

THE BOSTON WOOL MARKET IS VERY DULL.

French Worsteds Spinners Are Heaviest Buyers and Foreign Product Is Moving.

Boston, Dec. 13.—The local wool merchants say that the reasonable dullness of the market is greater than for several years. The volume of sales is exceedingly small, although prices hold firm. The principal business is in territory and scoured wools. French worsteds spinners are the heaviest buyers. A quantity of Idaho in original bags has changed hands at 18 while ordinary fine and fine mediums sells at 65 to 56 cents clean. Puled wool is dull but some interest is shown in foreign products.

UNIVERSITY OF MINNESOTA CHOOSES NEW PRESIDENT.

Dr. George Edgar Vincent, Son of Famous Chautauqua Founder, Receives the Honor.

Minneapolis, Minn., Nov. 13.—Dr. George Edgar Vincent, dean of the faculty of arts, literature and science at the University of Chicago today was chosen president of the University of Minnesota, to succeed Dr. Cyrus Northrup resigned. The new president is a son of Bishop John Vincent, founder of the Chautauqua institution and is 46 years of age.

STUBBS ATTACKS THE RAILROAD

Declares They Have Combined to Rob the People of Millions

FAVORS AN INCOME TAX LAW

He Opposes the Appointment or Election of Judges for Life.

Chicago, Dec. 13.—Governor W. R. Stubbs, of Kansas, made a sensational attack upon railroads and trusts, at a banquet of the Illinois Manufacturers Association last night. He declared that "the advanced freight rates demanded by the railroads, were agreed to by the combined railroads and are therefore clearly in violation of the Sherman anti-trust law," and were unjustifiable.

The speaker condemned the judge who fines corporations for violations of law and "discharges the officers who get the money and are the real criminals in the case." He asserted that "the relation of the federal government to unlawful commercial institutions organized for spoils and plunder is one of the most humiliating and disgraceful chapters in American history." Governor Stubbs said in part:

"It is common on occasions of this character to sugar-coat words and round out sentences to please the audience. The question of entertainment is not a matter of deep concern to me at this time. It is my purpose and hope to present in a plain, businesslike way facts and conditions that may be worthy of your careful consideration and serious consideration."

"In the evolution of government, every generation has its own responsibilities to bear, its own work to do, its own problems to solve, its own battles to fight. This generation must meet the problems of today like men who are conscious of their power and ability to meet every emergency, and determine every question of government in a broad, liberal spirit for the benefit, and in the interest of a majority of our citizens."

"Let us have the courage to tell the exact truth, about unwholesome commercial conditions that have grown up during the last score of years. Anything short of a plain, accurate statement of facts concerning the iron grip which monopolies, trusts and illegal combinations now hold on the commerce of our country, means either moral prostitution or personal cowardice."

"Every student of public affairs and every public official charged with the enforcement of law, knows that the alliance between professional politicians, corporation lawyers and the financial and commercial interests which are concerned in shaping state and federal legislation to serve their own special interests, is a menace to the welfare and life of our republic."

"It is well known for instance that within reasonable limits the packing house trust exercises arbitrary power to fix the purchase price of cattle, hogs and other livestock, and determine with accuracy the amount of profit which they will take as their share of the transaction. It is well known that the packing house trust was formed and is being operated in open and flagrant violation of moral and statutory laws."

The speaker said that the methods employed by the giant masters of finance who have destroyed the natural laws of supply and demand throughout the nation are in open and flagrant violation of the Sherman anti-trust laws, the plain provisions of our federal constitution, the common laws of our land, and all moral obligations imposed upon respectable citizens."

"In this connection, the transportation question is perhaps the most important issue before the American people today. The Wall street financiers, through a 'community of interest' scheme have by indirect methods formed what practically amounts to a gigantic railroad trust, which controls the rates and policies of the most important railroad systems in the United States."

"There is a well established principle of law which prohibits a man from forbidding that which the law forbids him to do directly. If penalties are provided by law for doing an act, the same penalties should attach when that act is accomplished by indirect means."

"The Northern Securities Company, which was organized to consolidate the Great Northern, Northern Pacific and Burlington railways, all competing lines, was declared illegal by the federal supreme court. James J. Hill, J. Pierpont Morgan and their associates proved themselves to be above the law and higher than the courts by proceeding immediately to destroy competition in railroad rates throughout the northwestern states by indirectly doing what the supreme court had decided was unlawful for the Northern Securities Company to do."

"The railroad is a government agency, and is therefore, supposed to be subject to law. It is a creature of government, but the creature has grown to such proportions of wealth and political power that provisions of law and decrees of courts have proven

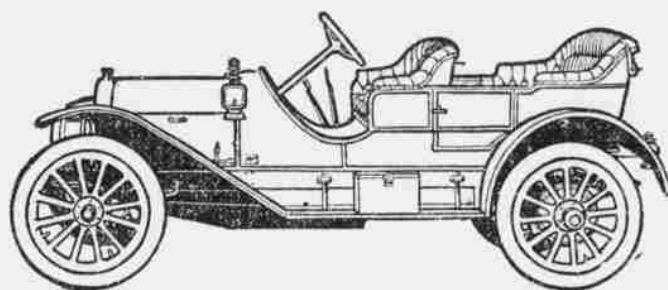

STUBBS ATTACK THE RAILROAD.

(Continued From Page One.)

ineffective in so far as they were in-
tended to exercise direct control over
the operation of these commercial
giants.

"In 1898 the dividends paid by the
railroads of the United States amount-
ed to ninety-seven million dollars. In
1908 these dividends amounted to
three hundred and eighty-six million
dollars, an increase of four hundred
per cent in ten years.

"In 1909 the railroads earned ninety-
three million dollars more net reve-
nue than they did in 1908, and for the
first five months of 1910 have earned
thirty-three million dollars more net
revenue than they did in the five cor-
responding months of the previous
year."

"These figures prove that there is
no reasonable basis upon which the
railroads can demand an advance in
freight rates. Upon the contrary,
they prove conclusively that railroad
rates are already too high. And yet,
practically all the railroads in the
United States have formed a gigantic
combination to increase freight rates,
which the shippers who have investi-
gated the matter claim will ultimate-
ly enormously increase the cost of
freight transportation.

"The advanced freight rates de-
manded by the railroads, and now
being considered by the Interstate
Commerce Commission were agreed to
by the combined railroads of the
United States, and are, therefore,
clearly in violation of the Sherman
anti-trust law. I submit to you, gen-
tlemen, the proposition that it is un-
wise and contrary to sound public
policy for the federal government to
permit these railroads openly and
flagrantly to violate the anti-trust law
by combining for the purpose of ad-
vancing freight rates, and through
their unlawful acts enormously to in-
crease the cost of transportation to
the American people. If the railroads
are thus permitted to violate the
federal laws with impunity, in broad
daylight, and thereby increase their
profits millions of dollars per annum,
what incentive has any citizen to re-
spect the law, when he can increase
his income by breaking it?"

"The amount of tax money collect-
ed by the British Empire from the
American colonists, without represen-
tation, probably would not amount to
one per cent of the tribute and ex-
tortion which the consuming Ameri-
can public are now compelled to pay
to illegal combinations, trusts and
monopolies every year. The honor,
manhood and moral character of our
republic are involved in the relation
of the federal government to this
monstrous condition, which offends
every sense of justice, decency and
morality.

"We have passed beyond the stage
where self-respecting public officials
can barter and dicker and compro-
mise with law breakers, rich or poor,
high or low, great or small, on the
theory that the rigid enforcement of

law, without fear or favor, will in-
jure business.

"The relation of the federal govern-
ment to these unlawful commercial
institutions organized for purposes
of spoils and plunder is one of the
most humiliating and disgraceful
chapters in American history. The
plain duty and task set for this gen-
eration is to establish once and for-
ever the supremacy of law and its
power to control organized corpora-
tions, firms or individuals who direct-
ly or indirectly form combinations in
restraint of trade, and thereby de-
stroy free competition and equal
opportunity in the commerce of the na-
tion.

"The Sherman anti-trust law pro-
vides that a combination in restraint
of trade is a crime punishable by fine
or imprisonment or both. The judge
on the bench who insists on holding
the corporation responsible for viola-
tion of law, and, not being able to
send the corporation to prison, assess-
es a fine against it as punishment for
robbing the public of thousands of
millions of dollars, through illegal
combinations in restraint of trade,
and discharges the officers who get
the money and are the real criminals
in the case, is wholly unfit to occupy
so responsible a public office.

"I do not in any sense share the
opinion sometimes expressed that the
official acts of a judge are too sacred
to be criticised. No citizen of this
republic occupies a more honorable
or desirable position than a just judge
who honors his office. But there is no
more disreputable citizen than the un-
just judge who brings discredit and

disgrace to the office that should be
held sacred and used solely for the
purpose of meting out justice to all
kinds and classes of persons.

"A judge belonging to the last
named class is and ought to be a
proper subject for public criticism,
and he ought to be publicly branded,
so that he could be forever after iden-
tified."

Governor Stubbs strongly opposed
appointment of or election of judges
for a life term; urged an income tax
law; a mandatory law providing a
prison sentence for persons or officers
of corporations who are responsible
for unlawful combinations in restraint
of trade and also providing a receiver
shall operate such corporations un-
til assurance is given they will obey
the law. "When Congress enacts
these laws and they are rigidly en-
forced, extortion, injustice and com-
mercial cruelty of monopolies will be
placed on the same basis as other
crimes and will be no more respect-
able in the community," said Gov-
ernor Stubbs.

The speaker favored the develop-
ment of the Mississippi, Missouri and
Ohio rivers, and declared that "the
American people are being robbed ev-
ery year of enough money by unlaw-
ful combinations, trusts and mono-
lies to build this entire work."

The New Mexican is the oldest newspaper in New Mexico. It is sent to every postoffice in the Territory, and has a large and growing circulation among the intelligent and progressive people of the Southwest.

THE BOUNDARY DISPUTE.

The contention that any boundary dispute with Texas will delay statehood for New Mexico is positively silly. The description of the boundary in the New Mexico constitution follows the description in the Organic Act and no one has as yet ventured to assert that this description in the Organic Act has interfered with the territorial form of government. New Mexico could not have adopted any other description in the constitution. The boundary has been fixed by treaty, by Congressional act, by official surveys, as well as by Texas, on the 103d meridian. Whatever dispute there is over the location of the 103d meridian must be settled by official survey, and neither the constitution of New Mexico nor the Organic Act fixes its location. If the Clark survey fixed it, well and good, if the Clark survey did not locate it, then it will take a new survey by the United States and its acceptance by Texas and New Mexico to settle the boundary question. Even if the Clark survey is accepted, it will have to be relocated for most of the monuments have disappeared and Congressmen Stephens of Texas, has for many years, tried to get this survey located so that it would add portions of Eddy, Chaves, Roosevelt and Quay counties to the Lone Star state. It was beyond the power of the constitutional convention to settle that controversy, it could only state the boundaries as they were given in the Organic Act. All this has nothing to do with the admission of New Mexico as a state, except that this is an opportune time to survey the 103d meridian and mark it with proper monuments. If Texas and President Taft insist upon locating it three miles west of the true meridian, it is up to them for they have the power and New Mexico will have to acquiesce as it has acquiesced in so many other wrongs which it was powerless to oppose.

The fact that Texas was forced to accept the Clark survey for its boundary between Oklahoma, has no bearing on the New Mexico boundary, for the Clark survey in the instance now cited by Texas, was a correct survey and had nothing to do with the 103d meridian, which he surveyed indirectly, or as a matter of fact, did not survey at all except for a short distance. If President Taft said that the equity lies with Texas, he merely meant to say that Texas has had possession for sixty years, of the area between the true 103d meridian and New Mexico's present eastern boundary, that it should stay there by reason of limitation, but Texas itself, by its constant agitation of the boundary dispute, has negated the strongest argument that can be urged in its favor. But be that as it may, there is nothing in the constitution of New Mexico that need be changed, or could well be changed, for the constitution merely describes the boundaries as they are laid down in the Organic Act and have been acknowledged by treaty and officially in Washington as well as at Austin, Texas.

Even in Bernalillo county, H. B. Ferguson was unable to secure a delegation to the convention in this city, that would solidly oppose the constitution. With friends of the constitution, like Colonel J. G. Albright, on the delegation, there need be no fear that all the Democratic leaders will bow down to the one man who acknowledged that he had been retarded by a railroad and admitted other accusations that demonstrated him to be more human than god-like after all.

FINISH THE ROAD TO ALBUQUERQUE.
Now that Bernalillo county is willing to do its share toward completing El Camino Real between Santa Fe and Albuquerque, no time should be lost by the Good Roads Commission to complete the highway south of La Bajada and Algodones. The heaviest and costliest part of the road has been built but to be of the greatest use it should be completed to the Duke City. With one force working on the road from Algodones to Albuquerque and the other from Glorieta to Las Vegas, and a third camp on the scenic highway in the Santa Fe canyon, there is no adequate reason why by next summer there should not be completed a superb highway from Albuquerque to the Pecos and to Las Vegas via Santa Fe. The Good Roads Commission has at its command the necessary funds, it has gathered considerable experience and can build roads better and quicker than any other agency in the southwest. With the commission directing the work and each county helping financially, the Mills administration before it gives way to the state government, may have built for the people a monument useful as well as permanent, in completing El Camino Real and the scenic highway linking together the three largest cities of the Territory.

With Democratic papers like the New Mexican Democrat, the Roswell Daily Record, the Carlsbad Current, the Clovis Journal, the Silver City Independent, Knowles News, Rock Island Enterprise, and with leaders like O. A. Larrazole, W. B. Walton, W. S.

hand, declares that the vacant lands of the Territory are worth so much more than the minimum of \$3 to \$5 an acre fixed in the Enabling Act that the bad, bad Republicans of the Territory with the aid of some bad Democrats, have fixed the constitution that it will enable them to gobble up all the public lands at that minimum price. These two statements do not agree but then the New Mexican has referred to Democratic consistency before this.

THE FEVER IS GOING DOWN.

The initiative and referendum fever in Oregon is going down. But a few more years, and the patient will have regained his normal health. However, his neighbors who have been infected and who are infecting others, may also have a siege of the disease, some more, others less. New Mexico has thus far escaped it but there are symptoms of the virus having entered the system. Says the Arizona Republican:

"A study of the Oregon election returns is encouraging to those of us who have an abiding faith in the ultimate good sense of the people."

"At the November election the people of Oregon were called upon to vote for or against more than three dozen propositions proposing various amendments to the constitution, and numerous laws, started under the initiative system. Most of these propositions were rejected, chiefly, the Oregon papers explain, because the voters could not study the merits of these measures in the election booth and for safety voted no."

"But one proposition, at least, offered no opportunity for mistake as to its meaning, and its defeat by a decisive majority, furnishes unmistakable evidence that the Oregon voters are growing tired of the 'direct legislation' fad. This proposition, put forth and pressed by U'Ren, the man most responsible for the 'Oregon plan,' was one 'to increase the initiative, referendum and recall powers of the people.' The title of the proposition clearly showed its meaning, and the people would not have it. They have given proof of their belief that plenty of a thing is sufficient. It is not a wild prophecy to say that in all probability before another ten years have passed the voters of Oregon will have either repealed their constitutional provisions of direct legislation or will have made them obsolete by neglecting to use them. Fanaticism always runs its course in time, although the time may be comparatively long."

"And so, while Oregon is recovering from her craze and Arizona is still in the first stages, there is every reason to expect that Arizona will turn to the proved principles of American government in time and be glad to forget the year 1910 for the people of this territory are equal to the best people in the world."

Democratic Congressman Stephens of Texas, who in the past has proved himself an inveterate hater of New Mexico has introduced a joint resolution in Congress providing for a boundary commission to settle the boundary dispute between Texas and New Mexico, following in its provisions the bills he repeatedly introduced in the past but which were defeated by the watchfulness of Delegate to Congress Andrews. This proposed commission is to have represented on it Texas and the United States but not New Mexico, the party most interested, and is otherwise unfair in its provisions. Let us have a boundary commission, but one upon which all parties interested are represented and under instructions to be fair in every respect.

All the railroads of the country, the past year, averaged less than six per cent dividends. That is small enough return on an investment which in many instances is precarious. How many people, right here in Santa Fe, are satisfied with a return of less than six per cent on their money? Who is there in New Mexico who would place money for investment in other hands for uncertain returns of five or six per cent a year? It is because the railroad companies have been harassed by demagogues and by government agencies the past few years, that no new railroads are being built in New Mexico, that the day of railroad improvements has passed, that people are fighting shy of railroad stocks and bonds, and that American railroads are vainly begging European investors to take gold bonds at par. The address by Governor Stubbs, therefore, on another page, must be taken with more than one grain of salt.

Bully for the Bernalillo county Democrats! They have adopted the following resolution despite the harrowing protests of H. B. Ferguson:

"Whereas, it seems advisable, particularly from the standpoint of all the parties, as such, that the voting on the constitution should not be made a party question.

"Therefore, be it resolved, That it is the sense of the Democratic party of the county of Bernalillo that all the voters in the Territory of New Mexico, no matter to what party they have heretofore belonged, shall be at liberty to vote without involving the question of party fealty, for or against the adoption of the said constitution as each one may individually feel himself determine."

It is rather strange that after expressing such fervor for the initiative and referendum, that the Democrats will hold a convention for the avowed purpose of bidding the voters to oppose the constitution. Are not the Democratic voters of sufficient intelligence to judge for themselves? Why a convention, instead of the initiative?

Oklahoma is even dryer than eastern New Mexico for reports have it that trains with water tanks are being run in that state to various towns on passenger schedule to keep the people and stock from dying of thirst.

WESTERN UNION'S SPECIAL OCEAN MAIL SERVICE.

The Western Union Telegraph Company announced today another innovation in telegraph service called the "Special Ocean Mail Service" designed to save time in foreign correspondence. A letter from San Francisco to London requires as much time crossing the continent as it does crossing the ocean. A New York merchant writing to Yokohama must post his letter practically a week before the mail steamer sails from San Francisco or Vancouver. The Western Union

has arranged for the use of its night letter and other telegraphic service in connection with outgoing mails so that this week of transcontinental time may be saved. Its New York office will receive telegrams from any part of the country destined to European addresses and will forward them in a sealed specially addressed envelope by the first outgoing Atlantic steamship mail. The same plan will be followed in San Francisco, Seattle and Vancouver for trans-Pacific mails. This will enable correspondence to be dispatched from any part of the United States for an ocean mail within a few hours of sailing time.

The only charge in addition to the usual telegraph tolls to the ocean mail will be five cents for postage. Telegrams should bear the full mail address of the foreign correspondent for whom they are intended and marked "Care Ocean Mail New York" or "San Francisco, Seattle or Vancouver as the case may be. No charge will be made for the address.
