THE NEW SCHOOL LAW

set intendent J. E. Clark Calls At-. on to S me of Its Provisions.

J. E. Clark, territorial superintendent of public instruction, has issued a circular letter addressed to county school superintendents and calling their attention to some of the provisions of the new school law enacted by the thirty-seventh legislative assembly. For the benefit of the teachers and school directors and all others who take an active interest in the schools, The Chieftain reproduces Superintendent Clark's letter, as follows: Dear Sirs:

It is quite unfortunate that our educational bill was made one of the very last orders of business in the recent legislative assembly. Some very unsatisactory conditions result from this fact.

A digest of school legislation if 1907 is mailed to you, and I wish to call your attention to certain points in as brief a way is possible.

You will note that Section III. dispenses with the County Board of School Examiners. The attention of District Judges and Boards of County Commissioners will be called to this point.

The County Superintendent will hold examinations at such times, places, and in such manner as may be prescribed by the Territorial Board of Education. All papers will be graded at the office of public instruction. Let me caution against being too liberal with permits. The law forbids issuing twice to the same person.

The new law requires every institute conductor and instructor to hold a certificate from the Territorial Board of Education. The County Superintendent cannot make a legal contract for stitute work with a person not holding such a certificate.

All institutes should be held late in the summer, in August. and also, that I have compared the preferably. 
W. H. Herrick, who has recently been engaged on the United States geological survey, has just returned from work at Fort Bayard and will be at home for a few days.


