## ATLANTIC CITY.

### Almost Wiped Out by Fire.

### The Famous Board Walk Suffers.

### Eight Hotels and Many Other Buildings Were Destroyed.

LOSS IS \$2,000,000.

Atlantic City, April 3.—Fire broke out this morning in the Tarleton hotel at Illinois avenue and The Board Walk. A south wind is prevailing and the flames have communicated to the Luray hotel, which is adjoining on the north, and this is now burning. Hotels are crowded close together at this point and as nearly all are wooden structures a great conflagration is feared. Atlantic City has called upon the Philadelphia fire department for help and three engines left for the scene of the fire at 11 o'clock on a special train. So far as known no request has been made of the Camden, N. J., department for assistance.

At 11:55 a. m. the Tarleton hotel had been completely destroyed, and the Windsor, Luray, Berkeley and Stratford hotels are now burning. The wind is high, making the work of fighting the flames most difficult.

The fire is reported to have started in Brady's bath houses on The Board Walk near Illinois avenue. In a few minutes it communicated to Smith's photograph gallery and the two small shops adjoining. Within twenty minutes all these flimsy structures had been destroyed and the Tarleton hotel was in flames. The wind drove the blaze toward the Windsor and Luray hotels, and these too, were soon a mass of flames. The Stratford hotel, at the corner of Kentucky avenue and The Board Walk, one block north of the Tarleton hotel, also caught fire. These three buildings, it is feared, will be a total loss. The Hotel Berkeley, adjoining the Stratford, caught fire and was soon burning fiercely.

The Board Walk is crowded with thousands of spectators. All hotels on Kentucky and Illinois avenues adjoining those on fire, have been emptied of their guests and furniture, in expectation that they, too, will be burned.

At noon the fire is still raging, having spread to the block north of that in which it originated. Young's Pier is ablaze and will be a total loss. Fanned by high wind the flames are rapidly spreading eastward along the beach and the local fire department is unable to cope with them. Marine Hall, on Young's ocean pier, is on fire and it looks as though the entire pier will be destroyed, as no line of hose can reach that point. Fralinger's fine Academy of Music is on fire and doomed. Fralinger's drug store, Partridge & Richardson's notion store, Woolworth's 5 and 10-cent store, Berry Bros', art store, and Moore Bros', art store, all on The Board Walk, between New York and Kentucky avenues, are burned out. Hotel Bryn Mawr, Hotel Rio Grande and Hotel Mervine, adjoining the Academy of Music, are afire and likely to be burned to the ground. The Board Walk has now been destroyed between New York and Illinois avenues, as well as a half dozen cottages in Westminister avenue, at the rear of Hotel Berkeley, which has been totally destroyed. The loss at the present writing is estimated at \$2,000,000.

Eight hotels are entirely or partially destroyed in the fire besides many other buildings. The wind is blowing in a direction to carry the flames away from the most valuable hotels and cottages. It is reported six men are burned to death, as two policemen, two firemen and two musicians are said to be in the ruins of the Berkeley hotel. The hotels destroyed are the Windsor, Berkeley, Stratford, Stickney, Luray, Tarleton and Eward.

2:20 p. m.—The fire is now under control, the firemen having checked it at New York avenue. The estimated loss is \$2,000,000.

### Beyond Control.

Philadelphia, April 3.—At noon the chief of the Atlantic City fire department notified the electrical bureau of this city the fire was beyond control.

### TIED THE KNOT.

### The City Building Was Enlivened by a Wedding.

Last evening at 8 o'clock there was a wedding at the city building in which Judge Crawford tied the knot in his happiest manner. The bride was Miss Salda Sanchez and the groom was Bartolo Baca. Both are employed at the scouring mill. After the wedding they went on a tour to old town where a big reception was given them.

### Socorro In Line.

Socorro, N. M., April 3.—The democrats endorsed the candidacy of Captain M. Cooney for mayor, Robert Collins for city clerk, and Richard Abeytia for city treasurer, and in consequence these well-known and popular republicans were unanimously elected. In the race for alderman only one republican was defeated, H. R. Har-

ris, in the First ward, who met his Waterloo at the hands of A. C. Torres, democrat. The republicans elected all of their candidates for board of education.

## STRICKEN AT THE POLLS.

### Hand That Cast a Ballot—ruck Numb by Chill of Death.

Two fatalities marked the canvass of the Fourth ward in Tuesday's election. Jesus Jose Barela cast his last vote on earth at 11 o'clock at the polls of this ward Tuesday morning. Hardly had his hand released the ticket until it was frozen in death. He lived about thirty minutes after casting his ticket which was straight republican. He leaves two small sons, their mother having died six months ago.

The second death was that of Senio Lucero. He was not well enough to walk to the polls but wanted to vote. A carriage of one of the candidates was therefore dispatched to him. On arriving the driver found he was too late for Lucero was a corpse. He had a large family of grown sons.

Both men lived in Chihuahua and both men were republicans.—Las Vegas Optic.

## Five Cars Ditched.

Utica, April 3.—The north bound passenger train on the Mohawk & Malone division of the New York Central & Hudson River road, jumped the track at Moose Lake early today, and five coaches loaded with emigrants were ditched. The train was badly wrecked and fourteen people were hurt, but none fatally.

## CHRISTMAS CRIME.

### The Crazy Indian's Bloody Deed Again Dished Up for Reading.

### SHERIFF SECRET'S NARRATIVE.

Winslow, April 1.—F. P. Secrist, sheriff of Navajo county, tells an interesting story about the tragedy and capture of Jim Scott or "Christmas," as he is sometimes called, the Indian who killed his wife and child near Clear Creek a short time ago. "Christmas" is now in the Navajo county jail at Holbrook, waiting the setting of the grand jury.

"Christmas," with wife and three children, lived in a little hut in the Clear Creek canyon district about fifteen miles north of Winslow. A little after noon on the day of the killing, Scott, after a morning of poor hunting, returned home from the mountains in a stage of savage insanity. His wife came out of the house to tell him to come to dinner, and without a word of warning the crazy man raised his rifle and fired twice. The unfortunate woman had a four months baby in her arms. The first ball pierced the abdomen and at the same time cutting the infant's leg off just above the ankle. As the woman fell forward the second shot was fired, going in at the breast and ranging downward, coming out the lower part of the back. The shooting was witnessed by the little 5-year-old girl. The boy, who is about 12 years of age, was only a short distance from the house watering horses and heard the shots fired. He returned to find mother and baby dead and father gone. The young man was old enough to realize the enormity of the deed and jumped on a horse and rode to Winslow to notify the officers of the law.

Sheriff Secrist, who happened to be in town, immediately formed a party and took up the trail. It soon grew dark and the party was compelled to return to town to wait for the daylight. The next morning, when the searching party arrived at the scene of the murder, they found the two little children sitting under a tree, where they had spent the night within a few feet of the dead mother. A brother of the murdered woman had arrived a short time before and was breaking the brush, looking for the villain.

The body was wrapped in blankets and buried in a mound near by. The grieving brother brought a pinto pony and shot it on the grave for the departed spirit to ride to the happy hunting grounds.

"Christmas," after the crime, had taken all the provisions in the house and fled to the mountains. After eight days in the woods his provisions had become exhausted and he was compelled to come to civilization by hunger. Scott for several years lived in Winslow, did washing and odd jobs around town. He was subject to having fits and for several years has been considered crazy.

### GAGE'S NEW JOB.

Washington, April 3.—The investigation of the charges in connection with the Danish West Indian negotiations was resumed today by the house special committee. Among those present when the hearing began were Abner McKinley, Colonel W. G. Brown, Carl Fisher, Hansen and Representative Gardner, of New Jersey. Mr. McKinley was the first witness. When asked whether he knew Christmas, the witness said he had met him once in a most casual way in the lobby of the Manhattan hotel in New York. He never held any conference with him of any kind or character.

"Was there any talk about the Danish West Indies," asked Mr. Dalzell.

"None, whatever, either remotely or otherwise," answered the witness.

Representative Richardson asked the witness if he knew Hansen. The witness replied he had known Hansen for some time and prior to the casual meeting with Christmas. Hansen desired to retain him in this matter. In reply the witness said he told Hansen he could have nothing to do with it.

Mr. Richardson asked if Mr. McKinley ever had any talks with the Seligman on the subject. Mr. McKinley said he never had any conversation with them on this transaction or with any one except Hansen. Representative Gardner followed with a statement disclaiming all knowledge of Christmas except of a casual character.

Colonel Brown testified he met Christmas once at the Manhattan hotel in New York. He had no conversation at that meeting except the usual interchange of courtesies.

### Denmark Denies.

Copenhagen, April 3.—An official note was issued today, formally announcing the Danish ministry had no connection with Captain Christmas. The latter applied for an audience but the premier refused to see him. The premier also refused to receive a copy of Christmas' report on the subject of negotiations for the sale of the Danish West Indies.

## LAID ON THE TABLE.

### Sample of Oleomargarine Was Presented to the Senate.

Washington, April 3.—In the presentation today of some petitions in the senate against the passage of the oleomargarine bill, Mr. Kean, of New Jersey, laid before the senate a sample of oleomargarine. The chair laid the sample of oleomargarine on the table. Consideration then at the conclusion of routine business was resumed on the oleomargarine bill. The house today resumed consideration of the senate bill to promote the efficiency of the revenue cutter service. Mr. Pammett, of Tennessee, the first speaker, opposed the measure.

The final test of the oleomargarine bill was a motion to recommit, which was lost by 35 to 37.

Washington, April 3.—The oleomargarine bill passed the senate at 5 p. m. by a vote of 39 to 31.

## STRONG WORDS USED.

### United States Judge Threatens Strikers With Life Imprisonment.

Indianapolis, Ind., April 3.—The Redwood Manufacturing company today appealed to the United States court for protection for employees against the iron moulders who have been on strike for a month past. The complaint charged that men who want to work are terrorized by the striking union men and some are afraid to come to the factory.

Judge Baker ordered the strikers, whose names are given in the complaint, to appear before him April 15 and show cause why a restraining order should not be given.

"I want you to change your bill of complaint," Judge Baker said to the plaintiff. "I want you to include a prayer for damages. It does not matter whether these men have property or not. The judge will keep them in insolvency so long as they live or until the judgment is paid. Things have come to a pretty pass when a city of Indianapolis will not give men who want work protection from men who do not want work."

## GOT A GOOD JOB.

### Ex-Secretary Gage President of Trust Company.

New York, April 3.—Lyman J. Gage, former secretary of the treasury, was today elected president of the United States Trust company, to succeed John A. Stewart, who resigned on account of ill health.

## PARTY LINE INVENTION.

### Any Bell on the Line May Be Rung.

The "Palmer-Dascomb Selective Call Bell" has been patented by Charles H. Dascomb, a conductor on the Santa Fe between Albuquerque and El Paso, and William Palmer, of Rincon. The object is to provide a means whereby one bell on a party line may be rung without ringing any of the other bells on the line. The appliance can be applied to either a telephone line or be used by a train dispatcher by placing a bell in the operator's room at different stations. In this way one man can do the work at many stations where it is now necessary to have a day and night man. There will be a great saving in telephone service as the invention permits any number of bells to be placed on the line.

## A FINE TRAIN.

### The Santa Fe Planning a Most Magnificent Passenger Train.

### KNOWN AS "CLUB TRAIN."

The Santa Fe is planning to put into service next fall the most magnificent California passenger train ever constructed, on which the fare charged will be just double the regular fare. Two full fare tickets will be required of each passenger.

This train will operate between Chicago and Los Angeles and will make only one trip a week each way. It will be known as the "club train," and only 50 passengers will be given accommodations each trip.

It has also been decided by the passenger department officials to discontinue the daily California limited after June 1 and operate it throughout the summer as a semi-weekly train. In the fall it will resume its daily schedule. The proposed new palace train will be in addition to the daily California limited.

The equipment of the new train will consist of drawing room sleepers. There will be four of these cars, one composite car, one observation car and a diner. The cars will be the finest ever built and will cost from \$30,000 to \$40,000 apiece. The total cost of the seven cars of the train will be in the neighborhood of \$250,000.

The "edition de luxe" trains is to be operated only during the tourist season and will not run to San Francisco. It is proposed to make this the fastest as well as the most elegant transcontinental train in the United States. It will be given the right of way over everything else except the fast mail and will be rushed across the country at a rate which will place the Santa Fe in the front for swift service.

The experience which the Santa Fe has had with the California limited has shown it that there is a demand for even more luxurious accommodations than is afforded by that splendid train. Parties from the east anxious to go to California to escape the rigors of eastern winter are frequently desirous for the very best accommodations, regardless of the expense. The new Santa Fe train will cater to this class of trade. The whole equipment and management of the train will be upon the same luxurious basis. It will be beyond doubt the acme of railroad accommodations. Even the private cars of the great railway magnates and of the multi-millionaires do not excel in elegance the equipment of the proposed new Santa Fe train for California.

The officials of the passenger department think that the proposed new train will prove to be a great drawing card and a money maker. They say that they anticipate making the train a tri-weekly, and possibly a daily.

## Boston Copper.

Boston, April 3.—Market in coppers has been a trifle quieter today and there was more or less realising. There appeared to be buying orders enough there to more than take care of the better class of stocks that were offered. It is believed that there is considerable short interest in some of copper. That it may be driven to cover. Exports of copper during the first three months of the year amount to over 51,000 tons, which is twice as much as was exported in the first quarter of 1901 and exceeds the banner record of 1900 by over 6,000 tons. There is a strong bullish sentiment both here and in New York, and we look for higher prices all around.

## HAS GATES LOST?

### Colorado Fuel and Iron Company.

### The Texas Anti-Trust Law Whacked.

### Peace Negotiations in Africa Still Without Definite Results.

### ALLIED PARTY MEETS.

Chicago, April 3.—The Gates syndicate has lost the Colorado Fuel & Iron company, says the Daily News. Edwin Hawley and H. E. Huntington have secured control of the valuable property. This announcement, the paper says, may be accepted as authoritative and it solves the mystery of ownership which has hung over the stock for several sessions. The Gates people were well aware on Tuesday they were no longer solvent, but did not know who held the whip hand in the organization. Today they learned that Messrs. Hawley and Huntington were the captors. It has been the general information for some time that Mr. Hawley was aware of the value of the Colorado & Southern railway is largely contingent upon the business of the fuel company, and had offered Gates and his associates an interest in that railway, of which Mr. Hawley secured control recently. It appears, however, the terms demanded by Mr. Hawley were not satisfactory and hence the negotiations were discontinued.

## Someone Is Lying.

New York, April 3.—Edward Hawley said today he had not secured control of the Colorado Fuel & Iron company, either for himself or for any associates.

## UNCONSTITUTIONAL.

### Texas Anti-Trust Law Gets Another Whack.

Houston, April 3.—The decision of the Austin court of appeals in the case of the Shippers' Compress company is important. Aside from the fact it declares the Texas anti-trust law unconstitutional, the court also says:

"One may, if able, acquire all the property of a given class, providing the purchase is not made to injure the public; and from the exercise of this privilege cannot be inferred an intention to create a monopoly."

## PEACE NEGOTIATIONS.

### Rumor That General DeWet Still Wants to Fight.

Kroonstad, Orange River Colony, April 1.—The Transvaal delegates are still here. It is believed General DeWet is influencing President Steyn not to meet Acting President Schalk-burger.

## PERMANENTLY ORGANIZED.

### Enough Delegates Present to Fill All the Offices.

Louisville, April 3.—The second day's session of the National Allied Party convention was called to order by Temporary Secretary Reiter. The convention formed a permanent organization with Milton Park, of Texas, chairman; J. L. Pierson, of New Jersey, secretary; Miles Williams, of Missouri, and L. B. Spire, of Kentucky, assistant secretaries; A. H. Staples, of Georgia, sergeant at arms. The report of the platform committee was then read.

The platform practically sustains that adopted at the Missouri People's Party convention at Kansas City last September and made the demand for the initiative and referendum the chief point at issue, holding the other principles desired will follow as a matter of course.

## AGAIN POSTPONED.

### Mrs. Walker Hearing at Las Vegas—Prosecution Not Ready.

It now appears that the preliminary hearing of Mrs. G. B. Walker for the killing of J. S. Judd will not occur tomorrow morning, but will be postponed for several days, says the Optic. April 1. It is understood that the district attorney desires a delay of ten days. Either he is very much engaged with the court or else he desires to hear definitely from the Judds. Mrs. Walker did not appear in the court room on occasion of the coronor's inquest yesterday. The judge declared her presence unnecessary as there was nothing to prove except Judd's death and the cause of it. He stated to the jury that it was not the purpose of the inquest to determine as to the right or wrong of the killing. The jury examined only three witnesses. These were Dr. Mills, Dr. Cunningham and Mr. Furlong. Their examination was conducted by Lewis Fort, of the council for Mrs. Walker. The prosecution, if there

is any, was not represented at this inquest. The doctors simply testified that Judd was dead. Mr. Furlong said: "I heard something heavy fall on the floor and immediately after, Mrs. Walker came rushing down stairs with a revolver in her hands and said, 'I've shot a man, Mr. Furlong, I've shot a man.' 'Who is the man?' I asked her, and she replied, 'Why, it's that man Judd.' I went up stairs, thinking the man might be only slightly injured, and that I might be of some assistance to him, but when I got there I saw that he was just as dead as a man could be."

Judge Wooster had anticipated the jury's verdict and had it prepared for the jurymen's signatures. It was simply that Judd came to his death from a wound made by a pistol in the hands of Mrs. Walker.

Mr. Walker, himself, is an exceedingly pleasant and agreeable gentleman with a kind disposition and altogether fine spirit. Knowing of his wife's very poor health, he had written her, only a week ago, that should she ever need his presence, to telegraph him as it requires a letter a week to reach him. While he lives on a farm, he has a telephone in his residence, and the telegram reached him immediately. He naturally supposed that she was simply very sick. The doctors have decided that her health is too delicate to ever stand another winter in the climate of Iowa. For this reason the Walkers had planned to eventually make this city their permanent home. It is to be hoped that they will not allow this very unfortunate affair to interfere with this plan.

## IMPROVEMENTS.

### Hyde Exploration Company is Developing the Navajo Land.

### NEW BUILDINGS.

Richard Wetherill, manager of the Hyde Exploration company, and J. W. Bennett, superintendent of construction, came in yesterday and last night. Mr. Wetherill left for New York. Mr. Wetherill says he has heard nothing of being deprived of his homestead in Chaco canyon and says he took it out in good faith, expecting to make it his permanent home.

The chief blanket house of the company is at Pueblo Bonito, where the most expert weavers are kept at work. There is also a warehouse with a capacity for ten car loads. At Thoreau is a blacksmith shop and a warehouse. Sixty-eight miles from Thoreau are the famous Chaco ruins, the largest in the world, and a stage has been put on between the two points. From Chaco to Farmington over 1,500 telephone poles have been scattered and the line from Chaco to Farmington is being extended to Thoreau. Big trading posts have been established at Two Gray Hills, Largo, Ho Ho Alamo, Escavada and other places. At Farmington there is a new \$14,000 brick building. The country is filling up rapidly, the water supply is abundant and the country is fertile and rich.

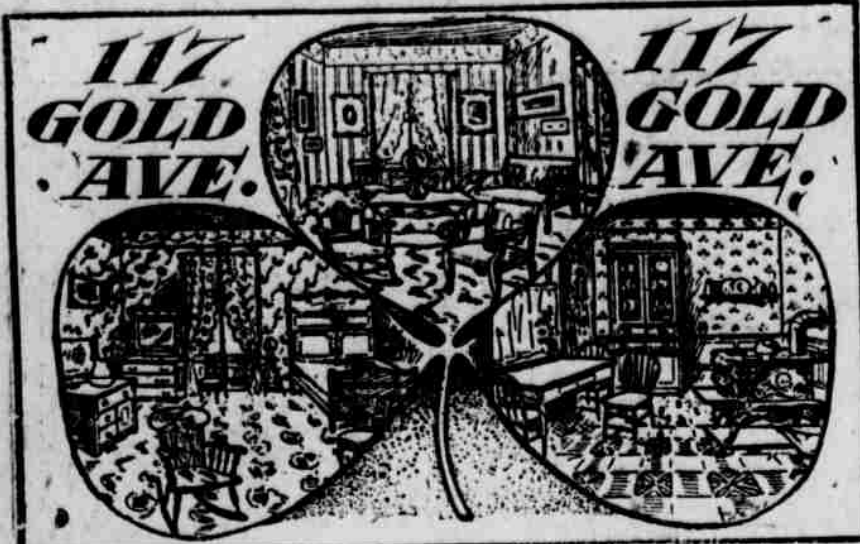

The court of private land claims convened yesterday in the court room at the federal building, Santa Fe. Chief Justice J. R. Reed presided and on the bench with him were Associate Justices Wilbur F. Stone and H. C. Sluss. Only grant survey matters came up for consideration.

**A FINE LECTURE.**

**"The Philosophic Basis of Twentieth Century Happiness" at City Library Last Night.**

In opening his address Mr. Wilson said that so far as his message was concerned he wished his hearers to understand that he spoke his own message of truth as he saw it in his own way.

"I do not speak in the interest or by the authority of any school of science and cult in metaphysics, or any church in religion. In taking this position of the utterly free soul, enjoying an original relation to the universe, seeking for the truth, and witnessing to that truth, with utter indifference to its agreement or disagreement with any authorities—in doing this—I am myself standing on the first requisite of twentieth century happiness."

"Happiness," said the speaker, "is the precipitate in human experience of an harmonious relationship to the good, which the universe eternally is. All evil is relative: All suffering is the pain in the school of experience, resulting from ignorance or objection of the truth of our being."

"There is but one supreme subject in the universe, so far as we are concerned: that is to produce perfect and happy human life. The whole universe is a dynamo for bringing this about. All nature is a conspiracy to make us complete and divine."

"And the only sane endeavor and purpose of our lives as individuals and as cities and states and nations is to work with this dynamo and conspiracy, for the betterment of every phase of human society, and for the loftiest enlightenment of every individual."

"Those to whom this goal of effort is a delight and choice may learn four great lessons from modern science and philosophy."

"1. They should learn the perfectibility of all the people."

"2. No program of social happiness—political, educational or religious, should content itself while one single human being is left out of the scope."

"3. With all the power of truth science has shown us how environment hinders or helps all forms of life. So of the life, physical, mental and spiritual, of the people. The present social and industrial environment, the competitive system, is militating against moral and spiritual unfoldment of the people, to say nothing of its effect in the physical life."

"4. But the paradox of truth appears, viz., that we can control environment. Environment transforms the criminal. Man transforms his environment."

The speaker concluded by showing how any message of life for this century must be two fold in its character: individual and social.

He will speak again tonight at the same place.

M. Myers, who passed through Topeka Monday on his way to Raton, N. M., to accept a foremanship under Master Mechanic Patterson of that place, has been with the Missouri Pacific at Cypress yards, opposite Kansas City, for about thirteen and a half years. He learned the machinists' trade there and afterward rose to the position of general foreman. He was formerly associated with Mr. Patterson at that place. Myers worked in the transportation department of the Iowa Central years ago when John Player was at the head of the mechanical branch of that road.

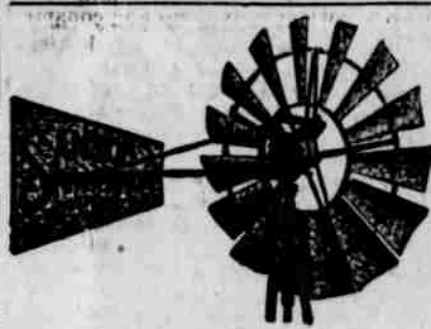

A slight wreck occurred at Rincon Tuesday night. The engine of the north bound passenger train run into engine 28, which was running light. No one was hurt.

Tuesday morning compound engines 796 and 798 double-headed south from Las Vegas to Albuquerque with a test load of 1,650 tons, 150 tons more than has ever been tried before.

The Topeka State Journal says: John Barnes, a machinist apprentice in the south shop and a son of William Barnes, formerly foreman of that department here, is talking about leaving soon for Albuquerque, N. M., to go on the Santa Fe pay roll at that place.

In an item about the big local railway shops, the Topeka State Journal says: Electricity has been installed in Albuquerque shops, the first of the large mechanical plants on the Santa Fe to use this power. Reports indicate that it is satisfactory. There was no time lost in the transfer from steam to the electrical fluid, the change being made one noon hour.

### SIX CONVICTED.

District Attorney Llewellyn Makes a Good Record.

The El Paso News says that Major W. H. Llewellyn, district attorney for the Third judicial district of New Mexico, was in that city last Monday, leaving that night for Tularosa, New Mexico, on oil business. He had just finished the work of one term of court at Silver City, N. M., where six criminals were sent to the penitentiary, the docket there being unusually light. There were two mistrials in cases of alleged cattle theft. The only case of any importance tried was that of one Portillo, who was given a life sentence for the murder of an unknown man at Pinos Altos, presumably for the purpose of robbery. Portillo took his vicum while the latter was intoxicated from a saloon and beat his brains out with a rock; and that of a woman named Sanchez, who was given three years for scalding her 12 year old daughter. She and her husband had separated and the act was presumably done to spite him.

When asked as to the chances of a prompt retrial of the Elephant Butte dam case in the event of its coming up again, the major said to a News reporter:

"I do not know anything about that; but you can say, as coming from me, that El Paso will never get that international dam as long as the restrictive clause against New Mexico remains. It has been put in again, and the bill will be fought to the last. We are not in the least opposed to the building of the international dam, but on the contrary would like to see it built, if we are free to build others of our own above it. Unless this is done the dam will never be built."

Walker Arrives on the Flyer and the Hearing is Set for That Time.

G. B. Walker arrived on the delayed flyer at 9:30 o'clock Monday morning, says the Las Vegas Optic. He was met at the depot by one of Mrs. Walker's friends and conducted over the Furlong gallery on Douglas avenue. Here for the first time he learned the nature of the trouble in which Mrs. Walker is involved. Her first telegram simply advised him to come, and her second telegram he never received. This second telegram stated that she was in serious trouble and urged him to hurry to this city. He is a farmer, and on receiving the first telegram he rode directly to Clinton, Iowa, and took the first train for Las Vegas.

Mrs. Walker's hearing was postponed from 4 o'clock Monday afternoon until 10 o'clock Wednesday morning. The sitting of the coroner's jury has also been postponed to that hour. The taking of the evidence by the coroner's jury will necessarily take some little time. Whether or not the Judds will care to bitterly prosecute the case is not known. Reports concerning this are conflicting. It is believed that her counsel postponed a hearing in the hope and belief that the Judds would not prosecute the case when they had more maturely considered it.

Mrs. Judd is said to have expressed the deepest sympathy for Mrs. Walker in the trouble in which she finds herself, and to have expressed the hope that Mrs. Walker would experience no abuse at the hands of Mr. Judd's friends.

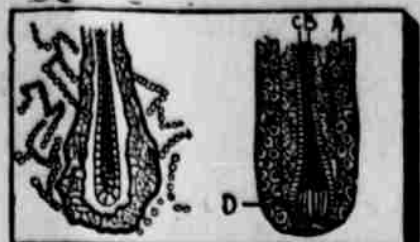
