## A CONFERENCE.

### Delegates Meet With Speaker Henderson.

### Guyer's Story of the Murder at Clayton.

### Commission Will Devise a New Postal Currency System.

### ARMY OFFICERS APPOINTED.

Special to The Citizen.  
Washington, D. C., April 2.—Chairman Knox of the house committee on territories, with Delegates Rodey, New Mexico, Smith, of Arizona, and Flynn, of Oklahoma, spent an hour today in consultation with Speaker Henderson. Mr. Knox presented the omnibus statehood bill and the report, and Speaker Henderson promised to give an early day for its consideration. He says it is a question for consideration the same as an appropriation.

### GUYER'S STORY.

His Official Report of the Murder of Searies.  
Washington, April 2.—Details of the killing of Searies by Postmaster Guyer, of Clayton, N. M., have been received by the postmaster general. In a letter written by the postmaster, he declares that Searies came into the office on March 26 about 1 o'clock in the afternoon and asked for 10 cents' worth of stamps. The postmaster was standing at the delivery window and as he reached for the stamps, Searies, he says, opened fire on him and emptied his revolver. The postmaster says he immediately picked up a revolver nearby and returned the fire with the result that Searies is dead. The postmaster declares Searies never said a word beyond asking for the stamps and he is entirely ignorant of the object of his endeavoring to kill him.

### POSTAL CURRENCY.

New Plan for Transmitting Small Amounts of Money.  
Washington, April 2.—A commission consisting of three officials each from the postoffice department and treasury department will meet here within a few days to consider the subject of the establishment of a postal currency. The plan is to provide for a small currency to take place of one and two dollar bills, which, it is believed, will provide a safer method of transmission of small amounts than through the mails, as it is intended these notes shall be payable only at the place designated thereon by the purchaser.

### ARMY OFFICERS APPOINTED.

List of Major and Brigadier Generals is Filled.  
Washington, April 2.—The president today appointed Brigadier General R. P. Hughes a major general, and Colonel Isaac D. Rusey, Colonel Andrew S. Burt and Colonel M. V. Sheridan brigadier generals in the regular army to fill existing vacancies caused by retirements.

### WHOLLY IMPRACTICABLE.

Populists Do Not Believe in Nominations By Referendum.  
Louisville, April 2.—The national populist committee which held its first session last night reconvened today at Willard hotel. Chairman Jo A. Parker presided over the meeting, which was held behind closed doors. The committee appointed last night to devise means whereby the referendum and initiative plank adopted by the populists at Cincinnati could be made practicable, reported that nominations by referendum ballot, as proposed at the Cincinnati convention, would be wholly impracticable and delegates to the convention should be governed by the wishes of the people they represented. This report was adopted. The matter of the adoption of a platform was left to the committee on resolutions.

### WAS PURELY ACCIDENTAL.

Boers Did Not Wreck Train in South Africa.  
London, April 2.—It has been suggested the train wreck near Barberton, Transvaal Colony, on March 30, resulting in the death of thirty-five soldiers and the wounding of forty-five others, nearly all of whom belonged to the Hampshire regiment, was caused by the Boers, but Lord Kitchener reports it was accidental. The train was descending a steep grade when the engine and five trucks jumped the track and turned over.

### MISS HILL MARRIED.

Brilliant Wedding of the Daughter of President Hill.  
St. Paul, April 2.—At high noon today in the family residence on Summit avenue, occurred the wedding of Miss Ruth Hill, daughter of President James J. Hill, of the Great Northern railway and Northern Securities com-

pany, and Anson McCook Beard, an attorney of New York city. Only 130 guests were invited, the bride desiring a quiet wedding. The ceremony was performed by Archbishop John Ireland, assisted by Rev. Thomas J. Gibbons, of this city, both in the full vestments of their office. The bride was attended to her place before the clergyman by her father, who presented her to the groom. She was assisted by her sister, Miss Rachel Hill, as bridesmaid, while Eric Dahlgren was best man for the groom. An informal reception followed the ceremony. Mr. and Mrs. Beard will reside in New York city.

### BACKING WATER.

Iowa House Don't Know About the Assessment Bill.  
Des Moines, Iowa, April 2.—By a unanimous vote the house this morning reconsidered its action of yesterday in passing the railway assessment bill introduced by Mr. Larrabee at the direction of Governor Cummins. The senate has not yet granted the request to return the bill, and it is possible it will pass the bill as it originally came from the house.

### THE GREATEST YET.

Over Five Hundred Entries in a Live Bird Match.  
Kansas City, April 2.—The Grand American handicap is the feature of the Interstate association's tenth annual tournament which is being shot at Blue River Park today. There were close to 550 entries from all over the country for this Blue Ribbon event when the shooting began this morning which stamps it as one of the greatest live bird races ever held. So large is the list of entries, it is believed it will take the rest of the week to shoot it out.

### HAS NO REGRETS.

William Lane Says His Victims Deserved To Die.  
Philadelphia, April 2.—William Lane, the negro, who yesterday murdered Mrs. Ella J. Furbush, her daughter, Madeline, and fatally shot Eloise, another daughter, was held today to await the action of the coroner. He expressed no regret for his crime. When asked what caused him to kill the woman and child, he said: "They deserved to die." At the hospital today it was said there was little hope for the recovery of Eloise.

### BLOCKADE LIFTED.

Great Northern Finally Gets Its Overland Train Through.  
St. Paul, April 2.—The Great Northern lifted its blockade early today, bringing in its overland train from the Pacific coast in three sections. It is expected traffic will be resumed on the old schedules during the day. The Northern Pacific's blockade from floods was nearly as long as from the recent snow. The interruption of traffic was the longest the system ever sustained.

### CONCESSION OFFERED.

Des Moines City Railway Offers a Three-cent Fare.  
Des Moines, Iowa, April 2.—The Des Moines City Railway has voluntarily proposed to the city council to sell eight tickets for a quarter, acceptable from 8 to 7 p. m. and 6 to 7 p. m. If any other street railway company is granted a franchise the fare is to be restored to the 5-cent basis.

Twenty-eight Suspended.  
Lawrence, Kan., April 2.—Twenty-eight members of the freshmen and sophomore classes of the University of Kansas were today suspended for thirty days for participating in the recent contest over class colors. Other members of both classes threatened to quit the school if the suspensions were made, but up to this time have not done so.

### In Congress.

Washington, April 2.—When routine business had been concluded the senate today took up consideration of bills on the calendar and a number of minor importance were passed.

The house proceeded with the consideration of the sundry civil appropriation bill.

### Dock Laborers Strike.

Vienna, April 2.—Dock laborers at Fiume, Hungary, have again struck for an increase in wages and work at that port is practically at a standstill. A number of vessels there are unable to unload their cargoes.

### Re-elected the Directors.

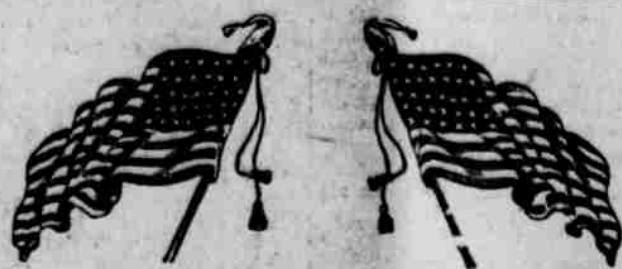
Fort Worth, Texas, April 2.—The annual meeting of the stockholders of the Fort Worth & Rio Grande railroad elected the old directors.

### San Francisco Postmaster.

Washington, April 2.—The president today nominated W. L. Montague for postmaster at San Francisco, Cal.

### Knight of Columbus.

Albuquerque Council, Knights of Columbus, will exemplify the work in the first and second degrees with a class of twenty-five candidates on next Sunday afternoon. Deputy Grand Knight John H. Reddin, of Denver, and a team from the Denver council will come here April 10 to give the third degree. The next day the Denver team and thirty members of Albuquerque council will go to El Paso, where on Saturday, April 12, a new council will be instituted. El Paso will handsomely entertain the visitors.



## SWEEPING VICTORY

Republicans Capture all Their Candidates Except Alderman in Second Ward.

### CHARLES F. MYERS ELECTED MAYOR.

Harry F. Lee for Clerk, and L. H. Chamberlin for Treasurer, Snowed Their Opponents Under Avalanche of Votes.

### READ OVER THE INTERESTING FIGURES.

The election in this city yesterday resulted in a complete sweep for the republicans with the exception of one candidate for alderman. The socialists made the most active ward workers and succeeded in evenly dividing the democratic vote. The new party did not draw to any appreciable extent from the republican party. In fact, the heretofore solid democratic majority in the Second ward was split in two, enabling the republicans to secure pluralities in that ward for all their candidates except Mr. Holman, for alderman. The republican party workers made a special and hard fight to secure Mr. Holman's election, but the vast pocket republican vote favored Mr. Beaven and he was elected by a small plurality.

The election in this city yesterday was the greatest republican victory ever secured in Albuquerque. The vote in the various wards may be found below:

In all the wards, only 12 votes were registered against the issuance of \$35,000 worth of bonds for school house improvements.

**Short Notes.**  
The flag, the great American emblem, won over the rooster and socialist yesterday. Thus the city is redeemed.  
The next city council and board of education will have republican majorities, and they will do good work for the city for the next twelve months.

Next year it will be the republicans against the socialists, and to put the words few, following year it will be the republicans against the democrats. These are predictions.

It is rumored the democrats will try new leaders next time, who will follow the plan of the socialists and suggest voting straight tickets, with a full ticket in all the wards.

A. B. McGaffey, the democratic candidate in the Fourth ward, defeated yesterday by Dr. Harrison, is selling Navajo curios and glassware today. He is not talking politics.

Sheriff Thos. S. Hubbard and County School Superintendent F. A. Hubbard are happy today. They worked faithfully all day yesterday for the success of the entire republican ticket.

With the appointment of all the judges and clerks, the democrats went down in one of the worst defeats imaginable. They don't know how to take advantage of good opportunities.

No candidate, not even Marron, could have won yesterday. The republicans of the city were thoroughly organized, and Marron was wise that he finally concluded not to offer himself up for the slaughter.

A few years ago Dr. Pearce ran for mayor and at that time only one democrat was elected—Frank McKee for city treasurer, and yet it is said the doctor is not discouraged in the least over his second defeat.

The Citizen's kid band and a ragtime band, the latter organized on the spur of the moment, helped to make noise throughout the city last night. The Italian brass band was also out, and serenaded Mayor-elect Myers and the other successful republican candidates.

O. N. Marron is a lucky individual. He just escaped defeat, when Larrazola was nominated last year for delegate to congress against the victorious candidate, B. S. Rodey, and yesterday—well, he escaped again and of course Dr. Pearce was offered up for the slaughter.

Two years ago Marron won over Alfred Grunfeld by a vote of 695 to 541, a majority of 154 votes. The democrats are trying to drown their remorse over the defeat of yesterday by pointing to these figures, stating that Marron had more votes than Myers yesterday. Had Marron been in the race yesterday he would have gone down in defeat the same as Dr. Pearce and Beauregard. No consolation whatever, and again the conditions yesterday were entirely different from those of two years ago.

### DISTRICT COURT.

#### Motion for a New Trial for Baca Was Overruled.

Judge Baker this morning overruled the motion for a new trial in the case of Jose S. Baca, convicted of manslaughter. It is expected he will be sentenced tomorrow.

The case of the First National bank against Sussman Lewinson was heard on demurrer. The demurrer was sustained on the ground that the same cause of action is pending in supreme court.

The case of Raymond P. Ripley against the Cochiti Gold Mining company was referred to W. D. Lee who, as referee, will report the amount of indebtedness.

The case of the territory against Gargona Garcia was continued until next term on account of the illness of witnesses.

## ADJUSTING MAIL.

### Texas Will Build a Sugar Mill.

### The Labor World is in a State of Unrest.

### A BIG MILL.

Washington, April 2.—The postmaster general today received a communication from the secretary of war officially notifying him that on May 30 next Cuba will be a foreign country. Upon the withdrawal of the United States on that date, there will be no statute or postal condition by which mail can be transmitted. Secretary Root states it is fair to presume diplomatic representatives of the two countries will at an early day, frame a postal convention similar, in general character, perhaps, to that which the United States now has with Mexico; but in the meantime he suggests that congress be asked to authorize a continuance on the present basis, upon an informal agreement of the postal authorities of the two countries. The postmaster general will immediately take steps to have the matter put in proper shape.

### WILL SELL SUGAR.

State Will Build a Mill on Its Own Farm.  
Houston, April 2.—The governor and penitentiary board decided to erect a sugar mill on the state farm in Brazoria county. A proposition was adopted for the erection of a 100-ton mill to cost \$268,500, and to be completed by October 15. The state has 2,000 acres in cane on the farm.

### THE LABOR WORLD.

A Long Strike is Ahead in the Mines of Pennsylvania.  
Dobois, Pa., April 2.—All the bituminous coal mines of the Rochester & Pittsburgh Iron & Coal company are idle today. The resolutions declaring the strike were obeyed by all the men and as a consequence 10,000 are idle. The final clause of the strike resolution reads: "No settlement of the question in dispute shall be recognized unless sanctioned by a properly authorized committee and the officials of the organization." This means the men will insist on a recognition of the miners' union and it is also interpreted as indicating a long struggle as the company has always refused to recognize the union leaders and insist upon dealing with the employees as individuals.

### Builders Strike.

Chicago, April 2.—A strike of the hod carriers and building laborers was called today. Herman Lillian, the agent, being compelled by the men to repudiate the agreement he made yesterday with the employers' organization.

Yesterday an advance from 30 to 35 cents, effective June 1, was agreed upon. Lillian agreed not to call a strike until the men met and ratified or repudiated the agreement. When the men learned this they were indignant, and said they had delivered the ultimatum to strike unless the advance was granted immediately. They flocked to headquarters today and compelled Lillian to call the strike. The strike, it is said, will involve the helpers, thus affecting 1,000 men. Building operations will be seriously retarded, according to the strikers.

### Extend the Time.

Meyersdale, Pa., April 2.—The miners comprising the various local unions of the United Mine Workers of America in the Meyersdale-Salisbury coal region, in a convention at Red Bridge, decided to extend the time of signing the scale until April 10, when it is expected the signatures of all operators in the region will be attached to the scale. The committee asks a nine-hour day with an advance of about 10 per cent for drivers and day laborers.

### A BIG MILL.

It Will Cost \$15,000,000 and Will Employ 6,000 Men.

Chicago, April 2.—The steel tube mill planned by Andrew Carnegie just before the formation of the United States Steel corporation is to be built near Conneaut Harbor, Ohio, this year, says a special to the Chronicle from Pittsburgh, which is said to be semi-official.

According to this report the original plans made by Carnegie have been changed. He projected a \$12,000,000 mill to employ about 3,000 men. The new plans will call for an expenditure of \$3,000,000 to \$5,000,000 more and the mills will employ 6,000 men.

tried their very best to beat Heaven,

### ROOSEVELT AND IRRIGATION.

President Roosevelt's new position  
in regard to irrigation is radically dif-  
ferent from that taken by him in his  
message to congress last December,  
says the Denver Republican. In that  
message he pleased the people of the  
far west by declaring for state control  
in the distribution of water in irriga-  
tion. But now he comes out with an  
opinion that the national government  
alone should control in the distribution  
of water from irrigation works con-  
structed at national expense.

Practically this declaration by the  
president means the defeat of irriga-  
tion legislation, for no bill can pass  
congress which provides for national  
control. The members, both of the  
senate and of the house, from the arid  
states would vote against any such  
measure. They appreciate that the  
new policy of President Roosevelt  
would lead to disastrous results in all  
the arid states, and they will have  
nothing to do with it.

There has from the start been little  
chance for the enactment of an irriga-  
tion law, notwithstanding the senate  
so promptly passed the Hansbrough  
bill. Senator Hansbrough managed to  
secure a foremost place on the calen-  
dar for his bill, and then the senate  
passed it to get it out of the way. The  
strong vote in its favor cannot be taken  
as evidence of the senate's views  
concerning the matter. Doubtless many  
senators voted for it in the belief that  
it would not be passed by the house,  
and in that they were right.

The president's change of front  
makes the death of the measure cer-  
tain, for its declaration is equivalent to  
notice that he would veto the bill if it  
came to him in the form that it passed  
the senate. It looks very much as if  
the administration had become weary  
of the irrigation proposition and were  
willing to dispose of it in some way  
such as this. If this is true, it is im-  
probable that there will be any legisla-  
tion of that kind by any congress in  
the near future.

## RAILROAD SITUATION.

## Interesting Facts About Santa Fe Central and Albuquerque Eastern.

## IMPORTANT ROADS.

The Santa Fe Central railway and the Albuquerque Eastern railway at present under construction in New Mexico, hold the key to the railroad situation in New Mexico, says the New Mexican. The Santa Fe Central, 116 miles long, is being built from Santa Fe to Torrance, Lincoln county. It will connect the Denver & Rio Grande system with the Rock Island & El Paso railway. It will form a junction with the Santa Fe system at Santa Fe and will cross the system at Kennedy near Galisteo. At Santa Fe it will also connect with a second proposed railway to Durango, Colo., and also with a proposed line to Fort Garland, Colo., by way of Questa, Taos and Embudo. At Torrance it is to form a junction with the proposed Choctaw extension into New Mexico and also with a line to Roswell in the Pecos valley. All future transcontinental lines that intend pushing to the coast by way of central New Mexico, will have to cross the Santa Fe Central.

The Albuquerque Eastern is to be a branch 45 miles long from Moriarty in Santa Fe county through Tijeras canyon, to Albuquerque. At Albuquerque a third junction will be formed with the Santa Fe system. Ileta is the junction point with the Santa Fe & Pacific system. Thus it will be seen that the Santa Fe Central with its branch will occupy a position of unusual importance among New Mexico railways.

All the preliminary work for actual construction on the Santa Fe Central is completed. Ties have been distributed all along the route, and telegraph line is being built well drillers are drilling for water, station buildings, barracks for the construction forces, stables for the horses and storehouses for supplies have been built and everything is in readiness to begin actual grading. The contract for 14,000 tons of rails, just sufficient to construct the 116 miles of the Santa Fe Central, has been let and the first delivery of rails is to be completed before the snow of next winter begins to fly. Bridge timbers are being delivered and soon all streams and arroyos will be crossed by substantial bridges. The engineering work on the Santa Fe Central is not of an expensive nature and one tangent of the line will be 30 miles long. On the Albuquerque Eastern there will be six miles of hard construction work through Tijeras canyon, but outside of that the branch will also be easy of construction and of maintenance. A branch is to be built seven miles long from Blanca, in Valencia county, to the salt lakes, the largest of which has been purchased by the railroad company and will be exploited for its salt. Another branch will leave the main line at Stanley to San Pedro, where there are extensive copper mines and the big copper smelter of the Santa Fe Gold & Copper company. From Vega Blanca, south of Santa Fe, to Moriarty, a cut-off is to be constructed by way of Galisteo, which will be 35 miles long. An extension from Torrance to Roswell in the lower Pecos valley is also under consideration.

The Santa Fe Central Railway company will do its utmost to develop the country which it will traverse. At Santa Fe shops and offices are to be built as well as a fine union depot, the latter in company with the Santa Fe and the Denver & Rio Grande systems, which have already given their consent to the depot project. Extensive coal lands are being exploited by the company between San Pedro and Galisteo while in the Manzano mountains saw mills are to be erected to treat the big timber of that section. New towns are being laid out and irrigation works are under contemplation. The road forming an important link between the great railway systems can from the first day of its completion command an immense amount of local traffic for it traverses a region which produces several million pounds of wool annually, in which several hundred thousand sheep and thousands of cattle graze. A country that is rich in gold, silver, copper, lead, turquoise and other minerals; a section that has extensive beds of the finest coal to be found in the west, a domain having large tracts of timber, a country that can produce thousands of tons of salt annually and a country rich in many other resources.

Like the El Paso & Rock Island railway, the Santa Fe Central will be constructed with Pennsylvania capital. Its president is Senator W. H. Andrews, of Pittsburgh; its vice president and manager is Hon. W. S. Hopewell, chief engineer, A. G. Kennedy, secretary, J. E. Saint, and treasurer, J. T. McLaughlin. The Pennsylvania Development company has the contract for the building of the road and its branches. Senator Arthur Kennedy, of Pittsburgh, is its president. One of the main backers of the railway company is General Torrance, one of the wealthiest and most

prominent citizens of Pennsylvania, who is spoken of as a candidate for the republican nomination for governor, which is equivalent to election, of the great keystone state.

Naturally there is much speculation as to what great railway system is in back of this new railroad enterprise. The facts are that it is an entirely independent venture although naturally close traffic alliances will be made with the Denver & Rio Grande, for it furnishes that system a direct line to El Paso from Denver and Durango, besides being in the way of a future extension from Santa Fe to the fertile lower Pecos valley and through Texas to the gulf port of Galveston. It will also be an important feeder to the Rock Island and will be important to the Choctaw system by giving it entrance to Santa Fe and that means to Durango and Denver, and to Albuquerque and that means to Los Angeles and San Francisco by way of the Santa Fe Pacific. The possibilities of the system are great and this much is certain that it will be a dividend payer from the start and that it is of far greater importance to the southwest than its mileage would indicate.

The following are the stations on the Santa Fe Central determined upon, their elevation and their distance from Santa Fe: Donaciano, 6,650 feet, six miles; Vega Blanca, 6,400 feet, 17 miles; Kennedy, 6,950 feet, 23 miles; this is the station at the junction with the main line of the Santa Fe railway; Clark, 6,125 feet, 29 miles; this is the station in the O'Mara coal fields; Stanley, 6,370 feet, 41 miles, from here the branch to San Pedro will probably be built; Moriarty, 6,250 feet, 53 miles, from the Albuquerque Eastern will be built and also the Galisteo cut-off. The above stations are all in Santa Fe county. In Bernalillo county is McIntyre, 6,175 feet, 62 miles. In Valencia county, Estancia, 6,140 feet, 69 miles; Willard, 6,125 feet, 82 miles; Progreso, 6,210 feet, 93 miles; Blanca, 6,285 feet, 100 miles; from Blanca or Progreso, the branch is to be built to the salt lakes. In Lincoln county are Camaleon, 6,425 feet, 110 miles; and Torrance, the junction point with the Rock Island, 5,475 feet, 116 miles.

Upon looking up the date it was found that a house had been broken into that night and that the burglar was shot at. The discharge being so close to him and coming through a window, it is thought the cut on his face came from the flying glass. His wounds were dressed at the hospital.

C. Orrin, clerk; Alford Peterson, Henry Jones and Milton Narvaiz, aldermen; W. S. Connett, T. B. Thompson and F. Gauna, members of the school board. The democrats elected C. M. Houck, treasurer; C. O. Madoulet, Con Murray, aldermen, and Bryant Rhea, member of the school board. A light vote was cast. Great rejoicing by republican candidates last night.

A telegram to The Citizen from Santa Fe says: I. Sparks, republican candidate for mayor, received 62 majority over N. B. Laughlin, democrat, and Leo Hersch, fusionist; Facundo Ortiz, clerk and W. H. McPherson, treasurer, republicans, were elected. The republicans have a majority of five out of eight alderman, and six out of eight school board, counting hold overs.

### HIS OBSERVATIONS.

While at Albuquerque, Tuesday we had the pleasure of a trip through the new Alvarado hotel being built by the Santa Fe company. The entire building, furnishings and everything in connection with it has a rich massive appearance, and is built on the old Spanish style. The outside finish is of stucco; on the first floor is one of the finest appointed saloons in the west, or east for that matter, an office with a balcony, where an orchestra will discourse sweet music during meal hours, a large and elaborate dining room; the finest Harvey lunch counter on the system, a kitchen with plenty of room and everything up-to-date to work with, and a first class steam laundry with the latest improved machinery. On the second and third floors there are something over 100 sleeping rooms, about every two or three being supplied with water closet and bath room. Each room is papered and painted in different color and design. All the furniture is heavy and has a wealthy appearance, the iron bedsteads being furnished in maroon, and the wood of solid oak with black finish.

## Railroad Topics

G. R. Henderson, superintendent of machinery of the Santa Fe, passed through in his private car enroute from Topeka to El Paso.

W. E. Geary, formerly railroad agent at Carrollton, Ill., was in Las Vegas en route from California to Carrollton, where he will resume his old position.

A bulletin was posted in the Las Vegas round house stating the men who had been on the change shifts, changing every two weeks, will hereafter change once a month, the time being at noon on the first day.

The general solicitor for the Denver, Kansas & Atlantic railroad announced today that active construction on the line from Denver to New Orleans will begin at once. This road is financed by the Yerkes, of Chicago, and passes diagonally through Oklahoma from northwest to southeast.

New activity is promised on the Laramie, Hahn's Peak & Pacific railway of which about twenty miles, south of Laramie, is already in operation. The road is intended to tap the copper region of southern Wyoming and the Hahn's Peak mining region of Routt county. The appointment of R. D. Stewart to be chief engineer of the line has been announced. Mr. Stewart was chief engineer of the Florence & Cripple Creek railway.

The provincial government of Canada has refused the application of the Northern Pacific for permission to build spurs into Manitoba and notified that company that having sold its lines in Manitoba to the government, it would not now be allowed to build competitive lines. It is also understood that the Great Northern will be kept out and the traffic of the province monopolized by the Canadian Northern as long as the present government is in power.

He also said it is the intention of the Rock Island people to ultimately extend the line to New Orleans, by way of Beaumont. He denied the report that the Harriman syndicate had acquired a controlling interest in the Rock Island.
