New Mexico demands Statehood  
from the Fifty-Seventh Congress.

WEDNESDAY, JAN. 8.

There will be at least three hun-  
dred miles of new railroad built in  
New Mexico this year.

It was eighty-seven years ago today  
when General Jackson whipped the  
British at New Orleans.

The assessment work on over one  
hundred mining claims in this county  
was completed last month.

Congress is getting down to business  
and may reach the New Mexico state-  
hood bill before many days.

The new year is doing its best to  
create a favorable impression. It has  
smiled ever since it arrived.

The Chicago man who died from the  
effects of a pint of whiskey which he  
drank at one gulp has earned the last-  
ing contempt of every thoroughbred  
Kentuckian.

This city certainly cannot afford to  
fall in securing the building of the  
Albuquerque Eastern railroad. Every  
effort should be made to secure the  
necessary subscriptions.

It didn't take Uncle Mark long to  
show the country who is boss in Ohio,  
after he woke up. It was hard for the  
senator to realize at first that the boys  
were trying to down him.

The city board of education will be  
compelled to enlarge two or three of  
the public school buildings during the  
coming summer. All the public school  
buildings are now crowded to over-  
flowing.

Dakota courts are proving them-  
selves of some use besides the manu-  
facture of divorces. The supreme court  
of North Dakota has just given out a  
decision that a contract made to re-  
strict trade is void.

From ten to fifteen million dollars  
worth of fruit products are yearly  
shipped from southern California, a  
country which was in many places al-  
most a desert until water was applied  
to it from its numerous streams.

A mine of prospect in Wyoming, lo-  
cated on Slate creek, is yielding nickel  
ore to the amount of \$52 a ton. Nickel  
has been discovered in several local-  
ities in the west, but somehow it has  
not been made to pay any definite  
profits.

To hold a successful territorial fair  
next fall the work of preparation  
should begin early in the year. It will  
be an easy matter to hold a territorial  
fair next fall, because the whole terri-  
tory will be interested in collecting a  
fine exhibit for the St. Louis ex-  
position.

Having won its suit in the United  
States supreme court against the At-  
lantic & Pacific railroad, Valencia  
county, will soon have in its treasury  
about \$70,000. This money will make  
the credit of Valencia county first  
class and will also enable it to pay off  
a large part of its bonded debt.

Next time a money panic comes it  
will find this country loaded for the en-  
emy and well fortified. In an address  
last week Ex-Governor Paxton, of the  
Curency Dances stated that the 15,000  
banks in the United States have assets  
of \$12,000,000,000, which is within 12 1/2  
per cent of the banking capital of all  
Europe.

Prof. J. H. Paxton, professor of  
Greek and Latin at the University,  
went to Santa Fe this morning for the  
purpose of being examined by a com-  
mittee of the bar association and ad-  
mitted to the practice of law in this  
territory. Professor Paxton is one of  
the best educated young men in the  
west and is proficient in five lan-  
guages. He will make his mark as a  
lawyer and be a credit to the profes-  
sion.

**ITEMS OF CONSIDERABLE IMPORTANCE.**

Engineer Seeger has returned to

the shops here.

of Boston, Mass.

The earnings of the Santa Fe system  
for November, 1901, were the largest  
monthly earnings in its history,  
amounting to \$5,429,578.

Investigation regarding the wreck  
at Krown's siding, which took place  
some time ago, was held in the office  
of Trainmaster Bristol at Las Vegas.

The position of fireman on the sec-  
ond main line is now vacant.

The oldest fireman applying for it be-  
fore January 10 will be assigned to the  
run.

Engine No. 655, one of the Glorieta  
mountain helpers, returned to its du-  
ties at Lamy Saturday night, after be-  
ing repaired and overhauled in the Las  
Vegas shops.

As stated in The Citizen the entire  
Santa Fe system are arranging to meet  
in Albuquerque as soon as the new  
hotel is ready for occupancy.

Brakeman Bert Towne returned to  
needles last Sunday from the Sisters  
hospital in Los Angeles, and his many  
friends are pleased to note his recov-  
ery from severe illness.

Fireman McLarty, who had been  
handling the "scoop" on the Waldo  
branch engine, as an extra man, has  
returned to Las Vegas from Los Cer-  
rillos, being relieved by Fireman  
Ginter.

F. A. Lagerwall, who has held the  
position of division storekeeper for the  
Santa Fe Pacific for over two years,  
more or less, has been transferred to  
East Yard station of the same com-  
pany at San Francisco.

Fireman Hugo Quigley, who has  
been firing one of the Glorieta mount-  
ain helpers for months, has given up  
that run and will enter the road ser-  
vice at Las Vegas, where he is en-  
gine No. 737, with Engineer Crossen.

Hotel supplies, furniture and fix-  
tures for "The Alvarado" are arriving  
daily from the east. Although work is  
being pushed as rapidly as possible, it  
will yet be several months before the  
big hotel will be ready for opening.

William Krause, a brakeman, walked  
or was thrown off a car at Piute, a  
station east of Santa Fe, and broke his  
leg, and had both ankles severely  
sprained. He was brought to the  
Needles hospital, where Dr. Freeman  
attended him.

A new bulletin has been posted in  
the round house, giving the amount of  
oil to be used by the different class  
engines of the road, and the amount of  
the use of oil in the past has been ex-  
cessive and the present method has  
been adopted.

The auditor of the passenger receipts  
of the Santa Fe, C. M. Wood, has  
been granted a leave of absence for  
three months on account of poor  
health. F. E. Mitchell, chief clerk,  
will attend to his duties at Topeka,  
while he is away.

The Needles Eye says: "George  
Conns, one of the old time shop boys,  
and at one time a member of the  
Needles band, was returned to his first  
love, and was shaking hands with his  
friends last week. George has been in  
Yuma for a year or two past.

The Santa Fe Pacific Railroad com-  
pany are getting ready to replace the  
California sand walk at the Flagstaff  
depot with a walk of vitrified brick.  
Three car loads of brick were unloaded  
this week, and the new walk will be  
put down some time this month.

The Williams News says: "Contract-  
or M. J. Kennedy, having finished his  
contract in the city, returned to Flag-  
staff this week to join his family, who  
are coming to the city. M. J. likes  
Williams and we shouldn't be sur-  
prised to see him move up some day  
to stay."

Four big boilers were hung to the  
new machine shops of the Santa Fe

for the shops, but also heat for the  
whole works. The work on the electric  
light plant has been suspended, owing  
to the non-arrival of material and the  
system will not be in operation before  
February 1.

Chief Engineer A. G. Kennedy of the  
Santa Fe Central Railway company,  
will leave for their home at Piute  
from Santa Fe to meet Superintendent  
J. E. Hurley and Division Superintendent  
F. C. Fox of the Santa Fe system.  
The matter of switching in the new  
Ortiz on the Santa Fe railway was  
discussed. The switch is to be for the  
accommodation of the Santa Fe Cen-  
tral, which expects to receive a large  
amount of freight over the Santa Fe.


