## SHE IS BETTER!

Improved.

"The doctors, after this morning's consultation, find that Mrs. McKinley is not improving, but has gained a little since last night's report."

GLOOM OVER PARTY.  
Palo Alto, Cal., May 14.—The president this morning telegraphed Secretary Hay that he would not leave Mrs. McKinley's bedside today. This casts a gloom over the entire party.

### NON-UNION MEN ATTACKED.

Stones and Bricks Thrown at the Albany Motormen.

Albany, N. Y., May 14.—The Union Traction company, whose employees are on a strike, made an effort today to operate its lines with non-union men. The second car out was chucked and the motorman knocked senseless. The crowd deserted the car after making two trips. Stones and bricks were thrown at motormen and conductors. Non-union men brought here are reported to have notified the corporation that they had decided not to take cars. No attempt has been made to operate the line at Cohoes, Rensselaer, Troy and Watervliet, on which the employees have also struck.

Motorman Woodward had his skull fractured in three places and his left shoulder broken.

## Wool Market Conditions.

Boston, Mass., May 14.—The conditions of the wool market here are not materially different from last week. The demand continues quiet and the total amount of business foots up to only a moderate total. There is nothing in the wool outlook to encourage speculation, and this keeps trade down to a hand to mouth character. Fine medium and fine territory is selling for 40 to 42 c; strictly staple article at 44 to 45 c. Fleeced wools are slow.

Stricken With Apoplexy and Dead.  
Chicago, Ill., May 14.—Winfield N. Satterly, one of the most widely known insurance men in the west and a prominent club man, was stricken with apoplexy last night, and died shortly afterward. He was born in Ferrisburg, Vt., in 1859.

Important Suit Ended.  
Yesterday afternoon Attorney Neill B. Field received cheering information that the supreme court of the United States had affirmed the judgment of the territorial supreme court in the case of Justo R. Armijo vs. Barbara Chavez de Armijo in favor of his client, the plaintiff. This suit was commenced several years ago for services rendered as manager of the N. T. Armijo estate, in which he received judgment for the sum of \$6,092.92 in the shops of New Mexico. An appeal was taken to a higher court and the decision was reaffirmed yesterday.

Wild West Performer Killed.  
Vincennes, Ind., May 14.—Miss Theresa Russell, of Denver, equestrienne connected with the Wild West show, was fatally injured last night while practicing a new act in which she leaps from one rapidly running horse to the back of another going at full speed. Her foot caught in the stirrup and she was dragged around the ring among the hoofs of the frightened bronchos. The cowboys made desperate efforts to stop the horse, but were unable to do so until finally one stuck a pitchfork into the animal, killing it instantly. Miss Russell was unconscious.

A Foreign Denial.  
Berlin, May 14.—Government circles furnish a denial that negotiations are going on between Austria and Germany for an European commercial league against the United States.

Confidential Clerk Shot.  
New York, May 14.—E. L. Chetwood, confidential clerk of Brown Bros., bankers, was arrested today, charged with being shot \$12,000.

News from France.  
Paris, May 14.—At a cabinet council today, M. Delcasse, foreign minister, announced that France joined in a most vigorous protest from the powers against the port's postal measures.

Delcasse also announced that the government would recall the French expeditionary corps in China as soon as the last clause of the collective note are carried out, and after a settlement of indemnities.

Mrs. Nathan Insane.  
Topeka, Kan., May 14.—The case of Mrs. Carrie E. Nation, charged with Sunday saloon smashing in Topeka last February, went to the jury at noon. Her attorneys set up a plea of insanity as defense. None of Mrs. Nation's crusader friends were in court.

SUSPECTS CAPTURED.  
The City Marshal Lands a Couple Supposed to Be Robbers.

City Marshal McMillin this afternoon captured the pair of traditional long and short men, who are suspected of having robbed the second-hand store of John Borradaile on Sunday or gave him a part of his fiery this morning. The marshal stopped at the Borradaile store with his prisoners this afternoon and the clerk recognized them as having been in the store last week. The boys were taken to the city hall, where they will remain until they have a hearing.

NEW COUNCIL AT WORK.  
Preparations Being Made for New Improvements in Various Parts of the City.

Last night the regular meeting of the city council was held and all members were present except Aldermen Rogers and Harsch. The minutes of the previous meeting were read and approved. By consent of the members J. W. Edwards was allowed to address the assembly in which he asked the council to assist the Grand Army of the Republic in making preparations for the rendition of a program on Memorial day. His remarks were favorably received and the council agreed to furnish city teams and laborers for the work of preparing for the celebration. The fire department will take part in the parade.

A statement from Tax Commissioner E. T. Cantledge, of the Santa Fe Railway company, was submitted and the total amount of \$22,579 was shown as railway taxes.

A petition signed by a number of property owners on south Edith street, asking for the construction of a cement sidewalk from Railroad avenue to Coal avenue, was received and granted.

According to the report of the fire chief it was shown that the total expense of maintaining the paid fire department for the month was only \$243.03. During the month three alarms had been responded to, kept

that four of the volunteers had tendered their resignations.

The bids for the printing of license books was considered by the finance committee and the council ordered the expenditure. Directory cards were ordered printed and the clerk was directed to look after that work.

In the report of the street committee it was recommended that a new 18-foot cement sidewalk be constructed on the west side of south First street, from Silver avenue to Coal; both sides of Silver avenue, from First to Third streets; east side of south Second street, between Silver and Coal; and a six-foot board walk from Copper avenue to Kent on Seventh street.

Mayor Marron nominated Charles F. Myers as park commissioner, and the city attorney was directed to prepare an order for the calling in of the city's 6 per cent refunding bonds.

Judge Crawford Satisfied.  
The commodious one-story building on north First street, commonly known as the Francis Frank property, leased to A. J. Crawford, the wool buyer, yesterday. The lease has been in the wool business for a quarter of a century, and since his residence in this city has never been able to engage as actively in this pursuit commensurate with his ambition as there is a scarcity of vacant buildings in the proper locality. Now that the judge has secured what he has long wished for, he will have an opportunity of spreading himself. The building has a capacity for the storage of a million pounds of the fleece white, and then there will be space for his office. A business office will be put in shape in a few days and the judge will be ready to entertain any and all orders for the purchase or storage of wool.

## CITY OF PADUCAH!

List of Dead in Steamer Wreck.

Rockefeller Loses Heavily in Cattle Speculation.

The Miners of the Clarkville Coal Mines, Gallup, Out on a Strike.

### ALGER WILL VISIT EUROPE.

St. Louis, Mo., May 14.—The first authentic information concerning the wreck of the steamer City of Paducah, which occurred at Brunkhorst Landing, Illinois, Sunday night, was obtained upon the arrival of the steamer City of Clifton here this morning. Fifteen persons lost their lives.

Dead. Dr. J. W. Bell, Cuba Landing, Tenn.; Miss Mabel Gardiner, St. Louis; Charles Johnson, aged 81, deck watchman; Frank Gardner, Texas tender, Paducah, Ky.; two white women, names unknown; Grant Woods, colored boat baker, and eight colored rowboats.

The City of Paducah stopped at Brunkhorst Landing Sunday night and took on a load of corn. When backing away from the wharf the boat swung around and struck the levee heavily with her stern. A snag tore an enormous hole in the hull, through which the water rushed. She at once began to settle and at the end of three minutes nothing but the roof, Texas deck and pilot house remained above the surface.

ROCKEFELLER'S LOSSES.  
His Cattle Speculations Were All on the Wrong Side.

Kansas City, Mo., May 14.—Uttley Wedge, who was yesterday appointed receiver of the Seigle-Sanders Live Stock Commission company on application filed by Frank Rockefeller, principal stockholder, took charge today. Wedge states the business of the company continued without interruption. From his own figures, Rockefeller's losses will not be less than \$100,000. Men connected with the business have quoted as saying he may lose \$400,000. It will take weeks to check up the herds on which the company has mortgages.

CLARKVILLE MINERS.  
They Quit Because a Union Miner Had Been Discharged.

Gallup, N. M., May 14.—The miners at Clarkville quit work yesterday on account of the discharge of a union miner. Afterwards a part of the men were discharged and ordered to take all tools out of the mine and vacate the company's houses in three days. The order is being complied with.

Will Visit Europe.  
New York, May 14.—General Russell A. Alger, former secretary of war, will sail to-morrow for Europe, to be gone about three months. His health is much better than while he was secretary of war, but he has not entirely recovered.

The 6-months-old son of Mr. and Mrs. Ambrosio Gingras died yesterday morning at the home of the parents on south Third street of stomach trouble. The funeral services were conducted at the church of the Immaculate Conception this morning at 9 o'clock by Rev. Father Mandiari. A large number of sympathizing friends of the family were present and escorted the remains to Santa Barbara cemetery, where another little spot was made sacred.

His remarks were favorably received and the council agreed to furnish city teams and laborers for the work of preparing for the celebration. The fire department will take part in the parade.

A statement from Tax Commissioner E. T. Cantledge, of the Santa Fe Railway company, was submitted and the total amount of \$22,579 was shown as railway taxes.

A petition signed by a number of property owners on south Edith street, asking for the construction of a cement sidewalk from Railroad avenue to Coal avenue, was received and granted.

According to the report of the fire chief it was shown that the total expense of maintaining the paid fire department for the month was only \$243.03. During the month three alarms had been responded to, kept

that four of the volunteers had tendered their resignations.

The bids for the printing of license books was considered by the finance committee and the council ordered the expenditure. Directory cards were ordered printed and the clerk was directed to look after that work.

In the report of the street committee it was recommended that a new 18-foot cement sidewalk be constructed on the west side of south First street, from Silver avenue to Coal; both sides of Silver avenue, from First to Third streets; east side of south Second street, between Silver and Coal; and a six-foot board walk from Copper avenue to Kent on Seventh street.

Mayor Marron nominated Charles F. Myers as park commissioner, and the city attorney was directed to prepare an order for the calling in of the city's 6 per cent refunding bonds.

The commodious one-story building on north First street, commonly known as the Francis Frank property, leased to A. J. Crawford, the wool buyer, yesterday. The lease has been in the wool business for a quarter of a century, and since his residence in this city has never been able to engage as actively in this pursuit commensurate with his ambition as there is a scarcity of vacant buildings in the proper locality. Now that the judge has secured what he has long wished for, he will have an opportunity of spreading himself. The building has a capacity for the storage of a million pounds of the fleece white, and then there will be space for his office. A business office will be put in shape in a few days and the judge will be ready to entertain any and all orders for the purchase or storage of wool.
