SENSIBLE TALK!

Japs Want China Trouble Settled.

If Not, the World Would Be Plunged Into Strife.

American Board of Foreign Missions Now in Session.

SIR THOMAS LIPTON AGAIN.

New York, Oct. 10.—A dispatch to the Journal and Advertiser from Tokyo says: Marquis Ito, premier of Japan, received your correspondent by appointment, and while discharging that duty he was official, talked freely on the paramount issue of the day. "I cannot understand," he said, "why the powers do not convene a conference of plenipotentiary representatives and speedily determine a concerted policy toward China. Though the armies are working harmoniously, conflict is sure to arise if the governments neglect longer to arrive at a definite understanding. Negotiations with Li Hung Chang and Prince Ching will be fruitless, unless ratified and enforced by the re-established government, for they alone, no matter what they promise, cannot carry out anything. Tuan, Kang Yi and Tung Puh Shung dominate the empire and say they will resist the foreign powers to the death if they are ignored. The empire should be evacuated, the emperor and court permitted to return and negotiations should come afterwards. Foreign powers should withdraw to the coast and hold their forces there pending final settlement. Further aggressive measures will plunge the whole empire into war and chaos will reign for years, trade will be ruined and life protected only at tremendous cost. War with China would be the greatest disaster of the century, for no nation could conquer her single handed and all the world would be plunged in strife."

RUSSIANS AND OTHER ALLIES.
New York, Oct. 10.—The Russians, without consultation with the other allies have agreed to hand over the summer and winter palaces in Peking to the Chinese, says a Tien Tsin dispatch to the Journal and Advertiser. But 200 British troops and also Germans and Italians, proceeded to occupy the palaces. All the Japanese section of the town is bustling again with commercial activity, while other parts, especially French and Russian, are comparatively deserted.
Many American missionaries are holding sales in houses of wealthy Chinese of large quantities of loot brought in by their converts.
The Japanese consider the expedition to Pao Tsin unnecessary and merely to gratify German desire for vengeance, which will surely fall heaviest on the women and children, inoffensive people, totally unconnected with Von Koteler's murderers.

PROPOSITIONS APPROVED.
Washington, Oct. 10.—There is no longer any doubt that this government heartily approves the propositions laid down in the French note made public on the 5th inst., in regard to the common program to be adopted by the powers as a basis for peace negotiations with China. A formal note embodying the views of this government is in preparation and probably will be handed to Mr. Thibaut, French charge in Washington, within a day or two.

NINETEENTH ANNUAL MEETING.
Of American Board of Commissioners for Foreign Missions.

St. Louis, Oct. 10.—The nineteenth annual meeting of the American board of commissioners for foreign missions convened here this morning in the Plurim Congress hall, church, and will be in session three days. Samuel B. Chapin, L. L. D. of Boston, president of the American board, said in his address: "It ought to be noted to the credit of the secular press as well as to the great magazine that as a rule, they understood the present crisis."

While at first there was some ignorance, speedily, great truths came home to them that the Chinese uprising was not chiefly because of the missionaries. They saw that the great reason was the injustice of foreign nations in stealing their ports and territory, and commercial progress, which had often selfishly and heartlessly, run roughshod over the Chinese traditions and which was depriving laborers in great numbers of their employment."

Wants Another Trial.
London, Oct. 10.—It is reported here that a challenge from Sir Thomas Lipton for another series of races for the American cup reached the New York Yacht club this morning.
London, Oct. 10.—Sir Thomas Lipton informed the Associated Press that he sent a challenge to the New York Yacht club on the steamer Germanic, due in New York Thursday, and prefers that all information as to its contents be given out by the New York Yacht club.

KILLING AT LOS GRIEGOS.
Jose Perez y Gurule Shot and Killed by Federico Serna.
The little town of Los Griegos, about five miles above the city, was the scene of a cold-blooded murder last night. At 3 o'clock Federico Serna, a young man about 25 years of age, called at the house of the son of Jose Perez y Gurule and was asked what he wanted. He replied by pulling out his gun and sending a bullet into the breast of Jose Perez y Gurule, death resulting in a few hours. The murdered man was about 60 years old, and a very hard-working farmer. The murder, so it is reported at this office, was brought to the county jail by a deputy sheriff this afternoon.
Later—Sheriff Hubbell telephoned to the town office at 4 o'clock this afternoon that he captured Serna and now has him behind the bars of the county jail.

POLITICAL POINTS!

Roosevelt Will Stay Two Days in Indiana.

While Bryan Will Do Duty in Michigan.

Senator Jones Fears Employers Will Coerce Employees.

NEWS FROM SOUTH AFRICA.

Chicago, Oct. 10.—Governor Roosevelt's special train passed through this city this morning for Indiana, where the governor will spend the next two days. The party is in charge of United States Senator Fairbanks.

AT LAFAYETTE, IND.
Lafayette, Ind., Oct. 10.—Governor Roosevelt to-day opened a two days' campaign in Indiana. His first speech was here and he was escorted to the public square in company with Admiral Brown, of the United States navy; Senator Fairbanks, National Committeeman H. C. Snow, Congressman Landis and John Barrett, minister to Spain. At Lafayette there was a large procession embracing a heavy escort of mounted riders.
Ex-Minister Barrett, who left the train at Monroeville, where he will speak to-night, conversed more than an hour with Governor Roosevelt, discussing the situation in the Philippines. Barrett, who was appointed by President Cleveland and until recently was a democrat, is now supporting McKinley and Roosevelt and in a few days will leave for the Pacific coast where he will speak until the end of the campaign.

BRYAN IN MICHIGAN.
Benton Harbor, Mich., Oct. 10.—W. J. Bryan began a two days' tour of Michigan to-day, making his first speech at East Buffalo. Bryan talked half an hour, dwelling especially upon the trusts and imperialism.

A DEMOCRATIC RALLY.
Chicago, Ill., Oct. 10.—A call will be issued to-day by the national democratic committee for a "Grand Rally," October 27th, of all democratic clubs throughout the country. The rally will be set apart as democratic day.

EMPLOYERS TO BE WATCHED.
Chicago, Ill., Oct. 10.—Senator Jones, chairman of the national democratic committee, said to-day:
"I intend to address a letter to the democratic clubs all over the country, requesting them to give me proof in all instances that the trusts with their knowledge of employees undertaking to coerce or intimidate employers. I have now some men in Ohio for the purpose of ascertaining the conditions there. Our people are thoroughly aroused to danger in this direction and are determined to have an honest election."

New York, Oct. 10.—It was announced at republican national headquarters that General Benjamin Harrison will this evening give out a statement containing some of his views on campaign issues.

announced to be 588, an increase of
\$9 per cent since 1890.

New Mexico.

The fire loss of the United States and
Canada for September, as compiled for
the Journal of Commerce, shows a
total of \$110,300.

The indications are that Colorado
will give a republican majority. The
people of that state are disgusted with
the calamity howlers.

The republican convention in Socorro
county will be held at Socorro on Mon-
day, Oct. 15, and will consist of 96 de-
legates from the several county pre-
cincts.

Millions of dollars are spent in a na-
tional campaign for expenses of public
speakers, and it is questionable if they
change a vote.

Republican prosperity note: The
Pennsylvania state factory inspec-
tor estimates that Pennsylvania industries
employed 448,000 more persons in 1900
than they did in 1890.

According to the director of the mint
the coinage executed at the United
States mints during September was as
follows: Gold, \$2,293,325; silver, \$3,922-
186; minor coins \$215,418.

The quarterly statement of the com-
missioner of navigation shows that 308
vessels of 83,790 gross tons were built
in the United States, and officially
numbered during the quarter ended
September 30, 1910.

Arkansas was the first state to have
its population counted by the census
bureau. Its population was found to be
1,311,564, an increase of 16.35 per
cent in ten years, or a little less than
the average increase of population
throughout the United States.

The Philadelphia republicans have
paid over to the republican national
committee \$63,411.13, instead of the
\$100,000 they promised in case the na-
tional convention was held there. In
other words the pledge of the Philadel-
phia committee panned out 63 cents on
the dollar.

Miss Clara Barton's appeal for aid in
the reconstruction of Galveston will
doubtless meet with a ready response.
The first outpouring of money and sup-
plies has served to feed and clothe the
survivors of the storm and to rebuild
the streets of Galveston partially pas-
sable, but permanent buildings must
be put up for the 8,000 or more who are
homeless.

PUBLIC SCHOOLS.

In the year 1896 the average attend-
ance in the public schools of the United
States was 9,747,015, for whom 409,325
teachers were employed at an expense
of \$116,377,775, the total outlay for edu-
cation in public schools being \$184,453-
780. In 1897 the attendance rose to 10-
469,620 children, and there were 408,333
teachers and 180,000 officers and employ-
ees. In 1898 the attendance rose to 11-
310,362, the whole expenditure for
public school maintenance being \$187-
320,602. In 1899 12,286,000 persons were
in daily attendance on the schools,
while 400,180 officers and teachers were
employed to conduct them at \$122,895-
412, and the whole cost of public schools
was \$194,020,470.

The street committee recommended that a drainage box be placed on south Arno, and the recommendation was adopted.

Mayor Marron appointed Aldermen Burkhardt, Leonard and Beaven delegates to the territorial municipal convention, which will be held in this city on October 22, 1900.

The following exceedingly important ordinance prepared by the city attorney and city physician was passed under suspension of the rules:

A HEALTH ORDINANCE.

Be it ordained by the city council of the city of Albuquerque:

Section 1. Every undertaker in the city of Albuquerque must be registered with the board of health.

Section 2. The body of a person who without a permit from the city physician, shall be buried, shall cost \$50.00.

Section 3. No dead body shall be removed from city to another without a permit.

Section 4. There shall be no public or church funeral of any person who has died of smallpox, diphtheria, scarlet fever, yellow fever, or Asiatic cholera.

Section 5. Physicians must report within twenty-four hours after making a diagnosis, every case of smallpox, diphtheria, scarlet fever, including membranous croup, occurring in his practice.

Section 6. In all cases in which it comes to the knowledge of the board of health that rooms or apartments in lodging, etc., which have been vacated by death of a consumptive, shall be disinfected by the city physician; no other persons shall occupy such rooms until the order of the board of health has been complied with.

Section 7. Physicians must report births occurring in their practice within five days after the event to the city physician.

Section 8. That any person violating any of the provisions of this ordinance shall, upon conviction thereof, be fined in any sum not exceeding \$50.00, and that it shall be the duty of the city physician to keep a record of the reports required by this ordinance in a book to be kept for that purpose, which shall be one of the records of the city.

THE RAILROAD VIADUCT CONTRACT.

The subject of the contract bearing on the railway improvement question, submitted by the Santa Fe company, was approved by the council on motion of Alderman Burkhardt, seconded by Alderman Wright.

The suggestions appended to the resolutions were accepted by the company, and the mayor was authorized to sign the contract when a favorable answer had been given by the company.

Agreement, made this day of September, A. D. 1900, between the Atchison, Topeka & Santa Fe Railway company, a corporation duly organized and existing under and by virtue of the laws of the State of Kansas (hereinafter designated the "Atchison company"), a party of the first part, and the City of Albuquerque, New Mexico, a municipal corporation duly organized and existing under and by virtue of the laws of the Territory of New Mexico (hereinafter designated the "city"), a party of the second part:

Whereas, the Atchison company is contemplating the erection of a hotel and passenger station and other substantial improvements upon its station grounds at the said city of Albuquerque, and

Whereas, the City has requested the Atchison company to construct a viaduct across the right of way and tracks of the Atchison company upon Coal avenue, one of the streets of said city;

Now, therefore, this indenture witnesses that the said Atchison company, on the one part, and the said city, on the other part, have agreed to and with the city, as follows:

First. To build, erect and construct, within the time hereinafter limited, a good and workmanlike manner and in accordance with the plans and specifications hereto annexed and made a part hereof, and marked Exhibit "A," a viaduct upon Coal avenue in the city of Albuquerque, over and

across the right of way and tracks of the Atchison company where the same cross said Coal avenue, and to furnish all labor and material therefor, and deliver said viaduct to the city free from all liens and incumbrances whatsoever for labor or materials, within the time so limited as aforesaid, such construction to be begun on or before the day of October 1, 1900, and to be completed, in all respects in accordance with said plans and specifications, on or before the day of December 1, 1900; Provided, however, that allowance shall be made for any delay in the completion of said viaduct caused by strikes, the elements or other causes, over which the Atchison company has no control.

Second. To build, construct and erect on the right of way of the Atchison company, between Railroad avenue and said Coal avenue in said city of Albuquerque, at the sole cost and expense of the Atchison company, and without any cost or expense whatsoever to the city, a modern hotel and passenger station, together with such appendages as the Atchison company may deem essential, and to furnish all labor and material therefor, and deliver said hotel and passenger station to the city free from all liens and incumbrances whatsoever for labor or materials, within the time so limited as aforesaid, such construction to be begun on or before the day of October 1, 1900, and to be completed, in all respects in accordance with said plans and specifications, on or before the day of December 1, 1900; Provided, however, that allowance shall be made for any delay in the completion of said hotel and passenger station caused by strikes, the elements or other causes, over which the Atchison company has no control.

ARTICLE II.

In consideration of the premises and of the benefits and conveniences to accrue to the city and the inhabitants thereof by reason of the building and construction of said viaduct and hotel and passenger station, and in further consideration of the covenants of the Atchison company hereto set forth and upon the condition of the faithful performance of the same, the city hereby covenants and agrees to and with the Atchison company, its successors and assigns, as follows:

First. To pay to the Atchison company, in good and lawful money of the United States an amount equal to one-half (1/2) of the entire cost of the construction of the viaduct and hotel and passenger station, and to each and every company, person or corporation which may hereafter own or be in possession of and operate the railroad of the Atchison company, as follows:
