DID NOT ADJOURN!

Congress Still in Session and at Work.

Great Ovation to Admiral Dewey in Ohio.

Connecticut Democrats Instruct Delegates for Bryan for President.

GOLD DEMOCRATS TO MEET.

Washington, June 7.—The house met at 10 o'clock this morning and adjourned. The legislative session to-day began at 12 o'clock.

At noon the legislative day of Thursday began. Many members who had already left for their homes, and there was danger of a quorum failing. Leaders on both sides could with difficulty persuade members to remain.

A bill was passed to amend the car company law so as to require railroads to report monthly under oath to the interstate commerce commission all accidents to their employees and make reports as to all collisions between trains. Cannon, on behalf of the conferees on the naval appropriation bill, formally reported another disagreement and moved that the house reconvene and consider the amendment which Cannon had introduced. The amendment provided for ocean surveys, including the waters of Porto Rico, Cuba and the Philippines, except the coast waters thereof.

Dayton of West Virginia, one of the supererogatory members, moved to reconvene and consider the amendment. This motion took precedence over that of Cannon. Dayton's motion was carried. The house at 3 o'clock considered the remaining items of the naval bill.

The house agreed to adjourn at 5 o'clock to-day.

Washington, D. C., June 7.—Congress adjourned at 5 p. m.

Great Ovation to Dewey.
Columbus, Ohio, June 7.—Admiral Dewey was conducted at 9 o'clock to the state capital, where the public awaited his coming. The drive from the hotel was amid a continuous ovation. From 9:30 until 11 the admiral greeted the public, there being a steady flow of people with outstretched hands. The event of the afternoon was a great parade in which 10,000 men marched.

Gold Democrats.
Indianapolis, Ind., June 7.—A meeting of the national executive committee of the gold standard democratic party has been called for this city, July 25. It is understood that the chief business will be to organize for the coming campaign and see that an independent ticket is placed in the field.

Committed suicide.
Chicago, June 7.—Thomas B. Correll, a well-known speculator on the board of trade, today shot himself in the head. His brother, Edward Correll, of New York, formerly one of the heaviest speculators on the board, is now in an insane asylum near New York. Despondency over Edward's condition, as well as financial reverses, is believed to be responsible for the attempted suicide. It is said the wound will prove fatal.

Connecticut Democrats.
Waterbury, Conn., June 7.—The Connecticut state democratic convention unanimously adopted a platform instructing the delegates for Bryan, and playing support to the platform of the Kansas city convention.

Taylor Declines.
Louisville, Ky., June 6.—The Evening Post prints a statement today under the signature of William B. Taylor, in which he announces that he will not be a candidate for the republican nomination of governor of Kentucky.

Colorado Democrats.
Denver, June 7.—The democratic state convention met here today to select delegates to the Kansas city convention. The first question to be settled was as to which of the contesting delegations from Arapahoe county

was entitled to seats. Much pressure has been brought upon State Chairman Smith to induce him to recognize one or the other faction in the temporary roll. A compromise was finally reached providing for a credentials committee of one from each county, to be chosen by the delegations, each faction from Arapahoe county being given representation. Col. H. E. Montgomery, of Crook county, was made temporary chairman, the credentials committee chosen, and a recess taken until 4 o'clock.

Senate Proceedings.
Washington, June 7.—When the senate convened at 11 o'clock to-day the conferees on the naval appropriation bill were still in session. On motion of Cockrell the senate began the consideration of private pension bills. Forty-eight such bills were passed.

At 12:45 Hale reported further disagreement on the naval appropriation bill, and moved that the senate instruct the conferees to report on the bill. The report and motion was agreed to. The senate took a recess until 2 o'clock.

An Ineffectual Attempt.
Chandler to obtain consideration of his resolution instructing the committee on elections to inquire into the constitutionality of the electoral laws of certain states. Berry of Arkansas and Pettus of Alabama simultaneously objected. At 11:45 the senate took a recess for an hour.

Fire at Fort Wingate.
At about 5 o'clock last night word was received here that the Post Exchange building and canteen at Fort Wingate, was destroyed by fire. The fire was caused by the explosion of a can of gasoline. A large quantity of provisions, which were stored in the canteen, was saved from destruction by the soldiers of the Ninth cavalry. The buildings were of wood, and owing to the scarcity of water, nothing could be done to check the flames. The total damage will amount to several hundred dollars.

J. W. Edwards Purchases the A. Simpson & Co. Undertaking Establishment.
The firm of A. Simpson & Co., the embalmers and funeral directors, this morning, sold their establishment on north second street to J. W. Edwards, an experienced undertaker of Newton, Kan. The sale has been pending for several days, and when the inventory was made to-day, it did not require much time to reach an agreement. Mr. Simpson has not definitely decided on his future occupation, but for the next few weeks will assist his successor in becoming acquainted with the people of this city.

Mr. Edwards, while an entire stranger in Albuquerque, comes here very highly recommended by members of the Commercial club and business men of Newton, Kan. He has been in the furniture and undertaking business for the past 25 years in Kansas, during which time he has occupied positions on the board of education and member of the city council. He is also a member in good standing in all branches of the Masonic order, I. O. O. F., Modern Woodmen of America and Knights of Pythias.

WAR IN AFRICA!

British Concentrating Forces at Pretoria.

Buller Armistice not Confirmed by Dispatches.

Strained Relations Between British Secretary and Gen. Wolsley.

WEST VIRGINIA DEMOCRATS.

London, June 7.—In the absence of anything from British sources enlightening the Boer statement that General Buller had requested a three days' armistice, military experts here are inclined to believe that a revised version of the story will show that General Buller summoned the federal to the conference and evacuate their positions within three days, failing in which, he will attack them.

According to a dispatch from London, the Boers under General Buller are now concentrating in the neighborhood of Matherly, twelve miles east of Pretoria.

The strained relations between the secretary of state for war, Lord Lansdowne, and the British commander-in-chief, Lord Wolsley, appear to have reached such a pitch that but for the exigencies of the situation Wolsley would have resigned. It seems Lansdowne attempted to assume some authority always heretofore wielded by the commander-in-chief, and the latter is now said to have laid the whole matter before Lord Salisbury.

West Virginia Democrats.
Parkersburg, W. Va., June 7.—The democratic state convention, which held three sessions yesterday and adjourned after midnight, re-convened this morning. The only nomination made last night was that of Judge Holt of Huntington, for governor.

Republican Nomination.
Weston, W. Va., June 7.—B. B. Doyen was nominated for congress by the republican convention of the first district.

Exciting Game.
The game to be played next Sunday afternoon between the Fats and Leans at the fair grounds is attracting widespread attention and will probably prove a great revelation to the younger enthusiasts of the sport. United States Marshal Forkner is in town and will occupy the position of short stop. If he don't do anything else, and it is learned that sheriff Hubbell will take command of the bat, while Uncle Jimmy McCortison will act as umpire. Unless Dr. Haynes presides as captain he will perform all the duties of the mascot. Barrels of ice water will be placed on third base for the benefit of the base runners only. The game will be called immediately after dinner.

QUALIFIED VOTERS.
Those Who Can Vote on Viaduct Bond Proposition.

Whereas, The city council of the city of Albuquerque, N. M., has ordered an election to be held on the 12th day of June, A. D. 1900, at which the question of the issuance of \$100,000 bonds, by the city of Albuquerque to pay half the cost of the construction of a viaduct along Coal avenue over the right of way of the A. T. & P. railway company, across said avenue, will be submitted; and

Whereas, Persons qualified to vote at said election, in addition to the ordinary qualifications, must be owners of real or personal property subject to be taxed for city purposes, and in order to have a full and complete ballot of all persons qualified to vote under the law authorizing the said election, the said city council has procured from the office of the assessor of Bernalillo county, N. M., a full list of all persons living in said city who own property, real or personal subject to be taxed for city purposes, a copy of which list is to be furnished the officers of said city as a proof of the qualifications of persons offering to vote.

Now, therefore, Be it resolved, that the city clerk of the city of Albuquerque be and hereby is, directed to deliver or cause to be delivered to the judges of said election in each ward, when the polls open on the 12th day of June, A. D. 1900, copy of said list of names; and

Be it further resolved, As a matter of instruction and direction to the officers of said election, that no person be permitted to vote whose name does not appear on the registration book used at the last city election in the ward where such person offers to vote, unless such person has moved into said ward within less than thirty days prior to the date of such last city election, or if having been a resident prior thereto and failed registering by inattention on part of himself or carelessness on part of registration board, then, upon satisfactory proof of such facts to the judges, he shall be entitled

to vote, and said officers are further instructed that, if persons offering to vote be found qualified electors including the last above additional qualification, then it shall be their duty to ascertain if same appear upon aforesaid assessment list, and if so it shall be sufficient proof of their qualification to vote; and

Be it further resolved, That any person found qualified as elector as above designated with the exception that his name does not appear upon the said assessment list, and who is the owner of property not so returned for taxation owing to the fact of its acquisition and sufficient proof to the officers of the election, and sufficient proof shall be in the case of real property a presentation of the deed of conveyance and personal property an affidavit in due legal form properly subscribed and sworn to before an officer qualified to take an oath; and

Be it further resolved, That the city clerk be and he is ordered, and directed to deliver a copy of this resolution properly certified by himself with the corporate seal of the city of Albuquerque to the judges of election in each ward of the city at the opening of the polls on the 12th day of June, A. D. 1900.

COUNTY COMMISSIONERS.
Thos. Crumpacker Reappointed—Other Important Business Transacted.

The board of county commissioners met at 2 o'clock yesterday afternoon in the court house with all members present. Following is the business transacted:

Cadet Thomas Crumpacker, who attended the Howell Institute last term, passed the examinations satisfactorily and proved himself an obedient and appreciative student, the county commissioners re-appointed him to again represent Bernalillo county in the coming term at the institute.

Manuel R. Armijo, having tendered his resignation as justice of the peace in precinct No. 17, the same was accepted by the board, and Estevan Baca was appointed to fill the vacancy.

Roman Baca and Felipe Bandoval were appointed custodians and caretakers of the new county bridge across the Rio Grande near Pena Blanca.

C. W. Graves was granted a franchise to place telephone poles along the sides of the highways in Bland and the Cochiti district.

The following resolution was adopted by the commissioners:

Whereas, The new bridge across the Rio Grande, opposite Pena Blanca, has been opened for traffic, therefore, the county commissioners of the county of Bernalillo seeing the necessity that the public road that approaches said bridge from both sides be convenient, and safe for traffic, it is ordered that the said public road that runs from east to west from Pena Blanca to the Cochiti mining district be changed and the main opened to the public, bearing at the arroyo, which is the outlet of the Santa Fe river on the south of said arroyo, traversing what is known as the old road, 60 feet wide from said point to the bridge.

The meeting then adjourned until the second Monday in July.

the Fourth of July than it has this
year.

The Territorial Fair will be held in
this city next September, and it will
be a big exhibition, lasting a whole
week.

The location of the capital is settled
permanently in Santa Fe, and a side-
walk should be built from the plaza
to the new capital.

The erection of the proposed railroad
improvements will add several hun-
dred thousand dollars worth of taxable
property to the city.

A feminine doctor in Arizona is
declaring that milkmen should be com-

Congress did not adjourn yesterday,
as was agreed. The house refused to
yield on the naval appropriation bill,
and adjourned until 9 o'clock to-day.

M. P. Stamm in the Journal-Demo-

up Albuquerque.

The New Mexican of last Tuesday
contains a valuable descriptive sketch
of Santa Fe and New Mexico. The
paper consists of twelve pages, neatly
printed and handsomely illustrated.

The Territorial University is closing a
week's interesting exercises. The term
just closing has been a most successful
one under the faithful work of Presi-
dent Herrick and his excellent assist-
ants.

Out of 17,000,000 pieces of registered
mail handled annually, the loss has
been one-thousandth of 1 per cent and
in the transmission of ordinary letters
the loss is but seven-thousandths of 1
per cent.

The fashion of foreign governments
owning their embassies or legations in
Washington is spreading. Both the

FROM DURANGO TO ALBUQUERQUE.
The proposed railroad to connect Dur-
ango in this state with Albuquerque,
in New Mexico, if completed, would be
the fulfillment of a dream in which the
people of those states have indulged for
years, says the Denver Republican.

As a practical project it has been dis-
cussed almost ever since the wealth of
the San Juan gave rise to Durango,
and the new city of Albuquerque was
founded along the Santa Fe railroad
within a mile or so of the ancient
adobe town of the same name—events
which occurred about nineteen years ago.

The entire northwest quarter of New
Mexico, is practically without a rail-
road. The San Juan line of the Rio
Grande runs for a short distance south
of the Colorado line, but even there
is clearly a Colorado road. The pro-
posed road would cut that part of New
Mexico almost directly from the north-
western to the southeastern corner. It
would open up a country of which few
people have anything other than
vague information. It is a high table-
land, the geological strata of which lie
nearly flat. There is, therefore, little
reason to believe that it will be found
to be rich in mineral, except, it may be,
along its boundaries. There is no ques-
tion, however, that it is a good stock

NEW MEXICO MINERAL PRODUCTS.

Figures that for Well-Known Reasons are in Part Misleading.

The Engineering and Mining Journal this week published the following figures on the silver production of New Mexico the past few years: 1906, 700,000 troy ounces, valued at \$460,700; 1907, 550,000 ounces, \$350,250; 1908, 425,000 ounces, \$265,625; 1909, 425,000 ounces, \$265,625. In 1909 it stood 8th among the silver producing commonwealths but of the 450,000 ounces credited to Texas, a considerable part is credited to the silver mines of the El Paso smelter which produces the El Paso smelter receives much of its ore from New Mexico. The same way Colorado is credited with the silver from New Mexico ore treated at Pueblo, Denver and other smelters. The total production of the United States last year was one-third of the total production of silver in the world.

The Engineering and Mining Journal also gives figures on gold production which do not do justice to New Mexico, owing to New Mexico ore being treated at the Pueblo, El Paso and other smelters outside of the territory. New Mexico is credited with the following: 1896, 23,017 ounces of gold, valued at \$745,800; 1897, 23,738 ounces, \$745,800; 1898, 23,222 ounces, \$745,800; 1899, 21,000 ounces, \$660,000. This puts New Mexico 12th among gold producing commonwealths. The total gold production of the United States was 1,814,000 ounces, which is over one-fourth of the gold produced in the world.

The figures of coal production are also given. In 1898 New Mexico is credited with 862,582 tons valued at \$1,416,000, and in 1899 with 1,049,825 tons valued at \$1,888,000. This puts New Mexico 19th as a coal producing commonwealth. The total production of coal in the United States was 252,115,387 tons valued at \$276,147,000.

MUNICIPAL AFFAIRS.

City Council Appoints B. Ruppe the
Chief of Paid Fire Department.

OTHER IMPORTANT BUSINESS.

Last night the city council met in
regular session with W. C. Leonard
presiding. All members of the council
were present except Mayor Marron,
Aldermen Burkhardt and McKee.
Minutes of the previous meeting were
approved as read.

A number of claims and accounts
were presented which were referred to
their respective committees for exami-
nation.

Tax Commissioner E. T. Cartledge,
of the A. T. S. railroad company,
submitted his tax report which shows
the amount of property subject to tax-
ation as follows:

19 miles main track, \$9,685; 9.15
miles side track, at \$100 per mile,
\$915; 1.49 miles telegraph line, at \$45
per mile, \$67; buildings of all descrip-
tion, \$7,320; tools, material, machinery,
fuel, etc., \$250. Total valuation
as returned for 1900, \$22,512.

City Clerk Medler reported a total of
collections for the month of May of
\$771.25.

For the month of May the amount of
fines collected and turned over to the
treasurer by Marshal McMillin was
\$432. The number of arrests made were
108 and the number of meals served
were 145.

City Treasurer L. H. Chamberlin re-
ported a balance on hand on June 1,
of \$9,351.42.

The sewer committee report advised
the council that the Doherty company,
submitted his report for the construction
of a sewer, which the council and
met the approval of the council and
was adopted.

The street committee made its report
favoring the grading of portion of
South Fifth street. Adopted.

Following is the report of the fire
committee, which was adopted:

We recommend that the volunteer
fire companies of the city be abolished,
that our hose carts and hose and all
fire apparatus belonging to the city be
consolidated as our hose house at the
city hall as soon as room is provided
for them.

We further recommend the organiza-
tion for a paid fire department, which
shall include a chief of fire department
at a salary of \$100 for the first year,
two men as firemen who shall give all
their time to the service, the wages to
be \$45 and \$60 a month; 20 men shall
be enlisted as firemen, whose duty shall
be to serve the fire department at all
times, four of the men shall be lodged
at the hose house; they shall receive
\$40 a year each for their services.

We also recommend the purchase of
one pair of horses, a set of harness,
two ladders for the department. It is
also recommended that the hose house
at the city hall be enlarged and made
convenient for men and horses and
room for all the hose, carts and fire
apparatus belonging to the city.

As soon as our fire companies prop-
erty is sold, the city hall shall be used
as a station, we recommend that our
hose, which are now leased for two
or three years, shall be put in condi-
tion to replace.

The following resolution bearing on
the report of the fire committee was
passed:

Whereas, the fire committee of the
city council, having submitted a report
recommending that the volunteer fire
companies of the city be abolished, and
the city of Albuquerque be reorgan-
ized, and outlining the proper method
for such reorganization; therefore be it
resolved, That the city of Albuquerque,
consisting of the fire departments of
the city of Albuquerque, consisting of
hose companies Nos. 1, 2 and 3, and
hook and ladder company No. 1, be and
the same are hereby abolished, and the
fire department of the city of Alber-
querque is hereby directed to deliver up
to the chief of the department, when re-
organized, all rubber coats, boots, hose,
hose carts, ladder truck, buckets, axes
and all other paraphernalia pertaining
to said fire companies and department;
be it further

Resolved, That it is the sense of the
city council, owing to the rapid growth
and advancement of the city, that the
property interests require the main-
tenance of a paid fire department, to
consist of a chief and at least 20 men,
to receive such compensation as the
council shall fix; and it is further re-
solved, That the city council of the
city of Albuquerque hereby tenders
its thanks to the volunteer firemen
who have devoted their time and
services to the city in the past without
compensation for their devoted and ef-
ficient work as such volunteer firemen.
City Clerk Medler was ordered to fur-
nish the judges of the court of the
viaduct question a copy of the names
of persons entitled to vote next Tues-
day.

An ordinance relating to the duties
of the fire chief and members of the
fire department, was read and passed
under suspension of the rules.

Acting Mayor Leonard then appoint-
ed B. Ruppe as chief of the city fire
department. L. H. Chamberlin as ex-
treasurer of the fire department, which
was confirmed by the council.

A special committee, consisting of
Aldermen Rodgers, Wright and Steyer,
was appointed to ascertain the cost
of remodeling the hose house on North
Second street, and to report at the next
regular meeting.

SHEEP SANITARY BOARD.

Stringent Measures Passed to the Sheep Growers of New Mexico.

A regular meeting of the Sheep Sanitary board of New Mexico met this morning at 10 o'clock at their rooms in the N. T. Armistead building. Those present were Hon. Sol Luna, president; H. W. Kelly, of Las Vegas, and Harry F. Lee, secretary. Vice President W. S. Prager of Roswell, being absent.

New bills were read and ordered passed by the board.

A circular order was issued to all sheep growers of the territory, notifying them that all sheep which show signs of having scab must be dipped twice, ten days apart. The sheep owners who neglect to comply with this order and whose sheep have scab after the first day of August of this year, will be subject to a heavy fine.

The Bureau of Animal Industry of the United States have employed a corps of inspectors to New Mexico to see that no sheep will be allowed to leave this territory that have any signs of scab.

Elopers Arrested.

Late yesterday afternoon Marshal McMillan received a telegram from Constable W. A. Smith of Gallup, requesting him to arrest John Whelan and Mrs. Lizzie Waechelwitz, a couple who eloped from the Carbon city on Tuesday evening. 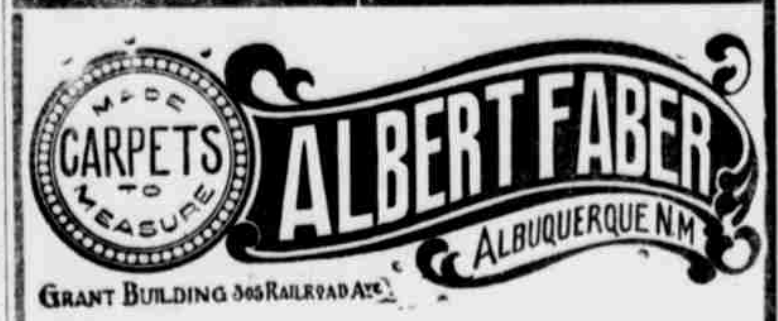
