### BRITISH ADVANCE!

#### Hamilton Occupies the Town of Nealwika.

He was Opposed at Every Step.

Assassin Tries to Kill the Premier of Cape Town.

AID FOR UTAH MINE SUFFERERS.

London, May 5.—Lord Roberts reports to the war office under date of Bradford, May 4: "Hamilton advanced yesterday to the town of Nealwika. He engaged with the enemy throughout his march. He speaks in terms of praise of the behavior of the troops, especially of the behavior of the brigade of cavalry and the mounted infantry."

Lord Roberts Moving.

London, May 5.—Lord Roberts is evidently losing no time in following up the occupation of Bradford. His whole force is apparently moving on Wynburg. The place mentioned in Roberts' dispatch to the war office this morning as "Nealwika" cannot be found on the maps. It is likely that it is a cable error for "near Wetzkop" in which General Hamilton seems to be, midway between Wynburg and Wynburg, and he has thus got between Wynburg and General Oliver's command from Wynburg, which is in occupying Thaba Patshos. Between Thaba N'Chu, Ladybrand and Wynburg the country is rough and suited for the Boer tactics, so the British are liable to be considerably harassed before they capture a stronghold. Experts differ as to which of the Boers is bound towards Kromdrif or in the direction of Bethlehem, the terminus of the line joining the Natal railroad at Van Rensburg's pass. The capture of that place would probably compel the Boers to leave the Drakenburg range and thus open the way for General Buller's advance. The British will have to repair the bridge over the Vet before they can cross the Drakenburg and Wynburg becomes available.

Aid for Utah Mine Owners.

Salt Lake, May 5.—In response to inquiries and financial assistance for the victims of the Utah mine disaster, Governor Wells will issue an address stating that contributions will be most gratefully received from the people everywhere and all subscriptions should be sent to James T. Hammond, secretary of state, chairman of the central relief fund. The governor will designate Spencer, Trask & Co., of New York, as the eastern collection agency.

Commander of the Philippines.

Washington, May 5.—An order was issued by the war department yesterday relieving General Otis of command of the division of the Philippines, and assigning General MacArthur thereto, and concludes as follows:

"Major General Otis is relieved from command only in compliance with his own expressed wish. The president directs this order to record his high appreciation of that officer's distinguished successful service in the Philippine islands in both civil and military administration. The president directs that he be accorded the highest honors and gratitude and honor from his country."

General MacArthur, in addition to his duties as commander, will exercise authority as military governor of the Philippines.

Shot the Policeman.

Cape Town, May 5.—The South African News says the policeman guarding Premier Schreiner's house has been shot. The policeman was smoking a cigar at the time, upon which fact is based the assertion that the bullet evidently was intended for the premier, who is an inveterate smoker.

BUILDINGS AND STOCK INSURED.

In Peralta canyon in the Cochiti district a very rich strike was made recently by J. A. Tucker and his brother on one of their mineral claims. Surface rock on the lead was given to three assayers and it was found to contain values from \$20 up to \$114.90 in gold and silver. The character of the rock is a sugary quartz, and the walls of the great vein have been found to be of pure green talc. The general trend of the lead is northwest and southeast, and without a doubt is unquestionably the greatest proposition ever unearthed in the Cochiti.

In the bankruptcy case of F. W. Hamm, an order discharging bankrupt from all debts was made this morning.

Kansas City Cold Storage company vs. Herman Block, judgment rendered against garnishees, Maloy, Pratt & Co. and Clothing & Co., for amounts of money belonging to defendant in their hands. Some time ago a judgment was entered against the defendant in the sum of \$100.

George W. Stubbs vs. Katharine B. Stubbs, decree of divorce granted.

TRYING TO SAVE HIS NECK.

An effort is being made to have the death sentence of Jose P. Ruiz, the murderer of the boy Patricio O'Bannon, commuted to life sentence in the territorial penitentiary.

Summers Burkhardt, the attorney who represented the unfortunate murderer, assisted by several ladies, are at work on the commutation sentence.

Judge J. W. Crumpacker, before whom Ruiz was tried and found guilty of murder in the first degree (the case being appealed to the territorial supreme court and the verdict of the lower court affirmed) was seen this morning by The Citizen representative and he stated that he would positively decline to interfere in the carrying out of the order of the supreme court as to the hanging, that he considered Ruiz a cold-blooded murderer, and that he purposely, and in a reckless manner, shot into the group of little children for the purpose of murder, killing one little innocent child and wounding another with a deadly bullet across the back of the neck.

The citizen also understands that Governor Otero will not interfere.

As stated in The Citizen yesterday afternoon, the supreme court set the day for the hanging on Friday, June 1. In accordance with a territorial law on the subject the hanging will be private, that is, only a certain number, about twenty-five, will be invited to witness the hanging.

#### Americans Conquer a Philippine Island.

St. Louis Whoops it Up for Admiral Dewey.

Appropriation Secured to Re-Establish Fort Whipple, Ariz.

WEEKLY BANK STATEMENT.

Manila, May 5.—Col. Hardin's expedition recently landed two companies of the 24th infantry on the island of Martinique. The troops already have taken four towns without opposition, and a few armed insurgents were encountered taking to the mountains. Leaving one company to garrison the island, the expedition proceeded to Maabete. The cable to the southern islands is broken, and details of recent fighting are not obtainable at present.

Dewey Celebration.

St. Louis, May 5.—The celebration in honor of Admiral and Mrs. George Dewey was practically concluded today with a military and civic parade, including organizations from all parts of the state.

The parade in which nearly one hundred organizations took part, was witnessed by hundreds of thousands of people, who gave the admiral an enthusiastic greeting all along the line of march.

Bank Statement.

New York, May 5.—Surplus reserve decreased \$1,500,000; loans, increased, \$1,222,400; specie, increased, \$2,100,000; legal tenders, increased, \$1,100,000; deposits, increased, \$17,000,000; circulation, increased, \$39,800. Banks hold \$15,978,415 in excess of requirements.

### A WIFE'S LETTER.

It Gave a Clue to Her Husband and He Was Arrested.

STOLE GRUNSFELD'S BLACK HORSE.

Under Sheriff Newcomer left last night for Pineville, Mo., with a warrant in his pocket for the return to this city of one Richard Nichols. En route he stopped over in Santa Fe today, to secure requisition papers from Gov. Otero on the governor of Missouri, and hopes to have Nichols behind the bars of the Hernaldo county jail inside of a week.

The story of Nichols' downfall and his arrest, all brought about by a loving, but innocent wife, who wished to know her husband's whereabouts, is about as follows:

On the night of April 8, Grunsfeld Bros' big black delivery horse was stolen from W. L. Trimble & Co.'s red barn, and one of the employees at the barn, known as "Tex," was missing.

On the morning of the 9th, a man with a Winchester and a six-shooter showed up at Camp Whitcomb and secured breakfast. A short time after breakfast he scanned the country round about and seeing no signs of officers, (although a posse of deputy sheriffs had left this city on his trail) mounted the black horse and rode off down the small mountain road and thence along the main road to the town of Tijera, passing through that town about 9 o'clock on that morning where the clue was lost.

However, his wife wanted him. Nichols had written to her, back in his home at Tiff City, Mo., from this city, that he would leave here on March 22 for home, riding a black horse and with plenty of money in his pockets, and that on route through the country he would stop long enough at towns to write her letters. Subsequent events show that he did not get away until the night of April 8, and he failed to write, according to his letter, to his wife.

The wife knew that her husband was in Albuquerque and that he worked for W. L. Trimble & Co. She grew uneasy about him; thought that he had been waylaid, robbed and murdered while on his lonesome ride to Missouri, and requested Mr. Trimble to assist her in locating her husband.

This wife's letter was the link needed in the capture of the horse thief, for up to that time the Trimble's did not know the man's name nor his home, believing that the fellow was from Texas and hence they called him "Tex."

have been advanced. Carpenters' wages at Minneapolis have been advanced to 34 cents per hour. At St. Paul, Minn., bricklayers and stone-masons have now an eight-hour day, with an advance of 5 cents an hour in wages. About half the employers at Duluth have given an increase of 5 cents an hour to painters and decorators. Copper miners got a 10 per cent increase at Houghton, Mich. At Spring Valley, Ill., the coal miners and operators have been granted an eight-hour day, with an advance of 25 cents an wage, while their helpers get an advance of 15 cents per day. Prosperity continues to extend among the wage-earners of the country.

Those who insist that our patriotism comes from abroad will not find much to sustain their assumption in the classification of the persons who received outdoor relief in Indiana last year. According to nationality, 18,837 were natives of the country, 1,400 were Irish and 2,862 were Germans.

## TERRITORIAL SUPREME COURT.

Opinions Handed Down in Several Important Cases—Cases Submitted.

The territorial supreme court, with Chief Justice Mills presiding, and Associate Justices Crumpacker, McFie and Parker present, resumed its McFie Thursday morning at 10 o'clock. The case of the United States of America, appellant, vs. The Rio Grande Dam and Irrigation Company, appellee, was concluded and the case submitted. Hon. W. B. Childers, United States attorney, represented the government. Judge A. B. Fall, of Las Cruces, and John Franklin, of El Paso, appeared for the appellee. The case of the Elephant Butte dam case.

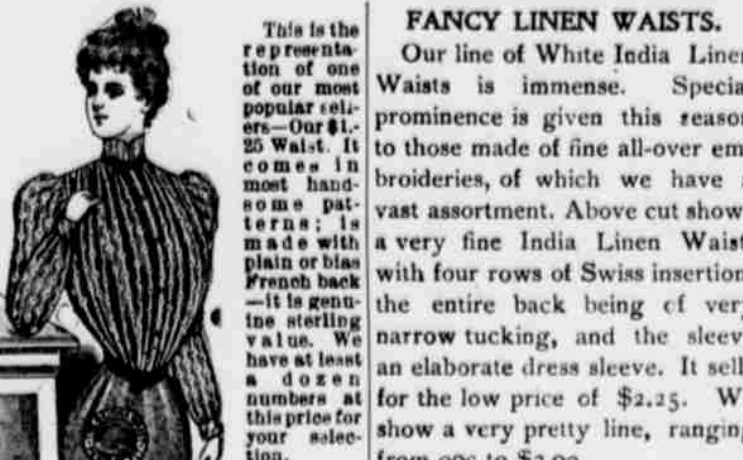

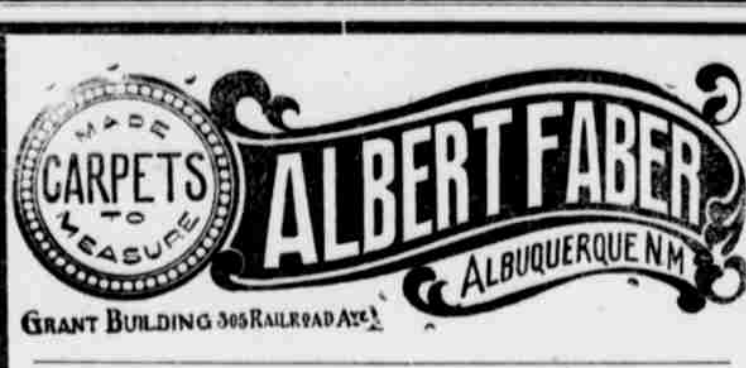

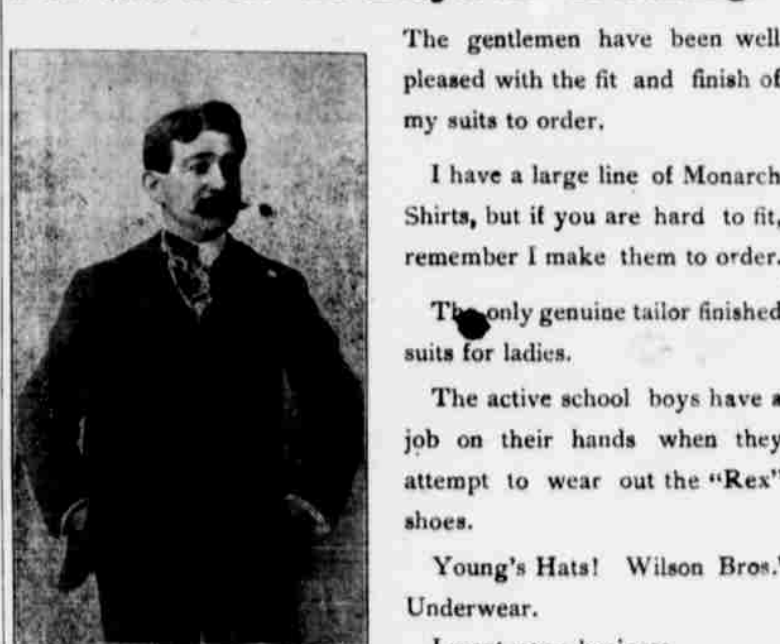
