## BRITISH ADVANCE!

Their March Unopposed by Boers.

Miss Parnell is Mad at Queen Victoria.

Kentucky Legislature Met Without Molestation from Militia.

IMPORTANT SUPREME COURT DECISION.

London, Mar. 12.—At the present rate of progress Lord Roberts should be in Bloemfontein on Wednesday next, though all indications may be upset by development of more strenuous resistance than the Boers so far have attempted. The distance between Lord Roberts and the Free State capital is now so small—only about twenty-five miles—it is apparent that the Boers either contemplate making a determined stand on the outskirts of the town, or for strategic reasons will allow Roberts to occupy it after merely harassing his advance.

The commander-in-chief's latest dispatch, announcing General Gatacre at Beithull bridge, and special saying that Gatacre commands the bridge approaches, put the Boers in that vicinity between two British forces. Aasvogel Kop, where Roberts sent his latest cable message, being one hundred miles almost due north of Beithull. However, there is a large plain between them and the main body of Boers now confronting Roberts, with its cautious activity, may be quite able to recover the retreat of the burghers confronting Gatacre. Once the British are in control of the railroad from Beithull to Bloemfontein, the junction at the Free State capital of General Gatacre and Roberts would be a matter of a few days.

Commenting on the fact that Roberts found the Boers holding positions in a part of the country supposed to have been left open, the St. James Gazette says: "No more damning indictment was ever preferred against any cavalry."

rumors of the relief of Mafeking continue to circulate, but full of confirmation.

From Natal, which Buller erroneously declared was free of Boers, and from Cape Colony, where General Kitchener's stern hand is upon the rebellion, there is no news of importance.

Miss Parnell is Mad

Dublin, Mar. 12.—Miss Anna Parnell, sister of the late Charles Stewart Parnell, has published the following letter:

"Since the queen, whose Irish soldiers hitherto have been punished if they ventured to sport the shamrock, has now ordered them to wear it, as a token of their degradation, it seems to me that those Irish who do not wish to be identified with the robber lord in South Africa should take some notice of this insult to their little island, whose very humbilities might have protected it from the queen's oppressor. I suggest that those who can not refrain from wearing the shamrock should dip it into ink until the shamrock is dyed black by the first triumph of the Boers, or in some other way."

Frankfort, Ky., March 12.—In anticipation of a possible attempt by the state troops to prevent the meeting of the legislature, a crowd gathered around the state house square, but the members of the legislature were allowed to meet without molestation. A squad of militia, under Lieut. Penke, who started for London on Saturday, as escort for Secretary of State Powers and Captain Davis, were obliged to surrender to officers at Lexington and returned this morning. No other reinforcements have arrived.

Newark, March 12.—Fifteen persons, the majority children, were smothered and burned to death in a tenement house on Morris and Fourteenth avenues this morning. Thirteen bodies have been recovered from the ruins within three hours after the flames were extinguished. ## PIONEER DEAD!

L. B. Putney, Pioneer Wholesale Merchant.

His Death Occurred at Topeka, Kansas.

City Mourns the Loss of One of Its Best Men.

FUNERAL TO-MORROW MORNING.

Lyman Beecher Putney died at Topeka, Kansas, yesterday morning after an illness of a few months, and in consequence there is universal sorrow throughout this city and the southwest.

For the past few days the end to this long life of general usefulness was expected, and being anxious to gain the latest bit of information from the sick chamber of his father, Robert E. Putney wired for facts to Dr. J. P. Kaster, last Saturday. The doctor promptly answered and wired as follows:

"Topeka, Kansas, March 10.—Father failing rapidly; can hardly survive the night."

The son knew by this brief message that the dissolution of life was approaching, and he wanted to see his father once more alive and he telegraphed to Dr. Kaster asking whether he should make the trip to Topeka, and would his father be alive on his arrival.

In response thereto came the following message from the bereaved wife yesterday afternoon:

"Topeka, Kansas, March 11.—Father died this morning; leave for home at noon Sunday with the body. Albuquerque, for it removes from the business circles of the city one of the pioneers of mercantile life—a man whose life is a written honor is given."

and one whose integrity, straightforwardness and business principles are words throughout the southwest.

SHORT SKETCH OF HIS LIFE.

Lyman Beecher Putney was born in New York, in 1832, and was therefore 68 years old. He left his old New York home when quite young to "go west," and when he reached Lawrence, Kansas, he had accumulated enough funds to engage in business there. He was enjoying a thriving trade when Quettrell and his guerrillas raided the town and he lost everything.

In 1866 the firm of Moore, Bennett & Co., of which the deceased was a member, was established at Lawrence, and several years later the Santa Fe railway company commenced building west and southwest. The firm followed the railroad, and first established a store, with Lawrence as headquarters, at Trinidad, thence at Haton, Las Vegas, Albuquerque and San Marcial, leaving a branch store at each of the places named. Finally, when the railroad had penetrated into the Rio Grande valley, all the branch stores were withdrawn and the immense business of the firm was concentrated at this city.

This was in 1879, and about a year later Mr. Putney purchased the interest of his two partners, and he retired shortly from the territory and he remained to help build up the country and at the same time continue to increase his own business.

The old frame store building—which is indeed one of the landmarks of Railroad avenue—was moved to Albuquerque in sections from Las Vegas after the firm had consolidated all their business interests in New Mexico at this city.

The deceased was married to Miss Jennie Coleman (the devoted and faithful wife that survives him) at Waukegan, Wis., in 1868, and besides her he leaves to mourn his death Robert E. Putney, the only son and child. It is understood that a brother resides somewhere in the west, but the deceased had not heard from him for many years.

FUNERAL ARRANGEMENTS.

The remains will arrive from Topeka on the No. 1 passenger train which will reach this city at 7:55 o'clock this evening, accompanied by Mrs. Putney and possibly by Dr. and Mrs. Kaster. The remains will then be turned over to Undertaker Strong and conveyed by him to the residence of the bereaved son, Robert E. Putney, No. 617 West Cooper avenue. The funeral services will be held at the residence mentioned, at 10 o'clock to-morrow (Tuesday) morning, conducted by Rev. T. C. Beattie. The music will be furnished by a male quartette which will be organized by Prof. C. E. Hargis. The following pall-bearers have been selected: Gov. E. S. Stover, O. N. Marron, A. J. Mayo, Noah Hild, John A. Lee, of this city, and John Becker, of Belen. All friends are invited to attend the funeral services, which will be followed with burial in Fairview cemetery.

SIMPLY BRAG.

The Anti-Imperialists, Hosts of their Strength in This Country.

New York, March 12.—A special to the Times from Boston, says: Irving Winslow, secretary of the anti-imperial league, says that between 2,000,000 and 3,000,000 will vote against the administration and support anti-imperialism as a strictly defined issue in the coming campaign. "We will probably have a regular delegate convention three weeks succeeding the regular conventions," said Winslow, "and will then select a standard-bearer and platform, probably in a way conforming to the already existing platform and already nominated candidates. The Puerto Rican tariff has had the effect of cutting the republican party in two. Puerto Rico is only the beginning of the difficulties we predicted."

IDEAL RIOTS.

More Testimony Relating to the Confrontation of the Riot.

Washington, Mar. 12.—L. J. Simpson, electrical engineer of Warner, Idaho, testified in the Court of Appeals today. He said he did not participate in the riot, but soon after was arrested by the United States troops, who went about the streets arresting persons pointed out by Hunker Hill mine "spotters." He detailed the outrages alleged to have been committed by the soldiers. He said he was taken from the bull pen by a squad of four soldiers and marched to an open enclosure where he was placed with his back against a building. The soldiers cocked their guns, apparently making ready to shoot him. At this point, a high official of the Hunker Hill mine appeared and said they had evidence enough to hang the witness or send him up many years, but if he would tell who blew up the mill he would be turned loose. Simpson protested that he did not know who the guilty parties were and the effort to get evidence from him was finally given up. Witness stated that at another time, while in the bull pen, he was offered \$100 to implicate two persons in blowing up the mill. One was the county assessor.

## THEY DISAGREE!

London, Mar. 12.—The war office issued the following dispatch from Aasvogel Kop, under date of March 12, 5:25 a. m.: "We were unopposed during the march yesterday. Officers 1 left at the last camp to record the list of casualties have not yet arrived. The following additional casualties are known, however: Killed—Lieutenant P. N. Parsons, and A. B. Codrington, Essex regiment. Wounded—Lieutenant C. Borsley (severely), Lieut. Arm and G. H. Balingh. General state reports that he was within a mile of the Bethulle railway bridge yesterday. The bridge was partially destroyed, the enemy holding the opposite bank."

New York, Mar. 12.—A special to the Herald from Washington says: "All attempts to unite the republicans of the senate in a compromise on the Puerto Rican bill thus far have failed. Aldrich and other members of the steering committee are trying to bring about an agreement, but Foraker is still unwilling to go any further than to accept an amendment allowing all food products to be imported into Puerto Rico from the United States free of duty. He is not inclined to yield the management of his bill to the steering committee. A compromise advocated by some senators is to have the pending bill amended by cutting the tariff feature entirely loose from the general government bill, and attaching it to the Puerto Rican relief appropriation bill, so amended as to permit all imports from the United States into Puerto Rico free of duty and reduce the duty on Puerto Rican goods imported into the United States below the proposed 15 per cent. Dingley rates. Senators and representatives continue to receive letters and telegrams urging that the original recommendation of the president be adopted and that free trade be given to the island."

Sheldon's Religious Paper.

Topeka, Kas., March 12.—Rev. C. M. Sheldon, who edits the Topeka Capital this week, had a conference this morning with visiting correspondents, promising to give them such information as he could during the week. At 11 o'clock he met the working force on the paper, and gave out instructions for the day.

New Mexico exports annually about  
ten million dollars worth of sheep, cat-  
tle, wool and other products.

Kentucky will be heard from this  
week in the shape of armed conflicts  
between the opposing political forces.

The opening of the first electric line  
in Mexico was marked by the coinage  
of a new Spanish word—*motocicleta*, for  
motorcar.

The production of aluminum in the  
United States last year did not greatly  
exceed that of the previous year when  
the output was 5,300,000 pounds.

The present high price of lumber  
and its future scarcity has caused  
architects to study how to build with  
the use of the least possible lumber.

The Santa Fe company has prac-  
tically decided to engage in the ice  
manufacturing business and will build  
a big manufacturing and storage plant  
at Newton.

The information comes from Tacoma  
that wool growers of South Dakota,  
Wyoming, Utah, Washington, Mont-  
ana and Colorado are combining them-  
selves into an association to maintain  
prices and protect their mutual inter-  
ests.

The march of the British to Bloem-  
fontein is over a treeless plateau about  
4000 to 4500 feet above the sea. There  
is little water found along the direct  
route. The distance from Kimberley to  
Bloemfontein is 37 miles, and from  
Paarde Drift to Bloemfontein it is  
about 50 miles.

To make its drainage canal a naviga-  
ble water way to connect Lake  
Michigan with the Gulf of Mexico,  
Chicago is already considering the  
question of spending \$25,000,000 for  
dredging 299 miles of the Illinois river  
to secure enough depth of water for  
light-draft vessels.

In 1840 Harriet Martineau visited the  
United States and reported seven oc-  
cupations only open to women—teach-  
ing, needlework, keeping boarders,  
working in the factories, typewriting,  
bookkeeping and household service.  
Now there are about 400 occupations  
in which women are employed.

Two-thirds of the world's sugar is  
now produced from beets. Prior to  
1871-72 the world's production of beet  
sugar had reached a million tons; in  
the present crop year it is, according  
to latest estimates, 5,510,000 tons, while  
the cane sugar crop which in 1871-72  
was 1,599,000 tons is in the present year  
2,904,000 tons.

Judge Henry Clay Caldwell, of Arkan-  
sas, who is talked of by some as a  
running mate for Bryan, was ap-  
pointed to the United States district  
court of Arkansas by Lincoln in 1864,  
and held the place for 26 years. He  
was made a circuit court judge by  
President Harrison. He was born in  
West Virginia, but grew up in Iowa,  
and was colonel of the Third Iowa  
cavalry in the war of the rebellion.

**TRUSTS IN AUSTRIA.**  
Austria is in the field for the forma-  
tion of many large combinations or  
trusts in various lines of manufacture  
and recent advances from our consuls  
in that empire show that the hat mak-  
ers have combined that the paper  
mill have consolidated or effected a  
price agreement, that the producers of  
sugar and saccharines have a close or-  
ganization and are discussing an ad-  
vance in price, that the shoe manu-  
facturers have effected a compact  
consolidation and that a single corpa-  
ration is acquiring all the gas plants  
throughout the empire.

Those who assert that the protective  
tariff in the case of all the trusts or  
combinations will find themselves "up  
against it" in Austria. There is no  
protective tariff in the empire of  
Francis-Joseph except on a very few  
articles, cigars and tobacco for ex-  
ample, tariff in which is a govern-  
ment monopoly. Yet the trusts exist  
in Austria, they are steadily increas-  
ing in numbers and they are pursuing  
the same course adopted by the trusts  
in the United States. The free traders  
who assert that "protection is the  
mother of trusts" will have to "guess  
again."

**TO BE SENT TO ST. HELENA.**  
There is a dramatic touch to the  
news from London that Cronje and his  
gallant men are to be sent to lonely  
St. Helena (there to remain as prisoners  
till the close of the war). That not  
only the Boer general, but also his  
men are to be deported to this prison,  
2,000 miles from Brazil and 1,400 from  
Africa, with Anderson island, its  
nearest neighbor, 700 miles away, is a  
great compliment to the prisoners. The  
fact, also, that it is announced no pris-  
oners will be exchanged is a still fur-  
ther tribute to the valor of an enemy  
which has tested British courage and  
generosity more severely than it has

St. Helena is an admirable prison

of the world. Whether or not English  
military authorities wish to compare  
Cronje with Napoleon, the association  
in fame will be an honorable one to  
the man whose presence in Africa is  
evidently regarded as dangerous to  
British interests. The island itself is  
only about 45 square miles in area, and  
from its rugged nature cannot accom-  
modate a great army of prisoners. It  
will probably be large enough, how-  
ever, to hold all the Boers the English  
may capture before the end of the  
war—which, at the present rate of  
Lord Roberts' advance, seems to be  
now at the beginning of the end.

**OFFICIAL CIRCULAR.**  
Regulations Governing Use of Timber on  
Public Mineral Lands.  
Department of the Interior, General  
Land Office, Washington, D. C., January  
12, 1900.—By virtue of the power  
vested in the secretary of the interior  
by the first section of the act of  
June 3, 1897, entitled "An act author-  
izing the citizens of Colorado, Nevada  
and the territories to fell and remove  
timber on the public lands for mining  
and domestic purposes," the follow-  
ing rules and regulations are hereby  
prescribed:

1. The act applied to the states of  
Colorado, Nevada, Montana, Idaho,  
Wyoming, North Dakota, South Da-  
kota and Utah, and the territories of  
New Mexico and Arizona, and all other  
mineral districts of the United States.  
2. The land from which timber may  
be felled or removed under the pro-  
visions of this act, must be known to be  
of strictly mineral character and  
subject to entry under the mining  
laws of the United States except for  
mineral entry. Parties who take  
timber from the public lands under  
assumed authority of the act, and  
without having secured the necessary  
rights, are liable to prosecution under  
the provisions of this act.

3. The privileges granted are con-  
fined to citizens of the United States  
and other persons, bona fide residents  
of the states, territories and other  
mineral districts, provided for in the  
act.

4. The uses for which timber may  
be felled or removed are limited by  
the wording of the act to "building,  
agricultural, mining, or other domestic  
purposes."

5. No timber is permitted to be  
felled or removed for the purposes of  
sale or traffic, or to manufacture  
therefrom lumber or other timber pro-  
duct as an article of merchandise, or  
for any other use whatsoever, except  
as defined in section 4 of these rules  
and regulations.

6. No timber cut or removed under  
the provisions of this act may be  
transported out of the state or territory  
for smelting purposes, smelting being  
a separate and distinct industry from  
that of mining.

7. No growing trees of any kind  
whatsoever less than eight inches in  
diameter are permitted to be cut.  
8. Persons felling or removing tim-  
ber under the provisions of this act  
must utilize all of each tree, except that  
which can be profitably used, and must dis-  
pose of the tops, brush and other re-  
fuses in such manner as to prevent  
the spread of forest fires.

9. These rules and regulations shall  
take effect February 15, 1900, and all  
existing rules and regulations hereto-  
fore prescribed under said act, in con-  
flict with these, are hereby rescinded.
