## VIOLENT STORMS.

Rage in All of the Northwest-  
ern States.

Great Loss Results to Life, Property  
and Crops.

Trains Are Wrecked in Washouts and  
Many People Killed.

CHICAGO AND SUBURBS FLOODED.

Chicago, May 29.—Since last Friday Nebraska, South Dakota, Iowa, Wisconsin, Minnesota and northern Illinois have experienced a series of the most violent storms ever known in years, resulting in the loss of nearly a dozen lives and doing damage to property and crops that will run into the hundreds of thousands. In Nebraska, South Dakota and Iowa, tornadoes laid waste large sections of the country, converting hundreds of farm houses into kindling wood, killing stock and tearing up trees like weeds. In many other sections violent wind, rain and hail storms, accompanied by terrible lightning have been experienced.

Yesterday tornadoes were reported from Hastings, Central City and Beatrice, Neb.; Keosauqua, Iowa; Mingo, Iowa; and Mame, Iowa; Bijou Hills, S. D. At Bijou seven lives were lost and two fatally injured. Near Keosauqua, Iowa, five persons were injured, one fatally. In Hamilton county, Nebraska, \$100,000 damage was done by wind, but no lives were lost. Michigan was swept yesterday by severe electric storms, many houses at St. Joseph, Benton Harbor and vicinity being struck by lightning. A violent storm in Chicago last night flooded the city and suburbs, causing much damage.

NINE PERSONS KILLED.  
Near Waterloo, Iowa, the road bed of the Burlington, Cedar Rapids & Northern railway was washed out by a cloudburst. The train from Chicago to Minneapolis ran into the washout. Nine persons were killed and twenty-three injured, most of them seriously.

The killed are: L. Arnold, lumberman, Minneapolis; W. A. McLaughlin, musician, Mich.; H. H. Sweet, Alton, Ill.; Will Schollman, Waterloo, Iowa; David Hall, Minneapolis; F. S. Carpenter, St. Louis; H. W. Hawkins, a Pullman conductor, George Wright, a train conductor one; unknown.

GREAT WESTERN WRECK.  
The Great Western passenger train from St. Paul was wrecked near Owelton, Iowa, by washout. One Pullman porter was killed and several of the passengers hurt.

GYPSY GIRL INJURED.  
Chicago, May 29.—In the terrible storm last night, at a Gypsy camp on Forty-seventh street and Western avenue, Oda Reed, a Gypsy girl of 14 years, was fatally injured.

THE PEACE CONFERENCE.  
The Hague, May 29.—A brief official record of the doings of the peace conference last week says:  
"Provisional proposals for mediation and arbitration have been submitted by the representatives of Russia, Great Britain, Italy and United States." The statement that the Americans submitted the arbitration proposal is incorrect. Their proposals for permanent tribunal are not ready, as the French translation is necessary. They will probably be submitted on Wednesday.

## CIVIL SERVICE RULES.

President McKinley Issues  
Amendments to Them.

Four Thousand Offices Released  
From Their Operation.

Debate on Revision of Dreyfus Case Be-  
fore Court of Cassation.

SANTA RITA COPPER MINES SOLD.

Washington, D. C., May 29.—President McKinley to-day issued the amendments to the civil service rules, which he has had under consideration for about a year. It releases from operation of civil service rules about 4,000 offices. Among such places are the following: Pension examining surgeons; Indians in service and not connected with the Indian school service; many places in the engineer department at large, the quartermaster department at large, the ordnance department at large of the war department. With reference to places outside of the war department service, it is provided that they shall be subject to the regulations provided by the secretary of war, approved by the president, thus placing these branches of the service on the same substantial basis as the navy yard service.

Numerous positions elsewhere under the civil service act, including many private secretaries, attorneys and various employees of the customs service, deputy collectors of internal revenue, certain teachers and finance clerks at large, postoffice inspectors, coal mine inspectors in territories, inspectors of the land office, superintendents of irrigation and logging in the Indian service, five special Indian agents and special agents for the allotment of the same, examiners of Indian timber lands, financial clerks in each Indian agency; agents and experts temporarily employed and all persons appointed by the president with confirmation of the senate are excepted from the requirements of the examination or registration.

"Manila, May 29.—The transports Ohio and Senator, with the Thirtieth Infantry, have just arrived. Private David R. Johnson, Company H, drowned; five men deserted at Honolulu. No other casualties."

Alaska Prospectors Meeting.

Seattle, Wash., May 29.—T. P. Robinson, of Oakland, Cal., who has just returned from the Copper River, Alaska, says eighty prospectors are missing. If not already dead they will die in the effort to reach civilization.

Moore pleaded guilty and the other two not guilty. The evidence showed that they were all equally culpable and they were given sixty days apiece in the county jail.

Petro Peres and Lucario Delgado, the two men who were arrested on the suspicion of having attempted to hold up John Mason, early Sunday morning near the Cocheti station, were found drunk and disorderly, as Mr. Mason reported to prosecute on the hold up charge. ### SAN FELIPE DE NERI.

Feast Celebrated in Old Albuquerque With Impressive Ceremonies.

LARGE CROWD IN ATTENDANCE.

Yesterday was a great day in the history of old town. It was the feast of San Felipe de Neri, the patron saint of Old Albuquerque and the priests and the people joined together to celebrate the occasion in a fitting and impressive manner. Many of the buildings had been decorated with red, white and blue bunting, the stars and stripes floated proudly from the flag pole adjoining the historic old guard house in the plaza, and the ancient tower presented a gala and festive appearance. The streets, too, were unusually clean and neat, thanks to the efforts of Justice Sefarino Crockett.

The celebration began Saturday night, when there were solemn vespers in the church and music by the First Regiment band on the streets. The services yesterday morning commenced with low mass at 7:30 a. m., which was followed by music by the band and solemn high mass at 9:30 a. m., attended by all the members of the congregation. At this service Father Duran delivered a homily on the feast of San Felipe de Neri, in which he gave a history of his life. San Felipe was a priest in Florence, Italy, in the sixteenth century and afterward went to Rome where he became a great churchman, founding several societies, which are flourishing at the present day.

Large crowds of people from the new town and neighboring towns wended their way to the old town in the afternoon to witness the parade through the streets, which took place at 4 o'clock. The procession was headed by the Children of Mary, a band of young girls dressed in white and wearing garlands of roses. They were followed by the societies of the church and old town carrying their banners, as follows: Society of Good Mothers, Children of Saint Aloysius, Society for Mutual Protection, the Catholic Union. Then came a choir of girls singing hymns, who were followed by four men carrying the image of San Felipe. The clergy and general public brought up the rear of the procession.

In the evening there was another impressive crowd to witness the celebration, which consisted of a pyrotechnic display and a program of music and speeches. There was a short church service, after which there was music by the band. Nestor Montoya then introduced Hon. O. N. Marron to deliver an address on "San Felipe de Neri." He spoke in English and Mr. Montoya acted as interpreter. Mr. Marron in opening referred to the fact that the people in all times have been prone to hero worship and to pay homage to those who are illustrious above their fellows. He referred to the heroes of civil and military life, paying glowing tribute to George Washington, Admiral Dewey and the heroes who fought for their country at Las Guasimas and San Juan. Likewise in church history, there were saints who, by their great and pious deeds, had won the admiration of the world. High in the category of Catholic church saints, by the side of the names of Xavier and St. Basil, he placed the name of San Felipe de Neri, the patron saint of Old Albuquerque. The sentiments of Mr. Marron's short address were frequently applauded.

A large chorus of girls sang the San Felipe de Neri hymn in Spanish and then Hon. Nestor Montoya was introduced by Father Person to speak to the multitude in Spanish. He referred briefly to the life and works of San Felipe de Neri and pronounced an eulogium upon Pope Leo XIII, whose grace and piety, he said, are admired by Protestant and Catholic alike. Mr. Montoya is one of the school directors of Old Albuquerque, and it was in his talk on education that his address reached its climax. To educate the children in the principles of true religion and inculcate in them the love of country, of its flag and free institutions, he declared to be the paramount duty of the parent, a sentiment which was loudly applauded. The exercises closed with the singing of hymns by a chorus of girls and young ladies.

Although there was a vast crowd in attendance at the celebration yesterday, the best of order prevailed and there was not a single disagreeable incident to mar the pleasure of the occasion. After the public exercises, the ball given at Botter's Sunnyside Inn and at the orchestra hall were largely patronized by persons who are fond of dancing. A delightful social time was had until far into the morning at both places. Next Sunday the holy sacrament of Corpus Christi will be observed in the old town. Altars will be erected in different parts of the town, where the persons carrying the sacrament can rest from time to time during the parade.

The Board of County Commissioners of Bernalillo county will receive sealed proposals for the furnishing of all material and the construction of a bridge over the Rio Grande near the village of Cochiti. Said sealed proposals will be received at the office of the clerk of said board of county commissioners at Albuquerque up to the hour of 12 o'clock noon of June 5, 1906, and will be opened on that day.

Bidders will submit their proposals complete and detailed plans and specifications for the bridge proposed to be constructed, and shall state the price to be charged for furnishing the material and constructing the said bridge in accordance with the plans and specifications as submitted. With each proposal should be presented a bond of undertaking with good and sufficient security in the sum of two thousand dollars, conditioned for the faithful execution of the work proposed and the carrying into effect of any contract made in reference thereto.

Information as to location, length, height, width and general characteristics of said bridge may be had on application to Jas. A. Sommer, county clerk, or to Edward A. Pearson, county surveyor of Bernalillo county, N. M., at Albuquerque.

The said bridge is to be constructed under and by virtue of the authority conferred upon the board of county commissioners of Bernalillo county by an act of the Thirty-third legislature, known as substitute for H. B. No. 21, relating to bridges, and the construction of the proposed bridge shall be in accordance with the provisions of said act.

The board of county commissioners reserves the right to reject any or all proposals, and to accept of such as it may deem proper. For further particulars, see the Board of County Commissioners, Albuquerque, N. M., May 28, 1906.

INFORMATION FOR BIDDERS. The highway bridge, for which proposals are invited by the board of county commissioners of Bernalillo county, is located eight miles from Pecos and distant eight miles from Pecos from Thornton station on the Atchison, Topeka & Santa Fe railway.

The bridge and approach will have a total length of 750 feet. Six hundred feet will be of trusses of the cantilever type, and 150 feet of approach built on piles.

The bridge will have a width of roadway of 24 feet. The height of the bridge over the river will vary from six to twelve feet. No span will be less than 100 feet. Bids should be per foot of truss and per foot of approach.
