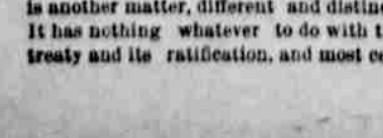

A PIONEER GONE.

Christian Flury, a Pioneer of Silver City, Died Sunday of Pneumonia.

Christian Flury, aged 61 years, died Sunday evening at his residence at old Fort Bliss, of pneumonia, after an illness of three days, says the El Paso Times.

Mr. Flury was a native of Switzerland, and spoke five languages. After receiving his education in Switzerland, he spent some years in Italy and Austria, and emigrated to South America in 1850, and located in Buenos Ayres. Four years later he crossed the Atlantic, and spent some years in Chile, Bolivia and Colombia. After acquiring a coffee plantation in the latter republic, he was forced to leave by reason of ill health, and he came to New Mexico in 1860, where he experienced the hardships of the early settlers, who had acquired ranches and cattle in that vicinity, and were afterwards forced to flee to town with their wives and children to save their lives from the murderous Apaches.

Mr. Flury owned a large ranch near Silver City, and he had been in charge of his own property for many years, and while he moved to El Paso to give his younger children the opportunity to attend school.

He was a man of rare simplicity and kindness, and possessed a most lovable character. He leaves a wife and five children to mourn his loss.

NARROW ESCAPE.

Engine Bursts in Alamogordo Saw Mill—Fragments Thrown in All Directions.

Yesterday afternoon at 5 o'clock the monster engine of the Alamogordo saw mill burst, sending fragments of steel in every direction with terrific force. By a miracle the engine escaped unharmed.

The extent of damage done could not be learned, but operations will be suspended for at least a month.

Mr. and Mrs. J. J. Kelly and F. R. O'Brien, who had just entered the engine room on a tour of inspection, were standing watching the revolutions of the fly-wheel when the explosion occurred. They beat a hasty retreat, but not before the room was filled with steam, making their situation for a few moments most perilous.

The terrible noise made by the explosion attracted about 100 people—El Paso Graphic, Jan. 21.

It is learned that it will require three weeks before the Alamogordo saw mill will again be in operation.

The cylinder head that blew out from the engine was a crack was noticed in that part of the machine when the cylinder was in its normal position.
