Ross Otero has made a signal failure with his pardon bureau.

Votes the straight republican ticket next Tuesday, and you will make no mistake.

Mr. FERGUSON is sure of carrying only five of the eighteen counties in this territory next Tuesday.

The only defectors this county ever had are now out with M. S. Otero about in economy and reform.

The people of San Miguel county will have an able representative in the territorial council if they elect James S. Duncan.

THOS. S. HUBBELL will have two or three thousand majority next Tuesday. He is the best sheriff this county has ever had.

The fight the Democrat is making on Thos. A. Finckel is liable to give the gentleman an increased majority in this city next Tuesday.

PEDRO PEREA has gained votes in every county in the territory the past week, and will be elected next Tuesday by at least 2,000 majority.

RIO ARriba county will give Pedro Perea at least 500 majority, and Thomas D. Burns, republican nominee for the council, may have 1,000 majority in that county.

HON. BERNARD S. BOBBY is doing good work for the whole republican ticket. He is one of the best speakers in the territory, and he has good arguments why Pedro Perea should be elected.

It is reported to this office from Las Cruces that Mr. Ferguson is making speeches against the ditch in this valley, while he is commended by his friends here as in favor of the enterprise, all of which proves that Ferguson is an adroit straddler.

THE SANTA FE Pacific shop men have a tangible evidence of republican prosperity. There are now about seven hundred employees in the big shops, while at one time during the Cleveland calamity period the works were entirely shut down.

THE TERRITORIAL board of equalization is composed of democrats and republicans, and the editor of this paper is one of that board. The board held meetings twice a year at Santa Fe and receive a salary of \$80 a year for their services. A new board will be appointed by Governor Otero in January.

LAST spring Mr. Grant hired a number of men to work on his corporation plants. On the morning of the election he discharged all who would not vote as he desired, and a few days after the election discharged all the rest. This is one of the reform methods of carrying an election that will not win next Tuesday.

In the appointment of the various boards of this territory the governor is empowered by law to select the members of them from the different political parties. This is why a few republicans in the territory are members of the board of regents of the university and the other public institutions of the territory. At present the majority of each board is democratic. After the next meeting of the legislature, the majority of each one of the territorial boards will be republican.

**COMPETEST CLERK.**

James A. Summers, republican nominee for county clerk has resided in this city since 1882. He has acted as deputy county clerk the past eleven years, and is one of the best informed men in the

county and certainly the best qualified man to be found for the position. He has perfected himself in all the details of the office, and just such a man is needed there to see to it that county affairs are properly conducted. Mr. Summers deserves every vote in the county for clerk, and will be elected by an immense majority.

**BUNDLE OF RECORDS.**

Perfecto Armijo in a signed card tries to explain away his shortage to this county, created while he was sheriff from 1880 to 1884. He makes a sorry band at explanations. In fact, he does not explain at all. He charges something about the records being stolen and taken to Bernalillo in 1882. Those records were removed to Bernalillo, so this paper is informed, by an election and afterwards were removed back to Albuquerque by another election. At that election, in 1882, Perfecto Armijo was elected sheriff, running on the people's ticket against the republican ticket. His party stuffed the ballot box in this city that year, casting about 1,000 fraudulent votes. A contest followed, and all the details of the gigantic fraud were thoroughly ventilated, and those elected by the ballots of the legal voters were given their offices by the courts. Perfecto Armijo's office was not contested, and he served through the term from 1882 to 1884. After securing their offices, J. R. Armijo and the other republican commissioners removed the records to this city, occupying offices on south second street in the Miller building. When M. S. Otero was elected a commissioner, he and Mr. Cronwell, another commissioner, located the court house in old town, and bonds were issued to erect the building. During Mr. J. R. Armijo's term as commissioner the accounts of Sheriff Armijo were investigated and a large shortage discovered. When Mr. Otero was elected this shortage was cancelled, to the great financial injury of Bernalillo county. These are the facts in the matter as it made plain by the county records.

Six years ago the republicans controlled the legislature, and passed a law reducing the salaries of county officials. Four years ago the democrats stole the legislature and promptly repealed the bill. Two years ago the republicans controlled the legislature by a majority of one, and passed a fee and salary bill, cutting down all sorts of county expenses and reducing the salaries of county officials at least one-half. If the democrats succeed in electing a majority of the legislature next Tuesday, Felix Martinez and the notorious Larraguna of Rio Arriba county will be in charge, and the laws reducing expenses will be repealed. There is no doubt about this.

This shameful sale of the democratic party to M. S. Otero has disgusted a large number of democrats in this city. They have no ticket, and many of them assert that they will not deliver to a factional republican ticket. H. B. Ferguson is the only democratic nominee before the people of this county, and next Tuesday he will realize the lonesome position in which he is placed by the action of his party managers.

PERFECTO ARMILLO should investigate things before he signs cards. He states that Justo Armijo is chairman of the republican central committee. Frank A. Hubbell is the chairman of the republican committee of this county. Perfecto should read cards before he signs them. His statement is a bundle of misstatements from beginning to end.

THE CHRONIC sorehead kickers are relieving themselves of a great deal of venom during this campaign. They are proud in falsehood, expert in plotting and adept in ordinary provarication. They state a falsehood with the gravity of solid truth, and all join in retelling the canard with an energy deserving commendation.

THE VOTERS of Valencia county are urged to turn out and give Pedro Perea a big majority. There is no opposition to the republican ticket in that county, and it is hard to arouse enough enthusiasm to get out the full vote. However, it is safe to say that old reliable Valencia will give Mr. Perea at least 1,500 majority.

In a signed card Perfecto Armijo asserts that he ran for assessor six years ago, and that THE CITIZEN supported him. Six years ago Perfecto ran for sheriff and was defeated, and this paper opposed him and did everything it could to help snow him under.

VOTERS in this county are requested to read the able speech of Thos. B. Catron, delivered in this city before the recent republican county convention. Mr. Catron shows up the straddling politician record of Mr. Ferguson in a forcible manner.

THE CITIZEN incidentally mentioned a few days ago that M. S. Otero, when county commissioner, cancelled the shortage of Perfecto Armijo while sheriff of this county. The sum was not much; only about \$30,000.

THE PRELUDE of Lamy, Santa Fe county, is almost sold for Perea and the county ticket. Felix Martinez was there a few days ago, and was announced to speak, but could get no crowd, and held no meeting.

THE SORERHEADS in this county have descended to a mud-slinging campaign. Voters are urged to pay no attention to political doggers and slanders as reports issued on the eve of the election.

THE DEMOCRAT went deaf staring it in the face, and has been excited and indulged in wild statements and rotten billingsgate.

THE DEMOCRAT this morning publishes at least a dozen absolute falsehoods against Pedro Perea.

Should the Soldiers Say Here Seal Skins Will Not Be Provided.

BUT THE TERMS ARE POOR CONSOLATION.

Camp Hamilton, N. M., Oct. 31.—Since the last dispatches had been sent away over the entire camp in the prospect of removal from here have increased, and we are daily anticipating an order to "cut the tent" and "pack the gear."

The reason for our retention here has been an account of the yellow fever epidemic (further south), and it seems to be the intention of the authorities at Washington to use the greatest precautions and are well warranted in their restrictions have been removed from the various infected districts before they and us in a hotter climate.

Of course the citizens of Lexington are persistently advocating the establishment of a permanent camp here, which enhances the possibility of a fixed post being made of the camp in the near future. They have started a subscription to erect quarters to accomplish this end.

On last Wednesday evening a great general of the various regiments left for the south to select some place for our winter habitation. At Atlanta they took separate routes to their respective points to look over the ground, and their reports have been already forwarded to Washington. A detachment of pioneer corps will follow as soon as the location is made to do the work before our regiments are moved.

The troops are becoming impatient and restless under this suspense, and would gladly welcome a change, notwithstanding the fact that there is a lot of hard work attached to establishing a new post.

A number of the boys of the Second Missouri have their fatigue hats adorned with lettering, which run about as follows: "Chickasawita Land and Improvement Company," "Chickasawita Park," "Rheumatic route," etc., on account of the labor they expended in beautifying and removing all stumps from that park. Now the first battalion of the Third Engineer Corps, who are expert workmen in bridge construction, road making and grading, have been assigned to the same work, and are now transforming a dilapidated farm in Woodford county, near the high bridge on the Chickasawita and Ohio in this state into a model park. The boys of the first territorial who have never been used to hard laborous work are grinning and bearing this ordeal like veterans, without the aid of any salve or ointment or grease that is usually prescribed for sore joints, lame backs and sprains.

Now fell on last Wednesday, the first of the season, accompanied by a driving rain, which penetrated to the very marrow of one's bones, making us all shiver and weep for our New Mexico homes, and well—for those dear girls who are away from the room warm when we call in the evening. The order for the "ditch" stoves was evidently countermanded, as they have not yet arrived, and the boys contented themselves on that day by rolling up in blankets, as in Klondike, and hibernating until the sun made its appearance.

Charley McDonald, who was detailed to do clerical work in the regimental aid station's office, detailed last week from the United States volunteers last week on account of disability, or "dread" feeling of soldiering for nothing (a complaint we are all all right with) and went to New York to visit friends. After a short stay there he will return to Albuquerque to enjoy life once more. A strong guard should be placed over his affairs, for Charley has consumed bread and beans until he has the "bites" grievous for goodies.

Sergeant Harding, has improved much of late that he will apply for a thirty day furlough. He will leave for Denver to visit his mother and relatives, and M. C. H. is not as enthusiastic as he was during the last day of June, when Sampson and Schley with their fleets were having a hot time at Santiago.

The Santa Fe, Las Vegas, Las Cruces and Albuquerque companies, which comprise the First battalion of this regiment are being drilled by Captain J. Bernalillo, who occupies Lieutenant Colonel Mitchell's position when Colonel McCord is absent. Colonel Mitchell taking command of the regiment.

William Chamberlain is no longer addressed as "Humpty Dumpty" by the high privates in the rear ranks on account of his accident to a corporal's ship. All the lately appointed corporals are men and are highly respected by the boys.

Private Dunlap and Sniddecki, who were left at Whipple, the former a fever patient and the latter as head chef in the hospital, arrived here Friday evening. Dunlap had a relapse on the train and is now confined at the general hospital quite sick. Sniddecki is not a Hibernian by birth, but does lay claim to being an eagle tamer. The eagle either died, strayed or was stolen after he trained him to eat out of Whipple.

Our mess room has been christened "The Chinese Jook House." The company parts are taken by boys who don't like to see their name in print—hence I am silent.

Percy McRae is recovering slowly from his sickness, and this morning felt so much better that he asked permission to go out and eat at the convalescents table. It is reported that this camp also adopted the sick (those that can stand the trip) will be moved to Camp Thomas.

John Q. Royalty, who was a former member of the Santa Fe yards, is reported to be a very sick man, and Lieutenant Melton, who paid a visit to the general hospital this morning, says his

condition has been critical for the past several days, but is somewhat better at present writing.

A pete range of patients in the general hospital from the First battalion (New Mexico boys) is very small compared to the other companies. Out of a total of 53 sick there, Albuquerque, Company K, has 4; Santa Fe, company G, 2; Las Cruces, company H, 2; and Las Vegas, company F, none.

Several of the boys are having their photos taken to-day—some in full marching order, others in plain fatigue uniform, and a few with white shirts and standing collars, which are invisible.

The "volunteer set" (the non-commissioned officers, and they are a handsome, athletic set) all crowned their faces with winking smiles and had a group taken. These photos will come high, even if some of them are under medium height.

To-day was muster day also, when the rolls must be signed and a lot of red tape gone through with in order that we may draw the minimum sum of \$16.00 a month.

An effort is being made by the citizens of Lexington to have President McKinley visit Lexington and Camp Hamilton, probably with the view of having him recommend this place as a permanent post.
