Russia Will Endeavor to Secure a Settlement.

The Santa Fe Reduces Rates From Colorado to New Mexico.

President Names Nov. 24 as a Day For National Thanksgiving.

EVERYTHING QUIET IN CHINA.

London, Oct. 27.—The Pall Mall Gazette this afternoon summarizes the result of the British cabinet meeting yesterday as follows: "The cabinet has decided to proceed with the Fashoda question, and to make no undertaking or promise can be given to discuss the questions raised by France in this regard except as to the Nile and such like. When Marchand has withdrawn, it will be determined whether the question raised admits discussion and under what conditions the discussion can be proceeded with. If Marchand is not withdrawn there will be no interference with his remaining at Fashoda or a date fixed for his withdrawal. No military reinforcements will not be permitted to reach him. He will be treated courteously as a foreign visitor and be regarded in no other light. Therefore it is left to France to adopt any active measures to precipitate the conflict."

The Pall Mall Gazette adds it has good reason to believe that Russia has promised to throw its weight in the scale, at no distant date, for the purpose of bringing the whole question of British occupation of Egypt to the front for settlement.

MARCHAND AT FASHODA.

Paris, Oct. 28.—The French foreign office has received a dispatch from its diplomatic agency at Cairo announcing that Major Marchand has arrived at Khartoum from Fashoda.

Major Marchand being it necessary to personally bring to Cairo the unfinished portion of his report. Captain Germain was left in command of the French mission at Fashoda.

Seneca Lake, N. Y., Oct. 28.—The steamer "C. D. Dyer," which was lost during the recent great storm on Lake Michigan, was owned by the Cuyahoga Transit Co., of this city. She carried a crew of sixteen men. Among the lost are: Chester Smith, engineer; Henry Sharp, first mate; W. J. Housie, second mate; Thomas A. Barnaby, engineer. The steamer was insured for \$100,000.

REDUCED TARIFF RATES.

The Santa Fe Gives Colorado a Big Advantage For New Mexico Trade.

Denver, Oct. 28.—In compliance with the request of the Colorado business men who visited in their efforts to extend their business into New Mexico, the Santa Fe to-day issued new tariff rates from Colorado common points into New Mexico far below the old rates. Though printed copies of the new tariff reached the local office only this morning, the low rates have been in effect since September 1. No publicity was given the matter when the rates were first announced for fear the Chicago and Missouri river shippers would become antagonistic.

Orders already have been given to the gunboat Helena to prepare for the trip through the Suez canal to the far east. She will start next week. Rear-Admiral Dewey has impressed upon the department the necessity of having a large number of light draught gunboats among the Philippine islands. The Yorktown, it is understood, will be placed in commission at the Pacific coast, and will start for Manila. In addition to these gunboats, it will be necessary for the department within a few months to send an auxiliary cruiser carrying another draft of men to take the places of those on the Asiatic station whose terms of enlistment have expired."

The Gunboat Helena.

Washington, Oct. 28.—The gunboat Helena was built with especial reference to usefulness in the shallow Chinese waters. It is expected she will sail about the first of November for China, by way of the Suez canal. An agreement has been made by the United States government that in case of resumption of hostilities with Spain the Helena shall not be used against that country.
